# James Walsh, Oracle Historical Society present history of Arizona's first governor

George Wiley Paul Hunt: his life, accomplishments, experiences and death.

These were the topics of a talk given by James Walsh at the Oracle Historical Society on Sunday, Sept. 25.

Walsh, who served as the Pinal County Attorney and was a Constitution professor at ASU, visited the society on Sunday to give a talk on the biography of George Hunt and his seven terms as Arizona's first governor.

George Hunt was a heavy-set man and also had a handlebar mustache. Walsh said because of his mustache he was supposedly known in some instances as "Curly."

According to Walsh, Hunt was not the kind of person who could just escape your notice.

"This is not a fellow you're going to miss on the street," said Walsh.

Walsh said Hunt served overseas, he was an electoral mediator, a territorial legislator, and "a great friend of labor."

Walsh said that some of the views Hunt expressed even during his terms of office in the 1910s and 1920s would be even considered radical today.

Walsh said Hunt was born in November, 1859 in Huntsville, Missouri into an agricultural community. According to Walsh, Huntsville was named after Hunt's grandfather.

"He was a person of his times," said Walsh, "regardless of how he considered himself as both a lowercase and capital P 'Progressive.'"

Walsh said Hunt couldn't afford a textbook which caused him to fail a class which later in life caused him to support education and free textbooks.

Hunt eventually made it to Eastern Arizona by walking and then train hopping through several states, Walsh said. He tried his hand at mining with

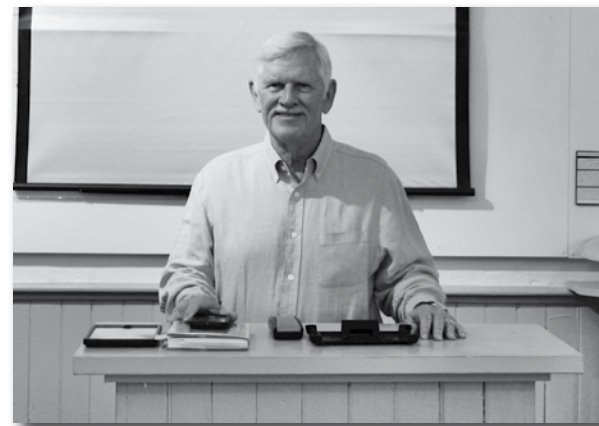
another man he met, but it didn't work out. He traded for a burro, and used that to ride into Globe in 1881. He was about 22 or 23 at this point.

This is where Hunt spent the majority of the rest of his life other than leaving to California for a couple of years and working abroad in Siam.

Walsh continued by saying Hunt worked in a couple of jobs when he got to Globe. He was a waiter, a mucker for the mines and he worked in a general store, AE Bailey when he got back from California.

"He never forgot how hard working in a mine was

# Coming Soon: Apache Sky Casino

Residents of the Copper Corridor will soon have a new entertainment venue to visit – the Apache Sky Casino in the Dudleyville/Mammoth area. The San Carlos Apache Tribe is investing in the construction of a new casino for their tribe and they anticipate that the casino will open in the temporary building no later than mid January 2017.

“We are hoping for a mid December opening,” Kurt Schmidt Interim COO for Apache Gold Casino told *Copper Area*

*News.*

Late summer monsoon storms have delayed some of the construction.

The tribe anticipates that the casino will have about 200 employees. The long term plan for Apache Sky includes a hotel and RV Park. The temporary building will also house a full service bar and food court park.

The majority of the needed infrastructure is being built in this first phase of construction which will allow the tribe to build the more permanent structures as the casino gains in popularity.

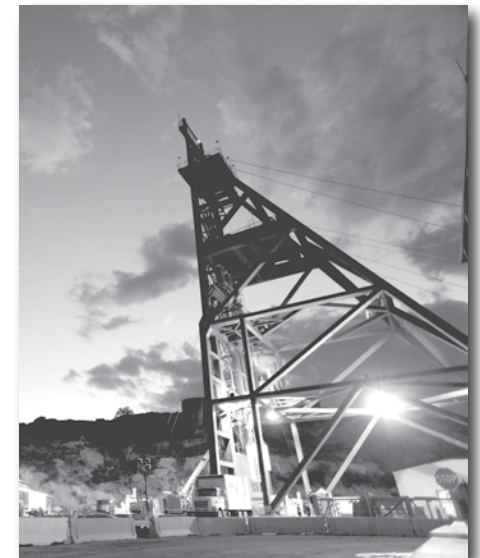

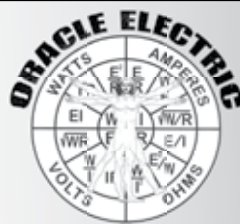

# San Manuel Elks pass grant on to local scout troop

## Apache Jii is Saturday in Globe

The downtown corridor of historic Globe will be a pageant of color and sound on Saturday, Oct. 15, 2016 as the 33rd annual Apache Jii (Day) celebration gets under way.

A full day of entertainment, arts and crafts booths and savory foods is planned for the event, which will be held in front of the historic courthouse in downtown Globe. Tribal royalty in full traditional dress and native entertainers from flute players to hoop dancers will be on hand for a day packed with activities.

The day begins in the courthouse square at the corner of Broad and Oak, one block east of the US 60 highway. Opening ceremonies begin at 9 and then it's on to a full day of entertainment, shopping and native foods.

Booths featuring jewelry, painting, beading, wood and stone carving and more are planned for the street fair. Several

demonstration booths are planned with artists showing the intricacies of beading, rock work and weaving. Entertainment, including crown dancers, b dancers and native flute players, is planned throughout the day and no one will go hungry if they stop by the food booths which will feature everything from delicious Apache fry bread and Indian tacos to more traditional dishes like acorn stew.

Live art demonstrations by three young artists will be under way at 10 am; these large scale works will take form throughout the day in a special demonstration area.

There is no admission charge for Apache Jii; the festival has grown every year and offers a unique chance for visitors to talk one-on-one with Native Americans from throughout the Southwest. There is nothing like choosing a piece of jewelry or

# Miners notch first win of season on Senior Night

The San Manuel football team celebrated its seniors in style by earning its first win of the season, defeating visiting Willcox last Friday night, 20 – 12. The loss ended

a 14-game losing streak that dated back to last season. "Our defense stepped it up and came together as a unit," San Manuel head coach Daniel Williams said after the game. "They basically produced the win."

Antonio Gallego, one of seven seniors playing his final home game for the Miners, started the scoring when he returned a blocked punt for a touchdown.

Freshman Benny Laguna scored a rushing touchdown on a reverse and junior running back Christian Velasquez,

who ran for 116 of the Miners' 213 rushing yards in the game, also scored a touchdown.

Gabe Velasquez, a junior, led the defense with a team-high 10 tackles, which included two of the Miners' three sacks in the game. His brother, Christian, had the other sack. Freshman Cesar Guerrero picked off two Cowboys' passes while Gallego recovered a fumble and blocked a field goal in addition to his touchdown return, which was set up by Armando Estrada's punt block.

Other seniors honored on Senior Night, in addition to Gallego, included Christian Ramirez, Andrew Gomez, Matt Franco, Nikita Buzan, Roy Cline and Robert Allison.

The Miners' will look to make it two wins in-a-row when they renew an old-time rivalry with Hayden in a very unique game this Friday in Winkelman.

Kickoff is scheduled for 7 p.m.

"It's a pretty big rivalry for the schools because Hayden used to play 11-man

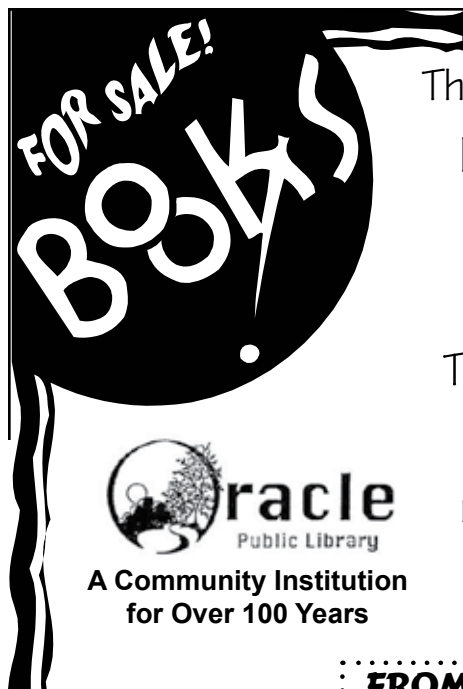

and he had a great deal of sympathy for the workers in Arizona, particularly the miners," said Walsh.

After working at the store for 10 years, which became a bank, he became the president of the store.

"He had really risen to the top of that company and really to the social and economic heights of Globe," said Walsh.

Walsh said Hunt always had an interest in what was going on in town, and in the 1892 election, he ran for the Gila County recorder and lost.

A couple of years later, he was a member of the Arizona Legislature as a representative for Gila County. This is what started his political career.

Hunt did go around speaking and meeting people, but his opponents called him illiterate and uneducated.

"He was no Jack Kennedy," said Walsh.

Hunt was re-elected twice before being elected to the Arizona Council as the president of the council in 1900. He went back to the legislature in 1904 and

then got married. In 1910, Hunt then gets elected as president of the Arizona Constitutional Convention, right around the time Arizona was in the process of becoming a state. When Arizona was finally made into a state, Hunt was sworn in as Governor.

"Hunt was a pretty active governor," said Walsh.

Hunt held this position through the 1920s. However, during these years, Hunt was sent out to Siam to represent Arizona abroad.

During his terms as governor, Walsh said, Hunt had pretty liberal ideas for that time.

"He was a regular bleeding-heart," he said.

One of the bills that Hunt did sign during his term as governor, was a segregation law. "This was a law that said that if you have a school district with six or more African Americans, you had to have a separate law for those students," explained Walsh.

The year 1916 was an interesting year for Hunt, Walsh said. The miners were very much against Hunt at this time and during the 1916 election, a mining engineer, Thomas Campbell, was running against Hunt.

"When the dust cleared after the election), Campbell had 30 more votes than Hunt," said Walsh.

After many re-votes, moving into January, the Supreme Court mandated that Hunt get out of Campbell's office, since he won. But, in December 1917, the Supreme Court finally said that Hunt was the winner by 47 votes.

"We had close to a year where Campbell was serving as acting governor," said Walsh.

During his 1918 term, Hunt was accused of being pro-German and anti-American during WWI.

"He was a supporter of our troops," said Walsh,

After 1918, Hunt did not run for governor again but he was later appointed as

"administer potentiary" to the court of Siam, which is known today as Thailand. He then moved to Siam. Walsh said that while Hunt was in Siam, he was writing to people in Arizona "establishing his connections."

Hunt did come back to Arizona in 1922. He gets re-elected again. He then runs in 1924 and 1926 and wins.

Hunt was the Governor of Arizona in 1912, 1914, 1916, 1922, 1924 and 1926. By the time 1926 rolls around, Hunt began to have health problems, Walsh said. Hunt lost in 1928 to John Phillips, a Phoenix lawyer. Walsh said the 1918 term doesn't count since Campbell was in acting office.

Hunt then moved back to Siam to take a break and then comes back again to Arizona.

He gets elected for his seventh term in 1930, which was his final term in office. He loses in 1932 and 1934.

Hunt's wife died in 1931 in Globe and then Hunt passed away on Christmas Eve in 1934.

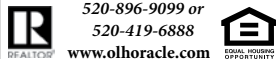

State Championship Meet in November. The Girls 200 Freestyle Relay Team of Darien Apuron, BaiLee Hill, Raya Woods, and Gianna Sweeney swam a season's best time of 2:01.62 which is not fast enough to qualify for State yet, but getting very close. The Boys 200 Freestyle Relay Team of Colbey Stratton, Michael Primero-Predgo, Michael Garcia, and Robert Sweeney swam an outstanding time of 1:41.96 which is likely good enough to get them to the State Championship. The Girls 400 Freestyle Relay team of Gianna Sweeney, Darien Apuron, Bonnie Bridges, and Raya Woods swam a season best time of 4:35.15 to keep ranked in the top 16. The Boys 400 Freestyle Relay had already posted a great time at qualifying meet in September, but showed that they have the firepower to finish in the top 8 at State. The relay team of Colbey Stratton, Michael Primero-Predgo, Michael Garcia, and Robert Sweeney swam a time of 3:47.22 which was 9 seconds faster than their September time.

In addition to great relay swims, Miner Swimmers had many great individual performances. The fastest 24 swimmers in each event will compete at the State Championship Meet. Robert Sweeney had two very good swims in the 200 Freestyle (2:03.95) and 500 Freestyle (5:45.34), both of which will most likely be good enough to swim at State. Colbey Stratton

swam the 100 Butterfly in a time of 1:00.81 which will get him a spot at the State Meet.

Some of the most outstanding swims came from the Sophomore Girls. Darien Apuron had already qualified for the 100 Butterfly and 100 Backstroke, while Gianna Sweeney had already qualified for the 200 IM, 100 Breaststroke, and 100 Freestyle. Darien Apuron swam a very good 200 Individual Medley (IM) to get a time of 2:27.14 which is good enough for a top 10 ranking in the State. Coach Alex commented on his excitement with the fact that Miners could have two girls (Apuron and Sweeney) ranked in the top 10 in the IM "The 200 IM is the all-around event in swimming and to have two Miners ranked so high is quite an accomplishment". Apuron went on to swim an incredible 100 Butterfly to better her school record to 1:04.48 and also rank her in the top 10.

Gianna Sweeney looked to expand her choices by swimming the 50 and 500 Freestyle events. Sweeney swam both races in school record times; 26.58 in the 50 Freestyle and 5:46.94 in the 500 Freestyle. Both times were good enough to qualify for State and will give Sweeney the luxury of having choices when it comes to selecting her events for State.

The next competition for the Miners will be the TGS Hawks Swim Invitational on Saturday, Oct. 15, at the Amphitheater pool at 9 a.m.
