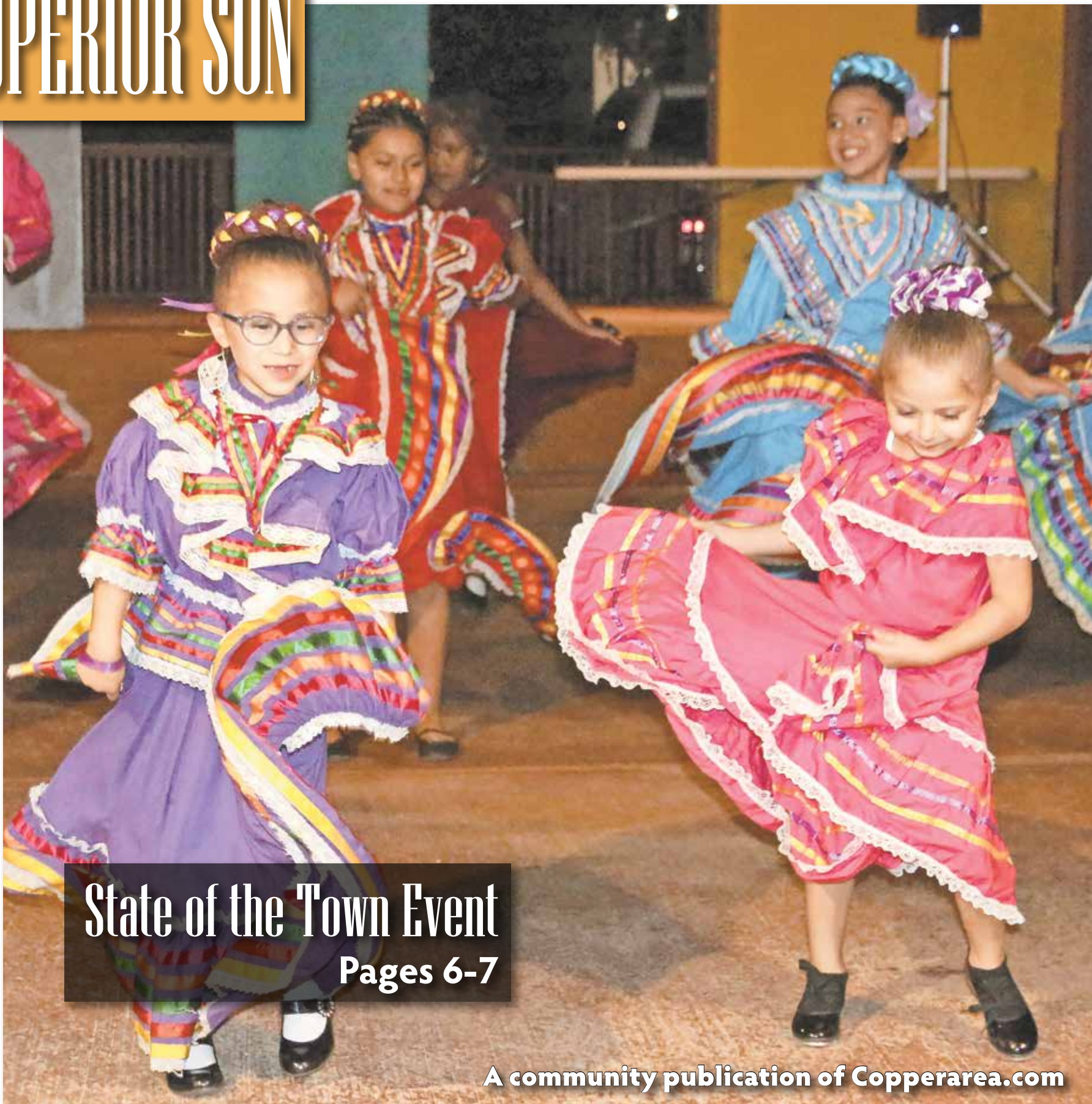
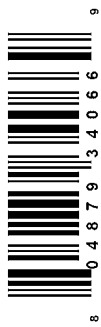

Angelina Flores.

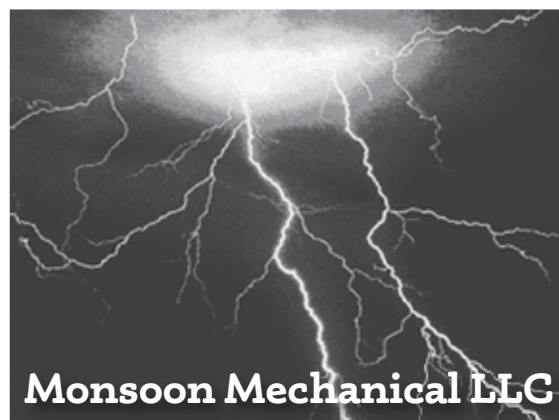
A memorial service was held on Aug. 29, 2022, at the

# Support for Proposition 469 from Mayor Mila Besich

**P**inal County is growing, there is no doubt it. We can no longer continue to assume that the transit corridors of the past will lead us into the future. In order to develop the infrastructure we need for the future, we must fund the plan on our own; we can no longer continue to wait for grants or state funding. We must take action of our own

to preserve our future.

The transportation plan that Pinal County voters approved in 2017 provides funding for projects across Pinal County, and even provides direct local roads funding for our smallest and older towns such as my community of Superior, Arizona. For Town's like Superior, Kearny, Mammoth and Eloy,

Proposition 469 will be a tremendous boost to our local road budgets bringing in \$450,000 a year. This will allow these tiny towns to repair and maintain their roadways. For Superior, this will mean we can accelerate our road maintenance and preservation plan, which likely will include full road replacements in some high traffic areas.

Superior and all of Pinal County needs to address our transportation infrastructure urgently. I encourage you to please support Prop. 469 and help us ensure we have the infrastructure to take us well into the future.

# Rebuild Superior Hosts

October is one of my favorite months. The weather cools off; the leaves begin to change. There are so many reasons and events to gather with friends and family. But one of my newest favorite traditions is our annual State of the Town event.

Last week we hosted our second annual State of the Town event. This annual tradition is hosted and coordinated by Rebuild Superior Inc. along with the support of many sponsors. This year we celebrated Superior's 140th Anniversary of being founded – the theme "Celebrating 140 Years of the Superior Spirit."

During my remarks I explained the progress being made on the multi-gen center at the original Superior High School and further elaborated on the Queen Creek Restoration project. Residents can expect to see a test release of water in the creek sometime in November. These are just two of the major projects we are working on in the community.

Next month, we are expected to break ground on the major improvements to

the Waste Water Treatment plant, these improvements will save us money on costly repairs and utilities. They will also help us as the community grows as we can expand capacity as needed.

During my remarks I also shared that the Town of Superior will be purchasing 546 acres of land from the federal government in the Summer of 2023. These lands are also known as the land exchange parcels, connected to the Southeast Arizona Land Exchange and Conservation Act approved by Congress in 2014. As the town of Superior acquires this land, we will all need to be involved to plan how this land will best be used so as we boom, we boom mindfully and with intention to ensure Superior grows in a responsible way.

During the November election, voters in Pinal County will have Proposition 469 on their ballots. I encourage all voters to vote yes on this important proposition. This sales tax will generate much needed funding for local road projects for Superior and larger road projects for the entire county. For Superior, this tax will generate

10.9 million dollars for our local road improvement projects. We will host an open house on Thursday, Oct. 13, 2022, at 6 p.m. at the Superior Town Hall, I encourage you to learn more.

All of our recent accomplishments and growth in the community, comes after many years of collaboration with all of our community organizations and all of our community leaders, committing to working together. We also could not do this if there was not private investment from Resolution Copper and other companies making investments in Superior.

As I wrote those remarks, I was able to study a bit more of our community history and reminisce about how far we have come in the past decade! Superior has a unique spirit of resilience, grit, determination, generosity and family. I am proud to serve as the Mayor of Superior.

Now is an important time in our community – it is a time when likely our future never looked brighter. Now is the time to get involved in the community. Find one of our local clubs to get involved
