There were several statements in Mr. Aguirre's opinion piece that are misleading concerning the signs, closure of the Aravaipa campus, and state funding to Central Arizona College (CAC).

19, 2015 meeting thus the 45% was used. On June 9, the CAC Board of Governors (BOG) voted to change the outrageous tax increase to 20%. Due to the expense of these signs we crossed out the 45%, and wrote in 20%. There is a clearer picture of this sign on Twitter, go to search, type in 'sign recall petition', then scroll down to Sept. 18. In addition, flyers were distributed to Oracle residents describing CAC's meetings for the tax increase. While in Oracle gathering signatures, there was one woman who did complain that the 20% was not obvious. She was informed that if she would bring a magic marker her concerns would be accommodated. She refused. Further, this particular woman stated that CFFT wanted to close the Aravaipa campus. Even after it was explained to her that her statement was patently untrue, she persisted in this accusation until she was instructed to leave. Concerning state funding, I'm reminded of an infamous quote from Mark Twain, "There are three kinds of lies: lies, damned lies, and statistics." By using information from 2006 it appears that the state has

fiscally abandoned CAC. Further, one of CAC's contentions to justify their most recent tax increase has been to place the blame on the lack of state funding. Interestingly the facts don't substantiate CAC's accusation. In 2014 CAC received \$2,023,900 (http://1.usa.gov/1VQHMuY) while in 2015 they received \$1,903,500 from the state (http://1.usa.gov/1LJ6Tu7 ) The difference in state aid from 2014 to 2015 was \$120,400. For example, this amount could have been replaced by using one less administrative position (salary = \$100,000 to \$200,000/year). CAC could also have replaced these monies with the 6% increase on our property tax assessments this year, which CAC automatically receives.

There's additional information that many may not know. In 2008 Pinal County voters agreed to let CAC obtain 98 million dollars in bond money which the taxpayers would ultimately have to repay. Personally my share of this bond money has increased 203% in 5 years, from 2010 to 2015. Of this bond money CAC irresponsibly spent \$8.3 million for the 203 acre

A big consideration for all of us is the news that the Town Council, after a work session and a special council meeting, voted to instruct staff to enter into discussions with the towns of Hayden, Winkelman, and Mammoth over the possibility of establishing a common police force.

The rough outline of the proposal is that an oversight board would be established. There would be one Chief of Police, a single dispatch center, and three sergeants to oversee permanent squads in Kearny, Hayden/Winkelman, and Mammoth. This would bring about great efficiencies in finances and equipment, and would provide improved training.

The Arizona Department of Public Safety would work with us and a coordinating board from the four towns to hone the proposal over a period of time. If the other

towns agree to proceed, I suspect that it will take at least a year to overcome all logistical and legal hurdles to bring this about. I do believe that this is something we should do, and that if we succeed in this, it will be a model for other rural police forces in Arizona. San Tan Valley campus. According to an October 12, 2011 article in the Wall Street Journal, Group Manages to Pull Off Desert Flip in Arizona, CAC spent \$43K/ac for much more land than needed for this campus. In January 2011 this land had been purchased for \$23K/acre. So in 9 months the original purchaser made \$20K/Ac. Further, CAC didn't even bother to have an appraisal performed. In addition one would have to question why a community college satellite campus needed so much acreage. Then there's the issue of recent tax increases. In 2013, the CAC BOG voted to increase property taxes by 35%. There was such an outcry from voters that three weeks later this particular increase was changed to 16%. As there isn't any oversight of CAC's tax

increases, they continue to increase taxes, burdening Pinal County taxpayers. In 5 years, from 2010 to 2015, my taxes for CAC have increased 57%. These are just a few of the fiscal issues that I had concerning CAC.

As many of us know there are always two or more sides to every story. The language on the sign was due to economic factors; we did cross out the 45% increase, changing it to 20%. CFFT does not advocate closing any campuses; however it does advocate that the CAC BOG be fiscally responsible to Pinal County taxpayers. CAC BOGs current tax increase is not due to a decrease in state funding.

# Hambly students learn about prickly pears

On Wednesday, Oct. 7, students at the Lenor Hambly School in Winkelman learned about the fruit of the prickly pear cactus. The 4th grade students and their teacher Cathy Cruz were given a presentation about the prickly pear by Charlie Allen of Aravaipa.

Charlie and his wife Jeau run the Mesquitery, Prickly Pops and Aravaipa Heirlooms. The Mesquitery sells mesquite flour and mesquite pancake and waffle mix. Prickly Pops are frozen treats made from local, wild and heirloom fruits. Aravaipa Heirlooms is a farm that grows and sells organically grown, non-GMO endangered, local and regional heirloom vegetable plants from the southwest and Mexico.

Charlie taught the class how to harvest the prickly pear, freeze them, dump them in

a bucket of water and stir them to remove the needles and thorns. The fruit is then steamed to defrost them. The thawed out fruit is then placed in a cider press where it is juiced. The juice is run through a series of filters to make sure all the tiny thorns are removed. It is then ready to drink or be turned into syrup or other products.

Charlie also told the kids about the health benefits of prickly pear juice which includes lowering blood sugar.

Cathy Cruz's class is preparing projects for the State Fair in Phoenix. Cathy said that Raimie Manch also helps the class. One of the projects, the monarch butterfly has already been turned in. The students prepared an exhibit explaining the butterfly's migration from Canada to Mexico. The monarchs stop along their way in the area surrounding Winkelman. The





# Mic Johson: Life in the POW Camps

worst" of the prison camps that Mic would experience.

The Woosung prison camp was made up of seven flimsy wooden barracks surrounded by barbed wire, an electric fence and four manned guard towers. There was no heat, no fresh water or plumbing. The men slept on wooden pallets. In the winter when temperatures got as low as the 20s, "you had to cuddle up with a couple of other guys to stay warm," said Mic.

For the first few months the prisoners were given a starvation diet. Mic described the meal as a vegetable soup type dish consisting of mostly a light broth with some vegetables; they were served rice with wood chips and pebbles in it and tea. The green tea was a blessing as the prisoners were warned not to drink the water from the well without boiling it due to contamination. Occasionally they received some meat or fish but protein in their diet was rare. The Japanese commissary only prepared enough food for 300 men although there were 1,500 prisoners. The POWs received a diet of 500 to 600 calories a day. Most of the prisoners lost an average of 60 pounds during their stay in this camp. Mic was one of them. He weighed 165 pounds when he was captured but got down to 107

The starvation diet, along with the poor sanitation, cold and cramped quarters led to the prisoners suffering from many diseases including dysentery, pellagra, constipation, and malaria.

"Everybody got malaria," said Mic.

Many died from malnutrition and disease, some from the brutality of a few of the guards. Mic said that many of the civilian workers were in their 50s and 60s. They had a harder time than the young men. Woosung "was the


The brutality and mistreatment of the POWs was partly a result of the military culture and Bushido the code of the samurai warrior. The Japanese soldier was taught that one accepted death before dishonor or defeat. Total obedience to the Emperor and their commanding officers was instilled in the Japanese soldier. Because the Americans had surrendered they were considered cowards and inferior. Their lives were meaningless and at the mercy and power of their captors. Mercy was considered a

weakness in a warrior.

Although some of the guards were indifferent towards the prisoners, most of them treated the POWs harshly. The slapping and striking of prisoners was common. Many prisoners received beatings for minor rule violations. Mic said he was beaten a few times. One Japanese became known as the "Beast of the East" for his sadistic treatment of the POWs. His name was Isamu Isihara. He was a civilian interpreter who insisted on being treated as an officer and saluted by the prisoners. He was known to fly into a rage without warning or reason and strike prisoners with a leather riding crop that contained a leaded handle. Isihara was later tried for war crimes and imprisoned.

Colonel Yuse was the camp commandant. He was known for his violent temper. He organized the prisoners into 10 man shooting squads. It was explained to the prisoners that if one man from the squad escaped, the other nine would be executed. Yuse died in March 1942 and was replaced by Colonel Otera. Otera, upon discovering a hole in a 100 pound bag of sugar and some sugar missing, ordered that all prisoners in the camp go without food for 72 hours.

Back in the United States, the families of the civilian workers did not know if their husbands, fathers or sons were still alive. They had heard about the battle of Wake Island but had not heard from them since December 1941. The dependents of the civilian workers now prisoners were also suffering as they no longer received the income from their providers. As the prisoners were no longer working, their pay stopped.

Mic and the other prisoners were finally allowed to write and receive letters at the end of May 1942. They were forced to salute the Beast of the East to receive their mail which took three to four months to get to them. Mic wrote his first letter home on May 30, 1942. He said he wrote and received over a dozen letters. He was lucky he said as some men never received any letters. The letters to and from the prisoners were censored by the Japanese and packages sent by family were pilfered by the guards especially if they contained food.

After nearly a year at Woosung, the prisoners were moved to another camp, Kiang Wang.
