# Saying thanks to Kearny's 'Energizer Bunny'

just stood there and looked important." That's a direct quote from Sergeant Dave Blue of Arizona's Department of Public Safety (the highway patrol) who is completing his special assignment this week as Interim Chief of Police for the Town of Kearny. That's the way he sees what he has done in his few months with us, but I would like to fill out what he means by that simple statement.

Sergeant Blue came to be with us through a special program of Arizona's Department of Public Safety. This program enables officers from the department to serve as interim chiefs of police, with a charge to explore the needs and concerns of the local department and to provide advice and leadership to the town. We heard about the program from the Town of Superior, which had made use of it and recommended it to us (Thank you, Margaret Gaston, now serving as Clerk and Manager for Superior).

Well, we got a lot more than we expected. Sergeant Blue reminds me of the Energizer Bunny, who "keeps going and going." In a matter of weeks he made his way into the

hearts of our department and was able, working with the people we already have, to make significant changes. Sergeant Blue did not merely command, he lead and encouraged.

There were material changes. In accord with state regulations, a new property and

evidence room was established and all back years were inventoried. A separate armory was developed and strict new standards established. One really helpful item is a new vehicle work order system. All vehicles were inventoried and repaired to meet state standards. The new work order system means that weekly and monthly the condition of all vehicles is known and maintained. This leads to considerable financial savings as well as increasing the readiness of all the vehicles.

There was much training for police officers, dispatchers, and EMS personnel and fire volunteers. The new training for Operations and Communications totaled thirty hours. Through it all, Sergeant Blue worked with everyone to developed a unified mission, to be "Team Kearny" with an emphasis on customer service. The focus was on employee growth (both professional and personal), provision of tools needed to accomplish the mission, and procedural development of

accountability to the mission and to each other.

"My aim is that no one works for me, but with me," said Sergeant Blue. "The people here are working to meet the mission that they developed to meet the town-peoples' expectations."

It's hard to imagine, but by his personal engagement Sergeant Blue and the team accomplished all this and managed to save the town money, too. New time accounting measures streamlined scheduling and, even with a small raise in wages to meet state law, the expenses came in 5% under budget.

Sergeant Blue doesn't like to take credit. "Every team has a leader, and Town Manager Anna Flores' vision leads the team," he remarked.

Well, Sergeant Blue, take credit for being the Energizer Bunny when we needed one, for being out and about in our town, and for developing the respect of all who live in our community.

# Good news for **HWUSD** taxpayers

The high property tax rate the Hayden-Winkelman residents will pay this year will not last long, said Jeff Gregorich, Hayden-Winkelman School District Superintendent. He said that the property tax rates will be lower next year because the school district bond debt will be paid off as of July 1, 2015. Therefore, the District will not have to levy a secondary tax rate next year. This should put the property tax rate similar to last year.

Gregorich added, "The HW School District appreciates all of the understanding and help we have received over the past decade to keep our school operating. We survived a much worse

financial property tax challenge in 2003 and in 2005. It seems that the more challenges we face, the stronger we have become and the more determined we are to fight to keep our schools open."

"We have a motto at HWUSD, Lobo Pride Never Dies; I truly believe it," stated Gregorich.

"Although this current tax issue is both surprising and concerning, it may be easier to swallow knowing that it is temporary. I am optimist that the property valuations of ASARCO will increase again over the next couple of years. At that time, I would expect property tax rates to drop again," stated Gregorich.

The Ray Unified School District Governing Board hosted its regular monthly meeting last week. The board was given a presentation on the new web site that has been designed for the district. The new site features a calendar and staff directory as well as several photos from school activities. Updates on the page will be done by the high school English students.

The board also approved high school students to

attend an overnight trip to Catalina Island in April, voted to approve a donation of two fully equipped first aid kits from Cobre Valley Heart Institute and Cobre Valley Regional Medical Center. ASARCO also donated a Sheldon 17"x30" lathe. Other housekeeping items included hearing department reports and also approving various club fundraisers.

The board had two executive session items on the agenda. Board President Wayne Cude announced that the first agenda item in the executive session would not be discussed because he would have to recuse himself due to the fact that his relative was

the staff member to be discussed and without Cude's participation, the Board would not have a quorum present. The item would have allowed the board to discuss whether to pay that family member for their prep time. The agenda did not indicate which staff member was going to be discussed. The Open Meeting Law requires that the person or position being discussed in executive be posted on the agenda.

The second agenda item on executive session was a discussion on the permanent resident application for international teachers. There was no action taken following the executive session discussion.

# Kearny Koyotes share history of 4-H in Arizona

4-H began in Arizona in 1913, when volunteer leader George T. Peabody organized a Boy's Cotton Club in Chandler. When the U.S. Smith-Lever Act was passed in 1914, Professor Stanely F. Morse, of The University of Arizona, College of Agriculture Experiment Station, organized 12 cotton, corn, and grain sorghum 4-H clubs. Canning, swine, and poultry clubs were organized in 1915 by Leland Park, a University of Arizona State Agent who became the first employee to devote full time to clubs for boys and girls. In the early years, most clubs were organized through schools, with teachers serving as leaders. Boys' and girls' clubs became known as "4-H Clubs" in the early 1930s. In recent years, 4-H Youth Development programs have been organized in the communities with a continued emphasis on a balance of experiences for young people in project work, personal development opportunities, leadership and citizenship.


In 4-H, young people make new friends, develop new skills, become leaders and help shape their communities. Arizona 4-H builds upon a century of experience as it fosters positive youth development that is based on the needs and strengths of youth, their families and communities. Youth have the opportunity to participate in 4-H experiences that strengthen a young person's sense of belonging, generosity, independence and mastery.

More than 9,000 Arizona youth are enrolled members of 4-H community clubs in Arizona. They are supported by more than 2,000 adult volunteer leaders. Another 184,000 Arizona youth get involved in 4-H through special educational opportunities

4-H gives them a chance to pursue their own interests – from photography to computers, from building rockets to raising sheep or rabbits. A comprehensive list of 4-H

edu/4h. Arizona 4-H youth also places – to camp, to state and national conferences and even on international cultural immersion exchanges. They learn to be leaders, active citizens and citizen scientists. In 4-H clubs, they serve as officers and learn to conduct meetings, handle club funds, and facilitate group decision-



making. In a growing number of communities, 4-H youth serve as youth representatives in municipal or county government or as members of Teen Courts. They give back to their communities. 4-H members are involved

# Winkelman celebrates 100 years

Two major milestones were reached Saturday in the smallest incorporated town in Arizona.

Winkelman celebrated its 100th birthday and the second ore cart in the Copper Corridor's Ore Cart Trail was revealed and officially welcomed to the Winkelman Wall Park at the intersection of Highways 77 and 177.

The Ore Cart dedication was first on the event list Saturday.

After a welcome and introductions, dignitaries including Winkelman Mayor Louis C. Bracamonte, Gila County Supervisor John Marcanti, Pinal County Supervisor Pete Rios and Ore Cart Project Manager Bill Bolin (Copper Corridor Economic Development Coalition) all spoke about the project and what it means to Winkelman and the whole Copper Corridor.

"A Penny for Your Thoughts" was selected many years ago by the community members of Winkelman. The cart, designed by renowned artist Nancy Dunst, has the load of giant copper pennies being upended out of the bucket, much the way copper ore was discharged.

Dunst lives in Sedona and has enjoyed a great career. She was commissioned by Sky Harbor International Airport in Phoenix, shown at the Phoenix Art Museum and was invited to the Biennale Internazionale Dell'Arte Contemporanca in Florence, Italy. She was also one of the first artists to receive the Sedona Project Grant from the Sedona Arts and Culture Commission.

The Ore Cart Trail is one of the first projects started by the Copper Corridor Economic Development Coalition. It began as a way to promote tourism by creating public art pieces to encourage visitors to stop and enjoy each cart as they travelled through the entire region. The first cart was installed in Mammoth in the Miners Memorial Park


