After its first loss of the season at Mogollon a week ago, the Superior football team looked like the state championship contender it is last Friday, defeating visiting NFL Yet Academy, 56 – 8.

Junior quarterback Steven Ybarra threw for four touchdowns and rushed for three more in the lopsided victory on Senior Night.

"We came out a little flat and our offense had some trouble executing in the first quarter," Superior head coach Ryan Palmer said after the game. "By the end of the second quarter we were rolling and playing at a high level."

Ybarra finished 15-of-25 passing for 315 yards in addition to rushing for 109 yards on 19 carries. Matthew Diaz-Gonzales, a freshman, accounted for the only other Panthers' touchdown. He rushed for 36 yards on just four carries.

Junior receiver Cedric Mendoza caught eight passes for 159 and a touchdown. Jared Moreno, another junior, had totaled 107 receiving yards on four receptions with two touchdowns. Freshman Adam Navarrette also had a touchdown grab, one of his three catches in the game. Ybarra didn't just star on offense, the junior led the Panthers' defense with 13 tackles and also picked off four

bounces back behind Ybarra's 7 TDs

Eagles' passes. Andrew Martinez and Sammy Lopez each recovered fumbles in the win.

The No. 3 Panthers appear to have their mojo back heading into the state playoffs. Their defense is championship caliber and as they saying goes, defense wins championships.

"When this team plays together and executes we are as tough as any team in the 1A Conference," Palmer said. "Our defense played excellent and would have had an-

other shutout, but we gave up a fourth-quarter kick return for a touchdown."

The top four teams in the conference earned a bye in the opening round of the playoffs. Superior awaits the winner of No. 10 Valley Union and No. 7 Ray in the second round on Saturday, Oct. 28.

"The week off is a huge advantage," Palmer answered when asked if he prefers the week off versus playing through. "It gives us another week to get healthy and bet-

ter prepared."

What do the Panthers need to do to win the state title? "Discipline and fundamentals are what set talented teams apart from champions," Palmer responded. "We have to do the little things right."

So far the Panthers have. Can they do it three more times?

No doubt about it.

The second-round game is scheduled for a 6 p.m. kickoff.

Arts and crafts from tribal artisans from throughout the Southwest will be available. Everything from beadwork to baskets, carvings to sand paintings, paintings to photographs will be available. A full day of entertainment, arts and crafts booths and food from sweet to savory rounds out the excitement of Apache Jii.

Tribal royalty in full traditional dress and native entertainers ranging from flute players to crown dancers will keep the excitement alive throughout the day.

Rebekah Miles, artist for this year's poster, is one of the featured artists at Apache Jii.

Festivities begin in front of the Cobre Valley Center for the Arts at the corner of Broad and Oak, one block east of the US 60 highway. Opening ceremonies begin at 9 and then it's on to a full day of entertainment, shopping and native foods. There is no admission charge for visitors

to Apache Jii; and visitors will have the opportunity to talk one-on-one with Native Americans from throughout the Southwest. There is nothing like choosing a piece of jewelry or artwork after visiting with the artist who designed it.

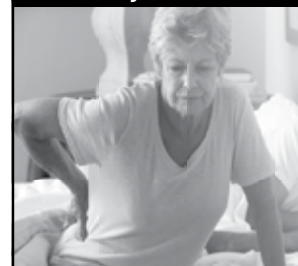

BE IT ORDAINED BY THE MAYOR AND TOWN COUNCIL OF THE TOWN OF SUPERIOR, ARIZONA, AS FOLLOWS:

That Chapter 12, Article 12-5 FLOOD DAMAGE PREVENTION is REPEALED IN ITS ENTIRETY;

That Chapter 12, Article 12-5, "Flood Control Regulation" is adopted as follows:

Section No. 1: That certain document, known as the "Superior Town Code, Title 12, Pinal County Flood Plain Management Ordinance August 2006, three copies of which are on file in the Office of the Town Clerk of the Town of Superior, Arizona, which document was made a public record by Resolution No. 17-143, of the Town of Superior, Arizona, is hereby referred to, adopted and made a part thereof as if fully set out in this Ordinance.

Section No. 2: In addition to all penalties prescribed elsewhere in this Ordinance, any person, firm or corporation violating any of the provisions of this Ordinance shall be deemed guilty of a Class 3 misdemeanor and upon conviction thereof shall, in addition to all other penalties prescribed by the provision hereof, be punished in accordance with Arizona Revised Statutes Section 13-707, 13-802(C), and 13-804(4), is incorporated and made a part hereof by references as if fully set forth herein. Each day that a violation continues shall be a separate offense punishable as herein above described.

Section No. 3: All ordinances and parts of ordinances in conflict with the provisions of this Ordinance or any part of the code adopted herein by reference are hereby repealed.

Section No. 4: If any section, subsection, sentence, clause, phrase, or portion of this Ordinance or any part of this code adopted herein by reference, is for any reason held to be invalid or unconstitutional by the decision shall not effect the validity of the remaining portions thereof.

Section No. 5: Whereas, it is necessary for the preservation of the peace, health, and safety of the Town of Superior, Arizona, an emergency is declared to exist and this Ordinance shall become immediately operative and in force from and after the date of the posting thereof.
