Mayor discusses the challenges faced by the Town of Kearny

This is the first of an intended series of short articles about the Town of Kearny to keep the people informed about all sorts of things, including the challenges of being a small town in a city-dominated state. The challenges are easy to enumerate: an aging population, a small tax base, the declining school-age population, the sour economy and its effect on families and businesses, and so forth. We will consider these challenges, and we will also comment on the steps the town government is taking to address these issues.

One symbol of our town could be the mulberry trees. Fifty

years ago, almost every home sported a mulberry sapling or two, and in a few years the town's streets were graced with green. Mulberry trees have about a 50-year life, however, and now the trees are ragged, some are dying, and many are completely gone. Our once new homes have also aged. The bright sun which we love so much has also taken its toll on houses and fences. The economy has not been kind to us either, and many of our houses stand vacant for months or years at a time. Weeds and accumulated clutter are more common than we would like.

The Town of Kearny is choosing to remedy this in a variety of ways. A citizens' committee has been formed and planned its first event. Saturday, Jan. 17, has been proclaimed Kearny Clean-Up Day, and residents are being asked to clean up their yards and those of our neighbors. Trucks and trailers will travel around town to pick up the waste and clutter, and groups of people are being asked to take part. Posters will soon be out with the details of what can and cannot be taken to the waste site. Yes, you will hear more about this later.

The mayor and council and all city employees have been asked to begin with their own homes. By the time of the clean-up day, it is our intent to have all these homes city code compliant in all regards, from trimmed trees to clean yards and driveways.

The town has a new code compliance officer, Bob Jacobs, but until the town council and the employees are themselves are code-compliant, he will not issue citations for any but the most egregious violations. The specifics of

Ray Board holds executive session

On Tuesday the Ray Unified School District Governing Board held a three hour executive session. Executive sessions are private, secret sessions that allow governing boards to discuss items in a private session. The RUSD board agenda sited personnel matters but did not list which positions were being discussed. Close to 15 staff members from RUSD waited the three hours of the meeting, however upon return to open session no action or direction was given from the board.

There are only seven allowed reasons that elected boards can enter into an executive session. First, personnel must provide 24 hours written notice to an employee. Also only those that are noticed 24 hours in advanced can be discussed in executive. The second reason for an executive session is discussion or consideration of records exempt by law from public inspection. Third, legal advice – with public body's own lawyer(s). The RUSD attorney was not present at this meeting. Fourth reason, discussion or consultation with public

body's lawyer(s) to consider pending or contemplated litigation, settlement discussions, negotiated contracts. Fifth, discuss and instruct its representative regarding labor negotiations. Sixth, discuss international, interstate, and tribal negotiations. The final and seventh reason for an executive session is to discuss the purchase, sale, or lease of real property.

State law requires that a notice and agenda must be posted 24 hours in advance of an executive session. The agendas for executive sessions may describe the matters to be discussed more generally than agendas for public meetings in order to preserve confidentiality or to prevent compromising the attorney-client privilege. A.R.S. § 38- 431.02(I). Nonetheless, the agenda must provide more than a recital of the statute that authorizes the executive session.

The agenda posted by the Ray Unified School District Governing Board told the public that they were meeting in executive for the following reason: For the purpose of discussion or consideration of employment, assignment, appointment, promotion, dismissal,

Katherine Avenetti meets the Pope through Peace Corps

WASHINGTON, D.C., Sept. 23, 2014 – Peace Corps Albania volunteers and staff had the distinct honor of meeting Pope Francis during his visit to Albania on Sunday. The pope's visit was his first to another European country since becoming pope in March 2013.

Volunteers Susan Oupadia of Grand Junction, Colorado, and Katherine Avenetti of Yuma, Arizona, and Peace Corps Albania staff members Diana Djaloshi and Marsela Wahlberg shared brief greetings with the Pope as he entered the Presidential Palace of Tirana to meet with Albanian President Bujar Nishani.

In his remarks, Pope Francis spoke of "peaceful coexistence and collaboration" in Albania that brings him great joy. His message echoed Peace Corps' mission of promoting world peace and friendship through mutual understanding.

"I am so grateful for the extraordinary opportunity to have met such an exemplary human," said Avenetti, a graduate of The University of Arizona who has been living in Albania since 2013. "I am humbled by his dedication to serving the needs of his faithful, and encouraged by a leader who uses his position to lobby for world peace. I hope I can instill the same passion for humanity and humility in the young leaders of Albania's future."

The volunteers and staff were joined by six Albanian girls ages 15-16 who recently participated in Peace Corps'

Girls Leading Our World (GLOW) National Conference in Durrës. The conference was a culmination of the first year of GLOW projects in Albania and brought together 34 girls and 9 adult leaders from 13 cities throughout the country. Over the past year, Peace Corps volunteers and their local counterparts have organized camps and girls clubs in more than a dozen Albanian communities to empower and educate young women.

"GLOW has been the highlight of my service," said Oupadia, a graduate of Duke University who has been living in Albania since 2013. "Through GLOW, our hope is that people will see that girls are important and deserve recognition. Talk about empowerment and boosting self-esteem!"

Camp GLOW was first established in 1995 by Peace Corps volunteers in Romania to encourage self-confidence among women and girls by creating a safe and supportive environment for cultural exchange, individuality, creativity, leadership development and fun. Since then, volunteers in more than 60 Peace Corps countries have established GLOW camps.

Avenetti is the daughter of Guy and Laura Avenetti of Yuma, Arizona and the granddaughter of George and Christina Armenta of Kearny and the late Richard Avenetti.

About Peace Corps/Albania: There are 78 volunteers

in Albania working in the areas of health, community economic development and English education. During their service in Albania, volunteers learn to speak Albanian. More than 560 Peace Corps volunteers have served in Albania since the program was established in 1992.

salaries, disciplining, or resignation of a public officer, appointee, or employee of any public body, except that with the exception of salary discussions, an office, an appointee or employee may demand that the discussion or considerations occur at a public meeting. The agenda listed this item which is a legal and authorized discussion to have, except the public was not aware of the positions that were being discussed in this executive session. Was

the board discussing a coach, a principal, an auto body teacher, a custodian? The public will never know based on the agenda presented.

Copper Area News contacted RUSD about the conflict in the posting. In a discussion with board president Wayne Cude, he explained that the board had a discussion on how the personnel could improve school communications, he could not elaborate on the overall discussion because that would be a violation of executive session rules. He also commented that RUSD has always posted their executive session in this matter and was unaware that the specific positions being discussed should be listed

on the agenda. He assured the *Copper Basin News* that they would look into this matter and make necessary adjustments to posting.

The purpose of the open meeting law is to ensure that the public is aware of the decisions being made by a governing body. Occasionally even the most thorough board will have a faux pas and miscommunications occur.

Friday's game is scheduled for 7:00 p.m.



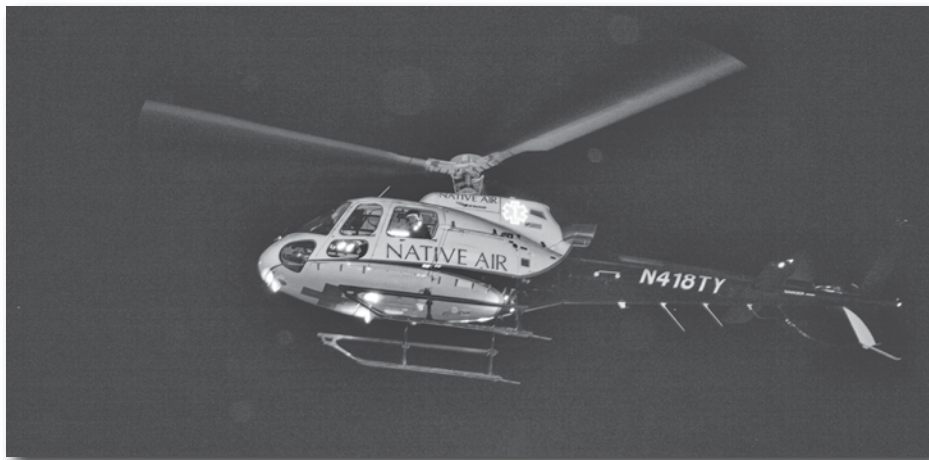
