Lee Roy Judd



Lee Roy Judd, 83, of Kearny, passed away on Oct. 12, 2021, fighting metastatic melanoma. He was born in Chuichupa, Chihuahua, Mexico to the late Leo Leroy and Marjorie Skinner Judd.

Lee Roy was preceded in death by his father Leo Leroy and mother Marjorie Skinner; brother Jeddie J. Judd; and sisters, Susanne Judd

Ashhurts, Margie Judd Works and Shirlene Judd Pace Davis.

He is survived by his children, Lee Ann (Blaine)Turner, Russell Judd, Gary (Tammy) Judd, Joanie (Tony) Judd and Ryan (Mariana) Judd; his grandchildren, Mandi Kirkland, Craig Judd, Katie Owadara, Kayla Prior, Julie Judd, Jenna Judd, Kyle Turner, Joshua Judd, Bailey Judd, Kenzie Judd, Miranda Judd, Taylyr Judd, Ashly Judd and Emily Judd; and 11 great-grandchildren.

At the age of 10, Lee Roy's family left Mexico and moved to Hineckley, Utah. Being an independent soul, his summers and weekends were spent working at local farms and ranches to earn spending money. Lee Roy was a 1955 graduate of Delta High School. He married Elaine Woody in 1956 and they lived in Nevada before settling in Arizona to raise their family. They were later divorced.

As a member of one of the first few families to buy a home in the newly created town of Kearny, Lee Roy's roots run deep. He was a member of the Church of Jesus Christ of Latter-day Saints and helped build the Kearny Ward building.

Lee Roy was a retired copper miner, having worked 42 years for Kennecott, in both Nevada and Arizona and Asarco at the Hayden smelter and concentrator. He

always took great pride in his work ethic. To support his growing family he worked as much overtime as possible and took on jobs out of town and state during multiple strikes.

On his days off Lee Roy enjoyed road trips, and along the way he would brag about being a driving champion at a state competition in Utah. He always loved to cheer on the Bearcats, especially the basketball teams. As a retiree, he enjoyed serving and helping others with the distribution of monthly food boxes, installing Home Alone alert kits, and helped watch over the community as a volunteer for the police department.

Lee Roy really loved to tell stories, read the daily newspaper to keep up with events to discuss later at the pizza place, was an avid crossword puzzler, prided himself on fixing things rather than buying new, was the original Dave Ramsey in many ways, and loved speaking Spanish with anyone who could. He always laughed, saying that his headstone should read, "Hecho en México!"

New group to help local families with spaying/neutering of pets

The Buddy Project (TBP) was uptown this past Saturday meeting with Kearny pet owners. They were completing the final steps for TBP to transport pets to a low cost spay/neuter clinic on Oct. 20, 2021.

Pinal County MASH has been very open to working with The Buddy Project. The MASH veterinarian is allowing the group to schedule several pets at once to be spayed/neutered at the clinic. The Buddy Project volunteers are providing the scheduled transport for free, but donations would be appreciated to help with the cost of transport. The next tentative spay/neuter trip will be in February/March.

René Dow was inspired to form The Buddy Project by a little brown and white dog. His circumstances were risky because he lived on the streets of Kearny for 2 1/2 to 3 months. He got food and water where he could and slept where he could. Many people recognized

"Buddy" but nobody would claim him as their dog. René named him "Buddy" to differentiate him from other roaming dogs. Community members would post on Facebook where he was traveling, where he was sleeping, and the close calls he had with cars and trucks. The little escape artist was finally humanely trapped and was taken in by René to foster him, provide veterinarian care and get him used to being around people. He is making great progress.

Volunteers from The Buddy Project have met with Kearny town management and police to learn from each other. They have been in contact with Pinal County Animal Control and will be helping with the next January rabies clinic. There will be a booth at the Nov. 13 car show to introduce community members to the services provided by The Buddy Project with information packets and raffle baskets. Owners and their dogs are welcome to stop by and sample

homemade treats.

The "Buddy Project" intends to reduce the stray pet population of the Copper Basin by facilitating spay, neuter, and

rescue opportunities for at risk animals. The project will offer reasonable assistance to struggling pet owners allowing them to enjoy the benefits of pet ownership.

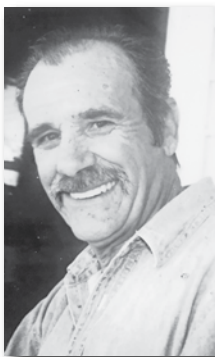

what is already in place,” said President Rosie Lopez. “Depending on what is needed at any particular time, the PTO

has provided help with different activities each year. In the past, we have provided food for the father and daughter dance,

donated water for field day, bought Kindles for the 8th grade valedictorian and salutatorian, donated money to softball for hotel rooms, donated school supplies, paid for music for school dances, provided food for faculty and sports teams, raffled off tickets to the annual Halloween Fun night, bought Eege’s for the K-8, and donated items to be raffled for faculty at the start of the school year.”

To help their community, the group donated tacos and water to the Hayden

Smelter strikers picketing, helped raise money to assist a faculty member who was affected by the Margo Fire, bought groceries for families affected with COVID, and donated money for fireworks for the 4th of July. Events and activities that have become tradition are providing dinner for the senior’s scholarship night, Winter Royalty for basketball season (which is based on academics and sportsmanship), providing food for our annual bonfire, and scholarships given to seniors.

“With donations from the community, Eddie’s Tire, and alumni we are able to have fireworks for Homecoming and the annual Hayden Ray football game. Before the Jr. High Football Championship game on Wednesday, we will provide food to our “Blue Crew” so they can cheer our Lobos to victory!” Rosie added.

COVID and the strike have affected their fundraising. “During this time of uncertainty, our communities and businesses have been very supportive,” Rosie explained. “The Hayden Smelter and Concentrator workers would support us by buying food plates that we sold. These plate sales were our biggest fundraisers of the year.”

The pandemic and the strike curtailed these fundraising events. “Despite losing this revenue, we have been overwhelmed with support,” Rosie said. “ASARCO has supported our tailgate efforts, donated masks, and also donated school supplies this year. The Towns of Hayden and Winkelman have supported our efforts with purchasing

items for our bonfire and supporting all of our endeavors. The Town of Hayden and Winkelman Fire Departments assist with our bonfires, help cook hotdogs, and shoot the fireworks. The Hayden Police have assisted us in events and have donated flares. They have donated so much of their time to us.”

Once restrictions were lifted, they were able to sell food at golf tournaments held by the Hayden Golf Club.

“The golfers have always been more than generous in supporting our students,” she said.

They have been able to have a couple of concession stands at the school which helped with their fundraising efforts. Former community member Chris Salas and his wife Vicki donated the proceeds of the sale of masks which provided a much needed boost in fundraising due to the pandemic.

Local businesses too have provided some much needed support.

“Eddie’s Tire has consistently donated to our firework fund by providing the barrage of fireworks for our National Anthem and firework boards. They have always donated food items for our bonfire. Giorsetti’s has also provided water and food items for events. James Ruiz and his businesses have donated water and other items for our school functions. Norm’s Hometown Grocery has provided water and food items for our various functions and activities and has had a school supply drive for the schools. Buzzy’s has cooked our taco shells for our tailgate food sale. Dirty Sno has

donated a portion of sales to our PTO.”

The school Principal and Superintendent have always assisted and promoted their activities and events.

“All staff members have contributed in one way or another,” Rosie said. “The students are their priority and it shows.”

Hayden High School alumni still continue to provide their support not just for the PTO but for the school, Rosie said. “Their support is unrivaled.”

Hayden’s PTO has also had some interaction with Ray’s PTO.

“Shawna Whitehurst of the Ray PTO reached out to us and wanted to work together on the ‘kidnapping’ of our mascots,” Rosie said. “We look forward to continue working with them.”

Rosie has been overwhelmed with the support the group receives from the entire community.

“In case someone or a business was missed we apologize. We can’t thank everyone enough for their support. Because of it, the students can look forward to having an amazing school year!”
