Gila County CASA Receives Award through Victims of Crime Act Funding

CASA of Southern Gila County has once again been awarded a three-year grant through the federal Victims of Crime Act managed through AZ Department of Public Safety. This grant funding source has provided an opportunity for the southern section of the county to be served by the CASA program where children are currently being underserved. Emily Nader has filled the role of CASA Volunteer Coordinator since May 2016,

targeting her efforts on recruiting, screening, training, supervising and supporting volunteers who advocate in the best interest of those children who have been affected by child abuse and/or neglect. Currently, there are only 8 advocates serving 12 children, leaving 116 who do not have an advocate. CASA of Southern Gila County needs to maintain and increase their volunteer base so more child abuse victims can be directly served.

Each year, millions of dollars are deposited into this fund from criminal fines, forfeited bail bonds, penalty fees and special assessments collected by the US Attorney's Offices, US Courts and the Bureau of Prisons. These dollars all come from offenders convicted of federal crimes.

Direct services to help crime victims achieve positive

outcomes in the four basic need areas supported by VOCA: Healing, Safety, Justice and Economic Re-stabilization.

A national study found that children with an advocate are substantially less likely to spend time in long-term foster care; more likely to receive needed services; more likely to have their cases permanently closed, and never return to child welfare system.

CASA Volunteers:

- Volunteers must be at least 21 years old.
- Volunteers go through a rigorous screening process including interviews, reference check, a fingerprint check, child welfare history check, and a polygraph exam.

- Volunteers are asked to make a commitment to one case until its conclusion, typically involving 15-20 hours per month.
 - Volunteers must complete 30 hours of pre-service training.
 - CASA volunteers build a 360-degree view of the child and his or her surroundings. To do this, they meet with teachers, counselors, physicians, care takers, etc.
 - CASA volunteers work to ensure that children are in safe, permanent homes where they can thrive.

Lonely elders hit hard by the rigors of social distancing and self-isolation

It's no secret that America's elderly population is among the hardest hit by the COVID pandemic. Not only are they at higher risk of infection, those who live alone are more likely to succumb to the loneliness of precautionary self-isolation, says Rebecca Weber, CEO of the Association of Mature American Citizens [AMAC].

How bad is it for our senior population?

"Bad enough that desperate residents of a long-term care facility in Greeley, CO, sick and tired of COVID-19 restrictions, recently staged a protest. Many of them were in wheelchairs and holding signs that read 'Rather die from COVID than loneliness,' 'Prisoners in our own home' and 'Give us freedom,'" says Weber.

She notes that Pew Research recently found that 27% of adults ages 60 and older live alone in the U.S. Meanwhile, the Centers for Disease Control reports that many of them are socially isolated or lonely in ways that put their health at risk. In fact, the CDC cites studies that show:

Social isolation significantly increased a person's risk of premature death from all causes, a risk that may rival those of smoking, obesity, and physical inactivity.

Social isolation was associated with about a 50% percent increased risk of dementia.

Poor social relationships (characterized by social isolation or loneliness) was associated with a 29% increased risk of heart disease and a 32% increased risk of stroke.

Loneliness was associated with higher rates of depression, anxiety, and suicide.

Loneliness among heart failure patients was associated with a nearly 4 times increased risk of death, 68%

increased risk of hospitalization, and 57% increased risk of emergency department visits.

"Those of us who have what we might call normal lifestyles feel lonely when we haven't seen our friends and family in more than a couple of days. Imagine not having friends and family in the best of times and now that the world is dealing with the deadly coronavirus your norm is solitary confinement," says Weber.

Copper Area News is committed to providing our readers with as much information as possible. We post a daily update on our Facebook page with the total positive COVID-19 Data. This graph shows the daily counts of positive cases for the past week as of press time on Oct. 20, 2020.

There are a few points we would like our readers to consider when following this data.

1. This will continue to be a rolling total of positive cases. It does not reflect recoveries or deaths. The Arizona Department of Health Services does not break out this data.
2. If you see a reduction in numbers from day to day it is most likely due to a data entry error or mis-coding of a zip code (at the state level).
3. This is all zip code based data; most of our zip codes include unincorporated areas. There is no way to track exactly which areas each of the positive cases are. Example, Kearny and Winkelman each have small communities in their zip code that are not in the Town's incorporated boundaries.
4. If you live in Gila County, please follow the Gila County Health and Emergency Management, Facebook. They have maintained their data on recoveries and current positive cases.
5. You can follow other data such as ICU bed use, Ventilator use and hospital capacity online: <https://bit.ly/3inh280>

Working together, we can slow the spread of the virus across the Copper Corridor. Wear a mask in public, remain physically distant (6 feet apart or more), practice good hygiene (wash your hands frequently, sanitize high touch areas) and stay home if you are not feeling well.

Project Description

This federally funded project consists of the construction of Water System Improvements as follows:

Removal and replacement of asphalt pavement, curb & gutter sections, and sidewalks; installation of 18" diameter RG-RCP storm drain; connection of storm drain through a channel wall; construction of Type A, 3'-6" curb opening catch basins; traffic control; mobilization; and miscellaneous and contingent items of work; to make drainage improvements on 5th Street for the Town of Winkelman.

Objective/Scope of Work

The contractor shall furnish all materials, labor, equipment, services, transportation, and perform all the work for the Town's project known as the 5TH STREET DRAINAGE IMPROVEMENTS, CDBG 131-20, for the TOWN OF WINKELMAN, Arizona, as called for in the Specifications and Plans (Construction Drawings). The successful proposer should be prepared to comply with all local, state, and federal safety and environmental requirements. The project shall be accomplished in accordance with all federal program and state statutory requirements to include 2 CFR 200, Executive Orders, and the Arizona Administrative Code.

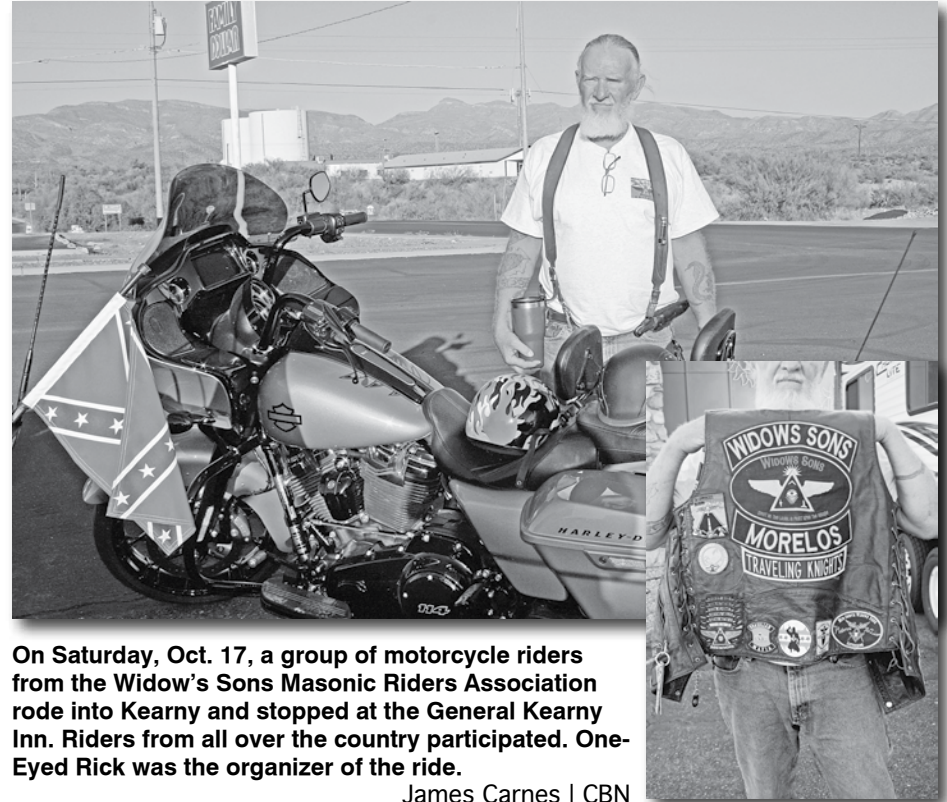
