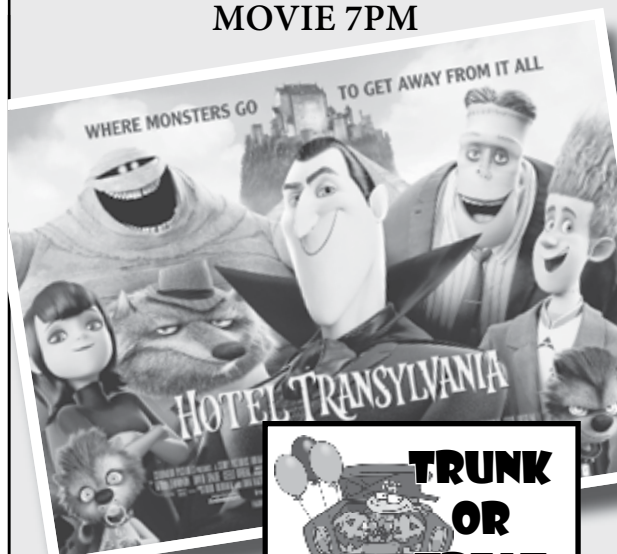

# natural gas SAFETY



**SOUTHWEST GAS**

# Bank of the West announces closure of San Manuel, Kearny branches

Earlier this month, customers at Bank of the West in the Copper Basin and Tri-Community areas began receiving letters announcing the closure and consolidation of the San Manuel and Kearny-Hayden branches. Accounts, the letters read, at the San Manuel branch are being transferred and combined with the SaddleBrooke branch while the accounts at the Kearny-Hayden branch will go to Superior.

The branches will close at 3 p.m. on Friday, Jan. 17, 2014. Transfers of accounts will happen automatically. Customers with safe deposit boxes will receive separate information about transferring the contents of the boxes to the new locations.

The announcements sparked a small storm of comments on the Bank of the West's Facebook page, many from Copper Basin residents.

"Everyone I talk to in Kearny AZ say there is no way they'll let you take their accounts to Superior," wrote Carol Hosler. "You won't have their accounts anymore to take up there. If, as you say, we should be happy with online tools, we can be just as happy with some other institution's tools."

Georgianna Wood also spoke out against the closure. "I hope those who are responsible for that change will realize what a mistake it would be to carry out what would be a stupid and uncaring act against businesses and residents of Kearny, and others, and would also be the cause of Bank of the West losing some of its customers," she wrote on the Facebook page.

One person said that the closures are becoming normal for banks. "Financial institutions will eventually change the way people do all their banking," said Erica Contreras Seitter. "As a veteran of this industry for the last 15 years, there have been more changes in the last 5 years. It will be a transition, but so will changing banks. Pretty soon there will be automated tellers in their lobbies. It's a shame about the Kearny Branch closing. It seems to be a trend among FI's these days to 'cut back'."

In an email interview with the *Green Valley News*, Debra Jack, spokeswoman for the San Francisco-based chain, said the closures were the result of an extensive review of branch usage trends.

It's unknown how many employees



will be affected by the move. Branches in Green Valley and St. Johns will also be closed and consolidated with other branches. Bank of the West is currently evaluating its ATM network. It's not known whether ATMs in San Manuel and Kearny will be maintained or closed.

through Thursday 9 a.m. to 4 p.m. and Friday 9 a.m. to 5 p.m. The SaddleBrooke branch is located at 63701 E. SaddleBrooke Blvd., Suite A. The branch phone number is 520-917-2700. # Celebrating local volunteers – L.S. ‘Jake’ Jacobson

This year’s Pinal County Town Hall focused on volunteers and the joys of

volunteerism. We at the Copper Basin News want to introduce our readers to volunteers in the Copper Basin area. You may or may not know these

people. They all have one thing in common – they give of themselves just because.

If you live in the Copper Corridor, chances are you

probably know who L.S. “Jake” Jacobson is.

Jake is the C.O.O. and President of Copper Basin Railway (CBRR), a short line freight railroad

headquartered in the Kearny-Hayden area.

CBRR is owned by ASARCO-GRUPO Mexico. It is also one of the safest railroads in North America thanks to Jake’s leadership, management style which emphasizes safety, and his railroad experience which spans over 50 years.

Jake is the only Arizonan to be named North America’s Railroader of the Year and Great Railroader of the Century. He also has a safety award named after him, the “Jake Award” which is given to North American short line railroads with excellent safety records.

Jake is well respected in the railroad business and by his employees. During a flood in 1993 which took a large section of track out and damaged the homes of some of his employees, Jake offered interest free loans and helped his people get back on their feet. He and his workers worked tirelessly to successfully save the remaining track. Jake believes in the “sincere caring of the well being of your fellow worker.” The company’s motto which appears on the trains is “Our Real Power Is in the Pride of Our People,” attests to his caring and management style. Jake says he has been giving back since he was a teenager. He continues to give and volunteers regularly.

“I feel that we are privileged to run our railroad through the community,” Jake said. “The railroad and community has been good to me and I need to put something back in the well.”

Jake believes in giving back to the community

and in supporting the local economy. The Copper Basin Railway purchases locally when they can.

Jake also does volunteer work as well as sponsoring charitable programs.

Jake volunteers as a member of the Copper Corridor Economic Coalition. He is on the Board of Directors Executive Committee for the Central Arizona College Foundation and has provided scholarships for the College for Kids program at Central Arizona College-Aravaipa Campus. Jake is on the Board of Arizona Operation Lifesaver a nationwide non-profit public safety and education program which works to eliminate collisions and deaths at railroad crossings and rights-of-way.

Every year he works with the Salvation Army and the Kearny Fire Department to collect toys and distribute them to kids who otherwise would not have gifts for Christmas. “The Salvation Army and the Kearny Fire Department do a great job getting toys for the kids,” he said. “I think I enjoy it as much as the kids.” Every year, Jake delivers the toys to the Kearny Fire Department just before Christmas in his vintage black Ford Mustang convertible (which the *Copper Basin News* fondly refers to as Jake’s “one horse open sleigh”).

When Jake was asked why he volunteers and gives back to the community, he said, “It’s kind of what goes around comes around. I have enjoyed my volunteer work and I am glad to be a part of it. We should set an example for our young kids and teach them the joy of giving.”

## Pinal Board of Supervisors to vote on food safety permit increases

This summer many restaurant and other food establishments received a notification from Pinal County Environmental Health Department that the fees for the annual health and safety permits to operate their establishments would go up. In some cases the proposed fees were almost a 600 percent increase from the current fees. One area of concern to many organizations in Pinal County was an increased fee for non profits and temporary events. Currently

temporary event vendors pay \$25 for each event. The proposed plan would have increased the fees to \$196 if the event permit was submitted two weeks in advance and \$246 for permits submitted less than two weeks in advance of the event.

Restaurant owners and event planners throughout the county attended the work session with the Board of Supervisors in August to express their concerns about the increases. If the proposed fees were to be approved, the new pricing would be the equivalent of increasing a cup of

coffee from one dollar to six dollars.

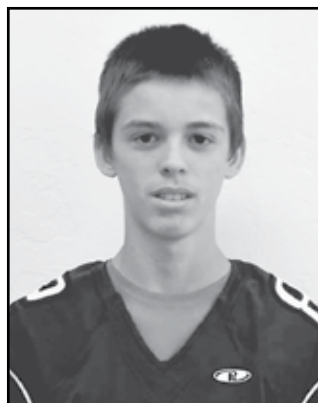
The County Health Department staff reported that the permit prices were determined after analyzing the cost of processing the permits and conducting the necessary inspections. The department’s original plan would have increased the permit fees to allow the process to become self sustaining and not require funding from the County’s general fund. After much discussion and comments from the public, staff returned to the drawing board to come

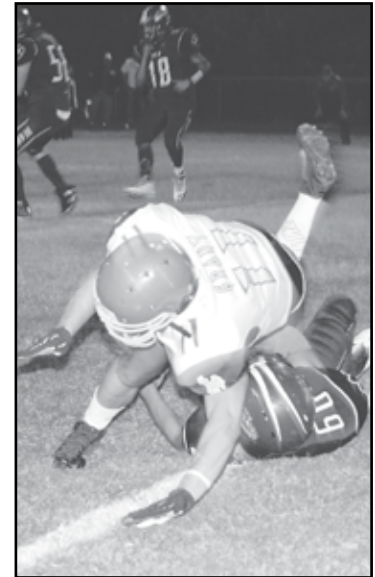

# Bearcats sneak by Wildkats in a thriller; will face off again Saturday in first round of playoffs

The Ray Bearcats traveled to Duncan to take on the Wildkats in a Division VI matchup last Friday night. The Bearcats who came into the game as underdogs not only battled a high tempo Wildkat offense, but also had to battle an officiating crew that seemed to favor the Duncan team.

The Bearcats could not catch a break from the officials. Every big play they made was called back. In spite of the rough calls, those who made the trip to Duncan saw the Bearcats play their best football yet, leaving Duncan with a 14-6 victory.

The night started off with Duncan taking the opening kickoff to midfield. Duncan threatened the Bearcats taking the ball down to their 24 yard line, but the tough Bearcat defense held the Wildkats forcing a turnover on downs. On the Bearcats first possession started from their own 24 yard line. Receiver Dominic Bravo fumbled the ball on an end around play giving the ball right back to Duncan with excellent field position. With Duncan trying to capitalize on the Bearcat miscue, the defense of the Bearcats denied them any points as they once again held the Wildkats to force another turnover on downs. With time winding down in the quarter the Wildkats broke the scoreless tie with their first and last touchdown of the night on a quarterback keeper to take a 6-0 lead at the end of one quarter of play.

The second quarter was a defensive battle as both teams once again forced turnovers and punts. The lone score of the quarter came with 37 seconds left in the half as quarterback Destry Yocum scored his first of two touchdowns of the night on a 13 yard run to tie

the game 6-6. The PAT by Jacob Pace was no good sending the Bearcats into the locker room tied with the Wildkats.

The second half of the game was a defensive battle as both teams played tough not allowing any points in the third quarter and mid-way through the fourth. It was with 7 minutes in the fourth quarter that the Bearcat offense struck again on a variety of run and pass plays. Running back Robbin Newman was key on the drive, as was receiver Joe Rudy Lorona who made a spectacular one handed catch to keep the drive alive. On the 8<sup>th</sup> play of the drive Yocum dropped back to pass and could not find an open receiver, so he tucked the ball away and scrambled 15 yards for the touchdown. The two point conversion was good giving the Bearcats a 14-6 lead. With plenty of time on the clock Duncan had one last chance to tie the game, but as the Bearcats had done throughout the game they held the Wildkats and forced a turnover on downs to seal the victory 14-6.

The Bearcats played an outstanding game on both sides of the ball. The offensive leader was quarterback Yocum who passed for 95 yards and rushed for 78 yards and 2 TDs. Running Back Newman led all rushers with 101 yards on 16 carries. Bravo led the receivers with 2 catches for 50 yards.

Defensively the Bearcats played a tremendous game. Leading the defense was linebacker Julio Noriega and defensive end Ryan Bickley with 6 tackles each; Bravo and Yocum with 4 tackles each; Pace, Lorona, Nick Lara, and Seth Harmon with 3 tackles each.

The Bearcats wrapped up the regular season with a (7-1) record. They will be the #7 seed in the playoffs which will start on Saturday, Oct. 26. The Bearcats will host the Duncan

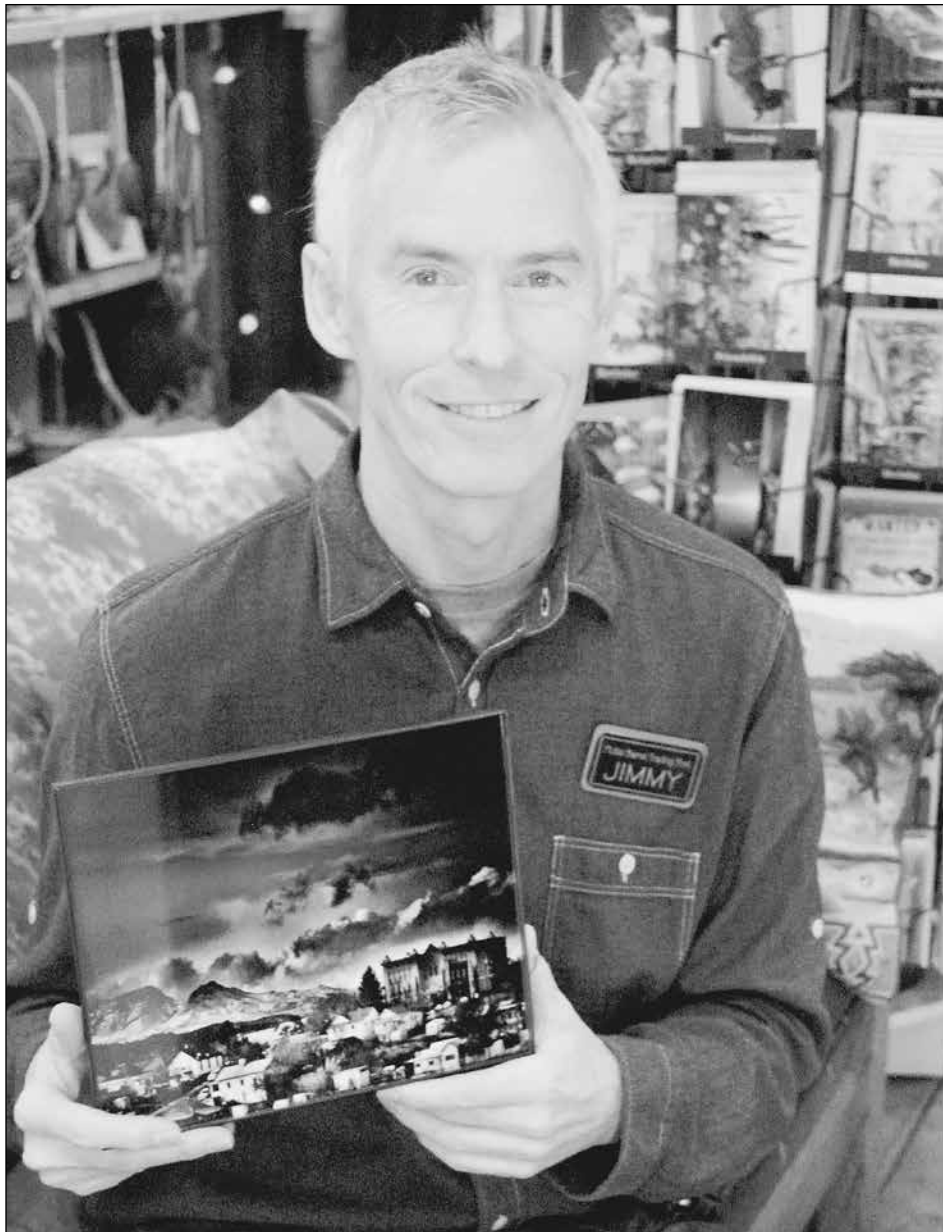

# Moving forward in our communities not backwards – tourism and new businesses versus moving out

Have you ever walked the Arizona Trail, picnicked in the washes, or taken any of the back roads surrounding us?

Maybe you've thought about it or you don't know what exists near by. Do you enjoy bird watching, tubing down the Gila River (when it has water), camping or picnicking along

the Gila?

There are a lot of people who enjoy those activities. Every destination point in Kearny, Hayden and Winkelman offers unique challenges for those

who have imagination, determination and ingenuity to put their businesses on the map.

Using the Arizona Trail as an example, it runs from the Utah border to Mexico. If you are hiking or biking from Utah to Mexico and get to Superior you can begin just west of Picket Post, hiking along a beautiful trail. When you get to Kelvin you might want to continue the trail to Oracle or get back to Superior. At the Kelvin area shuttle services are needed. Jeep tours can even be provided. Those involved want food and lodging, curio shops, and will be shopping locally for supplies for the next part of the journey. As publicity grows so grows the economy.

A tour guide group from Colorado already brings groups from all over the world to hike the Arizona Trail. Why not someone locally offering the same service, including equestrian trail rides. The unique beauty of the desert mountains, the sunsets, and the peace and quiet keeps the tourists here. It has been determined that these tourists spend approximately 14 days at a destination and spend \$1,000 to \$1,500 per visit.

At a recent forum sponsored by the Copper Corridor Economic Development Coalition guests from as far away as Sierra Vista, to the south, and Cottonwood, to the northwest, discussed the opportunities available for those that want to keep our rural communities alive. Buildings are falling apart in Hayden and Winkelman, some could be considered historical. There is so much potential for those willing to take a risk. Bisbee, Tombstone, Jerome and Cottonwood have turned their communities around by those willing to take a challenge. It did not happen over night but within five years of their re-starts they are what are called "Destination" towns and their businesses are thriving.

We have to do something. It was a shock to all of the communities in the Copper Corridor from Oracle, San Manuel, Mammoth, Hayden, Winkelman and Kearny to learn of the closure of Bank of the West. That closure affects our local businesses in many ways. We all saw what happened to Hayden and Winkelman when they closed the bank in

Hayden. It is simple to put on paper that there are branches in Superior and Globe that can be used but without public transit not everyone can get there. Of course there are credit unions in Kearny and San Manuel that will take our business and are making plans to do so.

Our communities are being treated as if we do not exist. We are rural but not remote. Necessary services provided by DES are being taken away. The Pinal County nurses have to work out of Florence. The families who need these services find it hard to travel so many of them just go without the necessary care offered. Chastain use to say, "it is as far from Casa Grande to Kearny as it is from Kearny to Casa Grande," when we had to make trips to the other end of the county for meetings. One Sheriff deputy, during our recent fire, described Kearny to Channel 10 News saying that Kearny had a population of 300 and was on the San Pedro. That is how we are perceived on the other side of the mountain.

Our local businesses are struggling to stay alive and having much needed service taken

up with other permit fees. The proposed plans will be presented to the board of supervisors for approval on Wednesday, October 30, 2013.

The health department staff has proposed three other

fee schedules – all three fee schedules eliminate the permit fee for temporary events and food banks. The temporary event fees will be waived for both non profit and for profit organizations. One plan would allow for \$200,000 from the general fund to be allocated to the department, the second plan would

allow for \$300,000 from the general fund to subsidize the department and the third plan would subsidize the department with 50 percent of the funds needed, which would amount to \$400,000.

The County Health Department plans on meeting with temporary event organizers to discuss how the county can improve the event permitting process. Under the original plan presented a level three eating and drinking establishment would be \$813 a year for their permit. If one of the other plans are accepted by the board that proposed fee will be reduced to \$609 in option B, \$506 in Option C and \$406 in Option D.
