



The No. 5 Hayden football team didn't end its season the way it had hoped on Senior Night with a 68 – 6 loss to No. 1 Williams. The Lobos will move on quickly as they prepare to reach the 1A State Championship game for a second-straight year.

"It was a challenging week with (us) being on fall break," said Hayden head coach John Estrada. "Our goal going into the game was to play with them to see what they have and come out of the game with no injuries.

"Our JV kids played most of the second half. Not taking anything away from Williams, they are sound with seasoned players. It's obvious why they're No. 1 in the state."

Now the Lobos will look ahead to the playoffs as the No. 5-seed. A top-four seed would have given them a much-needed

bye, but they'll host No. 12-seed St. David instead this Friday.

"We would have liked to come out No.4," Estrada said. "We needed that bye week to heal. We've been battling injuries for the last few weeks. Hopefully, we can play well this Friday against St David. We'll take it one game at a time."

The Lobos' seniors have been largely responsible for the rebirth of the Hayden football program, as evidenced by the four-straight playoff appearances during their careers. According to their head coach, they can also take great pride in another streak.

"Our group of seniors are special," said Estrada. "They've been fortunate and have worked hard to make it to the playoffs in their Lobos' careers. More importantly, they can always say they never lost to Ray."

**Up next:** Host No. 12 St. David in first-round of 1A Conference playoffs. Kickoff is scheduled for 7 p.m.

## Ray season still meaningful despite missing playoffs

The Ray football season officially ended following the release of the 1A Conference Championship playoffs bracket last Saturday, which didn't include the Bearcats.

Those who have played the sport will tell you that football is more than a game. Like all high school athletics, football teaches life lessons and creates bonds and memories with teammates for a lifetime.

"Playing with all my brothers," answered junior Alex Bravo, when asked to name his most memorable experience this season.

For most players, the end of their senior season represents the last time they'll put on shoulder pads and strap on a helmet as they transition to possibly college and/or a job. Football has helped them prepare

for whatever is next after high school.

"Responsibility and leadership, for sure," senior Christian Day said of the lessons he learned this season that will help him in life. "Leadership is the big one. Having to lead a team of 12 players; I mean, it's not that (many), but it's very important to keep everyone in check, grades and being eligible, especially with a small team. We don't want to be going into games with only nine players."

Ray concluded its season with a 3-5 record, including 2-3 in the region, which placed it fourth, just behind three teams that did qualify for the playoffs – Superior, Hayden and Arete Prep. The narrow 54-52 loss to Arete Prep on Oct. 4 likely was the difference in the Cats being included in the postseason.

Instead, the players will only have memories and lessons learned, and those are just as valuable as another game.

## CAC-CVIT students participate in SkillsUSA Leadership Conference

Earlier this month, students from the Cobre Valley Institute of Technology's welding program at the Central Arizona College's Aravaipa campus participated in the state SkillsUSA fall leadership conference. Approximately 2,000 students from across Arizona were in attendance.

"(Students) learned about the importance of going the extra mile and if you want to 'get to be' you have to 'be to get,'" said Professor Samuel Colton Sr., the teacher for the Aravaipa program. - · Region officers training; and
- Local industry involvement with students and advisors. "Our students are learning to be career ready 'day one," Colton said.

Whether or not the strike is over, discounts will be provided for miners. Sellers are encouraged to select items for re-use which they, themselves, would be proud to give as gifts. Therefore, items should be in good working order, neat, clean and entirely ready for Christmas wrapping. The coordinators reserve the right to refuse any consignment item not deemed appropriate for gifting. Consignment items not sold will return to the seller.

Sellers are encouraged to donate any unsold items to the Hand Me Up Shop for continued benefit to the communities.

Watch for further notice about time, registration and consignment procedures. In the meantime, people are encouraged to begin gathering items for this twin event.

## Halloween is Almost Here!

t's that time of year when kids of all ages and sizes look forward to the fun of Halloween. What fun memories do you have about Halloween? Trick or Treating? Carving the pumpkin? Dunking for apples at a party?

With the fun and activities of Halloween come some inherent dangers as well. According to the National Safety Council (NSC), kids love the magic of Halloween: trick-or-treating, classroom parties and trips to a neighborhood haunted house. But for moms and dads, often there is a fine line between Halloween fun and safety concerns, especially when it comes to road and pedestrian safety. In 2017,

7,450 pedestrians died in traffic or non-traffic incidents, according to Injury Facts. Non-traffic incidents include those occurring on driveways, in parking lots or on private property. NSC research reveals almost 18% of these deaths occurred at road crossings or intersections. Lack of visibility because of low lighting at night also plays a factor in these deaths.

Here's a scary statistic: Children are more than twice as likely to be hit by a car and killed on Halloween than on any other day of the year. In 2017, October ranked No. 2 in motor vehicle deaths by month, with 3,700. July is No. 1, with 3,830 deaths.

So, what can parents do to keep their little goblins and ghouls safe? There are several things to keep in mind.

When talking costumes consider the following:

- All costumes, wigs and accessories should be fireresistant.
- · Avoid masks, which can obstruct vision.
- If children are allowed out after dark, fasten reflective tape to their costumes and bags, or give them a flashlight or glow sticks.
- · When buying Halloween makeup, make sure it is nontoxic and always test it

in a small area first.

• Remove all makeup before children go to bed to prevent skin and eye irritation.

If trick-or-treaters will be out searching for goodies after dark or by themselves:

- · A responsible adult should accompany young children on the neighborhood rounds.
- If your older children are going alone, plan and review a route acceptable to you.
- Agree on a specific time when children should return home.
- Teach your children never to enter a stranger's home or car.
- Instruct children to travel

only in familiar, well-lit areas and stick with their friends.

- Tell your children not to eat any treats until they return home and you have had a chance to inspect them.
- Children and adults are reminded to put electronic devices down! Keep heads up and walk, don't run, across the street.

• Give kids a flashlight or glow stick to help make them more visible at night.
