Superior's police force has a new chief at the helm.

At the October Superior Town Council meeting, the town council accepted the resignation of Chief Mark Nipp who took the job as the Chief of Police for the City of Globe. The council then followed that action by hiring Sgt. David Neuss as the new Chief of Police for the Town of Superior.

Neuss was hired by the Superior Police Department in 2014 as the Sergeant for the department. Neuss began his career in law enforcement in 1993 for the Belmar Police Department in New Jersey. His early patrolling days included patrolling the beaches of New Jersey and being a court bailiff. In 1995 he applied for law enforcement positions for the City of Phoenix and Pima County. Both offered him positions but he took a position with Pima County, he worked for Pima County before

The No. 3-ranked Superior football team enjoyed its bye week and is more-than-ready for Saturday's quarterfinal playoff game versus No. 6 Gilbert Christian, a team the Panthers beat on Oct. 9, 62 - 37.

"This is a tough 2nd round match up for us, but we will be ready to meet the challenge," Panthers' head coach Ryan Palmer told the Superior Sun. "You have to beat the best, sometimes twice, to be the best and our kids are eager to prove themselves once again."

Jr. Panthers complete undefeated season with championship

The Superior Jr. High football team completed its season undefeated and as a champion after defeating Eloy 34 – 6 in the CJHL Championship Game on Oct. 20.

It certainly wasn't easy, but the Jr. Panthers made it look that in the championship game. "I was expecting a tougher game and for them to make some adjustments," Jr. Panthers' head coach Martin Navarrette told the Superior Sun.

"I knew that is what we planned for. They were a bigger team than us, but we definitely were stronger, faster, and better conditioned and it paid off."

The Jr. Panthers started slow, as was the case most of the season, but still led 12 – 0 after touchdowns by Adam Navarrette and Matthew Diaz-Gonzales.

Diaz-Gonzales' score came after he first blocked an Eloy punt and then recovered it in the end zone for a touchdown.

Superior got it rolling in the second half,

outscored Eloy 22 – 6 to win going away.

Benji Hernandez ignited the Jr. Panthers' after a 50-yard kickoff return setup Navarrette's second touchdown of the game.

Sammy Lopez would later add a touchdown that essentially sealed the CJHL Championship for the Jr. Panthers.

The Jr. Panthers' success this season can be contributed to the players' commitment to be consistent in the classroom so all of them were available to practice and play in games. It was

that continuity that led this season's results.

"Respect is one of the main standards for any student-athlete that plays for me," Navarrette said. "Their grades have to be good; if they're grades aren't good, they won't play. That's one thing we instill and we push. They boys did really well in those areas this year."

Indeed they did.

And now they have League Championship as their reward.

lingering. Maintaining the players' anxiety as they waited to find out who their opponent would be might have been the most difficult challenge as a result of the first-round bye.

"We earned the bye," Palmer said. "This team did everything right in the regular season and the bye was our reward. With that being said, we attacked last week like a championship team; we worked hard, as we will this week, in preparation for victory on (Saturday).

Junior quarterback Nicolas Cruz accounted for six touchdowns in the game a few weeks ago between the teams. He ran for nearly 300 yards and scored four rushing touchdowns.

The Panthers did allow 37 points – their most in any game this season – to the Knights in the first game. That may be one area they'll need to improve in the playoffs because as they saying

goes, defense wins championships.

"In the first match up with Gilbert Christian we made plenty of mistakes," Palmer answered when asked what his team needs to control to have success on Saturday. "We need to reduce our mental errors on offense and focus on executing the fundamentals of tackling and playing assignment football on defense."

He added, "We need to play as a team, win the turnover battle, and outplay them in all three phases of the game; offense, defense, and special teams."

coming to Superior.

In his position with Pima County he worked with the Air Marshals, DARE programs, and School Resource Officers. He also had the opportunity to be a liaison with the the Native American tribes in Pima County.

His inspiration to become a member of law enforcement came after he was mugged at gun point when he was eight years old. He remembered how scared and violated he felt in those moments. After that, he always wanted to be in a position where he could help people. After high school he attended Ryden University for a year, where he had planned to become a special agent with the Internal Revenue Service. After a year there he realized he didn't want to waste his parents' money so he decided to attend the police academy and start a career in law enforcement.

Chief Neuss credits his success in life to his parents and their devoted love for him. His mother flew in from New Jersey to attend the council meeting where he was selected as Chief of Police. Chief Neuss is married to his wife Marty and they have three children, Hayden, Taylor and Trevor. He and his family have a permanent residence in Tucson however he will reside in Superior Monday through Friday.

He has several goals to maintain and achieve as Chief. He plans to retain the staff to continue to build on continuity and keep cases moving forward so justice is served. The structure of the department is also important him and that the officers and staff have a good working report with him and the community. His other top goal is to work on code enforcement – he wants more of a helpful approach to the citations by having the community help those who cannot get their yards and home cleaned up.
