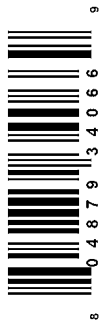

Repetitive removal of pro Life and pro Trump campaign signs in our area makes me wonder, "If you are willing to steal signs, are you also willing to steal the election?"

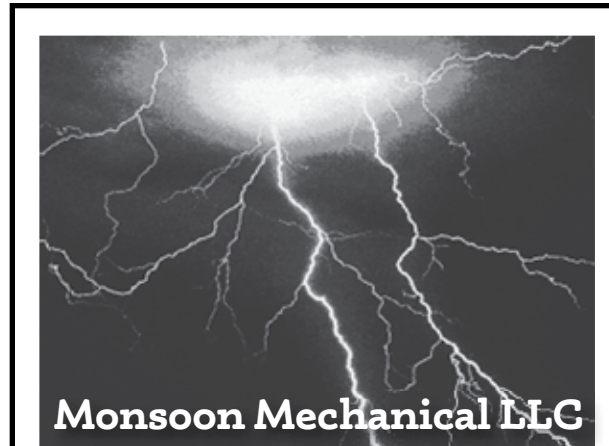

SIXtacular: Superior clinches sixth straight region championship

Amid a year of uncertainty, chaos, and change, the Superior football team won its sixth-straight region championship last Friday night by defeating visiting Tempe Prep, 54 – 7.

The Panthers, who have appeared in the last three State Championship games, hope to parlay their most recent region title into a fourth-straight title game appearance next month. After a 6-4 record in 2014, Superior started their recent run of region titles in 2015, going 9-1 that season with a core group of players that help build the foundation for what was to follow.

“All the credit goes to the players,” said Superior head coach Ryan Palmer, who deserves his share of acclaim as well. “We have high standards and work hard to maintain them. We strive to improve each year, building off the tradition of excellence set by our alumni. They have built a program that our entire community can take pride in.”

Many of the Panthers’ starters have yet to play a full game and last Friday was no different, but they’re making the most of their time on the field. Junior

quarterback Matthew Cruz threw for 393 yards and five touchdowns, all in the first half, including scoring plays of 99 and 96 yards to senior Nathan Duarte and sophomore Zachery Duarte, respectively. Senior Marc Mendoza was on the receiving end of a 79-yard scoring pass from Cruz. Senior Josh Marquez finished with a pair of catches for 46 yards and a touchdown. Cruz also connected with senior Adam Navarrette, who made a great reception, outleaping the Knights’ best defender and then running away from him for the touchdown. Matthew Diaz-Gonzalez had a game-high 106 rushing yards and a touchdown.

“Matthew is one of the best throwing quarterbacks in the state,” Palmer said. “Our senior-led receiving core – Adam Navarrette, Nate Duarte, Josh Marquez, Marc Mendoza and Matt Perez – is arguably the most talented, top to bottom, in the 1A conference. When opposing teams pressure and blitz we are equipped to capitalize.”

The defense was stellar again, allowing only a lone score for the third-straight game following a shutout in the season opener. It totaled five sacks in the game, two each by Adam Lopez and Zachery Duarte, both sophomores, and the other by senior Marc Mendoza. Navarrette snatched his second interception of the season and had a

fumble recovery. Diaz-Gonzalez led the team with 11 tackles while Navarrette added eight.

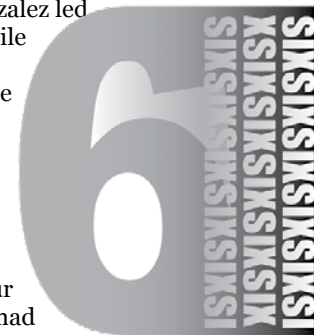
The Panthers’ performance last Friday was similar to their previous three: dominant on both sides of the ball.

“We came out ready to play,” Palmer said. “We executed well scoring on our first two offense plays. We had five offensive touchdowns in the first quarter, and our defense had a great goal-line stand early, setting the tone for the rest of the game.”

With two regular-season games remaining, the Panthers will be challenged to maintain their focus and not have a letdown between now and the playoffs, however unlikely that might be.

“We are focused on improving each day,” Palmer said. “We are humble and know that our potential is yet to be realized.”

Up next: Friday, Oct. 30 vs. Desert Heights Prep. Kickoff is scheduled for 7 p.m.

Lonely elders hit hard by the rigors of social distancing and self-isolation

It's no secret that America's elderly population is among the hardest hit by the COVID pandemic. Not only are they at higher risk of infection, those who live alone are more likely to succumb to the loneliness of precautionary self-isolation, says Rebecca Weber, CEO of the Association of Mature American Citizens [AMAC].

How bad is it for our senior population?

"Bad enough that desperate residents of a long-term care facility in Greely, CO, sick and tired of COVID-19 restrictions, recently staged a protest. Many of them were in wheelchairs and holding signs that read 'Rather die from COVID than loneliness,' 'Prisoners in our own home' and 'Give us freedom,'" says Weber.

She notes that Pew Research recently found that 27% of adults ages 60 and older live alone in the U.S. Meanwhile, the Centers

for Disease Control reports that many of them are socially isolated or lonely in ways that put their health at risk. In fact, the CDC cites studies that show:

Social isolation significantly increased a person's risk of premature death from all causes, a risk that may rival those of smoking, obesity, and physical inactivity.

Social isolation was associated with about a 50% percent increased risk of dementia.

Poor social relationships (characterized by social isolation or loneliness) was associated with a 29% increased risk of heart disease and a 32% increased risk of stroke.

Loneliness was associated with higher rates of depression, anxiety, and suicide.

Loneliness among heart failure patients was associated with a nearly 4 times increased risk of

death, 68% increased risk of hospitalization, and 57% increased risk of emergency department visits.

"Those of us who have what we might call normal lifestyles feel lonely when we haven't seen our friends and family in more than a couple of days. Imagine not having friends and family in the best of times and now that the world is dealing with the deadly coronavirus your norm is solitary confinement," says Weber.

Copper Area News is committed to providing our readers with as much information as possible. We post a daily update on our Facebook page with the total positive COVID-19 Data. This graph shows the daily counts of positive cases for the past week as of press time on Oct. 26, 2020.

There are a few points we would like our readers to consider when following this data.

1. This will continue to be a rolling total of positive cases. It does not reflect recoveries or deaths. The Arizona Department of Health Services does not break out this data.
2. If you see a reduction in numbers from day to day it is most likely due to a data entry error or mis-coding of a zip code (at the state level).
3. This is all zip code based data; most of our zip codes include unincorporated areas. There is no way to track exactly which areas each of the positive cases are. Example, Kearny and Winkelman each have small communities in their zip code that are not in the Town's incorporated boundaries.
4. If you live in Gila County, please follow the Gila County Health and Emergency Management, Facebook. They have maintained their data on recoveries and current positive cases.
5. You can follow other data such as ICU bed use, Ventilator use and hospital capacity online: <https://bit.ly/zinh280>

ORDINANCE NO. 2020-168

AN ORDINANCE OF THE TOWN COUNCIL OF THE TOWN OF SUPERIOR AMENDING SECTIONS 5-2-1 AND 5-2-3 OF THE SUPERIOR TOWN CODE AND DECLARING AN EFFECTIVE DATE WHEREAS, said Town Building and Safety Codes are in need of substantial revision to meet changed conditions and to conform to existing laws; and WHEREAS, said This Ordinance shall take effect 30 days from the date passed and adopted by the Town Council of the Town of Superior; and **BE IT ORDAINED** by the Town Council of the Town of Superior, Arizona, that the Code of Ordinances of the Town of Superior, Arizona, are amended to read as follows: **SECTION I:** Section 5-2-1 of the Superior Town Code is amended as follows: **Section 5-2-1 Adoption of International Fire Code.** The "International Fire Code" 2018 Edition, prepared and published by the International Code Council, shall be the Fire Code of the Town of Superior. **SECTION II:** Section 5-2-3 of the Superior Town Code is hereby amended as follows: **Section 5-2-3 Local Amendments to International Fire Code Amend Section 101 General** by replacing [name of jurisdiction] with "Town of Superior" Amend **Section 903.2.8.2 Care facilities** by removing the word "shall" and replace with "may". Amend **Section 5607.3 Blasting in congested areas**, by deleting the last sentence and adding the following subsections: **Section 5607.3.1 Testing.** Seismic and air blasting testing shall be conducted by an independent testing agency and the results recorded in the blasting log for each blast. Tests may be waived for distances greater than 500 feet if the code official determines there is little probability of damage to adjoining property from the blasts. **Section 5607.3.2 Blasting Mats.** When blasting within 500 feet of a structure, Blasting mats shall be used to prevent fragments from being thrown. Mats may be required at distances exceeding 500 feet if the code official determines that further precautions are necessary to protect adjoining properties. **Section 5607.3.3 Notification.** When blasting within 1000 feet of an occupied structure occupants shall be notified in writing no less than 48 hours and no more than 5 days prior to the blast. A copy of the notification shall be submitted to the code official at the same time as the occupants. Amend **Section 5607.4 Restricted hours**, by adding the following after the last sentence: "No blasting shall be conducted on weekends or holidays." Add a new **Section 5607.16** as follows: **Section 5607.16 Blasting Logs.** For all blasts within 1000 feet of a structure a detailed blasting log shall be maintained. The log shall be submitted to the code official within five days after the last blast authorized by the permit or upon expiration of the permit. For blasting within 500 feet of a structure, a copy of the log shall be submitted to the code official prior to the next blast. The code official shall review the log to determine that all blasting operations have been in compliance with this code. Subsequent blasting shall not be performed without permission from the code official. The log shall contain the following information:

- A copy of the approved permit and blasting plan
- The location of the blasting operation
- The date and time of each blasting occurrence
- If blasting mates or other cover was used
- A copy of the seismic readings and information on who conducted the tests
- Any and all known damage or injury that occurred as a result of the blast. If there was none, then that shall be stated
- Any other information the code official may require to demonstrate compliance with this ordinance

Failure to comply with the provisions of this section may result in revocation of the blasting permit. **SECTION III:** All other ordinances and parts of ordinances in conflict with the provisions of this ordinance or any part of the codes adopted herein by reference and are hereby repealed. **SECTION IV:** If any section, subsection, sentence, phrase, clause or portion of this ordinance, or any part of the codes or regulations adopted herein by reference is for any reason held to be invalid or unconstitutional by the decision of any court of competent jurisdiction, such decisions shall not affect the validity of the remaining portions thereof. **SECTION V:** The provisions of this Ordinance shall become effective thirty days after the passage of this Ordinance. **PASSED AND ADOPTED BY THE MAYOR AND TOWN COUNCIL OF THE TOWN OF SUPERIOR, ARIZONA**, this 8th day of October, 2020, by the Town Council of the Town of Superior, Arizona **TOWN OF SUPERIOR:** /s/ Mila Besich, Mayor **FORM APPROVED BY** /s/ Stephen R.
