

Free COVID-19 saliva testing offered at Hayden High School

Gila County Public Health and Emergency Management and Arizona State University's Biodesign Institute will provide SARS-CoV-2 (Covid-19) testing, utilizing a simple saliva collection method for the Copper Corridor.

Two testing days are offered: Friday, Oct. 9, and Friday, Oct. 16, 1-6 p.m. both days. Tests will be administered at Hayden High School, 824 Thorne Ave., Winkelman.

You must schedule an appointment prior to arriving at the test site.

Schedule an appointment

- Register for appointment with your cell phone, tablet, laptop or desktop computer.

- Agency code: SALIVATEST
- Once logged-in to the portal, click on "Appointments" to request an available appointment time.

Arrive no more than 15 minutes prior to your appointment.

Important guidelines

- You must wear a protective face covering either cloth or surgical mask.
- Bring the QR code you receive after scheduling your test appointment.
- Thirty (30) minutes before your appointment, rinse your mouth with plain water for 20-30 seconds and then spit the water out
- Do not eat, drink (even water), smoke, vape, or chew gum for 30 minutes prior to your appointment time (any of these factors may cause an invalid test and/or your test may be rejected by clinical personnel at site collection).
- Tip: Staying well hydrated by drinking water the day before and up to 30 minutes prior to your test will speed your saliva collection process.

Results will be available via the portal approximately 48 hours from your testing time.

Individuals will be available at the COVID-19 testing site to address questions you have pertaining to the sample collection process.

Deborah Gaines, President of the Friends of the Oracle State Park, stated, "We have created two ad hoc committees. One is exploring ways to restore the sisters' cottages for limited use, and the other is looking at rebuilding the nature blind."

With months of more persons being home from work and school, with social distancing in effect, there are not many distractions and forms of recreation left to enjoy. Most of the events that not only entertained the locals, but defined the Tri-Community area to the world at large, are big social affairs; and as such, have been at least temporarily stripped away.

Getting out in nature with your loved ones, perhaps seeing others enjoying the park from the small but important distance that must be maintained, may be a good way to add normalcy back into this strange new way of life, as well as a good method of getting in exercise.

She continued, "Attendance at the park has been high, although most events have been put on hold. We are excited to have a Virtual Star Party on Friday, Oct. 9."

While events are being scheduled, it must be noted that social distancing and the use of masks are still in effect and the Oracle State Park is no exception. For information about Arizona State Parks Covid protocol go to azstateparks.com/coronavirus.

gmail.com to have a membership form emailed to you. For those without internet access, a membership form may be requested at the Oracle State Park.

Currently, the hours at which Oracle State Park is open to the public are 8 a.m. through 5 p.m. with the Kannally Ranch House Gift Shop open from 9 a.m. through 4 p.m.. The Mt. Lemmon Road entrance gate closes at 4 p.m. and the exit gate is closed and locked at 5 p.m. As always, the American Avenue Trailhead is open daily, sunrise to sunset for hikers, equestrians and mountain bikers; and nightly for stargazers. No camping will be permitted, either in tent or vehicle, no water will be available and no fires are allowed.

Every day the park is open you are welcome to visit the park and take a self-guided tour of the historic Mediterranean-Revival style Kannally Ranch House which was built in 1929 through 1933 and is listed on the National Register of Historic Places. Wearing a mask and social-distancing is required, without exception to tour the house. A maximum of six persons are allowed to tour the house at one time, for your safety.

Beginning Monday, October 12 COVID-Safe Guided Bird Walks will head out at 8:15 a.m. Due to limited space, with no more than five participants able to join each walk, call ahead to make your reservation. Everyone must agree to wear a mask and socially distance on the trail during the entire guided bird walk.

For this walk, you will join volunteer guide Mary Ellen at the Kannally Ranch House upper patio, in the beautiful Oracle State Park. The park is a quiet place elevated both in height and experience. At 4500 feet elevation, it offers a different habitat to explore than that which can be found around Tucson, which means different species of birds which dwell in these higher climes.





Hispanic Heritage Month – The History of Hispanics in Wars

ispanics have honorably served in all the military branches of the United States. More than 300,000 Latinos enlisted in the armed forces during World War II. It is estimated that 3,070 Hispanics died in the Vietnam War. Latinos earned 14

Medals of Honor in Vietnam. They have served in every American conflict from the Revolutionary War to the present war against terrorism in the Middle East.

I was surprised to learn that Latinos were involved in the Revolutionary War. During the American Revolution and the founding of the United States, Spain still had numerous territories and interests in land that is now part of the United States.

In 1777, Bernardo de Galvez was appointed Governor of Louisiana with instructions from Spain to make friends with the United States. The American rebel colonists and France were at war with the British. During this time the British had blockaded the ports of the 13 colonies. Having control of the port of New Orleans, Galvez was instructed to sell badly needed supplies to the American rebels including muskets, gunpowder, food, and medicine. A supply route was established from New Orleans up the Mississippi River to rebel outposts.

On June 21, 1779, Spain officially declared war on Great Britain. Spanish troops commanded by Galvez captured West Florida. His military campaign defeated British colonial troops at Fort Bute, Baton Rouge and Natchez, freeing up the Mississippi Valley from British control. His armies recaptured Mobile in what is now Alabama. In 1781, the Spanish defeated the British and took the port of Pensacola, Florida. This meant the British had no bases along the Gulf Coast. Galvez's military campaign kept the British occupied so they could not encircle the American rebels from the south.

In 1783, the Treaty of Paris which ended the Revolutionary War, granted Spain the entire territory of Florida which had been in British control. In 1785, Galvez would be appointed Governor of New Spain which included what is now Mexico and the southwest United States, Texas and California. In 2014 the U.S. Congress conferred Honorary Citizenship on Galvez. In the citation he was called "a hero of the Revolutionary War who risked his life for the freedom of the United States people and provided supplies, intelligence, and strong military support to the war effort." The city of Galveston, Texas is named for him.



Pinal Rural Fire District celebrates the history of Fire Prevention Week

Ninety years ago President Calvin Coolidge proclaimed the very first Fire Prevention Week in 1923. This year, Pinal Rural Fire District celebrates 90 years of fire prevention and life safety events in the United States.

Fire Prevention Week is observed each year during the week of Oct. 9 in commemoration of the Great Chicago Fire, which began in the evening on Oct. 8, 1871, and caused devastating damage. This horrific conflagration killed more than 250 people, left 100,000 homeless, destroyed more than 17,400 structures, and burned more than 2,000 acres of land.

The Great Chicago Fire of 1871 started in the barn behind the cottage of Patrick and Catherine O'Leary at 137 DeKoven St., on the south side of Chicago. Although the popular story is that a cow kicked over a lantern to start the fire, Michael Ahern, the Chicago Republican reporter who created the cow story, admitted in 1893 that he had made it up because he thought it would make colorful copy. At the time of the fire, the street was in a less prosperous neighborhood of Chicago.

In the 1990s, a team of forensic fire investigators recreated the neighborhood where the O'Leary's lived. Their research provided information that a neighbor, Daniel Sullivan, was the last one in the barn that evening and was the likely cause of the fire. However, the investigators were not able to completely prove this hypothesis.

The Great Chicago Fire undoubtedly is the most famous fire in American history; however, it was the smallest of the many fires that burned on Oct. 8-10, 1871. On that very same night, some 250 miles north of Chicago, another inferno raged as well; this one in Peshtigo, Wisconsin. Although widely eclipsed in history by the Great Chicago Fire, the Peshtigo Fire proved even deadlier than its neighbor to the south, and in fact gained the infamous status of the deadliest fire in recorded history.

When the flames eventually died out, the damage of the Peshtigo Fire was staggering: The conflagration had consumed 1,875 square miles, obliterated 12 communities, and caused the deaths of between 1,500 and 2,500 people.

Fire Prevention Week is observed in the United States and Canada, during the week (from Sunday to Saturday) in which Oct. 9 falls. In the United States, the first Presidential proclamation of Fire Prevention Week was made in 1925 by President Calvin Coolidge.

The theme for Fire Prevention week this year is "Serve Up Safety in the Kitchen."
