# Election Updates: Rios behind, Cline wins and no changes for LD 8

Voters in the Copper Corridor turned out in record numbers to cast their ballots for the Presidential and statewide elections, along with those critical elections voters made their choices for County Supervisors in Pinal and Gila Counties along with Legislative Districts 8.

As the votes began to tally, Supervisor Pete Rios held an early lead over Kevin Cavanaugh for Pinal County Supervisor District 1. As the days of vote counting went on, the lead transferred to Kevin Cavanaugh. At press time incumbent Supervisor Pete Rios is behind by 417 votes. The race has not been finalized but at press time Kevin Cavanaugh was winning with 10,076 votes to Rios' 9,659 votes.

In a statement to Copper Area News Supervisor Rios said, "I congratulate Mr. Cavanaugh. Even though I never got to meet him or debate him on issues, but he got more votes and that's how democracy works. To my constituents in the Copper Corridor and Supervisor District one, thank you for four decades of support. I'll decide any future plans for me next year."

Gila County voters in District 2 easily re-elected Supervisor Woody Cline. Cline beat Bernadette Kniflen with 56.90% of the votes. Total vote count at press time: Supervisor Cline 4,334 (56.90%) to Bernadette "Bernie" Kniflen's 3,268 (42.90%).

"I learned a lot in my first four years in office and I look forward to working hard and getting even more things done in my next four years. Thank you to all that voted for me," stated Supervisor Cline

Voters in both Gila and Pinal Counties kept the Legislative District 8 incumbents in office. Democratic contender Sharon Girard had an early lead over Frank Pratt and David Cook for the Arizona House of Representatives. At press time the Arizona Secretary of State has declared that Rep. David Cook has secured another term in the House and he will be joined by Frank Pratt who was termed out in the Arizona Senate as the LD 8 House of Representatives. Rep. TJ Shope having been termed out in the House of Representatives ran against former State Senator Barbara McGuire for the LD 8 Senate Seat. Shope maintained a lead throughout the vote tally, winning the seat with 58.44% to 41.56% for McGuire.

The election results will all need to be certified by the County Board of Supervisors before they are official.

# Evan Apuron medals at State Championship Swim Meet

The 2020 Division III High School State Championship Swim Meet was held at the Phoenix Country Day Aquatic Center in Paradise Valley on Nov. 7.

The meet was held under strict COVID-19 protocols. Swimmers had to arrive at the pool in their swimsuits, maintain spacing on the deck and in the pool, and wear masks until stepping on the starting blocks for their race. No spectators were allowed at the meet. Instead of the normal Preliminaries and Finals sessions, the Championship was held as timed finals in the morning for the Boys. Girls had timed finals in the afternoon.

San Manuel Senior Evan Apuron finished 3rd in the 100 Yard Butterfly with a time of 51.59 and 3rd in the 100 Yard Breaststroke with a time of 59.04.

Apuron's Breaststroke time is a new School Record – it was 0.91 seconds faster than the record Apuron set in 2018 (59.95).

The 32 points that Apuron earned were enough for the Miners to finish in 18th place in the team standings (out of 62 teams in Division III).

In 2019 Apuron set the 100 Yard Butterfly Division III State Record (50.71), it was beaten at the 2020 meet by William Bansberg from Notre Dame Prep with a time of 49.09.

There were no medal ceremonies due to the COVID-19 Protocols.

It was great to be able to hold the State Championship meet during the Pandemic. Even though the conditions were tough, swimmers rose to the occasion and took advantage of the opportunity.

"Evan swam the fastest Breaststroke of his High School career during his last race." Coach Alex Gort proudly asserted, "The Breaststroke was an event that he struggled with this season, but put it all together at the end – some great perseverance to make it happen."

Evan finishes his high school swimming years holding six individual school records: 100 Fly – 50:71; 100 Breast 59.04; 50 Free 21.41; 100 Free 48.30; 200 IM 1:59.40; and 200 Free 1:52.63. These are marks that future Miner swimmers will straightful.


# Riley Stewart State Champion swimmer

# Celebrating Our Veterans: Cruz B. Aguirre

This year we celebrate the 75th anniversary of the end of World War II and today, Nov. 11, we celebrate Veterans

These two dates mean so much more to the family of Cruz B. Aguirre.

Like so many of our World War II Veterans, Mr. Aguirre is no longer of this earth. He died in 1987 at the young age of 67, leaving his family to grieve.

The Aguirre family reached out to *Copper Area News Publishers*, wanting to do a tribute to their father on Veterans Day, to tell his story so others could see what he gave in service to his country.

"I asked my mom questions about our dad," his son Daniel Aguirre said, "for he was not much for talking about the war. He would rarely talk about himself in general.

"My mom stated, 'He was a man that did a job and left it there. He wouldn't talk about it later," Daniel added.

Cruz was born May 27, 1920 and was a member of the Civilian Conservation Corps, working at the Grand Canyon. He served in the CCC from Oct. 10, 1939 until Sept. 13, 1940.

When he was 22, he enlisted in the Armed Services. Just like so many other young men of his era, he was ready to defend his country. The attack on Pearl Harbor on Dec. 7, 1941, brought so many uncertainties to all.

On Feb. 3, 1942, Cruz reported to Fort Bliss, Texas, to begin his training. The first assignment for this young Combat Infantryman was the Aleutian Islands in Alaska. He left on June 19, 1942.

Japan had invaded the small islands as a strategic stronghold.

"While traveling by Dutch Harbor, his first eyewitness of war was seeing smoke bellowing from the building that had been attacked," Cruz's son said.

The extreme weather on the Islands created a challenge to both American forces and machinery.

"He recounted having to guide himself from building to building by holding onto ropes that were secured to each building," Daniel said.

His service to the Aleutian Islands concluded March 31, 1944.

Cruz was sent back to the states for additional training and was reassigned to the 89th Infantry division under the command of General Thomas D. Finley. On Jan. 10, 1945, Cruz left for France and arrived at Camp Lucky Strike on Jan. 21, 1945.

His unit participated in several major battles as they made their way through Central Europe. The 89th joined the Third Army under the command of General George Patton while advancing through the Rhineland and crossing the Sauer, Moselle and Rhine rivers — all while under fire.

One of Cruz's worst encounters during World War II occurred while crossing the Rhine River.

"He once told my mom that he hid in the shadows of doorways as German troops marched in front of him. He was also listed as Missing in Action (MIA). He was with a group of men that took some German soldiers prisoners

# Veterans Day: Recognizing Native American Veterans

n Veterans Day, Nov. 11, 2020, the Smithsonian's National Museum of the American Indian in Washington, D.C., will open the new National Native American Veterans Memorial. This Memorial will remind the nation and honor the service and sacrifice of Native American, Alaska Native and Native Hawaiian Veterans. Native Americans have participated in the

military since colonial times to the present day. The U.S. Department of Defense estimates that 24,000 American Indian and Native Alaskan men and women are on active duty, and over 150,000 veterans identify as American Indian or Native Alaskan.

In Arizona we know about and are proud of the Navajo Code Talkers. The first Code Talkers were members of the Choctaw tribe and were first used in World War I in France. Although Navajos made up the majority of Code Talkers in World War II, the Code Talkers were also made up of soldiers from different tribes including Choctaw, Comanche, Cherokee and Sioux, 33 tribes total were used.

Alaska Natives using their Tlingit language were also instrumental in saving lives and defeating Japanese troops in the South Pacific and the Aleutian Islands of Alaska during World War II. Despite the efforts of missionaries and teachers to suppress the Native Alaskan languages, many natives clung to their culture and traditions. Tlingit was forbidden to be spoken at schools and punishment for using the language included washing the speaker's mouth out with soap and

having their hands struck with rulers.


Although five Tlingit soldiers were identified in 1968 as being Code Talkers, they were not honored until 2013. In November of that year, in Washington D.C., the five Alaska Natives were posthumously awarded Silver Medals from Congress. The Tlingit tribe was awarded a Gold Medal which was accepted by Alaska Native Veteran's Commander Ozzie Sheakley. The five Tlingit Code Talkers were: Richard Bean, Sr., Army; Mark Jacobs, Jr., Navy; Harvey Jacobs, Navy; George Lewis, Sr., Army and Robert "Jeff" David, Sr., Army,

#### NATIVE AMERICAN MEDAL OF HONOR RECIPIENTS

Thirty-two Native American warriors have been awarded the country's highest military honor for valor, the Medal of Honor. The Medal of Honor was created during the Civil War to honor those military service members who "distinguishes themselves by gallantry in action and other seamanlike qualities." President Abraham Lincoln signed the legislation creating the medal in 1861.

Some of the first Medal of Honor recipients from Arizona were Indian scouts for the military campaign against the Apaches. Not only did these brave warriors have to suffer indignations from the white populace and sometimes their own troops but were hated by some of their own tribal members. In 1875, ten Apache Indian scouts received the Medal of Honor for "Gallant Conduct during campaigns and engagements with Apaches" in the Arizona Territory. The ten scouts were: "William" Alchesay, Blanquet, Chiquito, Elsatsoosh, Jim, Kelsay, Kosoha, Machol, Nanasaddie, and Nantaje.

"William" Alchesay was born in the area of Limestone Canyon, Arizona Territory in 1853. He was a chief of the White Mountain Apaches. He served under General George Crook in the winter campaign of 1872 – 1873 against hostile Chiricahua Apaches. Alchesay earned the rank of Sergeant. He was an advisor to Indian agents on the reservation. He was a friend of Geronimo and helped track him and tried to get Continued on page 9

him to surrender peacefully. They remained friends until Geronimo's death in 1909. Following Geronimo's surrender in 1886, Alchesay left the Army and returned to the reservation.

Alchesay had two wives and became a successful cattleman and farmer. He was the last hereditary chief of the White Mountain Apaches and sought better conditions for his people. He met with three Presidents, Grover Cleveland 1887, Theodore Roosevelt 1909 and Warren G. Harding 1921, advocating for his tribe. In 1928, Alchesay died at Northfolk, Arizona. He is buried on the Fort

while an MIA. After a few days they came across an American camp. He was reunited with his troop at that camp," his son recalled.

Cruz once sent back a newspaper clipping of a photo, asking for them to keep it safe for him. "He never explained to us why it meant so much to him," Daniel said.

On April 5, 1945, Cruz's unit encountered resistance in the town of Eisenach, Germany. They continued fighting until April 18, 1945 when they secured the town of Zwickau, which was the last major engagement in Europe. Victory in Europe Day, V-E Day, was May 9, 1945.

Cruz separated from the Army on Nov. 13, 1945, and he returned to Hayden to work for the Kennecott Copper Company. He married Amelia Lopez on Dec. 28, 1947, and the couple raised six children, Cruz, Lupe (Guzman), Gabriel, David, Daniel and Edward.

"He was a very humble man," Daniel said. "As I look back, I realize my dad was the ultimate family man. He would cash in his vacation time to buy us school clothes or the necessities and rarely took a vacation. Holidays were always celebrated in our household. He loved the game of baseball, playing pool, and, as a young man, he enjoyed

#### HAWAIIAN BORN HERO

Herbert Kailieha PiliLa-au was born on the island of Oahu in Wai'anae, Territory of Hawaii. He was the ninth of 14 children born into his family. He graduated from Waipahu High School in 1948. He was drafted into the Army and completed basic training at Ft. Shafter on Oahu. Herbert considered declaring himself a conscientious objector as his Christian faith made him unsure about killing others but decided against it. In March 1951, he was sent to Korea where he served as a private first class with Company C, 23rd Infantry Regiment, 2nd Infantry Division. He volunteered to be his squad's automatic

rifleman and was assigned a Browning automatic rifle (BAR).

In August, the 2nd Infantry Division attacked and captured a ridge at the Battle of Bloody Ridge. In September he found himself in another bloody battle that would become known as the Battle of Heartbreak Ridge. On Sept. 17, 1951, Company C and two other companies were ordered to attack one of two peaks. When the attack stalled, they set up a defensive perimeter in front of the rest of the company. A major attack by North Korean troops using artillery and mortars threatened their position. Running low on ammunition, Company C received permission to withdraw. Pililaau's squad was told to stay back and guard the withdrawal. Soon Pililaau and his squad leader Richard Hagar found themselves the only ones left at their defensive position.

Pililaau used his automatic rifle to fight attacking troops while Hagar called

in artillery strikes close to their position. Pililaau told Hagar to withdraw while he continued firing on the enemy. He soon ran out of ammunition and began throwing grenades at the oncoming North Koreans. When he ran out of grenades, troop members from his company reported that he began throwing rocks at the enemy, then attacked them with his trench knife and fists before being surrounded and bayoneted to death. When his platoon retook the position the following day, they found 40 dead North Korean soldiers around his
