Oracle override fails by narrow margin

The Oracle School District budget override issue was defeated at the election held November 5.

Final unofficial voting results from the Pinal County Elections Department show 2,362 Yes votes and 2,422 No votes. The results were close (60 votes).

What this will mean for the district is a loss of \$240,000 to \$270,000 in funding for the 2014-2015 school year. The loss will increase by one third the following school year and the override funding will completely disappear in the 2016-2017 school year.

The votes are unofficial until they are canvassed by the Pinal County Board of Supervisors.



Override failure due to misinformation

These views are my own and do not reflect those of the Oracle School Board. During the recent election, I realized I hadn't worked hard enough to ensure voters were properly informed about what was at stake with the override continuation for the Oracle School District.

One voter even told me he was going to vote no because he knew that the cost would double in five years due to compounding interest. I am not sure what he meant, because this wasn't a bond election but an override. It would have continued the local funding previously approved (twice) by District voters. The amount currently paid is \$2.25 per month per \$100,000 of full market value, or less than \$10 per month per average homeowner. We predicted no change to that amount.

The funding the override would have continued isn't "nice to have" money. It is critical funding that goes directly into the classrooms in the form of textbooks, reasonable class sizes and professional development for

teachers. We've already cut music and art this year in the Oracle School District, decisions that were painful to make and hopefully, are temporary.

After all, research shows that students are most prepared for college careers, and full participation in our democracy, when they have a well-rounded education.

For now though, bringing back these programs is more a future goal than a near reality. That's why I was beyond disappointed the communities of the Oracle School District allowed the renewal of the override to be defeated.

It was all the more painful because it was a fairly close vote; the referendum, as of Nov. 8, was unofficially defeated by only 60 votes, or 1.26 percent. Our election was one of seven in Pinal County that failed, 100 percent, even though around the state 26 of 47 M&O overrides passed in Arizona this year for a 55 percent passage rate, close to the historical average since 2007.

In the end though, I guess it doesn't matter by how many votes the override lost. It only takes one and unfortunately in the end, innocent children are the ones who lose most. They deserve a good education not just because it is the right thing to do, but also because "establishment and maintenance of a uniform public school system" is guaranteed by the Arizona constitution. Make no mistake though, a lack of support for education will eventually affect us all. Thomas Jefferson certainly understood this when he said: "Educate and inform the whole mass of the people... They are the only sure reliance for the preservation of our liberty."

We won't preserve liberty forever with only 25 percent of our electorate voting and we won't preserve it by being short-sighted and viewing funding for education as a burden to bear rather than an investment to make. Our nation's future demands the investment and our children deserve it.

Pinal woman convicted for aggravated assault on a police officer, after shooting at a PCSO Deputy

FLORENCE, AZ (11/6/13) – On Friday, Nov. 1, Pamela Williams, 65, was found guilty by a Pinal County jury on Use of Marijuana and Aggravated Assault on a Police Officer for shooting at a Pinal County Sheriff's Deputy.

The case began four days into newly elected Pinal County Attorney Lando Voyles' term, on Jan. 4, 2013, when Pinal County Sheriff's Deputies responded to a dispute between neighbors near SaddleBrooke, AZ. One of the neighbors was the defendant Pamela Williams. As one of the Deputies approached the defendant's home to protect the peace of the community and to ensure the neighbor dispute did not escalate, he heard two gunshots and saw a muzzle flash of a gunshot from the property. The defendant only stopped firing because the gun jammed.

Williams was taken into custody and while speaking to police,

changed her story numerous times about where she fired and why she fired. The defendant consumed marijuana just prior to firing the shots.

"If you believe you're entitled to the right to lawfully carry a gun in AZ, you're right. If you believe that you're entitled to protect yourself when faced with imminent serious physical injury, you're right. But, if you believe that you're entitled to shoot at a deputy or officer, you've got another think coming! While we live in the West; this is not the Wild, Wild West," Pinal County Attorney Lando Voyles said. "The sentencing for shooting at law enforcement ranges from a presumptive 10.5 to 21 years in Arizona and the drug charge conviction carries the potential for an additional 0.33 and 2 years. Williams faces up to 23 years in Arizona Department of Corrections and a sentencing hearing is scheduled for Dec. 10, 2013."

Pinal Rural Fire Rescue passes donations on to another organization

A chance encounter while eating lunch at La Casita Mexican restaurant in Mammoth led to a first-time meeting of members of the Pinal County Sheriff's Office Search & Rescue and Pinal Rural Fire & Rescue. Out of this unplanned meeting came a plan to cross-train together in the Galiuros, and a donation of extrication equipment to the Sheriff's Search and Rescue Team.

PCSO Search and Rescue were conducting off-road training in the Galiuros and that happens to be part of the area that Pinal Rural Fire & Rescue protects in its 300+ sq. mile 911 service area.

PRF&R had been awarded an AFG (Assistance to Firefighters Grant) in 2012 and received all new extrication equipment. While discussing future training together, the SAR team members mentioned trying to find some extrication tools so Chief Bud Paine said, "We have some older equipment that had been donated to us. If you'd like, it you're welcome to it."

Chief Bud Paine and members of PCSO Search & Rescue Team meet at the PRF&R Station 625 in Mammoth with donated rescue equipment to PCSO SAR. The equipment was tested to make sure all was still working.

The SAR team received two gas power hydraulic units, two Hurst Jaws of Life spreaders, hydraulic cutters, hydraulic ram, a combi-tool (combination spreader and cutter in one) and a manifold to run multiple tools at once, and plenty of hydraulic hose for all of it.

Local Vietnam veteran honored by American Legion

Conrado Francisco Bilducia was born Jan. 18, 1947 in Tempe, Ariz. and grew up in Dudleyville, Ariz., the son of Conrado F. Bilducia and Margaret L. Bilducia. He was raised by his grandparents Felix and Romula Ramirez. He attended school in Hayden from kindergarten through high school. In high school he lettered in track throwing the shot and discus and football where he was the starting offensive and defensive tackle. He graduated with his class in 1965. After school he went to work for Kennecott Copper Corporation. He was drafted in 1966 and chose to go into the Army so he could attend airplane maintenance school. His good friend and brother-in-law Ruben Gonzales still remembers the day "Frankie", as Conrado was known, told him that he had been drafted.

Ruben had just got off of work when Frankie told him he had just received his draft notice. They joked about it, Ruben feeling lucky that it was Frankie that would be going into the Army and not him, as the war in Vietnam was escalating and more young men were being drafted and sent overseas. Later Frankie asked his friend Ruben to go into the Army with him on the buddy system. Ruben said that Frankie told him, "I want you to come with me, I'm afraid to die alone." After much contemplation and two days of drinking with Frankie, Ruben enlisted in the Army with his friend.

In June 1967 Conrado married his high school sweetheart Dina Gonzales. In September he left his now pregnant wife and was sent to South Vietnam. On March 3, 1968 at 3:50 a.m. Conrado's base camp near Ban Me Thuot was attacked. Specialist V Conrado Bilducia was performing his duties as the company Charge of Quarters when the attack started. He was on his way to the command post bunker where he would begin to organize and dispatch troops to defend the compound against an enemy ground attack. He had just left the orderly room when a mortar shell exploded a few feet away from him, killing him instantly. Ruben, who was also in Vietnam at the time, was notified a few days later. He would have the honor and sad duty of escorting his friend's body from San Francisco back to his home in the Copper Basin. Conrado was laid to rest in the Hayden Mountain View Cemetery with full military honors. Another friend of Rubens from Hayden had died a month earlier in Vietnam, Richard "Dickie" Contreras.

Although it was a time of deep sadness for Ruben, it would also be a time of joy. Ruben got to meet and hold his son for the first time. Ruben was able to spend 10 days at home before returning to Vietnam. Conrado's son, Conrado Jr. would be born a few month's later. Ruben believes that Conrado had a premonition about his own death. He had asked Ruben and his wife's family to have his son raised by his "Nana", Ruben's mother, should he die. His request was granted. Ruben would help Conrado Jr. to learn about his father as he grew up. Ruben would choke up when talking about "Frankie". He said "Frankie was a good man all his life beloved by all."

Ruben was able to visit the Vietnam Memorial Wall in Washington D.C. in 1998. He made a rubbing of Conrado's name and used it in a photo display memorializing Conrado. Ruben said, "He has lived 66 years with me." In some information that he gave me about Conrado, Ruben wrote, "Conrado was a quiet gentle man whose kindness and caring earned him many friends while on tour." He said, "Those same comrades in arms offering monetary gifts to his

widow back home. The letter of appreciation over shadowed by sadness and sympathy delivered to a fatherless home. Conrado Francisco Bilducia never had a chance to meet his only child, a son Francisco Jr. who was born months after his all too early passing. Francisco Jr. spent many years of his life wondering about this brave man who made the ultimate sacrifice. Father and son were joined in eternal rest in April 2010."

Specialist V Conrado Francisco Bilducia was honored 45 years after making the ultimate sacrifice for his country. On Saturday, Nov. 9, 2013 American Legion Post #124 in Guadalupe was named Conrado Francisco Bilducia Post #124 in his memory at a ceremony in Phoenix. Conrado's younger brother Rudolfo "Boy" Bilducia a Marine and member of the American Legion Post was in a position to make something happen to honor his brother. Conrado's father was raised in Guadalupe and was a World War II veteran who lost a leg in combat.

During his military service Conrado was awarded the Air medal, National Defense Service medal, Vietnam Campaign medal, Aircraft Crewman badge and Expert badge with rifle bar. Posthumously he was awarded the Army Commendation medal for Heroism, Purple Heart and the Good Conduct medal.

His commendation letter dated March 17, 1968 read, "For heroism in connection with military operations against a hostile force: Specialist Five Bilducia distinguished himself during an enemy mortar and ground attack. Even with mortar

rounds falling in the immediate area, Specialist Bilducia continued to perform critically important security measures within the company orderly room throughout the attack. As he was moving from the orderly room to insure ready access to the reserve ammunition supply, several mortar rounds exploded nearby, inflicting him mortal wounds. His actions were in keeping with the highest traditions of the military service and reflect great credit upon himself, his unit and the United States Army."

To all veterans: Thank you for your service and sacrifices



An exhibit of impressionist-style paintings by self-taught cowboy artist Lee Kannally will open on Nov. 23 at the Kannally Ranch House, Oracle State Park. Nearly 30 oils, many that haven't been on public display for decades, are included in the exhibit. with 24 on loan from Oracle Historical Society and the remainder owned by Friends of Oracle State Park.

A schedule of celebration events, including guided tours of the ranch house, a cowboy lunch, live music, and games, is planned for the day. The paintings will remain on display for the public through the end of April. Leonard L. "Lee" Kannally (1888-

1971) was one of five Kannally family members who established the cattle ranch in the early 1900s. An expert horseman and top roper, Lee took up painting as therapy after returning from service in WWI, where he suffered nerve damage due to gas poisoning while stationed in Siberia. According to one historic account, "he did most of his painting while kneeling next to his bed while the canvas was laid flat. This... minimized the involuntary movements" that were the effects of his war injuries.

His often-whimsical canvasses feature a mix of cowboys, horses, steers, campfires and even ballerinas. There are similarities in style and color palette to some of deGrazia's work, though Kannally painted for his own pleasure and neither signed or dated





Local World War II veteran receives medal

On Nov. 6, 2013 Marshall W. Baird of Oracle was presented with the French Legion of Honor medal, 69 years after serving in the United States Army and fighting courageously in France to help liberate the country during World War II. The presentation ceremony was held at the Valencia Library in Tucson. Marshall along with six other World War II veterans received the French Legion of Honor medal to World War II veterans. The Légion d'Honneur is France's highest award and is conferred upon men and women, either French citizens or foreign nationals, for outstanding achievements in military or civilian life. The president of France is the grand master of the order and appoints all other members of the order by convention on the advice of the government. Marshall was appointed as a Chevalier (knight) of the order.

Marshall Baird was born in El Paso Texas in April 1923. His family moved to New Mexico when he was five. He grew up in the Alamogordo vicinity and graduated high school in Reserve, N.M. After high school his two main jobs were working with the Civilian Conservation Corps and on a fire look-out tower for the U.S. Forest Service. Marshall then enlisted in the Army and received his basic training at Camp Wolters, Texas. He then went on to parachute school in Ft. Benning, Georgia. His MOS was rifleman but he also was a runner and bazooka man. He joined the 517th Parachute Regimental Combat Team and saw action in the Rome-Arno section in Italy. After a few weeks of combat his outfit was pulled out to begin training for the invasion of Southern France.

The invasion took place on Aug. 15, 1944. Marshall and his fellow paratroopers jumped inland north of Marseilles. They fought their way to the Italian border through the Maritime Alps. His outfit was in the frontlines for 94 consecutive days. From there he went to Soissons in Northern France to prepare for shipment to the Pacific theater. During this time, the Germans launched an attack and broke through the allied lines in the Ardennes. This became known as the Battle of the Bulge. The Battle of the Bulge was fought in Belgium, France and Luxembourg. It was the bloodiest battle fought by American soldiers in World War II. Over 19,000 American soldiers were killed in 40 days of fighting. The 517th was called in to help repulse the attack and arrived at the front line on Dec. 21, 1944. Marshall would be eventually evacuated to a hospital in England after suffering severe frost bite. After being treated and released he joined up with the 82nd Airborne Division and went to Berlin, Germany as part of the occupation forces.

Marshall fought in five campaigns (Rome, Arno, Southern France, Rhineland, Ardennes and Central Europe). His awards include the Bronze Star, Purple Heart, Combat Infantry Badge, Parachute Wings (one star), Presidential Unit Citation, and the Good Conduct medal. After the war he returned home in 1946 moving to Arizona in the 1950s. His work history included ranching, truck driving, labor foreman, and manager of an estate for an English Countess near Oracle. After retirement he served his community working as a fire department dispatcher, president of the Oracle Community Center, and secretary/treasurer of the Southern Arizona Chapter of the 82nd Airborne Division Association (18 years). He was married to Rita Romer

and they raised a son Bill and daughter Maggie, with three granddaughters and four great-grandsons. His wife Rita passed away in May 2012. Marshall lives by himself in Oracle.

In May 2013, Marshall received a letter from the French Ambassador to the United States announcing his appointment to the Legion of Honor. It read as follows:

I am pleased to inform you that by decree of President Hollande on May 21, 2013, you have been appointed a "Chevalier" of the Legion of Honor.

This award testifies to President Hollande's high esteem for your merits and accomplishments. In particular, it is a sign of France's infinite gratitude and appreciation for your personal and precious contribution to the United States' decisive role in the liberation of our country during World War II.

The Legion of Honor was created by Napoleon in 1802 to acknowledge services rendered to France by persons of exceptional merit. The French people will never forget your courage and your devotion to the great cause of freedom.

It is a true pleasure for me to convey to you our sincere and warm congratulations.
