Town of Hayden discussing potential for disincorporation

Throughout 2019, the Mayor and Town Council for the Town of Hayden has struggled with declining revenues and increasing costs to operate the Town. The council made the tough decision to close the library and not open the pool this summer. The Gila County Board of Supervisors along with the Pinal County Board of Supervisors came to the aid of the Town to provide additional funding to

keep the Hayden Senior Center open. Gila County also helped with providing library services, operating a temporary library out of the Hayden Senior Center.

These cost saving measures have only provided a small amount of relief to the Town's budget and the ongoing strike at ASARCO-Grupo Mexico has added another level of stress to the financial future of the Town of Hayden.

"With the smelter not producing, this will mean the loss of even more tax revenues for the Town," said Mayor Dean

Hetrick. "We can only operate the Town for another 14 months, if the strike lingers on."

The Town Council has not made any official decisions, but they do plan on discussing the subject this month. They are in discussions with Gila County and the Town of Winkelman regarding police services and what the disincorporation process will require. The Town of Hayden has provided police services to the Town of Winkelman under a contract for many years.

If the Town does disincorporate, Gila County will be the governing body responsible for police service, code violations and any other health and human safety requirements. The Town of Winkelman will also need to contract with another entity to provide police services.

The Hayden Town Council meets on the third Monday of every month at 5:30 p.m. at the Hayden Town Hall, located at 520 Velasco Ave. The next meeting is scheduled for Monday, Nov. 18, 2019. The meeting is open to the public.

Ray and Oracle school districts pass override/bond elections; other Pinal districts not as fortunate

Voters in the Oracle Elementary School District and the Ray Unified School District approved their respective bond and override elections. These elections help the districts to increase their budgets in addition to the revenues they receive from grants and the State of Arizona.

Ongoing cuts of state and federal funding have created an increased need for local school districts to call for override and

bond elections.

Voters in the Ray Unified School District approved their override continuation with 60.56% voting to approve the continuation of the override; 39.44% voted no on the continuation. There were a total of 568 mail in ballots returned.

The Governing Board of the Oracle Elementary school district called for an Override Continuation and a Bond election. Both requests were approved with a wide margin: 59.24% of the voters approved the override continuation,

40.76% voted against the ballot measure.

A total of 6,961 votes were cast in this election. The voters also approved a bond with 60.82% of the voters voting yes and 39.18% voting no. There were a total of 6,763 ballots cast in this election. The bonds will be used to improve school

facilities and technology.

Other Pinal County school districts were not as fortunate in their requests to the voters. Voters in the Apache Junction, Florence, Maricopa and Santa Cruz school districts voted no on bond and ballot measures.

Top-ranked Williams a challenge the Lobos couldn't overcome in Semi-Finals

A season during which the Hayden football team overcame several injuries and adversity came to an end after the No. 5 Lobos couldn't overcome their biggest challenge of the season against No. 1 Williams last Friday night



in the 1A semifinal playoffs.

The Vikings advanced to the 1A State Championship game with a 52 – 0 victory and will now face No. 3 and defending state champion Superior in this Saturday's title

game.

"We got beat," Hayden head coach John Estrada said. "(Williams) physically beat us in all aspects of the game."

Lobos' quarterback AJ Castillo returned from injury, but his appearance in the game didn't ignite the spark the Lobos needed against a dominant Vikings defense.

"AJ got released and was ready to go," Estrada said. "We were hoping to use his arm and complete some passes, but we never got the time to throw the ball."

Despite the loss, Hayden's program has much to be proud of, including a second-straight appearance in the semifinals of the 1A Playoffs and a fourth-straight overall.

"It was a great season indeed," Estrada said. "Our kids and coaching staff have nothing to be ashamed of. They did a super job, playing at the level we did after losing our starting quarterback.

"All the injuries we had during the season and fighting

through the adversity says a lot about our team. A lot of teams, and a few fans out there, counted us out when we lost AJ, but our motto was when someone went down, it was next man up. I can't complement those kids enough for the fight they had in them. Losing to Williams and how we lost to them wasn't the way I wanted the season to end. Unfortunately, we met up with a very tough Williams team."

Estrada credited his staff and the players for building "a very respectable, tough and physical Hayden football program." In doing so, he knows the Lobos are positioned to continue the pursuit of a championship.

"Hayden football is definitely back on the map and is very well respected throughout the state," he said. "Our young kids just need to keep working hard. Hard work will get us places."

It already has.

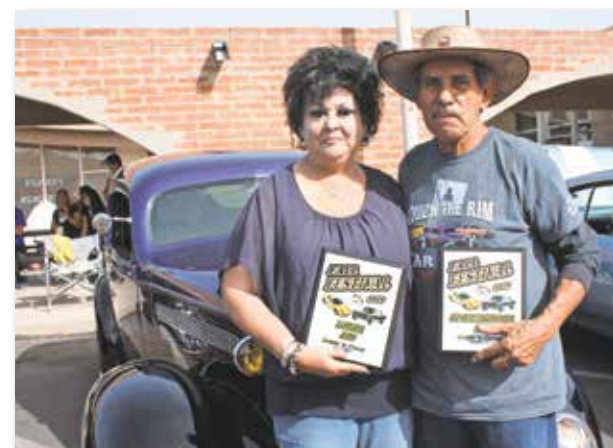

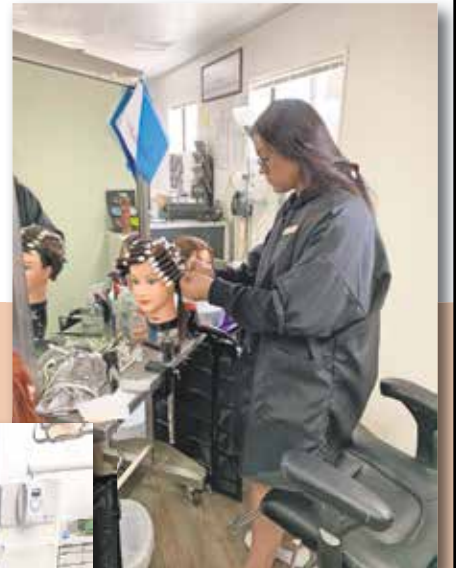

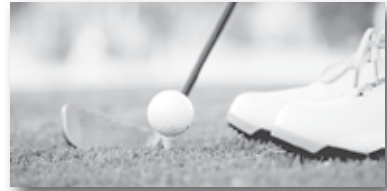
