New BLM veteran-staffed hotshot crew gets official name, logo

TUCSON, Ariz. – The Bureau of Land Management's (BLM) newest hotshot firefighting crew has an official name and logo that is uniquely Arizonan. The newly-selected name of the crew is Aravaipa. The crew is expected to be operational and responsive to local, regional and national wildfire incidents during the 2016 fire season. The BLM announced the creation of the crew in early October.

The crew namesake, Aravaipa Canyon, located northeast of Tucson in Graham and Pinal Counties, is a stunning example of a desert canyon and riparian ecosystem.

The Canyon is managed under the stewardship of the BLM's Safford Field Office.

"The name for a hotshot crew is about representing where you come from, so we selected something that people in southeast Arizona can connect to," said Timothy Shannon, Gila District Manager.

The BLM has also selected the superintendent for the new Aravaipa crew. Greg Smith, a seasoned wildland fire manager with more than 22 years of experience, will come on board in December, and will assist in hiring,

training and supervising the 20-person unit. Smith has extensive experience as a hotshot superintendent with the Ironwood Hotshots, Jackson Hotshots and the Globe Hotshots and is also a four-year military veteran of the U.S. Navy.

The crew will be seeking official hotshot designation during an intensive two to three year certification process, and will be stationed at Fort Huachuca thanks to a partnership between the BLM and the U.S. Army.

The BLM's long-term goal is for the Aravaipa crew to be made up entirely of veterans. Two crew captain job openings will be posted Nov. 11 at <https://www.usajobs.gov/>. In total, six year-round and 13 seasonal job positions will be posted in the coming months. All future job openings will be made available at the same website and will also be announced via BLM Arizona's Facebook and Twitter accounts.

Hotshot crews are the most skilled and highly trained units among wildland fire



personnel, meeting stringent requirements established by interagency fire managers and routinely engaged with the most complex wildfire incidents. The Aravaipa crew will be the only hotshot crew (also known as a Type 1 crew) in Southern Arizona and one of only 12 BLM hotshot crews nationwide.

Councils discuss public safety coalition

During their monthly meetings in September, the Kearny and Hayden town councils heard a presentation about the possibility of forming a Public Safety Coalition from Major Michael Orose who is from the office of the director at the Department of Public Safety. Orose made the presentations to the councils as a way to start the conversation. The idea came up after the communities of Hayden, Kearny and Mammoth have all had problems retaining a police chief and police officers.

Soon after the meetings with Kearny and Hayden, Orose approached the Town of Mammoth with the same proposal.

In his presentation to Hayden and Kearny, Orose explained that the coalition cannot be viewed as a cost savings plan. "The concept is intended to increase the level of service and professionalism of the law enforcement services provided to each town at the current funding levels," explained Orose.

In order for the coalition to be started there would need to be an interagency agreement set up and that agreement would cover what type of coverage each community wanted to receive; it would identify the funding commitments by each community. The agreement would also identify which town will be responsible for dispatching, administrative support and record keeping, what type of reporting does each town want and it would

establish an oversight board that would oversee the operations. Orose suggested that each town have two representatives and they could be two government officials or one community member and one government official. The oversight committee would also have by-laws for the board to operate under.

Currently each town is distributing resources for vehicles, equipment, facilities, maintenance, supplies and personnel costs. If the coalition were to be developed these costs would be shared amongst the coalition. The development of the coalition could streamline operations and create efficiency; the coalition would hire one Chief of Police to manage the coalition department, along with three Sergeants and up to 22 officers to cover the four communities. This staffing level would provide for 24/7 coverage in each town. The public safety coalition officers, chief and sergeant would wear the same uniform and all cars would be marked to match the coalition.

Both councils heard the presentation in an open forum and allowed for questions and comments from the public. There was a concern about dispatching services due to the fact that Kearny dispatches for the Hayden and Winkelman police

services. There were questions on whether or not the signal could reach Mammoth. Mammoth currently provides its own dispatching service and handles call outs for the San Manuel Fire Department.

Another topic of discussion was would personnel policies and codes be set up uniformly. Orose explained that these would be things that would have to be determined as the discussions continued but that it would be important to have consistency throughout the coverage area. He also indicated that it could take up to a year or more to get everything finalized for the coalition before it started to operate.

The Town of Winkelman currently contracts with the Town of Hayden for police services. Neither council took any official action at the meeting in September, but recently the councils have formed a coalition committee to explore this as a possible way to staff the police department administrations.

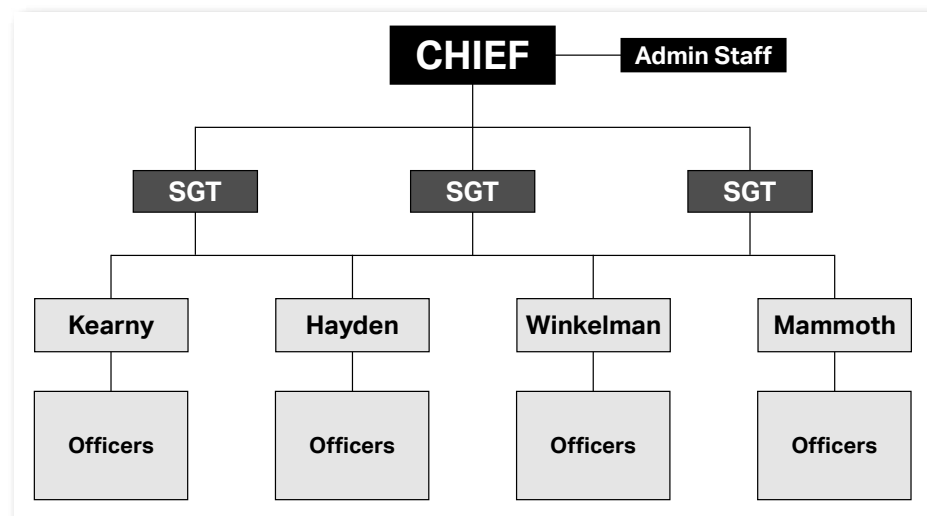

Learn about AZ black bears at Oracle State Park program

Anyone looking for amazing facts about black bears of Arizona will love the "Bear Necessities" interactive program by interpretive docent Richard Boyer, set for Sunday, Dec. 6. at the Kannally ranch house at Oracle State Park Center for Environmental Education. Safety around bears, an appearance of "Everywhere Bear", and a prize for the visitor with the most knowledge about black bears add to the fun. Program begins at 11 a.m.; reservation requested.

The program is free with park admission, as are almost all other scheduled events. When reservations are requested, they can be made by calling Jennifer Rinio, ranger, at the park office at 520-896-2425.

Other December weekend activities include a holiday wreath-making workshop on Saturday, Dec. 12, where participants will develop their designs with locally-gathered materials like soapberry, mistletoe, buckwheat, manzanita, and juniper. It begins at 1 p.m.; a \$10 fee includes park admission. Space is limited; reservation required.

Guided tours of the historic Kannally ranch house with docent Mary Bast are scheduled for Dec. 5 at 10 a.m. and 1 p.m.; Dec. 13 at 1 p.m.; and Dec. 19 at 11 a.m. The 45-minute tour visits rooms and patios extending down the hillside. The multi-level Mediterranean-Revival style house, built in 1929-33 by one of the earliest cattle

ranching families in Oracle, is listed on the National Register of Historic Places. An exhibit of impressionistic-style cowboy paintings by self-taught artist Lee Kannally is on display in the living room and dining room.

Also on display is a special exhibit of seven out-of-this-world astronomical images by Adam Block from the University of Arizona Mt. Lemmon Sky Center. Adam, recipient of the 2012 Hubble Award, is recognized around the world as a leading astrophotographer. His images are published in magazines, books, posters and widely on the internet. He will offer a presentation and film about astro-photography on Sunday, Dec. 20, beginning at 3 p.m. Reservation suggested.

For hikers, a guided hike along six miles of park trails with Gaston Meloche is set for Saturday, Dec. 19, starting at 8:15 a.m. Call Gaston for reservations at 520-638-5404. The park, at a comfortable elevation of 4,500 feet, has 15 miles of hiking trails, including a section of the National Scenic Arizona Trail, and numerous day-use picnic areas as well as vista patios at the ranch house.

The park is open 8 a.m. to 5 p.m. on Saturdays and Sundays; park admission is \$7 per car at the main gate on Mt. Lemmon Rd. in Oracle. Full Oracle State Park event information is always posted on the state parks website: www.azStateParks.com/Parks/ORAC.

- 1 small red onion, diced
- 1/2 cup olive oil
- 8 ounces sliced crimini mushrooms
- 2 cups turkey gravy
- 1 cup dry marsala wine
- 1 cup whole berry cranberry sauce

Sauté the onions in the olive oil until they start to become translucent. Add the mushrooms and cook until tender. Add the marsala wine and reduce by half. Add the gravy and cranberry sauce. Simmer until heated then add slices of turkey.

Serve over leftover stuffing when heated.

FLORENCE - Beginning Monday, Nov. 9, reaching Pinal County's Citizen Call Center will be as simple as dialing 3-1-1.

"This will be for any phone that is being dialed inside Pinal County," stated Pinal County Board of Supervisors Chairwoman Cheryl Chase. "The call center has the ability to reach the municipalities inside the county and dialing 3-1-1 will allow anyone to reach the government services they need. We are pleased to bring the public a service like this to make contacting us a little easier."

The first 311 Center was created in Baltimore Maryland in 1996. The 3-1-1 digits are reserved for non-emergency local government services, and now there are

3-1-1 contact centers throughout the US and Canada.

By activating this new simplified dialing, Pinal County becomes the first true 3-1-1 center in Arizona.

"Let's say if a person needs to reach Apache Junction and they don't know the number, they can just dial 3-1-1 and our helpful staff will be happy to direct them to the right person," Chairwoman Chase said. "In fact, we will be able to transfer the caller municipality inside the county."

The features of the new 3-1-1 system include:

- 3-1-1 allows customers to call one easy-to-remember number to access local government services and information within Pinal County.

- Hours of operation are Monday through Friday, 8:00 AM to 5:00 PM. The 3-1-1 Citizen Contact Center is closed on Saturdays, Sundays and holidays.

- Information Specialists use a state-of-the-art database of information and services offered by local government that can be continually updated so the most current facts are available.

- The 3-1-1 Center can quickly incorporate real time information when necessary for events like flooded streets, wildfires, or public health-related incident.

"The Citizen Call Center has been a huge success for the county and our residents," stated the Chairwoman. "The center has responded to nearly 870,000 citizen calls for information and services since they opened in 2007, and now callers can reach them by dialing 3-1-1 anywhere within the county."

Ray Federal Credit Union, focusing on the future – new branch and small business loans available

Adam Perlman the Manager for Ray Federal Credit Union set out on a mission to grow the Kearny-based credit union into more a regional financial institution. Perlman's first interactions with the branch was when he was working as an auditor that audits credit unions. When the branch manager job opened up he applied and the board hired him.

Two of the most recent projects by the RFCU is the successful application to the United States Department of Agriculture (USDA) which provides funding to local financial institutions to create a revolving loan fund small and emerging business loans. The USDA loans can be applied for at the Ray Federal Credit Union, and can be used to purchase capital expenses, equipment and in some cases operating expenses. These loans are only available to businesses in rural Pinal and Gila Counties

focusing on the communities of the Copper Corridor. In other areas of the country these loans are used to help a business grow or get off the ground; with low interest rates and flexibility these loans often to help fill a niche that other financial institutions can not meet. Businesses are still required to have solid business plans in their loan application process.

The other major project is the opening of a new branch in Superior. Construction of the branch is underway and RFCU is awaiting final clearance from the town council in Superior on the installation of an ATM on Main St. The branch will be located in the co-op space Smokey's Mercantile next door to the Superior Chamber of Commerce on Main St. The branch will feature the services available at the Kearny branch. Perlman is anticipating the Superior branch to be open by mid March.

He has been with the RFCU since 2012
