Local Vietnam veteran honored by American Legion

Conrado Francisco Bilducia was born Jan. 18, 1947 in Tempe, Ariz. and grew up in Dudleyville, Ariz., the son of Conrado F. Bilducia and Margaret L. Bilducia. He was raised by his grandparents Felix and Romula Ramirez. He attended school in Hayden from kindergarten through high school. In high school he lettered in track throwing the shot and discus and football where he was the starting offensive and defensive tackle. He graduated with his class in 1965. After school he went to work for Kennecott Copper Corporation. He was drafted in 1966 and chose to go into the Army so he could attend airplane maintenance school. His good friend and brother-in-law Ruben Gonzales still remembers the day "Frankie", as Conrado was known, told him that he had been drafted.

Ruben had just got off of work when Frankie told him he had just received his draft notice. They joked about it, Ruben feeling lucky that it was Frankie that would be going into the Army and not him, as the war in Vietnam was escalating and more young men were being drafted and sent overseas. Later

Frankie asked his friend Ruben to go into the Army with him on the buddy system. Ruben said that Frankie told him, "I want you to come with me, I'm afraid to die alone." After much contemplation and two days of drinking with Frankie, Ruben enlisted in the Army with his friend.

In June 1967 Conrado married his high school sweetheart Dina Gonzales. In September he left his now pregnant wife and was sent to South Vietnam. On March 3, 1968 at 3:50 a.m. Conrado's base camp near Ban Me Thuot was attacked. Specialist V Conrado Bilducia was performing his duties as the company Charge of Quarters when the attack started. He was on his way to the command post bunker where he would begin to organize and dispatch troops to defend the compound against an enemy ground attack. He had just left the orderly room when a mortar shell exploded a few feet away from him, killing him instantly. Ruben, who was also in Vietnam at the time, was notified a few days later. He would have the honor and sad duty of escorting his friend's body from San Francisco back to his home in the Copper Basin. Conrado was laid to rest in the Hayden

Mountain View Cemetery with full military honors. Another friend of Rubens from Hayden had died a month earlier in Vietnam, Richard "Dickie" Contreras.

Although it was a time of deep sadness for Ruben, it would also be a time of joy. Ruben got to meet and hold his son for the first time. Ruben was able to spend 10 days at home before returning to Vietnam. Conrado's son, Conrado Jr. would be born a few months later. Ruben believes that Conrado had a premonition about his own death. He had asked Ruben and his wife's family to have his son raised by his "Nana", Ruben's mother, should he die. His request was granted. Ruben would help Conrado Jr. to learn about his father as he grew up. Ruben would choke up when talking about "Frankie". He said "Frankie was a good man all his life beloved by all."

Ruben was able to visit the Vietnam Memorial Wall in Washington D.C. in 1998. He made a rubbing of Conrado's name and used it in a photo display memorializing Conrado. Ruben said, "He has lived 66 years with me." In some information that he gave me about Conrado, Ruben wrote, "Conrado was a quiet gentle man whose kindness and caring earned him many friends while on tour." He said, "Those same comrades in arms offering monetary gifts to his widow back home. The letter of appreciation over shadowed by sadness and sympathy delivered to a fatherless home. Conrado

Francisco Bilducia never had a chance to meet his only child, a son Francisco Jr. who was born months after his all too early passing. Francisco Jr. spent many years of his life wondering about this brave man who made the ultimate sacrifice. Father and son were joined in eternal rest in April 2010."

Specialist V Conrado Francisco Bilducia was honored 45 years after making the ultimate sacrifice for his country. On Saturday, Nov. 9, 2013 American Legion Post #124 in Guadalupe was named Conrado Francisco Bilducia Post #124 in his memory at a ceremony in Phoenix. Conrado's younger brother Rudolfo "Boy" Bilducia a Marine and member of the

American Legion Post was in a position to make something happen to honor his brother. Conrado's father was raised in Guadalupe and was a World War II veteran who lost a leg in combat.

During his military service Conrado was awarded the Air medal, National Defense Service medal, Vietnam Campaign medal, Aircraft Crewman badge and Expert badge with rifle bar. Posthumously he was awarded the Army Commendation medal for Heroism, Purple Heart and the Good Conduct medal.

His commendation letter dated March 17, 1968 read, "For heroism in connection with military operations against a hostile force: Specialist Five

Bilducia distinguished himself during an enemy mortar and ground attack. Even with mortar rounds falling in the immediate area, Specialist Bilducia continued to perform critically important security measures within the company orderly room throughout the attack. As he was moving from the orderly room to insure ready access to the reserve ammunition supply, several mortar rounds exploded nearby, inflicting him mortal wounds. His actions were in keeping with the highest traditions of the military service and reflect great credit upon himself, his unit and the United States Army."

Harvest Turkey

(12 pound) whole turkey, neck and giblets removed	powder
1/2 cup butter	Salt and pepper to taste
2 apples, cored diced	2 1/2 c. sparkling apple cider
1 tablespoon garlic	1/2 c flour

Directions:

Preheat oven to 350 degrees F
 Rinse turkey, and pat dry. Loosen turkey breast skin, and insert pieces of butter between the skin and breast. Place apples inside the turkey. Sprinkle with garlic powder, salt, and pepper. Place turkey in a roasting bag (dust the inside of the bag lightly with flour), and pour apple cider on inside and outside of the bird. Close bag, and place turkey in a roasting pan.
 Bake turkey 3 to 3 1/2 hours in the preheated oven, or until the internal temperature is 180 degrees F measure in the meatiest part of the thigh. Remove turkey from bag, and let stand for at least 20 minutes before carving.

Cheesy Broccoli & Penne

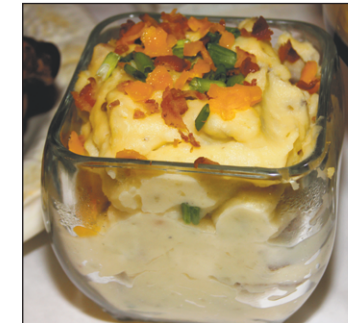
Cook pasta in salted water according to package directions. Reserve 1 cup pasta water before draining the pasta. In a second pot of water Add the broccoli to and cook over medium-high for 3-4 minutes, until fork tender, drain.

While the broccoli is cooking, transfer the pasta to a large bowl.

Add 1/4 cup pasta water, yogurt, and 1/3 of the grated cheeses and stir until the cheese has melted.

Stir in remaining cheese, one small handful at a time to prevent clumping. Add additional pasta water as necessary to thin the cheese sauce.

Season with salt and pepper. Add the broccoli and sundried tomatoes, mix well, and serve.

Pie Crust:

6 tablespoons COLD water
1 tsp sugar
1 tsp salt

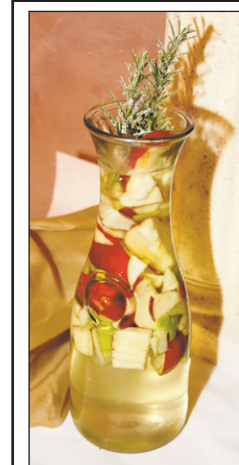
Combine flour, salt & sugar. Next, in separate bowl, stir the oil and ice water until creamy, then pour over flour mixture. Mix well. Save dough till needed.

Step 1: Cut off the top of 4 apples off and discard. Remove the inside of each apple with a spoon carefully, as to not puncture the peel. Salvage as much as you can so you can use it for Step 2.

Step 2: With remaining apple dice very thinly. These apple pieces will give you the additional filling needed to fill the four apples you are baking. Mix these with the innards of the first 4 apples. Mix sliced apples with sugars and cinnamon in a bowl. You may modify sugar & cinnamon to your preference. Scoop apple/sugar mix into hollow apples.

Step 3: Roll out pie crust and slice into 1/4 inch strips. Cover the top of the apple in a criss cross pattern with pie crust strips.

Step 4: Place apples in an 8x8 pan. Add just enough apple cider to the cover the bottom of the pan. In separate bowl mix melted butter & 1 tablespoon of sugar. Pour this over the top of the pie crust. Cover with foil and bake for 20-25 minutes. Remove foil and bake for an additional 20 minutes or until crust is golden brown and apples are soft

Volunteer Spotlight: Gary Birkett

No matter what your age do you recall the number of times you walked through the mouth of the Great Punkin' or waited for someone as they made their grand entrance at the mouth? Who was there to greet the little or big munchkins with his many Halloween jokes? What would the Great Punkin' be without Dr. Pizza himself, Gary Birkett?

Even though Halloween activities began in 1961 when Bill Belobradich and Jim Postel gathered the children in town for trick or treating and a costume parade, it was in 1975 when Bob Blasco and Gary Birkett devised the Great Punkin' for children to parade through the mouth. Gary was chairperson and Master of Ceremonies. There were only a few years when others might have filled in as MC. Thirty eight years is a long time. Now you know why he has so many Halloween jokes which range from very funny to just simple riddles. Jokes like, "What do you do when a pumpkin is injured—go to the pumpkin patch," or "What happens when it rains on a pumpkin? It gets wet." We all laugh no matter how he tells it. Being the MC requires keeping up with the latest trends and cartoons otherwise parents who work hard on costumes might get mad if you call it wrong and the children are quick to correct.

Gary was born in Kenosha, Wisconsin, later moving to Columbus, Ohio with his parents. A family move to Sierra Vista changed his life forever when he met Lorraine at Sierra Vista High School, Lorraine's family lived on Fort Huachuca Base. These high school sweethearts were married in June 1972 and celebrated 41 years of marriage this summer. Around this same time the Berle Birketts moved to San Manuel and Gary followed, working as the San Manuel lechero (milkman) and also working for his Dad at the Sears store for 75 cents an hour.

Gary and Lorraine moved to Kearny in 1974 to run the Sears store which was located in one of the buildings now currently owned by the ARC. Gary knew all of his customers by name, knew their likes and dislikes. In our household we had the first of anything new in the store because of his salesmanship. It was common to hear him say, you just have to have this new TV, eight track player (who knew), or the latest lawnmower. The great thing is that these products last a long time.

Recently a former customer walked in to Old Time Pizza and needed maintenance on a product and one man jokingly asked for a refund. One Christmas a man walked into Sears and Gary asked how his new router worked, was he enjoying it? The wife later came in madder than a hornet, Gary had given away her Christmas surprise.

There are many more Sears stories but the best for this young entrepreneur is that at 21 years of age he purchased his store without help from family and successfully ran the business from 1974-1988. He took a short time off before entering the pizza business.

When Gary takes on a project he does it full force and with passion. As a member of Rotary he has served as president for many years in succession and 15 years as the foreign exchange promoter for the District Rotary. Many families in this area helped by sharing their homes and family life with these great students from all over the world; the memories of these many students still linger and families still keep in touch with them. Have you ever thought about the three benches in the mall area, they were put there by the Rotary organization to commemorate the districts 75th anniversary,

Gary served on the city council for one term, Ray School Board for four terms, Elks in all capacities, and the Kearny Chamber of Commerce long before it became the Copper Basin Chamber. As a chamber member he has served on the board, served as president, and has been in charge of every committee and special event ever held in the community. He has gathered wood for the Pioneer Days BBQ, watched over the BBQ pit, where those who were with him have so many stories to tell. He has entered the Pioneer Days parade sitting on his unique toilet seat on wheels. He and Lorraine have hosted the Chamber's Christmas dinners. In the 1990s he met with the newly formed junior chamber members to discuss their purpose for existence and suggested that they should have a service project for the community since they were representing the businesses that sponsored them. It was one of the junior chamber members who suggested the Adopt a Highway program.

With all of this it is no wonder that Gary was selected as Citizen of the Year in 1981. Receiving this honor has not stopped him from giving to his community.

Has he ever sung Happy Birthday to you?

The older he gets the harder it is to hold that last note. He is quick to grab his guitar and sing for guests at OTP. He introduces himself to all new customers. It is him who makes OTP number one.

When attending the Bank of the West forum recently he addressed the group by saying, "I always thought people came to Kearny for my pizza but I just discovered that they came to do their banking and then eat pizza."

Gary has also served as a Little League coach. Actually his brain holds so much baseball trivia that he loves to challenge his customers with great questions especially trivia from the 50s and 60s, there are books on the counter of OTP where you can check your answers not only for baseball but history. Over these many years I have heard the jokes and listened to the trivia questions. Gary asked me, "Who was the 'winningest' pitcher in baseball?" It was Warren Spahn who pitched 363 winning games in his career and later developed his own Spahny 363 beer. When Gary was 10 years old and Warren Spahn was playing for the Milwaukee Braves, Spahn asked five boys to ride in his convertible and go for ice cream. Gary's dad would not let Gary go. On his dad's death bed he apologized to Gary for not letting Gary go with Warren Spahn for ice cream. Gary said, "It is OK Dad." During this interview Gary whispered to me, "But it really wasn't OK."

Gary honors his dad, Berle, every year

on Veterans Day by offering free pizza and med drink to all Veterans. Since 2000, Gary has accompanied his mother, Stella, to the annual reunion of the World War II navy service men who served on the USS De Grasse. His parents had attended this reunion for many years and now children and widow's attend. There are two Vets still alive. "The ship will not sail till all are there and ready for the Eternal Cruise," Gary said with a tear in his voice.

His sister Mary was quick to tell me, "There isn't anything I wouldn't do for my brother." Many people have worked with Gary over the past 40 years. All say the same thing, "His jokes, his energy, his great ideas and passion for his community and customers defines who he is, what a great guy, wish we could tell you everything."

Lorraine and Gary have raised three children. Kelly has a degree in aeronautics technology and is a pilot for KTAR radio in Scottsdale Monday through Friday and manages Carefree Airport on Saturday and Sunday; Jody is married to Shane Olson and manages OTP; Jimmy works for Copper Basin Railway and OTP and is a first responder firefighter for Kearny Fire Dept.

Quoting Gary, "Of all the things that I have done in the community, my claim to fame has to be the Great Punkin', something I have enjoyed doing for 38 years."

The Pinal County Sheriff Office has installed a drop box for area residents to safely and anonymously get rid of unwanted prescription and other medications.

The collection bin, bought with RICO funds, has been set up right outside of the Kearny Police Department and will be maintained by PCSO. "The community needs a

facility like this," said Kearny Police Chief Bob Ingulli. "And I'm grateful to the sheriff's office for setting it up and also for taking care of it." Along with prescription

medications, prescription patches, over the counter medications, vitamins, medication samples and pet medications will also be accepted.

Needles, thermometers, liquids, aerosol cans, inhalers and medication from businesses and clinics cannot be accepted at the drop box. These restriction are for safety reasons for those emptying the collections box.
