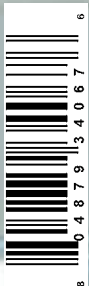

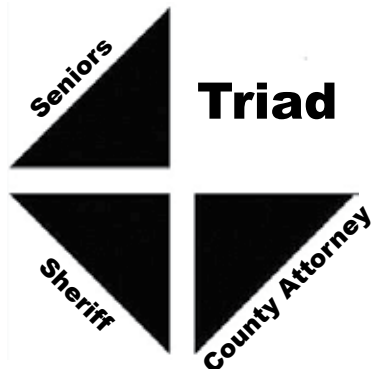

Town clerk speaks out about new senior group in Mammoth

I write this letter out of concern for the Town and its residents. There are many accusations that are unfounded and frankly unfair. The gossips that there are missing funds are rumors, and our auditors confirm that upon completion of the Town's audits. They (the auditors) have made it clear that beginning in the fiscal year 2010-2011 expenditures from the Highway User Fun had been supplementing other funds

such as the general fund and our enterprise funds totaling approximately \$600,000 (to date) from the Highway User Fund. Joe Brewer doesn't seem to comprehend the fact that funds are not missing but spent in areas that are not allowable by the State. So please stop saying that monies are missing. We have made changes in the way of disbursing and utilizing the revenues with hopes that will be acceptable by the State. I invite the public to express ideas and/or concerns and if you have questions relating to revenues or expenditures please contact me.

The employees of the Public Works Department have worked hard and continuously to provide sidewalks and curbing as well as constantly sweeping and patching our streets. The Town suffered damages caused by flooding earlier in the year. We are currently working with other agencies for grant monies to

aid in major repairs needed caused by the floods. We have had a few letters from residents thanking the Town responding quickly during this time of urgency. We have also received "thank you" cards and notes stating that the Town is beginning to look better and that they may appreciate the difference we have made in the appearance of the Town. To these residents, we say "thank you" for your positive attitude. The Council voted to increase pay in the Public Works and Police Departments to attract dedicated employees that would be happy to make Mammoth their home.

The really important news is that the Council approved the CDBG (Community Development Block Grant) to be used for a reverse osmosis water system. We anticipate the system to be ready for operation within a year. The improvements to our water system, such as

waterlines, fire hydrants, etc., will continue until the entire system is upgraded.

Pinal County Sheriff's Department is currently assisting the Mammoth Police Department in recruiting a dog for the developing Canine Project. Officer Cardenas will be our K-9 Officer and is scheduled for training in a few weeks. Another important project is the vehicle seizure yard that Chief McIntosh has been working on, and will be ready for implementation after the regular November Council Meeting when the final ordinance should be adopted by the Council. Both projects are geared to bring in much needed revenues to the Town.

The Town purchased the property at 337 N. Highway 77, in hopes of using it for leverage to attract new businesses in our area. We are currently contacting individuals who may be interested in establishing

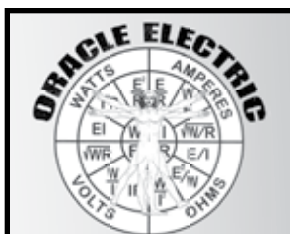
a business in the area. We have a chance to expand and get ready for future growth and prosperity to the Town, but we have to work to accomplish these goals. We are working with developers to start a new housing project on the Wasko property acquired by the Town a few years ago.

We have a newly formed Senior Citizen Organization. We are working with many agencies for donations and/or grant money to upgrade the stove and refrigerator at the community center to commercial appliances. The senior citizens are meeting twice a week for meals, socializing and games. They are planning fundraisers, and are planning the holiday events. In addition, I have been approached by several residents requesting the Town sponsor annual fiestas as we have in the past. We anticipate meetings to begin soon to start the planning

process. We invite all to attend our meetings and participate. Our past fiestas have been very successful.

The fact is that most of our Council wants to see a positive change in Mammoth. And although I lived near Dallas for the first eighteen years of my life, (prior to coming to Mammoth), I will always feel that Mammoth is our hometown. We welcome new residents to our area, but please don't drift into Town with the attitude that our residents are not intelligent enough to make the right decisions. Most of our residents can see through your pretentious ways and ideas.

Although we have accomplished a few goals, we have a long way to go. I hope that we will set aside our differences and work together and support our Council.

Life after the Oracle School District override

I write this to thank the many supporters of the Oracle School District and public education in general. It is true that we are reeling from the override failing by the slimmest of margins in the November election. It is also true that we and our many supporters are too strong to let any setbacks defeat us. We will likely try for an override again. We will not make this push for extra support out of anger from our defeat, nor will we attempt to lay guilt on those that did not support the override. Our efforts will concentrate on educating our district members about what exactly an override is, how the monies are utilized and why this type of support is so crucial to school districts.

I will begin this education effort by explaining what an override is. Overrides are extra financial support that schools are permitted to ask from their district residents. Overrides do not mean that a district is using their existing funding unwisely. It is absolutely true that these funds are raised by district tax payer revenue. We are very fortunate in our district that the tax rates resulting from school funding are extremely low and that they already include an

existing override that begins to expire next school year. It is important for people to understand that the November election was for a "continuation" of the district's current override. It is clear that many voters didn't understand that we were simply asking for this support to continue. Overrides are used by the majority of the school districts in Arizona. Next school year the override will decrease by one third which equates to approximately a \$144,000 loss for the district. If the override continuation were not to be successful next November the dollar amount would decrease by two thirds and then completely disappear the following year resulting in a net loss to the district of nearly \$500,000. Override monies pay for physical education, full day kindergarten as well as a few regular classroom teachers. Additionally these funds are used to assist in funding staff development and help purchase classroom teaching supplies.

The Oracle School District has great teachers and staff that are willing to do anything to increase their students' academic achievement. This is evidenced by the over forty students that participate in our

advanced placement program earning high school credit before they leave us and the multitude of students we have participating in San Manuel and Canyon Del Oro high schools AP and International Baccalaureate programs. This is not saying we think our students' achievement is "good enough". Our students face great challenges, we accept those challenges and will work tirelessly to help them. We are very fortunate to have amazing volunteers from the Oracle, SaddleBrooke and Eagle Crest communities that tutor our students in math and reading, teach after school choir, sewing, classical guitar and even an equestrian class. As thankful as we are for these wonderful people, nothing replaces the true value of a professional teacher that is with our students every day teaching and mentoring them. The power of great teachers with up to date resources is astounding. Losing some of these impactful people and the tools teachers need to be successful is what schools face when people don't understand why schools ask for the extra assistance allowed for by our State.

Mammoth man arrested in drug bust; MPD to receive K-9 unit

What started out as an investigation of a theft of guns and jewelry led Mammoth Police and the Pinal County Sheriff's K-9 Unit and SWAT team to serve a search warrant on the home of Louis Ernesto "Neto" Gallego (age 52) on Nov. 9, 2013, located in the 600 block of Tiger Dr., Mammoth.

During the search, 35 pills later identified as Hydrocodone and four grams of methamphetamine were found. The pills were found in a plastic baggie and no one at the house had a prescription for them. According to Mammoth Police, Gallego admitted to having the stolen weapons in his possession. The weapons had been seized at another residence during the investigation.

Gallego was arrested and booked into Pinal County Jail on

charges of: possession of a gun by a prohibited possessor, theft, trafficking in stolen property, possession of dangerous drugs, possession of dangerous drugs for sale and possession of narcotics.

According to police, the investigation started on Oct. 27, 2013, when a complaint was filed with Mammoth Police about a theft of some weapons and jewelry from an address on Tiger Drive. The reporting party gave the name of a suspect in the theft to police.

During the course of the investigation, leads pointed Mammoth detectives to Gallego.

Mammoth Police Chief Marty McIntosh commended his officers in their participation in the investigation and serving of the search warrant. He also thanked the Pinal County Sheriff's Office for its involvement and cooperation.

McIntosh also announced that the Mammoth Police Department, thanks to the Pinal County Sheriff's Office, will be starting up its own K-9 Unit. They will be receiving a dog and Pinal County Sheriff's Office Chief Steve Henry has approved a K-9 training program for Mammoth.

Mammoth Police Officer Alfonso Cardenas has been selected to serve as the K-9 Officer. The K-9 Unit will be used throughout the Tri-Community area in "fighting the war on drugs," said McIntosh. The training will begin the first of next year and last from 5 to 7 weeks.

The K-9 will be housed in a secure kennel next to the police station and monitored by cameras with night vision and supervised by dispatch staff. There is also a storage area for vehicles at the station which will allow the Town of Mammoth to get revenue for the storage if a vehicle is confiscated due to a police matter. Those vehicles that can be released to the owners will be.

Chief McIntosh said that he has seen families torn apart, divorces and children taken from parents due to drug related problems. He wanted to thank those that supported the start of the K-9 Unit which was approved by the Mammoth Town Council at a recently held special meeting. He especially thanked Mayor Alvaro Barcelo, Juan Barcelo, Erik Romero, Gina Medina, and Town manager Patsy Large.

What is next for Oracle School District #2?

The failure of the budget override election will result in cuts to the Oracle Elementary School District #2 budget of \$148,000 next year, and another \$148,000 the following year, according to Superintendent Dennis Blausier. Blausier was asked if the school district will be looking at making more cuts in spending

as a result of the failed override. "It's too early to tell but it is a possibility," said Blausier. "We will use every resource not too, but in the end we may have to commit to that as a last resort." The loss of budget override funds could be devastating to the school district in the upcoming years.

Blausier said that he hoped the school board will look at seeking another

override continuation election next November to save some of the funding. Blausier also talked about some new programs the school implemented, such as Cosmo Kidz (anti-bullying, character education program), a classical guitar class, Equestrian class, sewing class, and choir that are well attended. "Thanks to volunteers from SaddleBrooke,

SaddleBrooke Ranch, Eagle Crest and Oracle, these programs were made available," said Blausier. These programs have been added at no cost to taxpayers. "As great as they are, they don't replace regular curriculum classes," said Blausier. The override election results will be one of the items on the agenda at the next school board meeting on Nov. 19.

The San Manuel Miners return five players from last year's squad, including two starters – senior guard Alvaro Alvarez and senior forward Jordan Peasley. Senior Anthony Garcia,

Directions:

Preheat oven to 350 degrees F
 Rinse turkey, and pat dry. Loosen turkey breast skin, and insert pieces of butter between the skin and breast. Place apples inside the turkey. Sprinkle with garlic powder, salt, and pepper. Place turkey in a roasting bag (dust the inside of the bag lightly with flour), and pour apple cider on inside and outside of the bird. Close bag, and place turkey in a roasting pan.
 Bake turkey 3 to 3 1/2 hours in the preheated oven, or until the internal temperature is 180 degrees F measure in the meatiest part of the thigh. Remove turkey from bag, and let stand for at least 20 minutes before carving.

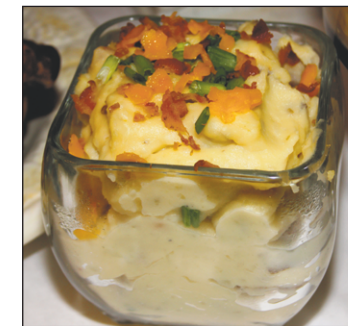

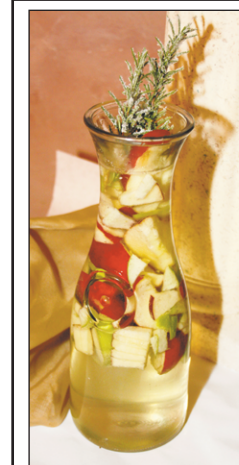
Combine flour, salt & sugar. Next, in separate bowl, stir the oil and ice water until creamy, then pour over flour mixture. Mix well. Save dough till needed.

Step 1: Cut off the top of 4 apples off and discard. Remove the inside of each apple with a spoon carefully, as to not puncture the peel. Salvage as much as you can so you can use it for Step 2.

Step 2: With remaining apple dice very thinly. These apple pieces will give you the additional filling needed to fill the four apples you are baking. Mix these with the innards of the first 4 apples. Mix sliced apples with sugars and cinnamon in a bowl. You may modify sugar & cinnamon to your preference. Scoop apple/sugar mix into hollow apples.

Step 3: Roll out pie crust and slice into 1/4 inch strips. Cover the top of the apple in a criss cross pattern with pie crust strips.

Step 4: Place apples in an 8x8 pan. Add just enough apple cider to the cover the bottom of the pan. In separate bowl mix melted butter & 1 tablespoon of sugar. Pour this over the top of the pie crust. Cover with foil and bake for 20-25 minutes. Remove foil and bake for an additional 20 minutes or until crust is golden brown and apples are soft

Manny Yubeta inducted into Wrestling Hall of Fame

Sunday, Nov. 3, was a very special day for San Manuel High School. Manny Yubeta, former head wrestling coach, was inducted into the Arizona Chapter of the National Wrestling Hall of Fame. Coach Yubeta was one of eight members inducted in the class of 2013. Nomination and induction into the hall of fame is a two year process, which means the next class won't be inducted until 2015. The induction ceremony was held at the Fort McDowell Radisson Suites and Conference Center in North Scottsdale. Coach Yubeta coached for 30 years in the Mammoth/San Manuel School District, coaching at Gardner Middle School for four years, at San Manuel High School as an assistant coach for four years and as a head coach for 22 years. During his tenure as head coach, San Manuel won eight region titles,

one state runner-up championship, and in 2002 and 2004 the Miners were state champions. He coached 69 individual region champions, 17 individual state champions, two individual academic all-Americans, and two of his wrestlers, P.J. Ponce and Jacob Ortiz, were college all-Americans. The Miner wrestling teams were tough on the mat but displayed sportsmanship and character both in victory or defeat. Coach Yubeta's teams won two sportsmanship trophies at the Coolidge Invitational and most inspirational team at the "Take down Cancer" duals at Canyon State. Coach Yubeta received five Coach of the Year awards while compiling a 515-188-6 record, second all-time Arizona winning record. Coach Yubeta and San Manuel High School will be enshrined at the National Wrestling Hall of Fame in Stillwater, Okla.

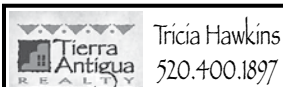
