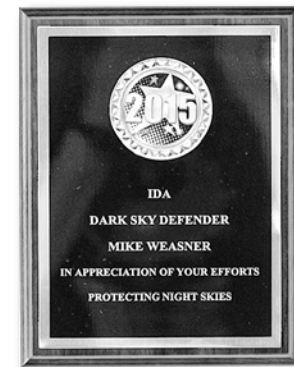
This award is "given to individuals and organizations in appreciation of their efforts on behalf of IDA and its mission to preserve night skies by promoting quality outdoor

Mel's Drive-in a San Manuel favorite

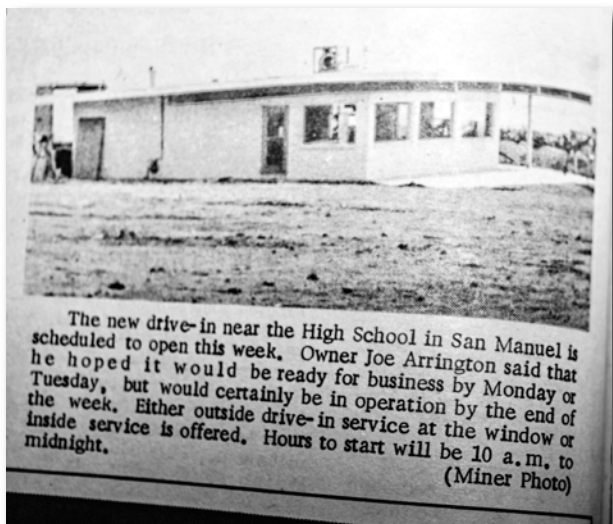
The building where Mel's Drive-In is located is nearly 50 years old. According to Val Childers, it was built by members of the Church of Jesus Christ Latter-day Saints and became Weldon's Drive-In. It was built with the idea that the young people in San Manuel had no place to go in the evenings. It gave them a place to "hang out." It was also a place to get something good to eat.

Weldon's had their grand opening June 4, 1966.

The building that has been home to Mel's Drive-in in San Manuel since the early 1970s turns 50 years old soon. Nothing much has changed in those 50 years. Its history is only part of the reason folks come back to visit. We're pretty sure the burgers bring them back too.

Joe Arrington was the owner. Their grand opening ad offered milk shakes for 19¢ and the hours were 10 a.m. to midnight. That year they advertised hamburgers 5 for 99¢. You could get outside service at the window or come inside.

Being that it was located across the street from the high school, many students before the days of a closed campus used to eat lunch there. Students went there after school and after athletic games. Opposing teams from out of town

Pinal County offers holiday safety tips for leftover food

FLORENCE - The Pinal County Public Health Services District, Environmental Health Services would like to wish everyone a safe and happy holiday season. Holidays are times we share the kitchen with family and friends. With all the food being prepared as we celebrate, having leftover food is inevitable. Proper handling of leftover foods is one of the best things you can do to keep your family and friends safe from food-borne illness.

Put Foods Away Promptly

While everyone is busy celebrating, it is very easy to overlook the foods sitting on the counter or on the dinner table. Everyone is stuffed from their holiday meal and it can be difficult to find motivation to clean up. Also, there is a lot of temptation to leave foods out so we can nibble on them or so they may be available for guests who arrive late. The one thing that should be prioritized after the meal is to put the foods away. The "danger zone"

is between 41°F and 135°F - the temperature range where food-borne bacteria multiply rapidly. The time that food sits on the counter should be minimized and certainly should not exceed two hours. Be sure your refrigerator holds a temperature at or below 41°F.

Safe Cooling

A lot of us assume that once food is put into the refrigerator that it is safe. Even after you put foods into the refrigerator it can still stay in the temperature danger zone for a significant period of time - allowing bacteria to multiply. Cooling the food down rapidly is very important to prevent illness. Here are a few hints to help you cool down your foods rapidly. 1) Keep the portion sizes small. Try to limit the depth of leftover foods to less than four inches. Realize that the outside of the food will cool first, but it can still take quite a while for the interior to cool down. 2) Keep the food uncovered until it is cold. This allows the cold

air to flow across the surface of the food. The air flow is just as important as the temperature in cooling foods down. 3) Don't overload your refrigerator. Ensure there is adequate space to allow for air to circulate around cooling foods. 4) Don't hesitate to check food temperatures in your refrigerator after an hour or two to ensure that the food is cooling down rapidly.

Safe Reheating

Reheating is another important step in handling leftover foods. Use a food thermometer to ensure that leftovers are

thoroughly heated. Make sure the food reaches a safe minimum internal temperature of 165°F. Bacteria can survive in leftovers that have not reached 165°F, possibly resulting in food-borne illness. Also, keep in mind that if foods are left in the temperature danger zone too long, even reheating them thoroughly may not be enough to ensure the food will not cause an illness.

Use Leftovers Quickly


Use your leftovers promptly. They should either be eaten or frozen for later use within

often ate there after the games or picked up their food to go.

Weldon's Drive-In had a pool table and a juke box. The original jukebox can be seen at the Chaparral in Oracle which is owned by the Childers.

In 1967 or 1968 Mel and Val Childers became partners in the business and began managing it. They bought out their partner five years later. It is believed that the drive-in changed names from Weldon's to Mel's in 1973. This is based on the research that showed that Weldon's was still running ads in 1972. The ads stopped in 1973. As there was no advertising done by Mel's, it appears that is when the name and ownership changed.

Three generations of the Childers family have worked at Mel's: Val, her daughter Lisa Langhammer and granddaughter Amanda Alvarado who works there now.

Albertina Zazueta has worked there since 1979 cooking up "the burger we drive back home for" as expressed by Mel's T-shirts. Many former residents visiting family or friends in San Manuel often stop by Mel's for a burger while in town.

The menu has changed over the years. Weldon's was serving up menudo everyday for 45¢ a bowl and barbecued beef sandwiches in the 1960s. Now Mel's offers up Mexican food, Navajo tacos, corn dogs, chilly willy's and of course Mel's burgers. Amanda said that the best selling item on the menu is the jumbo bacon cheeseburger.

Weldon's/Mel's Drive-In has been serving up good food continuously since 1966 making it one of the longest lasting businesses to operate at the same location in San Manuel.

Now we wonder if they will have to change the design on their T-shirt.

Mammoth Elementary student grabs top prize in County Attorney's Anti-Drug Poster Contest

In front of more than 200 parents, teachers, fellow students, community advocates, and top law enforcement, County Attorney Voyles awarded the Grand Prize for the 25th Annual Pinal County Attorney's Office Anti-Drug Poster Contest to Ariza Castillo from Mammoth Elementary School. As Grand Prize winner, Castillo and her 6th grade class win a trip to the Titan Missile Museum in Tucson, courtesy of PCAO's RICO funds.

Anissa Del from Combs Traditional Academy in San Tan Valley won the "T-Shirt Award" and Markayla Johnson of First Avenue Elementary in San Manuel took home the "Bookmark Award."

Rounding out the rest of the top ten winners, include Karina Avalos Hidalgo and Aubrie Keeling, both from Cactus Middle School in Casa Grande; Dinay Holmes from Combs Traditional Academy in San Tan Valley; Cade Chapman and Natalie Rodriguez of Eduprize in Queen Creek; Evelyn Abplanalp from Magma Ranch K-8 in Florence; and Jasmyn Herrman from Ranch Elementary in Queen Creek.

The top three prize winners get their posters printed on a bookmark and t-shirt which get distributed to all 60 contest winners. PCAO also designs and produces a master poster featuring all top ten winners' entries. Those posters get distributed to all Pinal County schools as well to local substance abuse coalitions.

"Our youth remain the foundation of our community, therefore we must reach out to them at an early age and teach them right from wrong. We continued this contest as a fun activity, while at the same time promoting drug awareness and education. I must thank our educators and parents who work tirelessly to teach our kids how to make proper choices and who instill values in them that benefit all of our Pinal families," said Pinal County Attorney Lando Voyles.

A panel of judges narrowed down the nearly 1,000 posters to the top 60, the top ten, and the top three. This year's judges included, Donna McBride with Pinal County Juvenile Court Services, Pat Griffen with Against Abuse, Breanna Boland with the Casa Grande Alliance and Betty Peterson with Eloy's Robson Ranch community.

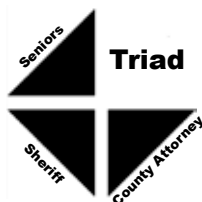

AN ORDINANCE OF THE TOWN OF MAMMOTH, PINAL COUNTY, ARIZONA, RELATING TO THE REGULATION OF VEHICLES ON TOWN ROADWAYS, VACANT OR PRIVATE PROPERTY WITHIN THE TOWN LIMITS; ADDING MAMMOTH TOWN CODE SECTION 10-06 VEHICULAR NOISE; PROVIDING FOR PENALTIES FOR VIOLATIONS, PROVIDING FOR SEPARABILITY; AND DESIGNATING AN EFFECTIVE DATE. WHEREAS, the Town has protected neighborhoods against all nuisances, blight, deterioration and excessive noise; WHEREAS, the to promote the health, safety, economic and general welfare of the citizens in the Town of Mammoth and; WHEREAS, the Mayor and Council have concluded that it would be in the best interest of the Town and citizens of Mammoth to adopt regulations for the use of vehicles which cause excessive noise within the Town limits. NOW, THEREFORE, BE IT ORDAINED BY THE MAYOR AND COUNCIL OF THE TOWN OF MAMMOTH, ARIZONA, AS FOLLOWS: Section 1: Section 10.06 is hereby added to the Mammoth Town Code: 10.06 VEHICULAR NOISE 10.06.010 Vehicular noise. A. It shall be unlawful for any person within any residential area of the Town to repair, rebuild or test any motor vehicle between the hours of 9:00 p.m. and 6:00 a.m. in such a manner as to create any excessive, unnecessary or offensive noise, such that a reasonable person or normal sensitivity residing in the area is caused discomfort or annoyance. B. No person shall operate, or cause to be operated, any motor vehicle within the Town unless the exhaust system of such vehicle: 1. Is free from defects which may cause sound level magnification; 2. Is equipped with a functioning muffler; 3. Has not been modified in such a manner which will amplify or increase the sound level emitted by the motor vehicle above that emitted by a muffler originally installed on the vehicle as manufactured for initial sale. C. The use of any and all exhaust brakes, engine brakes, engine retarders, or similar devices shall be prohibited within the Town; provided, however, that it shall be an affirmative defense to a violation of this paragraph that such device was used by the operator as a result of a bona fide emergency, and was reasonably necessary for the protection of persons and/or property. 10.06.020 VIOLATION - PENALTY Any person, firm or corporation violating any provision of this chapter is guilty of a misdemeanor and each person shall be deemed guilty of a separate offense for each day or portion thereof during which any violation of any provision of this chapter is committed, continued or permitted, and upon conviction, the person shall be punished by a fine of not to exceed three hundred dollars, imprisonment for not to exceed ninety days, or both such fine and imprisonment. Section 2. If any section, subsection, sentence, clause, phrase or portion of this ordinance is for any reason held to be invalid or unconstitutional by the decision of any court of competent jurisdiction, such decision shall not affect the validity of the remaining portions thereof. Section 3. The provisions of this Ordinance shall become effective on January 1, 2016. As the season went on, Buzan's stamina increased and she was able to more easily finish the conditioning that gave her trouble earlier in the season.

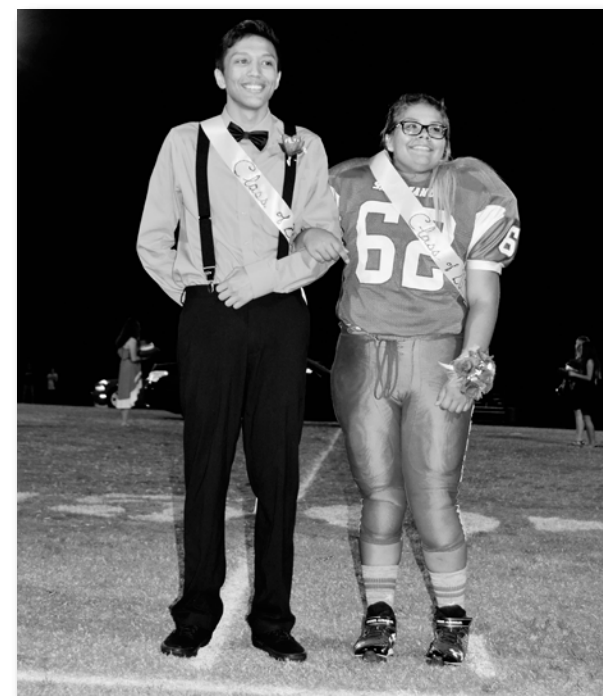
Buzan admitted participating in football provided her more than she ever expected.
