Central Arizona College celebrates Arizona Apprenticeship Week, recognizing successful business partnerships

Central Arizona College celebrated Arizona Apprenticeship Week, Nov. 15-21, 2020. CAC is providing innovative training and opportunities for companies to upskill their employees to ensure that Pinal County has a strong workforce.

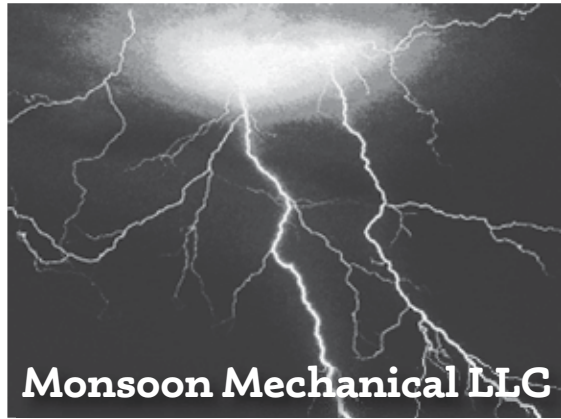
In 2019, CAC, in partnership with Pima Community College and the Maricopa Community College District, received the Industry Recognized Apprenticeship Model in Manufacturing (IRAMM) Department of Labor grant to help Arizona's manufacturers expand and strengthen their workforce. The grant focuses on a Learn & Earn model whereby apprentices receive classroom training at CAC while shadowing an experienced journeyman during work hours. Apprenticeships provide cutting-edge

training and give employers the ability to develop their own talent while reducing turnover.

In addition, CAC works collaboratively with Resolution Copper and Abbott Nutrition to develop apprenticeship pathways tailored to meet their specific workforce needs. To ensure they have fully-trained, multi-craft professionals, Abbott Nutrition provides their employees with an opportunity to attend the fully Automated Industrial Technology apprenticeship program and plans to hire several CAC students that have completed the one-credit online Manufacturing Pre-apprenticeship course.

The partnership with Resolution Copper is providing local workforce development opportunities while allowing

Local support for the food bank

Small towns like Superior are filled with folks who are ever willing to lend a helping hand. This time of year is no exception.

The Superior Food Bank is a great example of those helping hands. What started with a few volunteers during Thanksgiving and Christmas as Project Happy Face, has grown to a full organization that distributes food monthly to folks in need. It survives on donations and volunteers.

This year has been especially hard for the small organization. The pandemic has brought more people to the doors of the food bank and monetary donations have been significantly reduced due to the cancellation of important annual fundraisers, like the Superior High School DECA's Fill-A-Bowl event.

Two local ladies felt strongly that the Food Bank shouldn't suffer even with a pandemic looming. Tina Marie Casillas and Willa Ficarra decided to do something about the lack of donations and separately found a way to raise some funds for the food bank.

Tina Marie started a fundraiser on Facebook, setting a goal of \$1,000. She exceeded that goal. She wrote on Facebook:

"In honor of my dad Frank Aranda who was well known in our community for taking the lead to help families or anyone in need. I would like to ask my family and friends to please donate to the Superior Arizona Food Bank. They have a lot of families to help feed this year with the current pandemic still affecting

many families in need. With the holidays approaching quickly let's help put some warm meals on their tables. Those of you that knew my dad, know that he used his musical talents to raise funds anytime he was able to. I would like to continue his tradition of giving back to our community."

She assured anyone reading the post that 100 percent of the funds raised would go to the Food Bank. She encouraged folks to participate in another fundraising event, under the direction of Willa Ficarra of SunFlour Market.

Willa, with help from several different restaurant and business owners in town, hosted the 2020 Superior Food Bank Fall Soup Dinner on Friday, Nov. 13, on the patio of SunFlour Market. Donating soup for the event were Miners on Main, the Buckboard Restaurant, the Barmacy, SunFlour Market, Bert's Bakery, and Nancy's Kitchen Korner.

On Friday, Tina and Willa presented their donations to the Superior Food Bank. Sandy Van Gorp and Mabel Cox were on hand to receive the donations. In an odd twist, or maybe we just needed something wonderful for this not so wonderful year, the two donations added up to \$2,020. Tina collected \$1,020 from donations in her Facebook campaign and the Soup Dinner collected \$1,000 in donations.

Thank you, everyone who donated or ate soup. And thank you, restaurant and business owners for donating some truly yummy soup.

the company's employees to develop the skills required to safely operate and maintain the assets on site, including the recently completed Shaft 9 project. The apprenticeship program students work safely in highly sought-after technical roles, and will continue to be employed, applying their excellent skills and qualifications upon completion of the program in December

Just this past year, CAC and Wilson Electric, a major employer in Arizona, developed a program at the college's

Superstition Mountain Campus in Apache Junction. Students begin their studies at CAC in a 16 week, fast-track, pre-apprentice program where they earn industry recognized credentials and a college certificate. Upon successful completion of the program, students who are hired by Wilson Electric begin employment and continue to work toward their journey person status. To date, Wilson has hired 80% of the CAC graduates from this program.

Panthers' season ends sooner than usual

For the first time in four seasons the 1A State Championship Football game will not include Superior following a 44 – 26 loss against Williams in the semifinals last Friday night at Coronado High School in Scottsdale.

Williams has proven to be the Panthers' kryptonite. The Vikings have won four-straight games between the teams dating back to the 2016, all in the playoffs.

"We beat ourselves," Superior head coach Ryan Palmer said afterwards. "(We) had a bunch of mental mistakes, but we had more than enough chances to win."

Williams outscored Superior in the fourth quarter, 20 – 6. The

teams matched touchdowns in the first three quarters, each scoring one. The difference at the end of the three quarters was four points – a pair of PAT. Williams converted all their attempts while the Panthers succeeded on one of three.

"It was not our best night," Palmer admitted. "But at the end of the day, they were deeper and stronger. We didn't have answer in the fourth quarter."

Junior quarterback Matthew Cruz completed 36-of-51 passes for 313 yards with two touchdowns. Nathan Duarte, Matthew Diaz-Gonzalez and Adam Navarrette, all seniors, each finished with 10 receptions or more. Diaz-Gonzalez had a team-high 108 receiving yards.

Navarrette, who had 84 yards receiving yards, rushed for a team-high 89 yards and two touchdowns.

The Panthers' defense allowed its highest scoring total of the season after entering the game having allowed a total of 51 points in its previous six games combined.

The unit did recover three fumbles – one each by freshman David Drennan, Diaz-Gonzalez, and sophomore Benjamin Duarte. Diaz-Gonzalez and Navarrette led the team with 13 tackles each. Nathan Duarte ended with 10 tackles.

The Panthers simply made too many mental mistakes and it cost them.

"Great season, bad game," is how Palmer summarized his team's ending. He also praised the seniors after their high school careers

ended.

"(They) have a lot to be proud of," he said. "They will go down as one of the best classes in school history. It had great leaders on and off the field."

Palmer was clear on what it's going to take from the returning players.

"One thing is certain, if we are going to continue the program's standard of excellence, the underclassmen must all be committed to the weight room. There is no way to [winning] another state championship without a lot of hard work in the weight room."

If the players make that commitment, the Panthers return to the state championship game will be sooner than later.

JFK students celebrate Thanksgiving

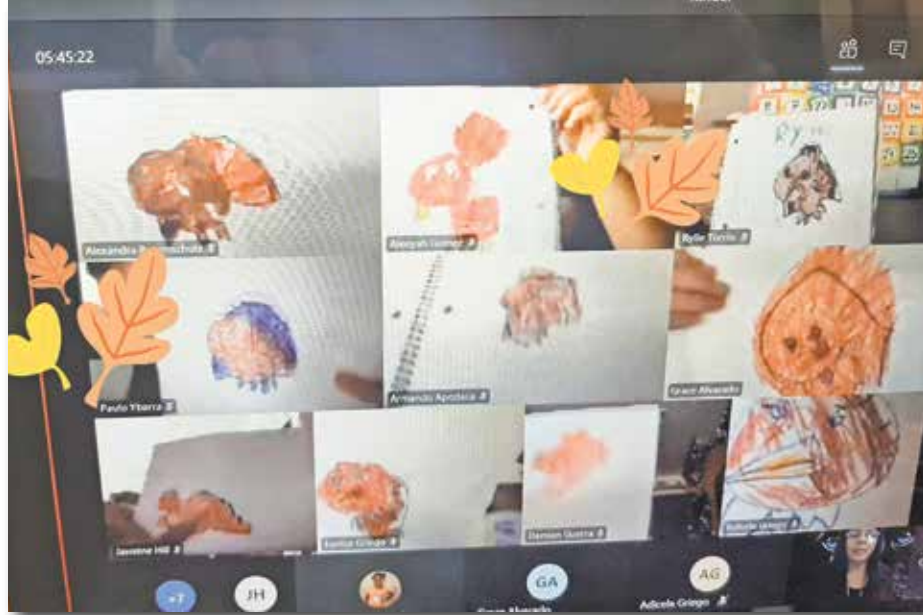
