Extending a Welcoming Hand to Winter Visitors

Most of the churches in the Copper Corridor are getting smaller and older. It's tough to have few or no children, and no new adults coming

in. Good Shepherd Church in Kearny is no exception. But Pastor Michael Eaton, almost as an aside, said this past Sunday, "Look around us.

We have many empty seats. Just think how much room we have to be more welcoming!"

It's the familiar question of water in the glass: half full or

half empty? Do we complain about not enough water or fill the glass?

Rural Arizona towns (especially mining towns) are similar to the churches. The towns are getting smaller, older and poorer. We are discouraged often and lament our situation. We retreat into our memories of the way things used to be. When we get this kind of mindset we give up our capability to look around ourselves and see the possibilities which might be available to us.

Let me recount something I did last February. With some other people from the Copper

Corridor, I went to the Great Canadian Picnic at South Mountain Park in Phoenix. Have you heard of it? It was new to me. It's a gathering of snow bird Canadians who meet their friends and trade information on things to do in Arizona.

I went prepared to invite Canadians to try Kearny for

winter living. I had 1,000 brochures touting Kearny and distributed 800 of them. I talked up our weather, the beauty, the outdoor life, and our businesses and health facilities. And I learned something. Canadian snow birds are tired of shuffleboard, golf, and expensive

Voter approved Pinal Regional Transportation Plan & half-cent sales tax: next steps

On Nov. 7, Pinal County Voters approved a 20-year Regional Transportation Plan (RTP) and a half-cent sales tax dedicated to funding the Plan.

Andy Smith, Public Works Principal Planner, has been appointed by the Pinal Regional Transportation Authority (PRTA) as General Manager and will begin assisting the Pinal Regional Transportation Board with coordinating the implementation of the Plan.

Mr. Smith currently serves as the Transportation Planning Supervisor for the Pinal County Public Works Department. Mr. Smith has over 25 years in State and County government in the areas of traffic engineering, safety,

partnering, and transportation planning disciplines. Mr. Smith holds a Bachelor's degree in Business Management from University of Phoenix and a Master's degree in Public Administration from Troy University.

Mr. Smith will begin working with the board members of the PRTA as they begin establishing the following items, approved in the RTP: Establish by-laws for the following: PRTA; Technical Advisory Committee; Citizen Transportation Advisory Committee; Establish the Citizen Transportation Advisory Committee; Establishment of a TIP (Transportation Improvement Program), starting with the 0-5 year plan; Coordinate discussions and

meetings with governing authorities; and Working on Financial Planning

Sad and Happy Times

I have often wished that the "old-timers" would record in some way what they remembered of their young life, and what they knew of their parents' lives. I really wanted to interview an elderly man who lived along the lower end of the San Pedro River, but I waited too long.

I am sorry that when I was younger and my mom was still with us that I hadn't asked her more questions about her earlier life, although I later learned more. She, who was named Lula Flora, but was usually called Lu, had been born on April 11, 1895, and she was 18 years old when she married 46-year-old Will Giles who was from a ranching family in New Mexico, the state that my mom's family had ended up in after having been in Texas and Oklahoma. Will Giles had been married, and after his wife had died their two very young children were under the care of members of the Giles family on their New Mexico ranch. A daughter named

June was born to my mom and Will Giles in January of 1918, but June died from pneumonia in 1919 and was buried on the Giles' ranch. Then on mom's birthday in 1926, the daughter Betty Jo was born in Clayton, New Mexico, but Betty Jo never knew her father Will Giles because he had died in Clayton, New Mexico at the age of 60 years, just three months before Betty had been born. My mom often said that Will Giles was so good to her that she was spoiled.

Mom ended up marrying George Kishbaugh, the man who would become the father of myself and my two brothers, Bill and Charley, and we, with our half-sister Betty, were raised in Hayden, Arizona where my dad worked for Asarco. Our mom was a tall, attractive lady with brown hair and eyes, and she could really play the piano, even with one finger missing. The story I heard about that is when she and her brother Earnest were kids, he kept telling her to keep out of the way

when he was chopping wood. It might have been a "dare" game between them when she got her finger chopped off. I understand that when I was a baby my mom played the piano for dances at the Green Lantern in Dudleyville, and that Louis Mendoza, Sr., who had his M&M Grocery Store in San Pedro, and Lanny Parker, father of Forrest Parker who had his Parker's Grocery Store in Winkelman, also played musical instruments for the dances. I imagine there were some good times held at the Green Lantern during the Prohibition days!

Winter Wonderland: Electric light parade and winter festival for the Copper Basin

"Baby, It's Cold Outside. Wear Your Pajamas" reads the flyer for this year's premier local winter festivity.

It's just one of those things that goes along with cooler weather, like hot cocoa, electric lights, bicycles, and ... well, whatever floats your winter boat, or, more to the point, makes your boat into a winter float. It's all about getting into the spirit of things, stepping out, stepping up when needed, and, having a great time with all your favorite people that you had the same sort of great time with during the same time of the year last year, and, maybe the year before that, and the year before that, for however many years you've been here and attending the Electric Light Parade and all the fun that accompanies it.

In your pajamas? I'm not sure. Before you show up in uptown Kearny, looking like a sleepover waiting

to happen, you'd do well to contact the Chamber of Commerce by calling 520-363-7607 or emailing eppab@yahoo.com, to ask how they would prefer you to be attired. This is also a good way to contact them for any other pertinent questions, including how to become a sponsor, volunteer, vendor, or entry in the Ugly Sweater contest. For instance, should you be wearing the sweater over or under your button front pajama top? Or, should it be covered in electric lights and be entered as a float? The answers to these questions and more can be yours. Just call or email and ask.

Once you know all that you need to know to be secure in making a decision in how you will be involved in the Electric Light Parade, it will be time to get those lights untangled, float decorated, Christmas sweater uglified-up, pajamas pressed, car or bicycle tires aired up, or, whatever else is needed for your part in the parade. The entry is free and starts at 5 p.m. on Saturday, Dec. 2.

Make sure to pack your flashlight. Check the batteries. Write down important, legible notes for the MC if you are going to enter into the parade. Otherwise, relax and prepare for fun.

Last year, the parade lined up by the Teen Center, with smaller floats lining up in front of Kearny Town Hall and larger floats lining up on Jamestown, and, it ended at the GKI. If there are any changes in this plan, it has not yet come to the attention of this news agency.

Let us assume, then, that uptown Alden will be where one will find the vendors for the Winter Festival, and,



later on, the site of a safe visit for the children with Santa and Mrs. Claus, also known as the couple most likely to wear their pajamas out in the cold, all year long.

Yes, like every year since it all began, there will be vendors of all sorts, including of food and beverages, and, music, and, a fat jolly old elf, and, contests. It will be the same-ol, same-ol, in all its ever-changing, yet, comfortable glory. Plus, perhaps, some nightclothes. Get ready! Don't forget your slippers!

Ray High School hosts annual Interview Day

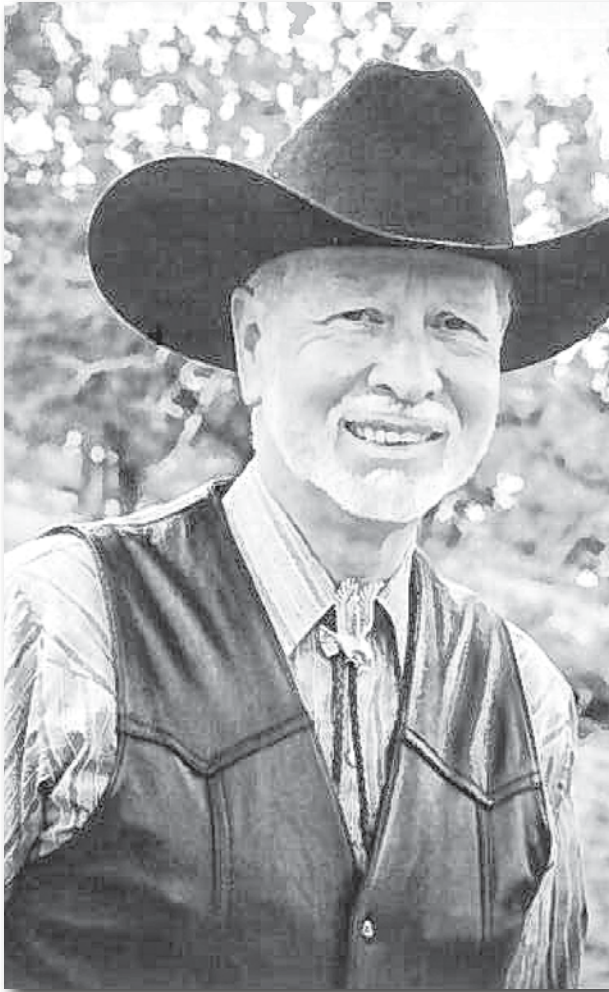
