# Regional Chief of Police - one step closer to happening

For well over a year, the communities of Hayden, Kearny and Mammoth have been without a police chief. As budgets continue to get tighter and revenues remaining stagnant, cost sharing is starting to become a norm for communities across the country, especially in the Copper Corridor.

For the past six months the local municipalities through the "Five Mayors' Meeting" have been woking on a process to hire a chief of police that could lead all three individual police departments. Currently Winkelman pays a contract to the Town of Hayden to provide police services in their community. Hayden took the lead to manage the advertising, posting and interviewing of the police chief, in September they made an employment offer to Sgt. David Blue who has served as an interim chief for all three of the communities over the past year.

At a special meeting on Monday night the Kearny town council approved an Intergovernmental Agreement with the Towns of Mammoth, Hayden, Winkelman and Hayden to share a chief

of police. Mammoth is expected to review the IGA again and approve on Tuesday, Nov. 29, 2016. A few minor verbiage changes were requested by Kearny to protect each community for each being liable if the chief has liability each of the communities.

Don Jones, Mayor of Mammoth, spoke to the Kearny council on Monday and encouraged the council to support the hiring of a joint chief.

"It saves us all a lot of money," he said.

Currently the IGA and calls for a one year employment contract for the multi agency position. Jones expressed his concern that the agreement should be at least two years to give the person in the position a chance to develop.

The hiring of a chief to serve each community does not mean that each community will be served under a coalition police force. That idea has been discussed through the Five Mayors' Meeting, but has not been actively discussed in over a year. No further developments have gone on there and it was shared in the Hayden and Kearny council meetings that the hiring of a shared chief was not the development of a coalition police force.

Each community will keep their individual police department, the chief will manage the leadership, policy development and administrative management of each department for each of the three communities with police departments.

# Kearny Police Report

According to state law, there are two methods by which police may arrest suspected offenders. 

# Andrew Lye named Project Manager at Resolution Copper as concern nears construction stage

Andrew Lye was named Project Manager of Resolution Copper Co., company executives announced on November 21. Lye succeeds Andrew Taplin, who is moving to a new position with Rio Tinto PLC, the British-Australian mining company that owns a 55% interest in Resolution Copper.

In assuming the new position, Lye brings more than two

decades of mining experience with Rio Tinto and its subsidiaries to the job. These include leading the La Granja copper project in Peru. He also had led operational, support and technical teams for Rio Tinto projects in Madagascar and Australia.

Lye also has experience in conducting studies, project development, commissioning and operations of block cave mines integral to future success at Resolution Copper. He arrived in Arizona last February where he assumed duties with Resolution Copper as General Manager of Studies.

"Andrew Lye brings to his new role a breadth of experience and a long record of partnering closely with the community to deliver mutual benefits," said Nigel Steward, a Rio Tinto executive. "We have every confidence that he will provide the leadership and expertise as Resolution Copper moves from the permitting to construction phase, onward to a world class operating mine."

Concurrent with Lye's appointment were the announcement of management changes at half-parent Rio Tinto, which is reacting to the revelation of a bribery scandal involving a company executive working on the Simandou iron ore project in the African nation of Guinea. These revelations are not expected to have any effect on the operation of Resolution Copper, which is on schedule to begin mining copper near Superior using new technologies in 2020, a Resolution spokesman told the Superior Sun.

The scandal became known in early

November when emails that were made public indicated that Alan Davies, head of Rio Tinto's Energy and Mineral Division, had made payments totaling \$10.5 million for "advisory services" on the project. This was compounded by the company's Legal and Regulatory Affairs Executive Debra Valentine allegedly knowing of the existence of the emails for more than a

These rules will be submitted to the U.S. Environmental Protection Agency for incorporation in Arizona's State Implementation Plan (SIP) as required by the Clean Air Act under Section 110 in order to attain and maintain the 2008 Lead National Ambient Air Quality Standards (NAAQS) and 2010 Sulfur Dioxide NAAQS.

The rules require control technologies recordkeeping and reporting, and emission limits to significantly decrease emissions of lead and sulfur dioxide in order to protect public health and the

see advertised so much this season? One Northern Arizona University researcher has studied whether they provide an advantage to a young child's learning.

Anna Sosa, director of the NAU Child Speech and Language Lab in Flagstaff, set out to see which everyday activities promote the best environment for babies and toddlers to learn language.

Early language development is critical to a child's learning. And babies, toddlers and preschoolers need to hear a lot of language in order to best learn how to speak and eventually transfer those skills into reading and writing.

year before the revelation and not doing anything about them. Rio Tinto reacted swiftly and terminated the employment of both Davies and Valentine. Bold Baatar was named to replace Davies as Energy and Minerals Chief Executive. Chief Financial Officer Chris Lynch assumes management of the Legal and Regulatory Affairs function until a permanent replacement can be named.

While early investigations have found no evidence that top Rio Tinto executives knew of the \$10.5 million payments, which are believed to have ended up with corrupt Guinean government officials, the company still faces additional probes by the U.S. Securities and Exchanges Commission, Great Britain's Serious Fraud Office and the Australian Federal Police. The mining concern could ultimately face fines from all three government

Rio Tinto is no longer involved in the Simandou iron ore project, which was cancelled earlier this year by Rio Tinto CEO Jean-Sebastien Jacques and its assets sold off.

Rio Tinto is the second-largest mining company in the world. It shares ownership of Resolution Copper with 45% owner BHP Billiton PLC, a global mining business based in Melbourne, Australia.


