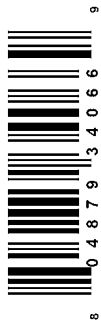

# Tribe invites Superior Councilman to Washington, DC

Superior Mayor Jayme Valenzuela and Councilmember Gilbert Aguilar met with Chairman Terry of the San Carlos Apache Tribe. In the meeting Chairman Rambler proposed taking a Councilmember with the San Carlos Apache Tribe to go to Washington D.C. The San Carlos Apache Tribe is hoping to revisit the Land Exchange Bill and hearing in reference to the Oak Flats Campground as to the sacredness to all Indian nations. The Mayor and Town Manager Margaret Gaston contacted Steve Cooper (the town's attorney) to make sure a Councilmember could legally go with the San Carlos Apache Tribe, who is paying for everything.

Cooper stated he did not see a problem with the San Carlos Apache Tribe's offer to pay for one Councilmember to observe the San Carlos Tribe's efforts to revisit the Land Exchange Bill passed last year in Congress.

Cooper stated he checked all the statutes before making that determination. On Friday, the Mayor informed Gaston that Councilman John Tameron was attending on behalf of the Town of Superior. On Friday, Oct. 30, Tameron was given a letter which to give to Terry Rambler, Chairman, on the plane Monday, Nov. 2. The contents of which are:

"The Town of Superior does appreciate the offer to pay for one Councilmember to observe the San Carlos Tribe's efforts to revisit the Land Exchange Bill.

"The Town does not have the budgetary funds to attend these meetings and hearing without the San Carlos Apache Tribe's help. There is no pending legislation before the Council as it relates to the mine. The Town is negotiating an Emergency Services Agreement with Resolution Copper for public safety, but this does not include any endorsement of the mine.

"One Councilmember will be selected to attend who will be gathering information and reporting back to the Town Council. The Councilmember will have no authority to take a position on behalf of the Town at any meeting or event.

"The Town Council will independently determine its position in the future. The offer of assistance will not

guarantee the Town's ultimate position will align with the San Carlos Apache Tribe. The Town Council hopes to in the future have more discussions and cooperation with the San Carlos Apache Tribe on areas of mutual concern and interest."

Tameron was given instructions that he cannot state anything on behalf of the Town, but he can on behalf of himself or his business, which the letter states the Councilmember has no authority to speak on behalf of the Town.

Tameron will report back to the Council what he observed in Washington on Nov. 12, 2015, at the Council Meeting.

## Superior Little League receives grant from Baseball Tomorrow Fund

(SUPERIOR, AZ) – The Superior Little League announced today that it was recently awarded a grant in the amount of \$24,120 from the Baseball Tomorrow Fund (BTF). The grant will provide funding for the replacement of the existing dugouts at the Superior Little League baseball field.

The existing dugouts will be demolished and replaced with new surface dugouts to address safety concerns and to better accommodate players and coaches. The field hosts approximately 100 games and practices per season.

The total cost of the project is approximately \$48,000. The funding received from BTF will be utilized for earthwork, foundations and dugout structures. The Superior Little League and local donors will provide funding for fencing, curbing, demolition and dump fees.

Major supporters of the project include Resolution Copper Mining and 5D Mining & Construction, Inc., which is the project contractor. The Superior Little League is still accepting in-kind and monetary contributions for the demolition of the existing dugouts. The Baseball Tomorrow Fund (BTF) is a joint initiative between the Major League Baseball Players Association and Major League Baseball designed to promote the growth of youth baseball and softball throughout the world by awarding grants to support field renovation and construction projects, equipment and uniform purchases, coaches training material and other selected program expenses. Since its formation by the MLBPA and MLB in 1999, BTF has awarded more than 800 grants totaling over \$28 million to non-profit and tax-exempt organizations in the U.S., Canada, Latin America, the Caribbean, Europe,

Fittingly, the team adorning the traditional Halloween colors – black and orange – had the last thrill as Superior junior running back Edgar Galindo scored the game-winning touchdown from five yards out with 22 seconds left to give the still-undefeated Panthers a come-from-behind 60 – 55 victory.

"This is a great team," Superior head coach Ryan Palmer said, amid a field full of happy Panthers' players and supporters. "When they're faced with adversity they come together and that's what we try to preach to them in practice, that's what we try to instill in them is that trust in each other and they're able to propel and overcome those obstacles because of (their) faith in each other and the togetherness they have. That's what makes this group really special."

The win advances Superior to this Saturday's semi-final playoff game versus No. 2 Valley Union at Maricopa High School.

"I was really proud of how (we) took on the pressure," senior captain Elias Olmos said after the game. "It was a big stage with a lot of young guys – juniors – and I was really proud of how they (dealt) with the pressure."

Superior junior quarterback and Player of the Year candidate Nicolas Cruz rushed for 384 yards and five touchdowns, including a 75-yard touchdown run in the opening minute of the game. Galindo, who finished with 99 rushing yards and three touchdowns, followed with the two-point PAT to give the Panthers a quick 8 – 0 lead.

Gilbert Christian, which suffered a 62 – 37 loss to Superior on Oct. 9, entered the rematch with a solid game plan, limiting the explosive Panthers' offense to only a few possessions in the first half with long, time-consuming scoring drives.

The Knights' successful execution resulted in an 18 – 14 lead at halftime. It was the first time all season that the Panthers trailed in a game.

Superior was set to kickoff to start the second half and used a trick onside kick to steal a possession from the Knights.

"It was kind of a gut feeling," said Palmer, admitting his team did not discuss the play during halftime. "I took a look at where they were lining up and they were spread out a little bit further than they normally are and I said, 'You know what, no risk no reward, we're going after it' and very fortunately it worked for us and our kids executed it."

The Panthers took advantage of the extra possession and the lead after Cruz dashed 38-yards for his third rushing touchdown of the game.

Two rushing touchdowns by Galindo and another by Cruz sandwiched a Knights' touchdown in the third quarter, which saw Superior outscore Gilbert Christian 26 – 8 and gave the Panthers the lead entering the fourth quarter, 40 – 26.

The teams traded touchdowns during the first eight

minutes of the final quarter before the last four minutes provided enough thrills to last the next two Halloweens.

Trailing 54 – 39, Gilbert Christian scored 16 unanswered points; the last coming with less than a minute left in the game to pull within 54 – 53. Rather than kick the PAT to tie the game, the Knights went for two and were successful, giving them a 55 – 54 lead with 54 seconds left.

A squib-kick by the Knights allowed the Panthers to start their game-winning drive at Gilbert Christian's 47-yard line. That's when Cruz sprinted up the middle 42 yards to the

five-yard line with 36 seconds left in the game, setting up Galindo's heroics on the next play.

"In the huddle it was nothing but happiness and intensity," Cruz said about his teammates focus during the final drive.

"A lot can happen in 36 seconds so we had to keep our cool and then execute on defense and we did. We got it done."

"I never once lost faith in my kids," Palmer added. "Our offensive line did an excellent job of getting their blocks. Edgar and (Cruz) were able to hit those seams and their speed took care of the rest."

The Panthers can reach the state championship with a win against Valley Union in a game that figures to feature the Panthers' speed versus the Blue Devils' power.

"Valley Union is a big team," Palmer said. "They run a lot of power and they're going to be a tough opponent for us. I think our speed gives us a huge advantage on the offensive side and hopefully we figure out some schemes to use our speed to our advantage on defense as well."

Saturday's kickoff is scheduled for 2 p.m. at Maricopa High School, located at 45012 W. Honeycutt Rd.

# Superior youth give time and effort to abandoned grave

It is easy to get caught up in the negative aspects to life. It is easy to start believing that all young people are stuck to their digital devices and not connected to their families let alone their communities. However that was not the case for seven young students from Superior.

Chanel Lopez and her grandfather, Rick Chavez, visit the Superior Fairview Cemetery regularly; often her friends join her and they spend time under the big Palo Verde tree. This summer while tending to family graves on the north side of the Fairview Cemetery they saw that there was a grave near their family plots that needed attention and beautification. The seven friends, in grades fourth through seventh, (Chanel Lopez, Julian Hernandez, Aliya Soto, Daren Hernandez, Nathan Duarte and McKenna Duarte) set out to complete a community project and hope that others in the community will be inspired to adopt a grave and help keep the cemetery clean.

At first they decided just to trim the weeds and clean around the grave, then they decided they should paint the edges of the grave. One side of the grave had a headstone the other side had a small metal sign that was hard to read and faded. They decided that the grave needed a proper

headstone for the other person buried there. The group did some research and, with the help of local resident Cheryl Castro who works at the Pinal County Recorder's office, they were able to determine that James and Matilda Grey were buried there. Rick contacted the last living relative of the couple and obtained permission for the youth to work on the grave and purchase a headstone. Their last living relative is a son in law who lives in Phoenix and is unable to come and care for the grave anymore.

These young adults didn't want Matilda's life to go unnoticed so they decided to raise money for her to have a headstone. With the help of Anthony Davis at Superior Mortuary, they found an affordable headstone that matched her husband's stone and raised the \$300 needed. The kids put some of their own money but then they went to local businesses and put jars up to collect money. It took them about six weeks to have all the money they needed to buy the stone.

With Rick's help the group installed the headstone and finished painting the grave in mid October. They are not stopping at this beautification project, they would like to find other projects that need some beautification at their schools and around town that they could work on.

"We just want to make things beautiful" said Chanel Lopez.
