Veterans often walk away with an ability to work cooperatively with individuals from various backgrounds as well as a desire to stand for what is right. Those skills translate well to becoming a CASA advocate and working within the system to speak up for abused and neglected children. Nationally the CASA Program has a relationship with the American Legion which offers its support to the program.

CASA of Gila County pays tribute to all Veterans who have served our county and to the CASA advocates who serve a dual role in both protecting our freedom and our children.

CASA volunteers are professionally trained to advocate for children in foster care. Advocates get to know one child or sibling group and speak to others involved in the children's lives, including family members, teachers, doctors, lawyers and social workers. Their recommendations and the information they gather help judges overseeing dependency cases make informed decisions on a child's best interest.

Court Appointed Special Advocates don't have to have any special degree or background. # Full closures of US 60 at Pinto Creek scheduled to begin Nov. 7

Motorists who use US 60 between Miami and Superior should expect long delays and a lengthy detour starting Thursday, Nov. 7, when the Pinto Creek Bridge closes to all traffic for rock blasting.

US 60 will be closed on Tuesdays and Thursdays between 9 a.m. and 1 p.m. for about six weeks. Crews will reopen the road prior to 1 p.m. if it is safe and passable.

All eastbound vehicles will be redirected at State Route 177 in Superior, and westbound vehicles will be redirected at the west end of Miami. Traffic will not be allowed to queue at the closure locations.

Motorists with a destination between SR 177 and Top-of-the-World west of

Pinto Creek or between Miami and Pinto Valley Mine Road east of Pinto Creek will be allowed to pass, however no vehicles will be allowed between Top-of-the-World and Pinto Valley Mine Road.

During the closures, traffic will be detoured to SR 177 in Superior and SR 77 in Globe. The detour includes a 10% grade and will significantly increase travel time.

Law enforcement officers will be stationed at the intersection of SR 77 and SR 177 in Winkelman.

Arizona Department of Transportation crews will also complete maintenance work (vegetation removal, guardrail repairs and pavement overlays) during the closures.

Because of the potential for long delays,

motorists may want to plan trips before or after the full closures.

# Turning household objects into toys for young kids

For anyone who's ever seen a baby, toddler or preschooler open a gift and then toss aside the shiny new toy to instead play with the box, the American Academy of Pediatrics says kids may know what's best for them.

The organization recently came out with a recommendation that the best toys for young children are the simple ones. And we're talking very simple, like everyday household objects.

First Things First reminds parents that children explore and make sense of the world around them through play. In fact, research has shown that play impacts everything from physical abilities and vocabulary to problem solving, creativity, teamwork and empathy.

Playing with ordinary household items allows a young child to explore their world and found objects. With babies, it's as simple as grasping an object and holding on to it. Families can focus on introducing objects that stimulate curiosity. Babies are fascinated by their surroundings, especially faces and bright colors. You can use something as simple as a small, lightweight scarf to play peek-a-boo or use it as a prop

as you make up stories. By adding music to the scarf play, you can get your baby moving and sharpen their listening skills as you give directions.

For toddlers between 1 and 3 years old, look for objects that encourage imagination and problem solving. They enjoy





# Survive and advance: Hayden continues to overcome challenges

The injury-riddled No. 5 Hayden football team will make its second-straight semifinals

appearance in the 1A state playoffs following a decisive 30 – 8 victory on the road last Friday against No. 4 Salome.

The Lobos, who have been without starting quarterback AJ Castillo since the midway point of the season, have persevered though injuries all season and now are

playing their best at the right time. "(Our) kids came out and played well and hit," Hayden

head coach John Estrada said. "Our line dominated their line in the trenches, both offensively and defensively.

"We're playing at a different level right now," he continued. "We're banged up, but we're overcoming that, playing Hayden football, and having fun. Now is the right time to peak."

Jorge Rodriguez had three touchdowns in the win, Mory Cruz added another, and Ano Cruz sacked the Frogs' quarterback in the endzone for a safety to account for the Lobos' scoring plays.

For their efforts, the Lobos get the opportunity to avenge the loss to No. 1 Williams this Friday. It'll be the second time the teams meet in a month.

Estrada knows what to expect from the "good and well-rounded" Vikings – "an awesome running attack" with a big line and an offense that can throw the ball well too.

"They're No. 1 for a reason," he said.

Estrada hinted that the first meeting between the teams - a 68-6 Vikings' victory - involved some strategic considerations on his part in anticipation of a second matchup in the playoffs.

"The first time we played them that game didn't mean (anything) to us, other than seeding purposes for the playoffs," he said. "We had to make a decision on how we would handle that game. We figured whether we came out No. 4 or No. 5 in the state, the outcome would still be the same – we would end up playing Williams in the semifinals regardless.

"The outcome of the game wasn't too pretty, but it was a strategy we had to endure to rest our banged-up kids."

The Lobos confidence hasn't been higher than it is entering Friday's game. Add to that the opportunity for

a second-straight state championship appearance and Hayden believes it can do what it's been doing for weeks: Survive and advance.

"We are healthier, we know what to expect, we know how physical Williams is, and what they do," Estrada said. "The key now is stopping them. We're playing better football now than we were four games ago. We've made adjustments from our first game. We definitely will be up for the challenge."

The question now is: Are the Vikings?

**Up next:** Friday, Nov. 8, vs. No. 1 Williams at Coronado High School in Scottsdale. Kickoff is scheduled for 7 p.m.

# Roll down your windows and roll up your sleeves: drive-through flu shots Nov. 8

Gila County Public Health is sponsoring a drivethrough flu clinic at High Desert Middle School in Globe Friday, Nov. 8, 9 a.m. to noon.

Need more incentive to drive over and protect yourself ahead of flu season? All participants have a chance to win a grand prize 50-inch LG smart TV (thanks to a generous donation by

Haven Health), with gift cards and gift certificates from other gracious donors including J & R's El Rey Cafe, Guayo's on the trail, and Guild Consulting. Three ways to win: earn one ticket just for showing up, or two tickets if you arrive with proof you've already had a flu shot, and three if you 'drive-through' and get a shot.

Influenza (the flu) is

a highly contagious respiratory illness caused by viruses infecting nose, throat and lungs - infection spreads through the air when a person who has the virus sneezes, coughs, or speaks. Flu season runs October-

to-May; Gila County Public Health Department staff advise getting the flu shot as early in the season as possible. The flu can come on suddenly; symptoms include fatigue, body aches and chills, cough, sore throat and fever. The flu virus affects animals too. An average of 5% to 20% of the U.S. population contract the virus. The flu results in 31.4 million outpatient visits and 200,000 hospitalizations every year. The 2017-2018 flu season was known as the deadliest in decades: 80,000 died from the flu, with more than 900,000 hospitalized. Sadly, 185

pediatric deaths were reported to CDC, of which 80 percent were children who did not receive the flu

playing hide-and-seek with different objects. As a toddler, your child may begin to arrange objects, which eventually turns into sorting and classifying them. This allows the child to develop thinking, reasoning and problem-solving skills.

For preschoolers from ages 3 to 5, look to use objects that will help preschoolers relate to each other and the world around them. Encourage their imagination by creating a pirate's telescope using a paper towel roll.

First Things First offers these 10 suggestions on every day household objects that can be used as toys that promote early learning:

- 1. Plastic cups can be used to sort items.
- 2. Toilet paper rolls tape two together and create binoculars for a game of I Spy.
- 3. Whisk babies love to hold whisks, but as your child gets older you can use a whisk in the bath to swirl the water or make patterns in the sand.
- 4. Cardboard boxes depending on the size, boxes can be used in a variety of ways. Facial tissue boxes make excellent building blocks to build towers.
- 5. Plastic containers use to sort items by color and size, take them into the bath to pour water.
- 6. Leaves rustling leaves outside. Let your toddler walk

through a pile of leaves. They'll enjoy the rustling and crunching sounds underneath their feet. For preschoolers, they can paint the leaves and use them to make patterns.

- 7. Screw-top plastic water bottle fill with pasta or beans to make a shaker. Or use them as bowling pins, to knock down with a ball.
- 8. Pots and pans and wooden spoon teach your toddler about rhythm by banging on the pots.
- 9. Laundry basket use to throw rolled-up socks or have them use their imagination to sit inside and drive a car or steer a boat.
- 10. Everyone's favorite: old blankets, sheets and towels use to build an indoor or outdoor fort.

To encourage imaginative play at home, parents and caregivers only have to look around the house to keep little ones entertained.

# Register now for the Church of the Good Shepherd's flea market, Christmas shop

The Flea Market and Christmas Gift Shop at Good Shepherd Church is coming up in a few weeks. Now is the time for members of the community to begin selecting items for Good Shepherd's Flea Market and Christmas Gift Shop – and to pre-register for sellers' spaces.

Sellers must pre-register for their space on Nov. 15, from 9 a.m. to 2 p.m. at Good Shepherd Church at the bottom of school hill. (If a seller can't be there during that time frame he/ she may send a representative.) Both outdoor and indoor spaces are available for \$10, to be assigned on a first come, first served basis. Sellers can register for multiple adjacent spaces if more space is needed. Whether or not the strike is over, miners will not be charged for their spaces. (Asarco miner employment I.D. will be required at the time of pre-registration.)

Outdoor spaces are for sellers who cleaned out their shed or storage room or need a good place to carry out their downsizing plans – a place where a few dollars can be made to get through these trying times. Many of us have items of unique quality or value - perfect things for re-gifting at Christmas time. That's where the indoor spaces come in.

On the day of the Flea Market and Christmas Gift Shop, indoor spaces at the church are for sellers who have items to sell of that kind of quality. Sellers should ask themselves, "Is this an item I would be proud to give or excited to receive at Christmas?" Items should be in excellent repair, neat and clean, reasonably priced, and ready for wrapping. (The coordinators reserve the right to refuse any indoor gift item not deemed appropriate for immediate gifting.)

All spaces, both outside and in, are to be set up, staffed and managed by sellers who conduct their own transactions directly with the buver.

In the Little Gallery at Good Shepherd, there will be Christmas-gift items which have been given to Good Shepherd Church to sell. The miners' discount will apply and the entire balance will then go to support the work of the church. Those wishing to wholly donate items to the church should indicate such at the time of pre-registration. (Tickets for a quilt raffle will be sold there as well.)

- Anemia, severe

# **During Hyperbaric Therapy**

Hyperbaric oxygen therapy typically is performed as an outpatient procedure and doesn't require hospitalization. If you're already hospitalized and require hyperbaric oxygen therapy, you'll remain in the hospital for therapy.
