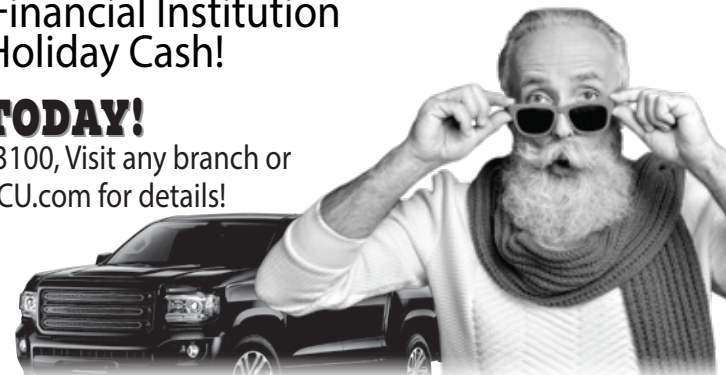

Free COVID-19 saliva testing offered at Hayden High School on Friday, Dec. 18

The Hayden High School site will continue free blitz COVID-19 testing on Friday, Dec. 18, 9 a.m. to 1 p.m. The COVID-19 testing is sponsored by the Arizona Department of Health Service, Arizona State University, Arizona National Guard, Department of Emergency and Military Affairs and the Gila County Health Department.

Preregistration is encouraged online at theazhealth.gov/covid19testing. It will allow you to select the time that is most convenient for you. Drive in and out in 15 minutes or less. Feel free to drive in and get tested without an appointment as well. Test results are sent in less than 48 hours, and sooner.

Important guidelines

- You must wear a protective face covering - either cloth or surgical mask.
- Bring the QR code you receive after scheduling your test appointment.
- Thirty (30) minutes before your appointment, rinse your mouth with plain water for 20-30 seconds and then spit the water out.
- Do not eat, drink (even water), smoke, vape, or chew gum for 30 minutes prior to your appointment time (any of these factors may cause an invalid test and/or your test may be rejected by clinical personnel at site collection).
- Tip: Staying well hydrated by drinking water the day before and up to 30 minutes prior to your test will speed your saliva collection process.

Results will be available via the portal approximately 48 hours from your testing time.

Individuals will be available at the COVID-19 testing site to address questions you have pertaining to the sample collection process.

Kearny PD arrests suspect in recent burglaries

Over the past few weeks there have been a series of burglaries in the Copper Basin. Most recently there was a theft of a trailer and many tools from the corrals in Kearny. Members of the General Kearny Sheriff's Posse received an anonymous tip on the location of the stolen trailer.

The Kearny Police Department began an investigation and the tip led them to a home on Velasco and Second Avenue in Hayden, where Chief Wallace Kenney and Sgt. Wells investigated the property with a search warrant.

They arrested Raymond Martinez on Dec. 10 after finding the trailer and many items that were stolen from the corrals. The investigation also turned up many other stolen items from ranches and properties outside of town limits in Pinal County.

Martinez was booked into the Pinal County Jail on theft of transportation and theft over \$4,000 which is felony theft. Martinez is currently out on bail. Pinal County Attorney Office has accepted the charges and Martinez will face trial.

Copper Area News is committed to providing our readers with as much information as possible. This graph shows the positive cases as of press time on December 15, 2020. We have also included a graph showing the daily counts for the past week. Daily statewide case counts are recording higher than they were during the last peak this Summer and hospitals are becoming overwhelmed by COVID-19 patients.

There are a few points we would like our readers to consider when following this data.

1. This will continue to be a rolling total of positive cases. It does not reflect recoveries or deaths. The Arizona Department of Health Services does not break out this data.
2. If you see a reduction in numbers from day to day it is most likely due to a data entry error or mis-coding of a zip code (at the state level).
3. This is all zip code based data; most of our zip codes include unincorporated areas. There is no way to track exactly which areas each of the positive cases are. Example, Kearny and Winkelman each have small communities in their zip code that are not in the Town's incorporated boundaries.
4. If you live in Gila County, please follow the Gila County Health and Emergency Management, Facebook. They have maintained their data on recoveries and current positive cases.
5. You can follow other data such as ICU bed use, Ventilator use and hospital capacity online: <https://bit.ly/3inh280>

Working together, we can slow the spread of the virus across the Copper Corridor. Wear a mask in public, remain physically distant (6ft apart or more) and practice good hygiene (wash your hands frequently, sanitize high touch areas), stay home if you are not feeling well.

Ray Unified School District – Perseverance Through the Pandemic

2020 – it has been a challenging year. The COVID-19 Pandemic has challenged every single system known to our modern world. Education was not spared and small rural school districts had even more challenges to ensure that students could be educated. Decisions that many never thought they would have to make were all thrust upon local leaders, and finding the right path was left to local control. Those decisions often had to be made when everything was changing rapidly, and, in some cases, the decisions made would need to be changed after another executive order was made. Patience, perseverance and resilience is what guided Ray Unified School District as they managed through the pandemic.

RUSD was the first district in the Copper Corridor to return to in-person learning. They do offer a stay at home learning option for families who prefer the home learning option but the majority of students have returned to traditional in-person learning on a daily basis. Students at RUSD come to school masked up and ready to learn. Their teachers returned, happy to see their students and get back to teaching in person. Parents also remarked that they now have a different appreciation for teachers and are more involved with their students work. Enrollment at the district has decreased but it is difficult to indicate if the student loss is due to the strike or parents opting for other education options. Across the state and nation, public schools are reporting that the pandemic has created a decrease in enrollment in traditional public school. RUSD, keeps the doors open for students despite these challenges.

Returning to in-person learning required a tremendous amount of coordination: keeping class sizes to a size where students can physically distance, larger cohorts would be moved to bigger classrooms, parents opted to drive students to school to free up seats in the school busses. Group assignments and partner work is now a thing of the past to ensure that physical distancing is maintained. Students stay with their classmates and do not get to interact with other students outside of their class. Managing the logistics to ensure that student had access to meals, play time and hourly hand washing all were worked into developing a schedule for school to reopen. Solutions were found to some of the challenges,

resilience was key.

Early on in the pandemic, when schools were closing it was an immediate challenge to ensure that every student had access to the internet and computer equipment. Teachers quickly learned how to teach online and use new programs such as Microsoft Teams to connect with their students and manage their virtual classrooms. Now those students who learn from home still use that program and if a student who is absent, misses a day of school they can go back to the recorded lesson.

“I believe we will transition in and out of student absences easier now the we have learned how to use technology,” explained Megan Corder a teacher at RUSD.

Some activities did not return with in-person learning such as fall sports. The RUSD Governing board voted not to participate in fall sports.

“It was a difficult decision to cancel fall sports,’ Superintendent Rochelle Pacheco explained. “We could not justify students playing football and volleyball but unable to attend school in-person. Our community handled the decision well especially when colleges and professional leagues were making the same call. It is hard to say how the cancellation of fall sports will affect future season, our main concern was and still is the health and safety of our students and staff. It is unfortunate that our students missed out on the experience of certain events associated with fall sports: such as homecoming, senior night, or the last time they played football on the home field.”

The administration, staff, students and families all came together through the pandemic, which made a difference and helped to make solid decisions for the district.

“There have been a few positive factors to come out of this experience,” Pacheco said. “People have been more compassionate, in some respect, created unity that we are all in this together. I am proud of the way our community has accepted the challenges, students and staff are wearing masks despite different beliefs, parents are doing their part and responding to the school’s needs, and everyone appears to be grateful of any social interaction. We have an appreciation now for normalcy and enjoy having our students back on campus. We have all had to learn to be more flexible and understand that conditions can change daily.”

Pacheco continued: “This situation has forced our teachers and students to

become more familiar with technology. Teacher’s knowledge and confidence has greatly improved and are now more accepting of implementing technology into everyday teaching. This has also introduced and promoted practices that colleges have used for years.

“Increased parent involvement in their child’s education, has also improved. Parents have a better understanding of what teachers go through daily. During remote learning, parents were enlightened on the challenges of getting students motivated and now have a better understanding of what teachers go through with 25 plus students in a classroom. This has opened the lines of communication

between parents and teachers bridging school and home.

“Lastly and most importantly, this has shown us how our teachers are committed to their students and profession. They have been able to shift from a teaching style that has been around for decades and move to something they are unfamiliar with. It has been a balancing act trying to be conscious of screen time, focus on the essential skills that need to be taught, and the emotional status of our students. They have put in countless hours to be as effective a teacher as they possibly can be.”

With COVID-19 numbers continuing to rise, the district hopes to maintain the metrics to stay open in person.
