

# Copper Corridor broadband study proposal goes before Pinal County Supervisors

FLORENCE - In last week's special session, the Board of Supervisors heard a proposal from Bill Bolin of the Copper Corridor Economic Development Coalition regarding a proposed study for the eastern portion of Pinal County.

Bolin came before the Supervisors to inform the Board on a proposed study that would look at how to set up a broadband network that would stretch from Oracle to Superior. This would give the Copper Corridor Economic Development Foundation an estimate on what a project of this magnitude would cost. Bolin said the study would cost in the neighborhood of \$17,000, he was asking the Board to consider investing \$10,000 to help it get off the ground.

The study would begin January 2015 and end in June. Supervisor Pete Rios, whose district is within the Copper Corridor, spoke in support of the proposal and encouraged the other board members to also support it.

"The Copper Corridor is not competitive," Bolin said. "We need to make them competitive. The Copper Corridor is losing business, we are in the middle of a brain drain in the area."

Bolin explained that a broadband network would be a key to helping create a better communications network for public safety providers, expand educational services, bring telemedicine to the area and to help small businesses

be competitive in southern Arizona.

Bolin, who represents the Copper Corridor as well as Systems Technology Staffing, LLC (STS) said his company along with One Random Act of Kindness (ORAct) would be spearheading the project. "We have a template that is workable and that has a track record," Bolin stated. "We will be working with several broadband providers as well as with stakeholders in the area."

Bolin added that such a plan to bring broadband service to the area would need the help of large employers like ASARCO and SRP. He added that ASARCO currently has fiber optic service for internet.

"Will people buy in?"
Bolin said. "I don't
know. But we will have
something to put on
the table. This will give
everyone a cost estimate of

this project."

The geography of the region with its mountain ranges and valleys along with its rural spaces has made it tough for companies that depend on broadband service to survive. Supervisor Rios said such a system is desperately needed.

"In the mountain area, if you have a cell phone, you might just want to turn it off," Rios said. "You can rarely find a signal."

Bolin said that such a study would be based on the success on getting broadband services started in Safford, Douglas and Tuba City.

"In the end, success


would be coming close to the Federal Communications Commission requirements for broadband service that would help public safety, telemedicine, education

### **Ernest C. Brace**

Ernest C. Brace, a Marine Corps pilot who was decorated for combat service in Korea, then was court-martialed for desertion after a stateside plane crash and later was celebrated for his fortitude as the longest-held civilian POW in the Vietnam War, died Dec. 5, 2014 in Klamath Falls, Ore. He was 83.

The cause was complications from a pulmonary embolism, said his wife, Nancy Brace.

He was born Aug. 15, 1931 in Detroit Mich. to Cary and Ruth Brace. The elder Braces were former residents of Ray and later moved to Superior. Before the family moved to Arizona he joined the Marines at 15 and was commissioned as an officer at the time of his 20th birthday.

Mr. Brace spent nearly eight years in captivity. Sen. John McCain (R-Ariz.), a

former Navy aviator who occupied the cell adjacent to Mr. Brace's at the infamous prison known as the Hanoi Hilton, once described him as "a man whose bravery and sacrifice for this country have had no bounds."

By his early 20s, Mr. Brace was a seasoned and accomplished pilot. He flew more than 100 missions in Korea — including one in which he encountered heavy enemy fire and was forced to crash-land in the Sea of Japan, where a U.S. ship rescued him. For those actions, Mr. Brace received the Distinguished Flying Cross.

In January 1961, he was a captain enrolled in an officers' training course at Quantico, Va., when a plane he was piloting crashed on Maryland's Eastern Shore. Mr. Brace abandoned the scene, reportedly hitchhiked to Baltimore and turned himself in 10 days later after authorities discovered his discarded flight suit.

He said at the time that he was burdened by domestic and financial problems and had hoped to "get away from it all." Law enforcement officials alleged that he had attempted to fake his own death in order to allow his family to collect on a life insurance policy.

Mr. Brace insisted that the plane had malfunctioned, and a federal jury acquitted him of purposely destroying the government aircraft. A Marine Corps court martial convicted him of desertion and sentenced him to "punitive dismissal."

Mr. Brace later became a civilian contract pilot ferrying supplies and passengers into Laos during the Vietnam War. On May 21, 1965, Communist forces attacked his plane on a Laotian airstrip. He was captured and taken to the jungle prisons where he would begin his seven years, 10 months and one week in enemy hands.

That period, he recalled in an account published on the POW Network Web site,

would be "spent mostly encaged in small bamboo cages, to be beaten, starved, buried alive, and humiliated as few modern day humans have known."

Mr. Brace was said to have repeatedly attempted escape. After one effort, the Associated Press wrote, he was buried up to his neck for a week. He recalled that he endured more than four years of solitary confinement. Once, he recalled, he attempted to choke himself.

He eventually was transferred to the Hoa Lo complex in North Vietnam, also known as the Hanoi Hilton, where through taps and furtive messages transmitted between cells, he embarked on a spirit-sustaining friendship with McCain, who had been captured in 1967.

"The wall was like a confessional," Mr. Brace recalled. "The person on the other side existed in voice only."

On March 28, 1973, Mr. Brace was released. Soon after, he met McCain at

a White House event for former POWs hosted by President Richard M. Nixon.

"A guy came up to me and I looked at him and he said, 'I'm Ernie Brace,' " McCain told an interviewer. "It was such an emotional moment for me."

In 1974, President Gerald R. Ford granted Mr. Brace a full pardon. Last year, in part through efforts by McCain, he received the Purple Heart and the Prisoner of War Medal.

"As a civilian, Ernie was under no obligation to adhere to the Code of Conduct," McCain wrote in his memoir "Faith of My Fathers." "But Ernie's conscience demanded much from him. He kept our code faithfully. When the Vietnamese offered to release him, he declined, insisting that others captured before him be released first. No one I knew in prison, Army, Navy, Marine, or Air Force officer, had greater loyalty to his country or derived more courage from his

sense of honor."

He and his first wife, the former Patricia Emmons, had four sons before his service in Vietnam. One son, Patrick, said in an interview that his mother remarried during Mr. Brace's imprisonment because she believed he was dead.

When Mr. Brace returned, his marriage was annulled. In 1974, he married Nancy Rusth, a nurse who had assisted him in his rehabilitation. Besides his wife, survivors include his sons, Ernest Brace of Bonita Springs, Fla., Patrick Brace of Abington, Mass., Michael Brace of St. Petersburg, Fla., and Cary Brace of Rapid City, S.D.; a sister Rose Bradford of Kearny and eight grandchildren. He was preceded in death by his parents and sister Betty Parr.

After his imprisonment, Mr. Brace told a National Geographic interviewer, he worked in Latin America, China, Russia and the Middle East on programs including narcotics control programs, foreign military sales and fuel contracts.


During the Persian Gulf conflict of the early 1990s, he said that he helped establish a medical evacuation system for firefighters in Kuwait.


Mr. Brace wrote two books, the memoir "A Code to Keep: The True Story of America's Longest-Held Civilian POW in the Vietnam War" (1988) and "Monkey Paw Soup: And Tales of Drugs, Thugs, Revolution and War" (2012).

Once, Mr. Brace reflected on how he had survived his imprisonment. "I never thought I would die up there, and escape seemed possible all the time in my head," he said. "Later, after they had crippled me, I felt that they were keeping me alive for some reason and someday I'd be going home."

But in the beginning, he observed, "I think my Marine Corps training kept me going."



### Southeast Arizona Land Exchange

The Southeast Arizona Land Exchange and Conservation act was approved in the Senate on Friday, Dec. 12, through





the passage of the National Defense Authorization Act. The bill was proposed by Resolution Copper in order to extend the life of the mine. The bill is expected to be signed by the President in the coming days, should the President not sign the bill it will take effect in 15 days.

Project Director Andrew Taplin explained, "There is much more work to be done before commercial mining can begin and Resolution Copper looks forward to working with all stakeholders as we continue to progress through the regulatory review process toward responsible development and operation of a world class copper mine that will safely produce over 25 percent of the current annual demand for copper in the United States."

There were a few amendments to the land exchange bill which include additional environmental protections; those amendments were approved in both the house and senate versions of the bill. The amendments included that the federal land will not be transferred to the mining company until the environmental studies are completed; it will also allow Native American tribes to access the property until the area in longer safe to use. Another critical amendment designates 807 acres of the Apache Leap Cliffs as a special management area which places it under Forest Service Protection. The designation of the Apache Leap will allow the Forest Service and other stakeholders to monitor the area and ensure that mine operations are not destroying the cliffs.

This legislation has been introduced into Congress several times over the course of a decade. Senators McCain and Flake along with Representatives Gosar and Kirkpatrick were instrumental in gaining approval in this Congress despite the opposition of the bill from the Superior Town Council, San Carlos Apache Tribal leaders and environmental groups. Opposition groups have criticized the fact that the bill did not pass on its own but it is not uncommon for lands bills to be included in the annual Defense Authorization Act. "To maintain the strength of the most technologically-advanced military in

### and Conservation Act approved by the U.S. Senate

the world, America's armed forces need stable supplies of copper for their equipment, ammunition and electronics," explained Senator McCain. "Most importantly Resolution Copper represents a game changer for an area of Arizona facing grave economic challenges."

Recently the Superior Town Council held an open discussion on the status of negotiations with the company. The town Attorney Steven Cooper is now at the helm leading the discussions. Councilmember Gilbert Aguilar was quoted in the Arizona Daily Star: "We're still going to keep negotiating our concerns. You can say there's going

to be jobs, but put it in writing that they're going to be here."

Rep. Ann Kirkpatrick sent this written statement upon the passage of the bill in the Senate. "Arizona is just one momentous step from the finish line. I urge the president to sign this legislation and open the door for thousands of good jobs in District One. My vision for this district is to build a strong and diversified, stable economy-and the Superior mine is an important part of that vision. This project will lift the local economy and out working families in Superior and the Copper Corridor."



The final draft presented four top priorities that could be addressed to improve the economy and included education, infrastructure, tourism and entrepreneurship and local business.

For the most part Stephanie agreed with the final

draft consensus, but she would also like to see Arizona civic health be addressed. "We need to motivate our communities involving civic action," she said. She added that she learned a lot and made many new friends even though she was the youngest kid on the block.

Also during the event several keynote speakers addressed the assembly.

Stephanie is a senior at Ray High School and is a honor student, plays flute with the Bearcat Band and has participated in Cheerleading. Community service has included volunteering at her church as an Altar server, helping with community clean-up activities and the annual Easter Egg Hunt. She also ran for and earned both the Junior Pioneer Days Queen and Pioneer Days Queen

Stephanie is the daughter of Chris and Ruth Alvarado and she is most grateful to her parents for all their support and encouragement.

Her future plans include attending either the University of Arizona or Grand Canyon University to prepare for her career goal as a medical examiner.

couldn't get any closer. Longoria hit 1 of 2 free throws to seal Panthers first win in five years versus the 'Cats.




Each interviewer is assigned seven to eight seniors to interview and from their pool of applicants they award a "Top Job


