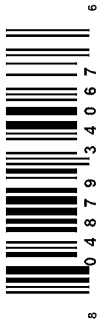

# Sea Lions shine at Winter Lights Swim Meet

Over the weekend of Dec. 5-8, the Sea Lions Swim Team competed in the Winter Lights Swim Meet in Oro Valley.

Out of the 19 teams from Arizona that participated, the Sea Lions finished 9th overall with 628 points.

Preliminaries were held each morning and swimmers who qualified in the top 16 swam in finals each evening. Medals were awarded for top three finishes in each individual event. This meet format is similar to the format used at State Championship meets. With the 2020 Age Group State Championship Meet scheduled to be held in the Oro Valley Pool in March, the meet was a great preview for many swimmers.

Eleven Sea Lions Swimmers earned spots in finals during the meet. Genaveeve Lopez (10), Jocelyn Hudson (10), Copper Dale (12), Ethan Erickson (12), Julie Ramirez (12), Ethan Kellam (13), Mason Stewart (14), Mia Dale (14), Marialena Molina (15), Evan Apuron and BaiLee Hill (18) all swam fast enough in Preliminaries to earn a spot in finals.

In nearly every case, Sea Lions swam faster in finals. Against some of the best swimmers in Arizona, the Sea Lions achieved 88 personal best times. The following Sea Lions had individual medal winning performances:

- Julie Ramirez – 1st 400 IM
- Ethan Erickson – 3rd 200 Backstroke
- Cooper Dale – 3rd 400 IM, 3rd 100 Butterfly
- Evan Apuron – 2nd 100 Free, 2nd 50 Free, 2nd 200 Butterfly

Coaches were very pleased at the how the team performed at the grueling four day meet. It was the first time several of the Sea Lions participated a prelim-finals format meet. The 12 year old Sea Lions (Julie, Ethan, and Cooper) had a tremendous meet, this was a great test of

how they perform in pressure situations and all three of them did great.

# Miners on a mission: they want a

The San Manuel boys' basketball team believes it's a state title contender, and right now, the Miners are looking the part.

They boast an 8 – 2 record to start the season, with the only losses to St. Augustine Catholic in back-to-back games, including one in the Boyd Baker Tipoff Tournament Championship Game on Nov. 27.

"We've run the same system for three years," San Manuel head coach Damon Lovato answered when asked to attribute the early season success by his team. "The players just react now. They just chop wood and get after it. The know what to do.

"It's rare that a varsity coach has the same group of kids for three years, and the chemistry between me and them allows us to make adjustments on the fly."

Since those two losses, San Manuel has won three-

straight games, including a pair on the road at San Carlos (65 – 41) and Coolidge (52 – 45). Last Friday, the Miners defeated Desert Christian at home, 51 – 45.

"It doesn't take very much," Lovato said about maintaining his players' focus during a busy week of

games. "They're very self-motivated. They have two goals: win the conference and the state title."

In the win against Coolidge last Wednesday, senior Javy Tamayo scored a team-high 14 points while senior Caleb Quintero added 10 points and senior Jose Moreno

## Encinas leads Lady Miners to victory against Coolidge

Sophomore Aubrey Encinas scored a game-high 27 points during San Manuel's 42 – 36 win at Coolidge last Wednesday.

Encinas accounted for more than 64 percent of the Lady Miners offense, shooting 12-of-15 from the field (80 percent). She also finished with seven rebounds.

"She played outstanding and displayed an intensity on the court I hadn't seen since the summer," San Manuel head coach Rome Porrás-Romero said. "She knew she could dominate an opponent and went out there and

showed it."

Junior Victoria Zazueta added eight points and a game-high eight rebounds along with 11 assists. Senior Selena Cruz finished with five points and sophomore Natalye Pinedo led the team with three steals.

The Lady Miners are 2 – 3 under first-year head coach Porrás-Romero, who is satisfied with his team's progress so far.

"I'm pleased with where we're at," he said. "The more disciplined we can be within our system, the more successful we can be down the road.

"For me, it's most about creating leaders on the court than it is (anything else)," he added. "As long as they're positive, holding each other accountable, and raising each other up then we're going to win a lot of games."



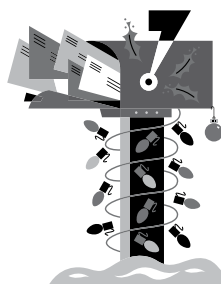

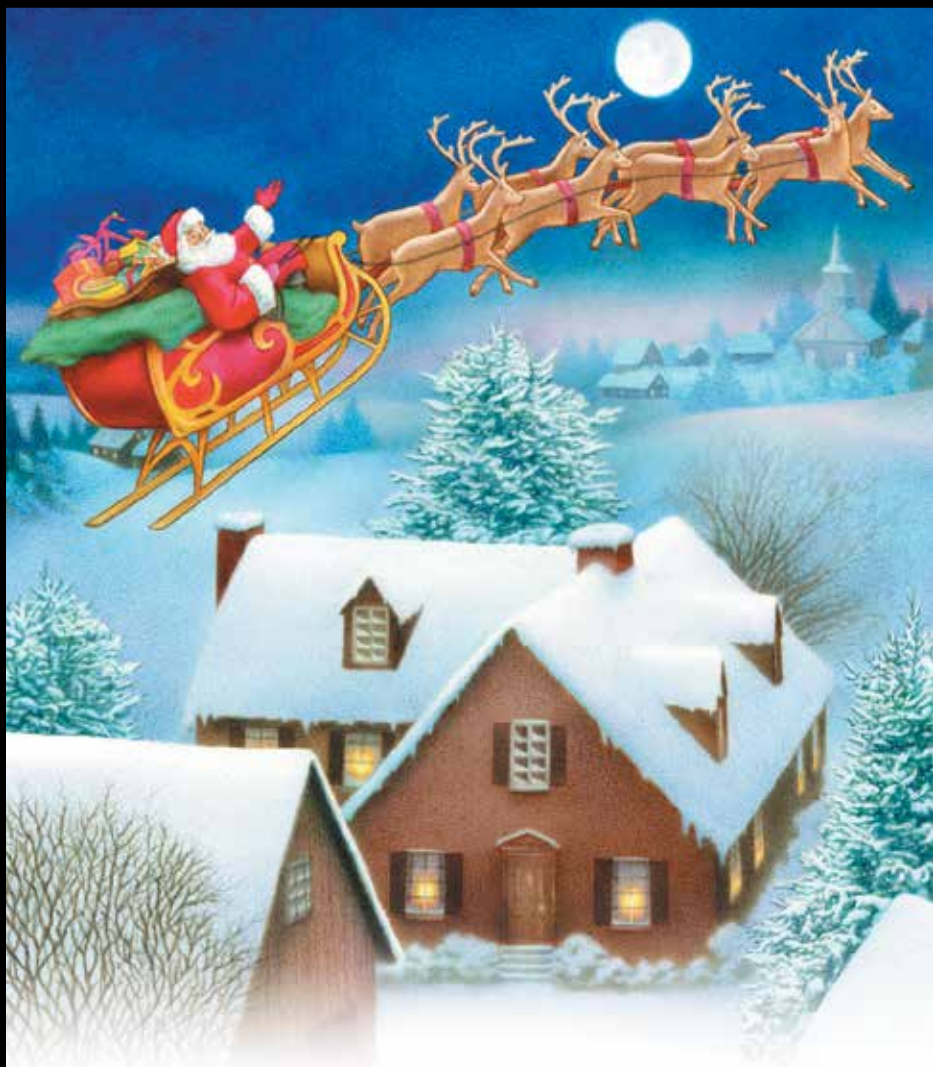
