

Towns Still Fact Gathering for Combined Police Force

he four-town task force charged with developing a new police force met in Winkelman last week. Some facts still need to be gathered, but a general picture emerged: a new force with one chief, three sergeants, and a fuller complement of full-time officers is within reach of our ability to fund them. There are complications, of course. The Town of Mammoth did not pass its budget override, something the other towns have done. This means that Mammoth's budget is severely restricted on what it can spend.

Interim Chief Dave Blue reported on the inventory which has been taken in all the police departments. A discussion on dispatching and communications led to the decision to focus on technical communications at the next meeting, which will take place Tuesday, December 15, in Winkelman. So far, so good, but much work remains.

The Kearny Town Council will meet Monday, December 21, at 7:30 p.m. At this meeting, there will be an open hearing for the purpose of developing a loan/grant for the improvement of our water infrastructure, especially our water tanks. Our present water rates are insufficient for us to qualify for the necessary loan to do the work. We have to prove that we will have sufficient funding from water bills to meet ongoing maintenance. As you know, our water and sewer infrastructure is not funded by taxes but, like any utility, is funded by the users.

Next week I hope to write about some possible new developments since the Gila River Fire. One development I want to mention now is Kearny's connection with the FIREWISE program sponsored by Arizona State Forestry. On Saturday and Sunday, December 12-13, a two-day course

materials and interview and feedback is provided to them on their evaluation form. The experience helps better prepare seniors for real life interviews as they participate in their job search in the future.



BLM releases management plan for Aravaipa Canyon Region; plan provides guidance for wilderness, surrounding public lands

SAFFORD, Ariz. - The Bureau of Land Management's (BLM) Safford Field Office has released a Decision Record and revised Environmental Assessment for the final Aravaipa Ecosystem Management Plan. The plan guides the stewardship of 69,000 acres of BLM-administered land, including the Aravaipa Canyon Wilderness, by establishing detailed management guidance for recreation and natural resources.

The Aravaipa Ecosystem Management Plan is the result of a long-term collaborative effort between the BLM, Arizona Game and Fish Department and The Nature Conservancy. The collaborative approach recognizes common management issues among the three organizations. A stunning example of a desert canyon and riparian

ecosystem, the Aravaipa
Canyon region is 120 miles
east of Phoenix in Graham
and Pinal Counties. The
planning area includes
the Aravaipa Canyon
Wilderness, surrounding
BLM public lands, and
private lands owned and
administered by The Nature
Conservancy of Arizona.
In total, the planning area

encompasses 69,609 acres of public lands and 7,802 of private land.

The plan recommends no major changes in the visitor permit system for the popular Aravaipa Canyon Wilderness. Visitors to the canyon bottom still are required to get a permit for day hiking and overnight use. BLM maintains a

limit of 50 total visitors per day. An administrative proposal to move the permit reservation system to a standardized national system is expected to be released later this year.

The plan does include modest changes to other recreation use in the area, including designation of camping sites along Turkey Creek and seasonal restrictions on some roads to protect bighorn sheep.
