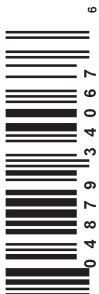

# Mammoth Police Report

According to state law, police may arrest suspected offenders by two methods. The suspect may be physically taken into the department and booked into jail, or the arresting officer may write a citation and release the suspect to appear in court later. All suspects are presumed innocent until proven guilty in a court of law. Only criminal citations are listed. All damage amounts are estimates.

Items are given to the San Manuel Miner by the Mammoth Police Department and reflect information available at the time the report is compiled.

The first day of the course is classroom based. The second day takes place in the field evaluating properties and may be a shorter day, depending on how many properties there are to assess. Participants will need to come eager to learn and have long pants and closed shoes for field day.

If you have any questions about the course, please contact your district coordinator or R.S.V.P. contact listed above.

At the end of the course, individuals will be certified to evaluate properties for Firewise and be registered with the Arizona State Forestry.

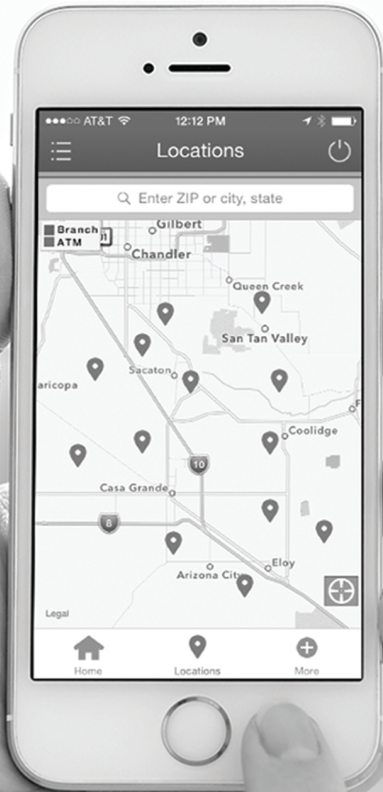

# San Manuel swimmers place well at IMX Meet

Our local swimmers are proving they can swim with the big fish and can hold their own in the bigger competitive meets.

USA Swimming held the IM Xtreme Games Challenge in Mesa, Arizona at the Kino Aquatic Center Nov. 20-22. To qualify, swimmers in the Western Region of the USA (10 States from New Mexico to Alaska) had to achieve an IMX score of 1500 points or more in the preceding 18 months. An IMX score is obtained when a swimmer swims each of the IMX events. The events vary for each age group but in general include a 100 or 200 of each stroke (Butterfly, Backstroke and Breaststroke), the 200 Individual Medley (IM) (+ 400 IM for 13 and over), and the 500 Freestyle (200 Free for 10 and Under). A score is assigned based on the time for each event and age of the swimmer. The scores from each event are then added together to obtain the IMX Score. It is quite an

achievement to complete all the IMX events and a milestone moment for any swimmer who achieves an IMX score of 1500 and qualifies for the IMX Meet. Seven swimmers from the San Manuel area qualified and swam in the meet. The top 16 swimmers in each age division received plaques.

Two girls from the Sea Lions Swim Team had great swims at the demanding 3 day event. Tabitha Kellam finished 28th place in the 12 year old girls division with a score of 2101. Darien Apuron finished in 21st place in the 14 year old girls division with a score of 2090. Both girls had a great meet with personal best times in several events and improved on last year's overall results.

Five boys from San Manuel qualified and participated in the meet.

Nine year old Ethan Kellam achieved his IMX qualifying score at the last possible meet of the season and swam like he was proving that he

belonged. His 1731 points earned Ethan a 4th place plaque in the 9 year old boys division.

Mason Stewart also swam at his first IMX Meet and finished in 11th place in the 10 year old boys division with a score of 1207.

Riley Stewart, returning for his second IMX Meet, finished in 2nd place among the 11 year old boys with a score of 2792.

Evan Apuron, also returning to his second IMX Meet finished in 3rd place in the 12 year old boys with a score of 2815.

Will Newman, who has competed in the IMX Meet for several years, finished with 3679 point on his way to a 3rd place finish in the 16 year old boys division. It was great

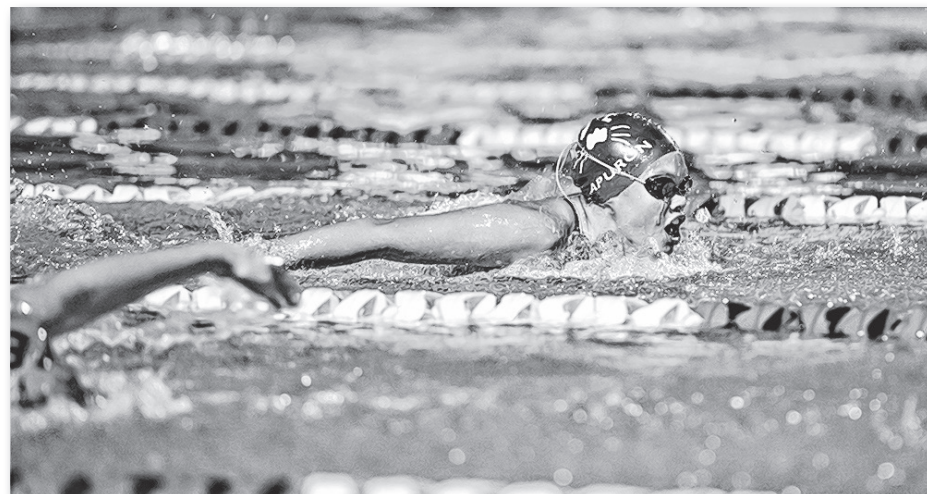
accomplishment for each of the five boys to take home a top 16 plaque.

All five boys had tremendous swims and battled for every point against some great competitors from the Western United States. Ethan, Mason, Riley and Evan swim with the Sea Lions Swim Team in San Manuel, while Will swims with the TJCC Stingrays in Tucson.

The San Manuel Sea Lions Swim Team practices in Oro Valley during November – March while the water is too cold to hold practice in San Manuel. Anyone interested in more information on the Sea Lions can contact Alex Gort (896-2190) or check the team website, sealionsswimteam.com.

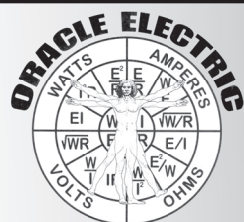

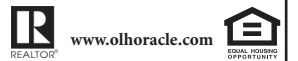

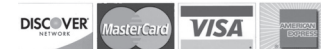

The Oracle School District's dream of making its Kindergarten Prep preschool program available to more children will soon become reality. Thanks to the Oracle Schools Foundation Board's hard work and the incredible generosity of community members, the "Toast to Teachers" Gala 2015 was a huge success. The event celebrated the District's teachers while bringing in almost \$16,500 to help fund preschool scholarships. Chantel Sloan, a District kindergarten teacher, said: "Thank you so much for making Oracle teachers feel so honored and special! We are going great places and the future is exciting!

Almost 150 were in attendance at SaddleBrooke's "The Vistas" restaurant. The District's music teacher, Kaitlynn Miller and her friend Johnny Vargas entertained guests with strings background music during the social hour and the Mt. Vista Elementary School Folklorico Dancers delighted them during dinner. The keynote speakers were Reagan Martin and Allison Soule, co-presidents of the Mt. Vista National Junior Honor Society. Their articulate, extremely well

presented speech paid tribute to the District's teachers and explained how growing up in a small town is not stopping them from pursuing big dreams.

Big dreams are the first step in achieving big successes. The Oracle Schools Foundation's dream is its vision: "A beacon of excellence in public education." Twenty-eight individuals and businesses supported that vision by sponsoring tables as well as teachers and their guests. District teachers and their guests attended free and were given gift baskets to take home with them.

A live auction wrapped up the event with attendees bidding on donated artwork; a week at a 5-bedroom house in Maine and a house on the Jersey Shore; and a catered party. Guests were also very generous in purchasing raffle tickets and others made donations at the event.

District who are unable to attend preschool due to the approximately \$3,000 it costs to enroll. We want to offer need-based scholarships to help reach those children."

Preschool is critical in ensuring children enter kindergarten ready to learn and the payback can be as high as \$7 for every \$1 spent. Much of this is in cost avoidance as disadvantaged, at-risk children who don't receive a high-quality early childhood education are 25% more likely to drop out of school, 40% to become a teen parent, 50% to be placed in special education (which is often much more expensive than the mainstream), 60% to never attend college and 70% to be arrested for a violent crime. One of our Nation's founding fathers, Benjamin Franklin said: "an ounce of prevention is worth a pound of cure." He may not have been referring to preschool, but there can hardly be a better example.
