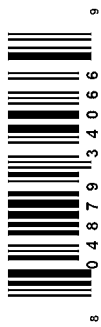

He loved telling the positive stories about games and the kids playing them. His goal was to mention as many athletes by name as he could, always in a positive light.

He covered college signings, interviewing the students, their coaches and parents to tell the story of how that student went

from playing Little League Softball to signing with a community college or university.

He celebrated when teams won games and championships and commiserated when they lost.

Andy had a gift for connecting with students and loved every aspect of the sports he covered, something that showed in the quality of his writing and enthusiasm he had for all the local teams. Superior, Ray, Hayden or San Manuel – they all counted him as their biggest fan.

Ryan Palmer, head football coach for Superior High School and good friend of Andy's, told *Copper Area News*, "He was a good man and friend. He not only promoted the students of Superior, but also the entire community. He went above and beyond, creating meaningful relationships with students and coaches. He is gone too soon, and will be missed by many."

years.

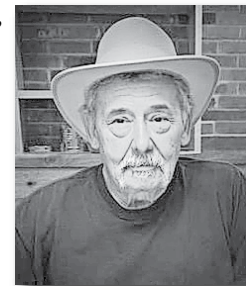

Looking Back and Moving Forward

Looking back at 2020, our attention easily gravitates towards the anxiety and loss caused by the raging COVID-19 Pandemic; state and federal election debates, and of course, the civil unrest that broke out across the nation. It is often hard to remember some of the good things that happened. We all have dealt with the loss of loved ones, cancelled plans and at some point, the uncertainty has made us all feel a bit uneasy and stressed.

Reflecting on this past year, I found so many areas of achievement that we all can be proud of. The Town of Superior finished many projects and improved the overall outlook for our entire community. Major park projects were completed, including the new playground and dog park at the US 60 Park, stage and amphitheater in downtown, and the swimming pool park now has a kiddie playground with shade structure. We continued to work on road repairs and this year Stone Avenue, a major north-south thoroughfare in town, was resurfaced. The Legends of Superior Trails alignment was completed, after a decade of planning, coordinating and fundraising. ADOT made repairs to the sidewalks and guardrails on Highway 177 and US 60. New homes were built, and new businesses have opened despite the challenges of the pandemic. The Town's audit validated that the financial position of the town has improved, and our value increased by twenty percent and we continue to pay down our HURF imbalance. The last available lot at the industrial park was sold and a new company will soon be operating in our industrial park. These are just a few of the long list of Superior's successes this year.. Our success comes from the dedication of our Town Staff who adjusted their work during the pandemic but remained

committed to getting the work completed with integrity and expediency.

What held firm for Superior, despite our challenges, is our community's spirit of generosity, love and support for one another as neighbors and friends. We mourned together as we lost residents to the pandemic. We found ways to honor and recognize our graduates and celebrate holidays in our community safely. Life did not look the same, but our fighting Superior Spirit remained alive and I look forward to our community events and activities returning when it is safe to do so.

Undoubtedly, 2021 will begin with the lingering challenges of the pandemic and a changing federal administration. The Town will remain focused on maintaining our forward progress. Some of the priority projects we will be focused on is the purchase and renovations of the original Superior High School as our multi-generation center. The construction of our Waste Water Treatment Plant and road resurfacing for Porphyry and several roads on the north side of town. We will complete our annexation, adding 6,000 acres to the southern and western boundaries of Town and we will welcome the Boyce Thompson Arboretum into our Town limits. In early 2021, I anticipate that the Town Council will be finalizing mitigation agreements with Resolution Copper to ensure that the mining operation will be a net positive for the Town and the company can successfully receive the Record of Decision to move onto the next phase of the mine development.

While we all continue to grapple with ongoing pandemic protocols and we hold our breath anticipating potential changes, let us all stand firm as a community to keep our friends, family and neighbors safe and keep our town moving forward. It is important we continue our healthy habits of physical distancing, wearing masks and maintaining good hygiene to slow the spread of the virus.

Let us all renew our commitment to being the best we can possibly be, as individuals and as a unified community, to build the best possible Superior for those

Students at Superior School District will be working remotely from Jan. 4 through 18, according to Superintendent Steve Estatico.

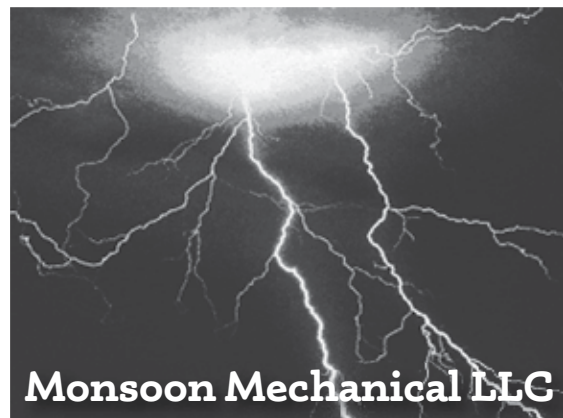
He reminds students that they will need to log in to their classes on Jan. 4. He also reminds students that they are responsible for taking care of their assigned devices during the Winter Break.

Copper Area News is committed to providing our readers with as much information as possible. This graph shows the positive cases as of press time on December 29, 2020. We have also included a graph showing the daily counts for the past week. Daily statewide case counts are recording higher than they were during the last peak this Summer and hospitals are becoming overwhelmed by COVID-19 patients.

There are a few points we would like our readers to consider when following this data.

1. This will continue to be a rolling total of positive cases. It does not reflect recoveries or deaths. The Arizona Department of Health Services does not break out this data.
2. If you see a reduction in numbers from day to day it is most likely due to a data entry error or mis-coding of a zip code (at the state level).
3. This is all zip code based data; most of our zip codes include unincorporated areas. There is no way to track exactly which areas each of the positive cases are. Example, Kearny and Winkelman each have small communities in their zip code that are not in the Town's incorporated boundaries.
4. If you live in Gila County, please follow the Gila County Health and Emergency Management, Facebook. They have maintained their data on recoveries and current positive cases.
5. You can follow other data such as ICU bed use, Ventilator use and hospital capacity online: <https://bit.ly/3inh280>

Working together, we can slow the spread of the virus across the Copper Corridor. Wear a mask in public, remain physically distant (6ft apart or more) and practice good hygiene (wash your hands frequently, sanitize high touch areas), stay home if you are not feeling well.

Re-delineation of Queen Creek and Mine Wash, Superior Arizona.
Resolution Copper Mine, in cooperation with the Town of Superior and Pinal County Flood Control District, is proposing new floodplain delineations for Queen Creek and Mine Wash. The study will be submitted to the Federal Emergency Management Agency (FEMA) in the form of a Letter of Map Revision (LOMR). The proposed study limits for Queen Creek extend from the limits of the existing mapping within the Town of Superior to a distance 400 feet upstream of Magma Avenue. The limits of Mine Wash extend from State Route (SR) 60 to the northern study limit within the Town of Superior. The proposed floodplain mapping is based on new hydrology, new topographic information and the construction of the SR 60 Bridge. When accepted, the revised floodplain designations will modify Flood Insurance Rate Maps, 04021C 0286E.
