

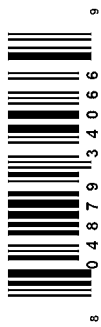

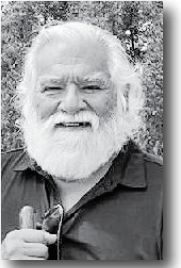

Fatal crash closes Highway 77 north of Oracle

On Dec. 5, at approximately 8 p.m., a two-vehicle fatal collision was reported on Highway 77 at milepost 106.5 north of Oracle.

According to Bart Graves, Public Information Officer for the Arizona Department of Public Safety, a sedan was travelling southbound when the right tires of the vehicle left the roadway. The vehicle overcorrected to the left, crossing into the northbound traffic lanes. Another vehicle was travelling northbound when it collided with the front

passenger side of the first vehicle.

"The driver of the first sedan was pronounced deceased at the scene," Graves said. "The driver of the second vehicle and a passenger were both transported to a hospital in Tucson with non-life-threatening injuries." He added that impairment was not believed to be a factor.

The name of the deceased driver was not released by DPS.

Driver survives impact with cow

Just after 7 p.m. on Saturday, Dec. 3, emergency crews responded to a report of a vehicle accident involving a cow near milepost 121 on Highway 77 between Mammoth and Aravaipa.

The Ford F350 had a single occupant and sustained major damage in the collision. Both airbags in the truck deployed and the driver sustained no injury.

"The size of the pickup truck was a substantial factor in this incident and likely saved the driver's life," said Pinal Rural and Medical District Fire Chief Bobby Apodaca.

Highway 77 was closed for a short period while the pickup truck was towed away and local ranchers removed the cow, which unfortunately did not survive the accident. Highway 77 was opened to all traffic by 8:30 p.m. Saturday night.

On scene were Pinal Rural Fire/Medical District, Mammoth Fire Department, Arizona Department of Public Safety, Hayden Police Department and Mammoth Towing.

Shop Local: Superior Barber Shop

Terry Beasley recently opened a new barber shop in Superior, “Superior Barber Shop” as it is named is located at 98 Pinal Avenue. Locals will remember that this location used to be the home of the original Mitchells Store, decades ago. The entrance to the shop is actually on the Empalme Street side of the building.

After working as a teacher for many years, Terry decided to pursue a new trade and career. He began researching a variety of trades and skills he wanted to learn. It was after he hosted a motivational speaker for his students, who happened to be a barber that he decided to pursue training as a professional barber. He attended barber school in Mesa and then went to work as a barber.

He and his wife Shayna Beasley moved to Superior, officially on Halloween 2020 and he saw the need for a barber shop in Superior, and also realized his home could accommodate a small barber shop. The one room barbershop is separated from the home and has its own bathroom for customers. Terry has focussed his barber services on classic and traditional haircuts for men, beard trims and straight razor shaves. He strives for a well organized and clean shop, and after every customer, the shop is disinfected and all hair is swept. With many high volume barbershops, these are often details that go unnoticed. The small but cozy space doesn't have much room for a waiting room, so appointments are highly recommended. He does encourage customers to pop in if they see they the barber pole for a same day appointment.

After opening Superior Barber Shop in Superior on July 28, 2022, he has grown his clientele to be able to stop working at a barber shop in the Valley and focus exclusively on his customers from the Copper Corridor area. Some of his loyal customers in the Valley have also found their way to Superior to continue their haircuts with Terry. He has also seen a growing clientele from surrounding communities such as Gold Canyon, Queen Valley and Kearny.

His shop has a vintage retro feel with a traditional barber chair, a welcoming and warm color scheme and the sounds of jazz music playing in the background. Terry enjoys the outdoors with his wife and has taken many great photos of Superior, which he displays in the shop along with a few plants that he grown.

Walk-ins or same day appointments cannot always be accommodated but you can pop in to check on availability. Currently he is open Tuesday through Saturdays, but will adjusting his open days after the first of the year.
