Frank Roy Middleton of San Manuel, Arizona passed away on Dec. 27, 2021. He died at the Oro Valley Hospital after a long battle with a COVID-related illness. Frank was 73 years old.

Frank was born at his home in Dustin, Oklahoma, on April 29, 1948, to Richard Roy Middleton and Edna Mae Haggard. He was the second oldest of four kids. In

the 1950s Frank's family moved to Eloy, AZ.

At the age of 19, Frank recognized his ambition of becoming a Highway Patrolman after riding along with Sergeant Hesselschwerdt. In August 1972, Frank accomplished his dream of joining the Arizona Department of Public Safety. Upon completion of the academy, Frank was assigned to the Picacho, Eloy and Casa Grande areas. Richard "Dick" Phelps, a near-lifetime Arizona resident and respected Oracle Ford owner, passed away on Dec. 16, 2021. The cause of his death is unknown, but the family believes he took an early morning walk, perhaps searching for his cherished, long-lost F-150 truck, and passed peacefully along the way. He was 94 years old.

Dick was born on Jan. 25, 1927, in Obregon, Mexico, to Morris Calvin Phelps and Carmen Tamayo. When Dick was a very young child, his father contacted tuberculosis, so the family moved to Tucson where Morris sought care at the Veteran's Hospital. Shortly after the move, Morris passed away. Dick was just two years old at the time, leaving young Carmen with two young children in her care. Carmen then married Oscar Phelps, Dick's uncle. Together, they had Winnie Phelps, Dick's youngest sister. Tragedy hit again when Carmen passed

of appendicitis when Dick was four years old. Oscar was working for the prison in Florence, Arizona and was unable to care for two young children and a 17-month-old baby. So, Dick, Anita, and Winnie were moved to Lehi (Mesa), Arizona to be cared for by relatives. Dick's aunt, Hazel Phelps Menhennet, ended up raising them, along with her own five children. This was a struggle, especially during the Depression.

Dick served in the Army as part of the Post War Army Occupation of World War II in Munich, Germany, and was discharged honorably in January of 1947. Utilizing the GI bill, he graduated from Arizona State University in 1951 with a degree in English. During college, he stumbled upon the used car business as a way to make a living. Pinal County Supervisor

On Jan. 6, at the San Manuel Community Center on Fifth Avenue, San Manuel residents were given the opportunity to question the Pinal County District 1 Supervisor on the state of the community.

Understandably, the town hall meeting drew a large crowd. The Community Center's seven rows of chairs was almost completely full, with residents curious as to what type of news they'd receive from the meeting.

The meeting opened with San Manuel Revitalization Coalition president Kennedy Ivy introducing guest speaker, District One Supervisor, Kevin Cavanaugh. The supervisor started off by thanking his team for being there to help him. Cavanaugh then took a moment to recognize to Cecilia Trujillo of the Simply Something Groceries and More in San Manuel.

"One of my campaign promises was to get a food co-op or grocery store, or something in San Manuel," said Supervisor Cavanaugh.
"I was working real hard at it, and then I heard that a lady named Cecilia was working hard at it also. So being an entrepreneur myself, and learning what Cecilia was doing, we stopped and visited and talked for a while, and I am so proud of Cecilia."

Supervisor Cavanaugh presented her with a challenge coin, in award of her excellence, to which she assured the audience, "If we don't have it, and you want it, I'll bring it to you, let me know."

Following Trujillo, Cavanaugh brought Constable Mike Sloan in front of the crowd. Constable Sloan was also given a challenge coin.

"We appreciate what you do. Mike works very hard," said Supervisor Cavanaugh. "He gets out there and does the job, serves people well, and for this we provide you with this award of excellence."

Dave Marshall of Snowflake was given a couple minutes

to speak next. Marshall is running for Legislative District 7. He gave some detail on his military and law enforcement background, while also informing residents that he would probably be seeing them more as his campaign started.

Cavanaugh then touched briefly on some noteworthy accomplishments for the district. The first thing being discussed was the **Community Center Park** Project nearing completion. Supervisor Cavanaugh then mentioned something that perked up many ears: "We're getting Broadband internet out here. That was one of my campaign promises, because we can't have economic revitalization without good internet."

Cavanaugh then informed residents that 10 new Sheriff's Deputies had been sworn in, fully staffing the sheriff's office for the first time in many years.

"The Sheriff promised me that he would keep the Copper Corridor fully stocked with deputies, so you

don't have to wait, they can be proactive and so on, so I'm very happy about that," the Supervisor said.

Touching on paving projects, Cavanaugh mentioned something that will have an effect on Oracle, and surrounding areas.

"We've got some paving projects. They're paving Mt. Lemmon Road, from the zip-line, to Summer Haven. to make it more useable and safe, so that's a good thing coming," Cavanaugh commented. "So my goal, at the end of my four years, is to have the bulk of that paved."

Once done covering the notable district accomplishments, it was time for the Q and A section of the meeting. Residents were given the opportunity to write questions on cards and give them to be read to the Supervisor then answered.

Q: "When are we going to get good internet?"

A: "So I think it's by June," responded Cavanaugh. "We don't want to make any promises we can't keep, but I think it's going to be by June."

Q: "Are we still doing the voucher program [for dumping], and how many do we get?"

A: "They split it down to three per January through July, and then three for July through December," answered SMRC president Kennedy Ivy

Q: "The school property sale?"

A: "So there was a vote taken, and the voters elected to sell the property," commented Cavanaugh. "[now] it's got to go through a big process."

Q: "Is there any effort being made to promote San Manuel as a retirement community?"

A: "We just had a discussion about this yesterday with our development department," began the Supervisor. "So, there's the Oro Valley Airport, and they're thinking of moving some of their stuff, their airplanes and things here [to San Manuel], and a natural consequence of that is, if you own a plane you're probably not 21 years

old, and you're probably going to buy a house closer to your recreational airplane. As a consequence of that, you might see an older population move in, but we don't have any plans underway to make San Manuel a retirement community."

Q: "Copper Mine?" A: "San Manuel **Revitalization Coalition has** been working with Eagle Mountain Mining, and they recently purchased the Oracle Ridge Mine, as well as a drilling company," answered SMRC president Kennedy Ivy. "They're doing a two-year geo-exploration. They were very interested in San Manuel. They wanted to exclusively hire from here, and have their business here, so they moved from Oro Valley, and leased a building from the county. We were able to help them get all that done, so we do have a mining company here in town now."

Q: "You mentioned the sale of the shopping center?"

A: "Basically, my wife and I lived here 20 years ago, and the town was in the throngs of going downhill, but we still had a grocery store and a bank," Mel Coonrod of Kenilworth Development Co., the new shopping center owner commented while taking the floor. "We obviously bought the shopping center to make profit, but at the same time, we really are going to do our damndest to get this community back to what it was. I'm counting on everyone here to help make this work. We're really anxious to see something positive happen."


