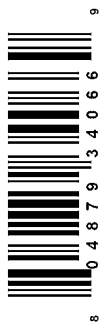

LETTER TO THE EDITOR

Many reasons for concern

I have filed complaints with the Attorney General's office before and asked for follow-ups, and not received a personal contact. The web site says I will be contacted. So here I go again. This is a letter to the editor from a local tax paying business man. At the past Superior town council meeting the mayor was accused of misuse of town funds at a local casino which occurred more than once. The whistle blower clerk (who has been there less than six months) was being fired after explaining the town credit/debit cards were being used by the mayor at which time the vote was 3 to fire and 3 to not fire the clerk. The mayor (accused) cast the deciding vote to fire her. So here is my complaint - Gross Conflict of Interest. In my opinion NO ONE should be walking around with a "key" to the town taxpayer's bank account. I have been told that the Town Manager (who was acting town clerk at the time of misuse) also has town credit cards, and then there are

rumors of missing checks. In my opinion there are many reasons to have a full audit for the tax payer's protection.

Also there is reason to believe dereliction of duty should be investigated such as not collecting all taxes, permit fees, license fees, sewer/water bills, and repairing the huge cracks in Main Street before the asphalt starts to fall apart, re-stripping the parking areas on Main Street and no animal control.

Obvious use of selective code enforcement: some of the businesses are required to have a number of parking spaces and some no parking spaces; some must adhere to sign regulations some not; some property owners are required to obey the residential zoning when some properties have 2 or 3 travel trailers on one lot and living in them. One council member is allowed to have an industrial storage lot in a residential zone, there is the use of town personnel and equipment on private property, and there is another dump being created on the driveway to the old dump.

Isn't it interesting that town assets are awarded to council members and or previous members? Where is the military truck that the town was awarded?

In my opinion there are many reasons the State's Attorney or the Attorney General should listen to the complaints that are voiced at many town council meeting of the past and which you will not find in the recorded town council minutes. The meetings have been reduced to once per month so now it takes two months plus to see the minutes on the town website, if then.

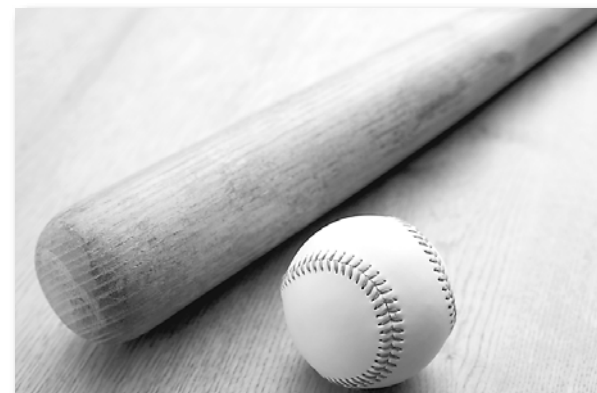

Property owners who have a widow, widower or disabled exemption need to renew that exemption by March 1

FLORENCE -- Pinal County Assessor Douglas Wolf announced today that property owners who have a widow, widower or disabled exemption need to renew that exemption by March 1st 2016.

The renewal process can be handled through the mail and must be notarized. Any person applying for an exemption for the 1st time must appear in person.

"Under state law, those who have lost a spouse and have limited income can apply for the exemption. Applications must be renewed every 3 years. Those wishing to renew or apply for a new exemption can do so at the Florence Assessor's office, at the Casa Grande county complex on Cottonwood road on Tuesdays or Thursdays, or at the Apache Junction county complex on Idaho

Road on Mondays or Wednesdays," said Wolf.

"For residents living in the eastern portion of the county, we have scheduled an outreach session in Mammoth in cooperation with Supervisor Pete Rios. We will have representatives at his office at 111 Catalina Avenue, in Mammoth on February 3rd from 9:30 AM -1:00 PM," added Assessor Wolf.

All applications require a valid Arizona

Driver's License or Arizona ID, Death Certificate, Arizona income tax return for 2015 and the deed and property tax bill. For more information call the Assessor's office at 520-866-6361 or visit www.pinalcountyaz.gov/Assessor and click on Exemptions in the left side menu.

In addition, all not for profit organizations must also reapply for tax exempt status by March 1st.

Litter Hotline delivers gentle, vital message: trashing Arizona costs us all

PHOENIX – Those who litter along Arizona highways can face fines up to \$500. But those fortunate enough to have fellow motorists rather than law enforcement see them may wind up getting a letter warning about the

harm litter causes – and a litter bag.

In partnership with Keep Arizona Beautiful, a statewide nonprofit organization that empowers citizens to care for their environment through litter prevention,

recycling and beautification, the Arizona Department of Transportation maintains a Litter Hotline allowing the public to report those who trash our highways. Providing a vehicle's license plate number and other details to 1-877-3LITTER, or through an online form on Keep Arizona Beautiful's website at kazb.org, results in a cautionary letter being sent.

About 1,500 letters go out each year. Nothing is shared with law enforcement, and those reported have no points added to their driver licenses.

"Besides harming Arizona's land, water and quality of life, littering along highways is a significant cost to ADOT and, in the end, to all of us," ADOT Director John Halikowski said. "While those who litter deserve what

they get if caught by law enforcement, a gentle reminder through the Litter Hotline can make someone think twice about tossing something out the window."

In the Phoenix area alone, highway maintenance crews pick up enough litter each year – about 1.2 million pounds in all – to fill more than 111,000 garbage bags.

In addition to the Litter Hotline, ADOT combats litter through its Adopt a Highway programs. Adopt a Highway volunteers can apply for two-year permits to clean up roadside litter, or businesses can contract with maintenance providers to perform the work as part of the Adopt a Highway sponsor program.

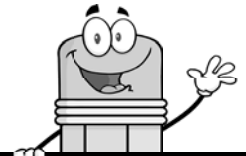
