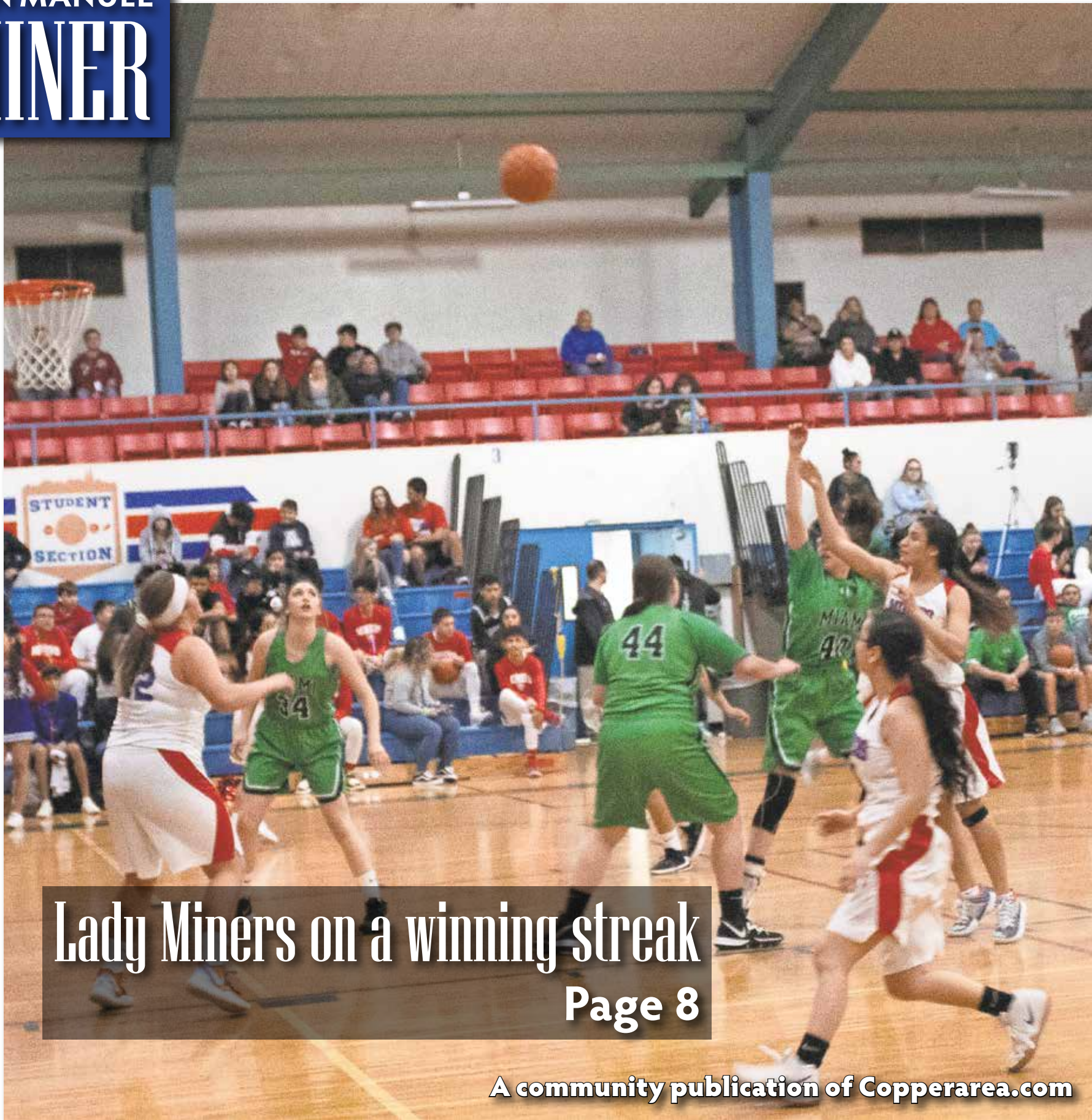
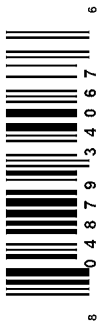

First responders from San Manuel Fire Department and the Pinal County Sheriff's Office were dispatched to the scene of an accident in the area of W. Webb Dr. and W. Main St. in San Manuel at 3:53 a.m. Tuesday morning, Jan. 14, after a 2014 Nissan Maxima, driven by Alex Lujan, 49, collided into the rear of a parked steel utility trailer.

A passenger, Elizabeth Raschke, 44, sustained critical injuries and was pronounced dead at the scene. Lujan was transported to a hospital by ambulance with non-life

threatening injuries.

PCSO Public Information Officer Lauren Reimer said the

case is under investigation. 'Impairment is believed to be a factor,' Reimer said.

A Look Back at Pinal County's 2019

As the 2019 year comes to an end, we want to highlight a few of Pinal County's major projects and accomplishments. Pinal County continues to attract new businesses, therefore creating job opportunities and healthy economic growth. Our Pinal County Board of Supervisors remain focused on implementing policies that will enhance both the quality of life for county employees and all Pinal County residents. This year various county departments led the way in innovative ideas, which generated national recognition for Pinal County.

This year we have welcomed Nikola Motors, which will be bringing the nation's most advanced hydrogen electric semi-trucks to market and more than 2,000 jobs to the area. Similarly, Lucid Motors has already celebrated its commitment to Pinal County during its groundbreaking ceremony in early December. Lucid Motors is a luxury automotive company that will create 4,800 new direct and indirect jobs within a decade and an estimated \$32 billion in revenue impact for Casa Grande and Pinal County over the next 20 years. Pinal County remains home to more familiar businesses like the Arizona Zipline Adventures, which continues to bring in tourist and provides the county with an adrenaline pumping destination.

For the third year in a row the Pinal County Board of Supervisors have approved a reduction in property tax rates from \$3.86 to \$3.79, which will

greatly benefit all county residents. In June, the Board unanimously approved an across-the-board salary increase of 2% for employees who met or exceeded performance standards. Sequentially, Pinal County was recognized by Forbes as being one of the top companies to work for in Arizona.

Another acknowledgment that Pinal County received was for our Mobile Voter Outreach Van which is the first-of-its-kind in Arizona and will help reach voters in rural parts of the county. The van will be able to host early voting events, register eligible individuals to vote and be used as an early drop off location.

These highlights merely scratch the surface of what Pinal County has accomplished in 2019. We are excited for the New Year and the new opportunities it will bring.

Public hearings held on Capstone Pinto Valley EIS

The Tonto National Forest held two public hearings last week to allow the public to comment on the expansion of the Pinto Valley Mine operations between Miami and Superior. The proposed expansion will extend the mine life to 2039 and will also consolidate previous and ongoing mining authorizations.

According to the Tonto National Forest website for the Capstone EIS, the proposed project would result in an estimated 1,011 acres of new disturbance (245 acres on Tonto National Forest land and 766 acres on private

land owned by Pinto Valley Mining Corp.). The EIS will evaluate and disclose the potential environmental effects from approval of the Mining Plan of Operations for activities on the Tonto National Forest.

Local, county and state leaders discuss impact of ASARCO strike on communities

Local and state leaders met Monday, Jan. 6, at the State Capitol to discuss the future of the Town of Hayden and Winkelman. The meeting was requested by the Towns of Hayden and Winkelman mayors to address concerns about the future of each town as the ASARCO strike looms into its fourth month.

The closure of the Hayden ASARCO smelter creates an unprecedented economic hardship. The Town of Hayden relies heavily on the sale of copper as major source of the Town of Hayden revenue. With the smelter shut down, the Town of Hayden is forced to make some difficult decisions over the coming months just to maintain basic town services. It is also considering the possibility of disincorporation.

The Town of Winkelman does not receive direct revenue from the sale of copper but will be severely impacted as well. The Town of Winkelman relies on the Town of Hayden's police services and would not be able to afford police services without the Town of Hayden.

"Both towns operate separately but support each other

in many ways. It is difficult to see how the Town of Winkelman could survive long term without the Town of Hayden," said Winkelman Mayor Chaco Bracamonte.

Likewise, the Hayden-Winkelman School District faces some hardships.

"Our District will also be affected over time because some students will leave the area as their parents search for employment," Superintendent Jeff Gregorich said. "At this time, the District has not seen a reduction in

enrollment, but it is early into the strike and one could only expect that the school district will lose some students as the strike lingers on. I would expect that the strike will likely hurt all the school districts in the area if it is not resolved over the coming months."

Gila County Supervisor Woody Cline has been meeting with the local leaders from the Town of Hayden and Winkelman over the past several months.

The second annual Oracle Chamber Music Festival began on New Year's Day when 30 musicians of esteemed professors and talented students convened at the Oracle Center for the Arts (OrCA). "The County understands the potential impact disincorporating a town would have on the residents and the challenges it would create for everyone. Our concern is that we continue to provide basic and essential services to the residences of both towns, as we work together to find a solution to keep both Towns operating and providing the needed services. This is the top of my list of proprieties over the coming year and I appreciate the local leadership in addressing the problem early and involving the County in the process," Cline said.

Gila County stepped in to keep the public library functioning, although in a limited manner. The library has moved to the Town Hall and shares space with the Senior Center. The Senior Center, also, came close to being closed, but Pinal County Supervisor Pete Rios stepped in with a donation to keep it operating. The Senior Center serves all of eastern Pinal County from Superior to Oracle with congregate meals and meals for homebound seniors.

"We provide our residents with police protection, senior meals, water, fire, sewer, garbage and other basic services people need to live," said Town of Hayden, Mayor Dean Hetrick. "This is something that we as community leaders need be prepared to address. The earlier we can begin the discussion on the potential options we have as a town, the better. I am directly working with each department

heads and asking them to do everything possible to reduce unnecessary expenditures. The council is working closely with the business manager to ensure we can keep the essential town functions operating while making this reduction. Unfortunately, even with major cost cutting strategies, it is difficult to see how the Town of Hayden can continue to provide basic services beyond 2020 without support from outside the town. I am optimistic and hope that there could be an end to the strike soon, but I also want to be honest and up front to our employees and community."

State Representative David Cook addressed concerns about the tax history of ASARCO and how the company is assessed. He will request the legislative tax policy consultant to review tax payments of ASARCO over the past years to ensure the Town of Hayden is receiving the correct amounts.

The State Capitol meeting with the state and local elected official from all levels of government ended with more questions than answers. The one positive outcome from the meeting is that everyone is aware of the potential crises that is lingering over our communities. There is still time to work through this issue and find solutions to keep both towns operating and providing basic services to our communities.

Lady Miners riding four-game winning streak

The 19th-ranked San Manuel girls' basketball team has won five of its last seven games, including four-straight against Arete Prep, Miami, Superior and St. Augustine, in order.

A pair of lopsided wins against Miami (48 – 16) and Superior (35 – 13) were sandwiched by single-digit victories versus Arete Prep (28 – 23) and St. Augustine (33 – 25) during the recent winning streak.

"I think there are a lot of factors that have played a role in our success," San Manuel head coach Rome Porras-Romero answered, when asked to what he attributed his team's recent success. "The biggest has been their confidence. We've had the opportunity to play strong teams from large cities during tournament play and now (the players) realize they are just as talented as any other team out there, so they are playing at the level I knew they could play at from the beginning of the season."

In the win against Miami on Jan. 7, junior Victoria Zazueta recorded a triple-double – 10 points, 11 rebounds and 10 assists – in addition to finishing with three steals. Zazueta was one of three Lady Miners' to score in double figures – Araceli Curry (10 pts) and Aubrey Encinas (23 pts) were the others. Encinas, who is the second-leading scorer in the 2A South Region, made 11-of-14 from the field while Curry was 2-of-3 from three-point range. Sophomore Natalye Pinedo led the team with four steals.

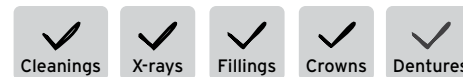

Rancho Linda Vista hosts acting workshop

A free acting class was held at the RLV OracleArt Wilson Barn at Rancho Linda Vista on Sunday, Jan. 5, 2020.

Around 20 people showed up for the class which was being taught by Sam Rush, an actor and director. In 1991, Sam co-founded New Century Theater in Northampton, Massachusetts. He holds a Masters of Fine Arts in directing and has taught acting and directing at the University of Massachusetts, Smith College, Asnuntuck Community College and in the Northampton community.

Sam grew up on Rancho Linda Vista and attended San Manuel High School in the late 1970s for two years before he decided to take

theater/acting seriously. He then attended school at Verde Valley School in Sedona which was renowned for its theater program. Sam said he remembered when he told his father, Andy Rush, that he wanted to be an actor and his dad replied, "oh great another artist." (Andy Rush is a well known artist from Rancho Linda Vista.)

The acting workshop was titled Crafting a Moment and was a brief introduction to learning about an actor's toolbox. It included instruction on relaxation techniques, breathing, imagination and awareness of body exercises.

"Your body is your paintbrush," said Sam. "Acting is a craft and can be taught."

The workshop was well attended and everyone seemed to enjoy the day. Sam Rush said he is looking at returning to the area so there may be more workshops in the future.
