he Town of Mammoth has had many police chiefs over the years. Some have been amazing, and others have brought the town nothing but trouble. Recently the town lost one of the best chiefs we have ever had when he was appointed to Justice of the Peace for the Copper Corridor Court. Rudy Lujan brought a much-needed change in policies and equipment that cost the town pennies instead of thousands of dollars. He left extremely big shoes when he retired.

The council was then faced with the difficult task of finding his replacement. Some council members felt the town should look within its ranks and then also seek outside candidates.

In his brief time as our Chief, our current Chief and our police department have been able to reduce the number of accidents, both serious and non-serious in town by increasing traffic enforcement from previous years. I am not sure if your readers are aware, but having a "quota" of tickets (which is what some on the council want) is actually illegal. Yet, through citizen contacts and education, traffic accidents are down from previous years while our traffic through town has increased.

Another and possibly the most important change our current Chief has brought to the town is we are FINALLY back to 24/7 in-house coverage. Our current police department no longer relies heavily on outside agencies to help fill in gaps. We now have living quarters for officers to stay in while they are in the middle of their days on shift, so they do not have to drive back and forth to the Valley or to Tucson, and we have been able to hire multiple full-time officers. Something our town has not had in a very, very long time

Our Chief has worked out agreements with PCSO to help us with dispatching costs. One of the biggest drains on the police department's budget was overtime. We did not have enough staff to cover Mammoth 24 hours a day, and officers were forced to do their own dispatching while on duty. So, in the event that the officer on duty was on another call and someone had a medical emergency, no one would have been there to answer the phone. People can only work so many hours before they need time off. Chief saw this drain on our budget, the stress to his staff, and the most important factor, the safety of the residents he is sworn to protect, and took action to rectify the situation before it had a chance to turn deadly.

Speaking of budgets, due to many budget cuts within the federal and state budgets, the Town of Mammoth is losing an enormous amount of money this upcoming fiscal year, leaving our town to make deep cuts within its spending. The last thing the town should be doing is increasing the cost of police services within the town by hiring new officers and a new chief. I can honestly tell you that the current Chief of Police is extremely underpaid, and the town will not be able to replace him without increasing the cost to the taxpayers by at least \$35,000. To give your readers an idea of the impact of that increased cost, the town would have to look at cutting jobs elsewhere, possibly in public works, town administration, the library, or closing the pool permanently.

I urge your readers and the people of Mammoth to attend the next council meeting on Jan. 19, 2023, at 7 p.m. in the community center. I urge your readers and the people of Mammoth to attend not just the next council meeting but all meetings, to inquire about the state and affairs within the town and take an interest. I urge your Mammoth readers to show up to support the Chief as a thank you for all he is doing to better our town.

Woman killed after jumping from vehicle

Pinal County Sheriff's Deputies were called to the scene of an accident Wednesday morning near the Mammoth-San Manuel PK-12 School at approximately 9:30 a.m. A man reported that his female passenger had jumped out of his moving vehicle.

When deputies arrived on scene, they found that the woman, later identified as Kandra Randall, 36, had died as

a result of her injuries.

According to Samuel Salzwedel, Public Information Officer for the Pinal County Sheriff's Office, "Deputies do not suspect any foul play by the driver."

We have issues to resolve in this state, and on the list of importance, this one does make the cut of 'important.' Hating the press is not a good enough reason for us engaged citizens.

Whenever the government takes over a task that is being done efficiently by the private sector, several things always happen. It becomes more expensive than originally planned, it takes more manpower than originally planned, and the result is less than desirable than planned. The current method of delivering important information to the taxpayers through the local newspapers' print and online platforms is not broken, and it serves the best interests of

the citizens.

Public Notices published in local newspapers is THE definition of transparency.

Newspapers are the last bastion of locally written, trusted, credible, verifiable information dissemination with a keen knowledge of the community. Senator Kavanagh, I'm sure you cannot say the same about government-controlled information sites. Let's all make sure that Public Notices remain in the local newspapers across this great state. 
