# Frustrated with mayor's refusal to resign

I am writing this letter in frustration that it is so hard for Mayor Valenzuela to do the right thing and resign from his post as Mayor of Superior. His 'defense' in Thursday night's Town Council meeting was that the cash advances made on the town credit card eight times were 'mistakes'. He refuses to step down even when everyone from the Town Council to the Townspeople expressed they have lost faith in him and cannot believe anything he does or says.

I have tried for three weeks to get the District Attorney's office in Pinal County to find out who is responsible for handling an investigation. Just this week, they finally said it would be the Pinal County Sheriff's Office. I had to make three phone calls to the Sheriff's office, before I finally spoke to a lieutenant in the criminal investigation office who said they could conduct an investigation if the State doesn't do one. Jayme is employed by the PCSO but in a special capacity. He serves at the discretion of Sheriff Babeu and was rehired by him in 2008 when the PCSO had let him go in 2002 for not preforming his duties. Evidently, Sheriff Babeu is the only one who can fire Mr. Valenzuela. The sheriff is running for Congress and employing a man who is facing felony charges. This

The current District Attorney is Mr. Voyles who ran with Paul Babeu on a joint ticket in 2012 for the DA/Sheriff. Is Mayor Valenzuela being protected

# Time to clean house for a 'new Superior'

I believe the citizens and taxpayers of Superior deserve to know what's going on with our Mayor, Jayme Valenzuela.

On Dec. 9, the Council and the audience were informed that 2 or more cash withdrawals had been made at ATM machines with a Town debit card. A number of questions and comments were made but only after the manager explained that there were only 2 cards, the Town having one and the Mayor having one, did he admit he made the withdrawals. He said it was a mistake because the Town card and his personal card had the same pin number. During the conversation he was directly asked if it was just the one time and he said yes, two withdrawals but just the one time. He further said that he had paid it back to the Town. The manager confirmed that he had paid it back and there were receipts. When asked at Town

Hall for the receipts showing that he paid it back people were told that the receipts had disappeared. There was no offer to pull the bank deposit records to show that the money paid back was ever deposited in the bank.

I requested, and reviewed, bank statements from November 2011 through November 2015. In a very quick review I found that there were a total of 8 cash withdrawals from ATMs, beginning August 2013 and ending December 2014, totaling \$2,323 plus bank fees. I believe that it is highly unlikely that this "mistake" could have been made 8 different times. On Dec. 15, 2015, one week after the Council meeting, the \$2,323.00 was paid back to the Town of Superior by the Mayor.

At the Jan. 14 Council meeting the independent auditors called in to review the transactions, confirmed the dollar amount that had been withdrawn. They further did a "sampling" of other charges made on Town debit cards and found approximately 50% of these charges did not

have receipts.

# Council members, citizens demand Mayor Valenzuela resign for misuse of town bank cards

"I made a mistake," Valenzuela pleads as Council enacted new safeguards against personal withdrawals

Calls for Superior Mayor Jayme Valenzuela to resign erupted from both Town Council members and angry citizens in the overflow crowd at the Jan. 14 Council meeting following the reading of an auditor's report that confirmed Valenzuela had used the town bank card eight times since 2012 to withdraw \$2,300 for personal use.

But Mayor Valenzuela countered that he had not done anything wrong and would not resign, prompting talk of a possible recall election.

The Town Council responded by voting to request that the Arizona Department of Public Safety to conduct a criminal investigation into the findings of the

auditor's report, and to adopt tighter controls over the use of town credit and debit cards. The Council also voted to begin the search for a new Town Manager with a financial background to replace current manager Margaret Gaston, who was criticized for the tardiness in which the card withdrawals were discovered.

Scott Powell of the auditing firm Colby & Powell PLC delivered the report, which found the withdrawals by Valenzuela were double what was reported by former Superior Town Clerk Rachelle Sanchez at the December 2015 meeting. Sanchez, who reported discovering four of the withdrawals from the town debit card some months earlier, made her discovery public as the Town Council considered retaining her as Town Clerk beyond her six-month probationary period. Mayor

Valenzuela cast the deciding vote not to retain Sanchez.

The auditor's report found that all eight withdrawals were made on a town debit card issued to the mayor for town business. Because the card issued by the Bank of the West is processed by a thirdparty firm, all the auditor could secure was the address of the ATMs where the card was used but not the business at that location. These locations included the towns of Chandler, Gilbert and Florence.

While Mayor Valenzuela said he had used the town card by mistake in place of his own and had refunded the withdrawals before the December Council meeting, Powell noted that the refunds were actually made in two checks after that meeting; the last the day before the January meeting.

The report did not sit well with some Council members.

"I'm disappointed in you, Mayor," said Council member Michael Alonzo. "You said this was a one-time occurrence; that the mistake resulted from similar PIN numbers between yours and the town's. But you lied to us. You made all-cash withdrawals and half the receipts are

"Your lack of accountability in this matter is unacceptable," Alonzo continued. "This was not a mistake. You hid this from us. There is no justification for what you did and for repaying only after the matter was brought up. What you did was stealing from the town," he added, prompting loud applause from the more than 100 citizens who attended the Council meeting. "You have lost the trust of this community and the town staff. How can we ask a bank to loan us money if we cannot show we properly use what funds we have? How



normally don't get involved in the politics of other small towns outside the Tri-Community but the actions of Mayor Jayme Valenzuela in Superior are deplorable. 
While most local consumers are not always

# Superior's Salcido signs with PVCC

Superior High School senior Gabby Salcido recently announced that she has signed with Paradise Valley Community College to play for the Pumas' softball team. Salcido, primarily a shortstop on the Panthers' 2015 State Championship team, chose PVCC over some other schools that offered her.

"The school just fit me really well," Salcido said about her choice. "It's a very small school and didn't want to start off at a big school. (PVCC) just felt like home. The coaches are really nice. There is tutoring (available) and the school really helps with academics. It's a really good school and I never considered any other schools once I visited (PVCC)."

In addition to her soon-to-be four-year varsity career at Superior, Salcido also played travel softball over the last three seasons for the Phoenix Heat, AZ Lady Dragons 97, and the Arizona Hot Shots.

PVCC coaches have indicated that she'll play her natural shortstop position for the Pumas.

Salcido credits her travel experience for exposing her to colleges throughout the state. She also acknowledged some schools approached her and some Panthers' teammates after last year's State Championship game.

As a junior, Salcido batted .562 with eight doubles, six triples, five HR, 31 RBI, a 1.291 slugging percentage, and a 1.924 OPS. She led the Panthers in triples, HR, RBI, and SLG Pct. Her batting average was the second highest on the team, just behind 2015 graduate Cierra Navarrette's .589.

Her career numbers at Superior are equally impressive: .503 BA, 14 doubles, nine triples, 17 HR, 67 RBI, a 1.038

slugging percentage, and a 1.618 OPS.

Salcido's parents – Dora and Joseph – have played a big role in her softball success, both serving as coaches during her playing career.

"My mom will have coached me all four years in high school and it was awesome to experience winning a state championship with my team and having my mom on the same field as (us)" Salcido told the Superior Sun. "My dad also coached me in little league and senior league. He's been very instrumental in keeping me focused. We always work out on the field and hitting too. I've loved having both of them as parents and as coaches."

In addition to earning her degree, Salcido hopes to continue her collegiate softball career after she's done at PVCC. She may have a leg up on other Division I recruits across the nation considering Pumas' head coach Nick Candrea is the brother of current University of Arizona head coach Mike Candrea.

Salcido, who plans to study Nursing, was asked what she's most looking forward to about attending PVCC.

"Just playing at the next level and being exposed to other big schools," she responded.

But before she's off to start the next chapter of her softball career and life, Salcido is anxious defend last year's state title with her Superior teammates.

"I just hope our last year is the best year and we finish on a good note," she said. "I'm really excited to play with these girls again for the last time."



# Panthers' eight-game winning streak snapped



Sophomore Marcos Bueno (19) and junior Austin Navarrette each scored in double figures in the Panthers' 45 – 33 rivalry win against Ray. Bueno recorded a doubledouble in the game after pulling down 10 rebounds to go with his 19 points. He also had a game-high five steals.

Junior Jalon Murray grabbed a game-high 11 rebounds, helping the Panthers win their ninth game of the season.

Bueno (20), Murray (17), and Nicolaus Cruz (13) combined to score 50 of the Panthers' total points against Duncan in a 59 – 51 victory. Navarrette, Jesse Lopez, and Andrew Lopez accounted for Superior's other nine points.

Murray had a monster performance in the win, recording 17 rebounds in addition to his 17 points. The junior is now averaging 10 points and more than nine rebounds – nearly a double-double – per game this season.

The Panthers play four of their final six games against potential playoff teams. Two of those four games are against top-ranked San Carlos, including the first matchup between the teams this Friday at San Carlos.

# Lady Panthers drop three-straight last week

The Superior girls' basketball team suffered threestraight lopsided losses last week to teams all in the top seven of the most recent AIA rankings.

No. 7 Ray, No. 4 Duncan, and No. 3 Ft. Thomas each handily defeated the Panthers.

In last Tuesday's 59-37 loss to Ray, freshman Lindsay Ketron scored a team-high 10 points and senior Phalicitee Thomas added eight points. Thomas and junior Maribel Castro each grabbed a team-high six rebounds in defeat.

The Panthers' recorded 16 steals against the Lady Cats, including three each by Ketron, Thomas, and Silvia Longoria.

# Resolution Copper kicks off 2016 with community update

Community members from throughout the Copper Corridor region attended an update meeting about the Resolution Copper project last week. The update covered many issues pertaining to the project including safety, leadership changes and El Niño weather conditions.

The company reported that once again they have earned a Sentinel of Safety Award by the National Mining Association. Resolution Copper worked more than 80,000 hours without a lost time injury or illness. The Core Processing facility and Water Treatment continue to operate without any major incidents or injuries.

The company announced that it will be hiring several local employees for Environmental Technicians in the Environmental permitting and compliance departments and another Native American Affairs liaison.

Another topic of discussion was the safety precautions the mine has put into affect to prevent from any environmental issues caused by El Niño. The company has increased their storm water management capacity to manage heavier rains, installed two million dollars in pumps and pipes to divert water to storage areas.

Resolution Copper management also unveiled a new score card to demonstrate the sustainable value within the local community. The score card will be advertised publicly and will show how many local employees are working, community giving, safety and environmental concerns. The scorecard is available at the Resolution Copper Main Street office.

The company has five main areas of focus for the 2016 including safety, permitting the project and engineering the study, continued reclamation, Construction phase and engineering work on shaft nine and to continue strong engagement with the local communities.

can we justify raising taxes to balance the budget if we don't have the people's trust?

"There is only one way to start restoring that trust. Resign!" Alonzo told Mayor Valenzuela, to more applause from the audience.

Upset that word of the ATM withdrawals was not reported to the Council until Dec. 9, Council member Mila Besich-Lira asked Powell when they were first discovered. When told the third week of November, Besich-Lira fumed, "We took the word that the town staff was working hard to watch our money. Being too busy isn't an excuse. This is going to affect our credibility in the community."

She added, "Mayor, you like our community. Then do what is best for the community. Resign so we can move forward."

While Council member Stephen Estatico refused to pass judgment, he asked Mayor Valenzuela to "do what is best for Superior. As much as I feel, I must ask you to resign." Vice Mayor Olga Lopez bristled about being blindsided by the report of the Mayor's transgression, she chastised the town staff under Town Manager Margaret Gaston for not telling the Council sooner.

Responding to the report and Council members, Mayor Valenzuela admitted he made a mistake, apologized for it, and noted that he had returned the \$2,300 plus \$45.50 in transaction fees incurred while using ATMs not operated by the Bank of the West. Valenzuela noted that until he was elected mayor Superior government never conducted audits, which he said "were important" in catching wrongdoing. He thanked Town Manager Gaston for her hard work and having to endure all the personal attacks since the withdrawals became known.

He concluded, "I remain committed to working for what is in the best interests of Superior. Thanks to those who never doubted my commitment and integrity. I made a mistake."
He did not mention resignation in his comments, prompting Councilman Alonzo to express disbelief that the withdrawals were merely a mistake and to renew his call for Valenzuela to resign.

Council member Besich-Lira then moved that the Council adopt as policy the safeguards against fraudulent card use proposed by Powell after reading the auditor's report. These included having the mayor and other Superior government officials to sign out town credit or debit cards, stating what the intended use would be. Receipts would be presented when the card is returned, verifying that it was used for the stated purpose. Two staffers would be required to verify that the necessary invoices or receipts were received with the card. The date and time of when a card is checked out or returned would be mandatory. Debit card transactions would need to be reconciled every month

on the town's General Ledger.

The proposal was adopted unanimously by the Council.

Immediately afterwards, the Council voted to request that the Arizona Department of Public Safety conduct a criminal investigation on the misuse of all town bank cards (not just the mayor's) described in the auditor's report.

Also on the agenda was a proposal for Superior government to post the positions of Town Manager and Financial Director for possible hire. After Councilman Estatico noted that Superior doesn't have funds for two positions, it was voted that the two positions be combined and posted as a single position. The measure was adopted unanimously.

Calls for Mayor Valenzuela to resign continued into the Public Comments section near the end of the meeting. Among those lending their voice to the chorus was Superior Chamber of Commerce President Sue Anderson, and residents Pamela Dalton-Rebago and Nancy Vogler.

"Considering all that has been revealed, the people can never trust you again. Your only choice is to resign," Anderson told Mayor Valenzuela, speaking as a resident of Superior and not as president of the Chamber.

Dalton-Rebago went further, praising Rachelle Sanchez for uncovering what was being covered up. She called for an investigation of how the cover-up occurred, and criticized town attorney Stephen Cooper for ruling in December that it wasn't a conflict of interest for Valenzuela to cast the deciding vote to fire Sanchez.

Vogler noted that when Valenzuela ran for Pinal County Sheriff in 2008, he told the Arizona Republic that the most important asset a candidate could have was integrity and that a candidate's downfall was arrogance. Yet she now found him without integrity and arrogantly denying any wrongdoing. She asked how Superior could find

honest employees if they fire people like Sanchez.

Citizen Sonny Sansom went so far as to suggest than Sanchez be hired as the new Town Manager during his comment.

The biggest tongue lashing came appropriately from Marilee Lasch, who told Valenzuela, "I voted for you in the recall election because you stressed integrity and that you said you'd find out what was going wrong with town finances. Instead you took our money. That is a crime. Even if you give it back, it is still theft. Resign and leave with dignity. I'm sorry I voted for you."


