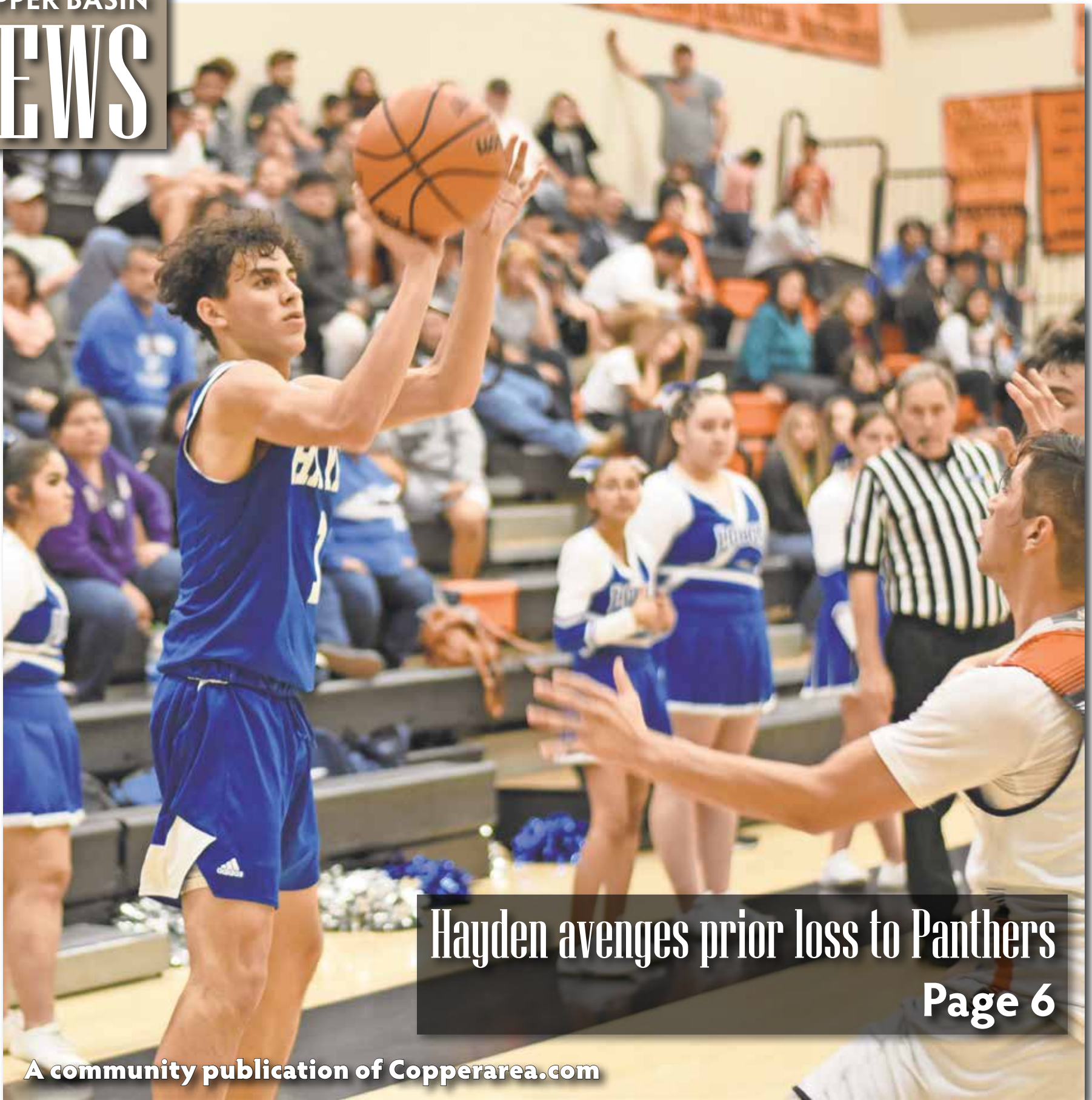

Hope Thompson Barnett

Hope Thompson Barnett, of Globe, passed away peacefully on Saturday, Jan. 11, 2020 at age 97. She was born on Aug. 14, 1922 in Hayden, Arizona to L. C. "Tommy" and Carrie Burnett Thompson. Brother Paul was 15 years older.

Hope graduated Hayden High School, married Lee Acton and had three children: Jerry, Pete and Lynell. Hope and Lee operated the Del Monte Tavern and the Del Monte Cafe in Ray. The family moved to a farm in Buckeye in 1951 "for a healthier lifestyle" where Hope worked as a bookkeeper and secretary for local businesses. In Buckeye she was very active in the 4-H Club, teaching classes and serving as President. They moved to Kearny where she opened the Copper Cup Cafe and later worked as Public Relations secretary for Kennecott Copper Corp. for 21 years. She was actively involved in American Legion Auxiliary and Emblem Club and originated the Kearny Koyotes 4-H Club.

In 1965, she married Les Barnett, and gained a

stepdaughter Linda and moved to Globe. Hope and Les bought a cabin in Pine to where they eventually retired, and Hope opened the Foxfire Steakhouse in Strawberry. After that adventure she and Les moved to Elfrida.

They went "totally mobile" from 1988 to 1994. They traveled extensively in their travel trailer from Alaska to Mexico acquiring long lasting friends along the way. They settled in Globe where Les passed in 1999.

At age 81 Hope connected with her third love, Walter Swingle, Lee's half-brother, whom she had known since childhood and became "Aunt Mom" to his children Lee and Jeanne. Hope had eight romantic years with Walt including Alaska and Panama Canal cruises.

After losing Walt in 2011, Hope continued to go to the gym three times a week, volunteered at the hospital and museum, delivered Meals on Wheels, hosted weekly spiritual meetings, attended Christian Science church, and didn't miss Wednesday night tacos at the Elks. She drove her car until she was 96!

In April 2019 she moved to Solterra Senior Living in Lakeside where she became the "favorite resident" of the Solterra staff and was warmly and lovingly cared for until her death. The family would like to thank Solterra and the "angel" hospice nurses.

Hope was a loving mother, grandmother and Aunt

Hope to many and a devoted friend to many more; she will be forever remembered for her kindness and generosity. She welcomed company to her home anytime with a hug and a smile. She visited friends and family whenever she could and loved to organize and attend reunions, birthdays, and holiday get togethers. She was a Diamondbacks fan, reader and crossword puzzler until the end.

Margret Celix-22 Years, Diana Wheeler-9 years, Pat Moore and Susan Moore-2 years, and Monika Sneezy-1 Year.

“We are extremely grateful for our advocates in Gila County,” remarked CASA Coordinator Emily Nader. “Our volunteers dedicate their time, energy and heart to children who are in out-of-home care due to abuse or neglect at absolutely no fault of their own.”

More volunteers are still needed in Gila County.

“Our volunteers go above and beyond to advocate for what the CASA assigned child needs while they are in care,” Mrs. Nader continued, “But we are still desperately in need of additional volunteers to meet the goal of an advocate for every child in out-of-home care within Gila County.”

Become a CASA volunteer today. Court Appointed Special Advocates are everyday community members who donate their time to be the voice for a child. CASA volunteers visit with the children regularly, filling that mentor role. They follow the progress of the child’s court case, interview important people in the child’s life, and report their observations

back to the court so the judge can make informed decisions on behalf of the child.

No specific background or training is needed to become a CASA volunteer. Anyone 21 years of age or older, who can pass a thorough background

check and complete 30 hours of free training, is encouraged to apply.

Twelfth Annual Home & Building Tour showcases Superior's unique structures: from restored homes to a historic hotel

On Jan. 25-26, 2020, the Superior Chamber of Commerce will present the 12th Annual Home & Building Tour. This unique event will offer attendees an opportunity to explore the eclectic collection of homes and buildings found in the quaint, historic mining town of Superior. Mattie Earp, the common law wife of the elder Wyatt Earp, is buried in Superior.

For art lovers, the Tour will showcase exquisite, handmade pottery from the village of Mata Ortiz in Mexico. The artists themselves will be bringing a load of their beautiful wares to the event. Weather permitting, pieces will be fired in an open flame during demonstrations. It's hard to resist taking home a piece of this special pottery!

In conjunction with the Home Tour, the Superior Fire Department will host a pancake breakfast at the event.

Forging a vibrant future while retaining its distinct charm as a historic mining town, Superior will soon proudly feature a world-class mine. In this region of Arizona, "copper is king," and will continue to be for many years as more and more uses of this precious commodity are discovered. Visitors to Superior will enjoy a bounty of shops, restaurants, art galleries and outdoor activities. Hayden avenges earlier season loss to Superior

The Hayden boys' basketball team avenged a Dec. 20 loss to Superior by defeating the Panthers in Superior last Thursday, 75 – 69.

The win was the Lobos second in their last eight games.

Superior, which has lost five of its last six games, was without one starter due to illness and three others fouled out in the loss.

"Hayden made their layups and their free throws," Superior head coach Ryan Palmer said afterwards. "We did not. Hayden [also] outworked us on the boards and getting to loose balls."

Superior junior Andrew Martinez scored a game-high 26 points, which was also his career high. He also had three rebounds and tied for the team lead with four steals in the game.

"Andrew did a great job playing aggressively on offense, Palmer said. "He drove to the hoop and carried our offense in the fourth quarter."

Panthers' senior Sammy Lopez finished with 16 points, four rebounds, two assists, and four steals. Junior Nathan Daurte also reached double figures scoring with 11 points to go along with three rebounds, three assists, and four steals.

Palmer admitted it wasn't a great game against the Lobos, but his team responded the following night, playing what he called "our best game of the season" against 2A member AZ Lutheran Academy.

The Coyotes defeated the Panthers, 65 – 58, but Palmer was encouraged by his team's performance.

"Although we lost, we played our butts off," he said. "We were flying all over the floor, and had we made a few more

layups we probably pull off the upset against a tough team. "If we play the rest of the season like we did Friday night, we still have a chance for a tournament berth."

officially certify student in Volunteer Management.

Staff members directly benefiting from this grant must attend the National CASA/GAL Annual Conference in 2020. This year's conference will be held in Washington, D.C. in June 2020.

"The coursework in the volunteer management program will strengthen and support my work as a volunteer coordinator," remarks Ms. Nader, "By shaping my skills in the seven core competencies and providing new knowledge to enhance my abilities to effectively train and retain volunteers, the course programs will allow me to serve our local CASA volunteers in a manner that is both professional and engaging resulting in an increase of the number of advocates serving the youth in our community."

The National Court Appointed Special Advocate (CASA) Association, together with its state and local member programs, supports and promotes court-appointed volunteer advocacy so every abused or neglected child in the United States can be safe, have a permanent home, and the opportunity to thrive.

More about our local CASA Program:

The CASA of Gila County program is administered by the Arizona Supreme Court with a focus of recruiting and training community-based volunteers to speak up for the rights of abused and neglected children in court. CASA volunteers are appointed by our presiding judge to foster children who have the greatest need for an advocate. Volunteers do not provide placement or a home for the child but are strictly advocates who submit their recommendations directly to the judge hearing a child's case. CASA volunteers complete 30 hours of training to prepare them for their duties.

CASA Volunteers:

- Volunteers must be at least 21 years old.
- Volunteers go through a rigorous screening process including interviews, reference check, a fingerprint check, and polygraph exam.
- Volunteers are asked to make a commitment to one case until its conclusion, typically involving 10-20 hours per month.
- Volunteers must complete 30 hours of pre-service training.
- CASA volunteers are advocates, not mentors. Their objective is to help the court system determine the best outcome for the child.
- CASA volunteers try to build a 360-degree view of the child and his or her surroundings. To do this, they meet with teachers, counselors, physicians, and guardians.
- CASA volunteers work to ensure that children are in safe, permanent homes where they can thrive.
