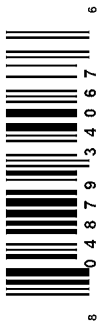

OBITUARY

Jack William Pritchard

Jack William Pritchard was diagnosed with bladder cancer in July of 2019 and after a series of illnesses contracted pneumonia and passed away in Tucson, Arizona on Jan. 14, 2020. He was 96 years old.

Mr. Pritchard was born on June 11, 1923 in Cambridge, New York to John Pritchard and Violet Filer. He was the fourth of nine siblings in a large family, four brothers and three sisters. Raised around Easton and Greenwich areas of Washington County in upstate New York. Mr. Pritchard lived a long life and had a long career.

Before World War II Jack held several jobs from being

a shoe cobbler to working with the Civilian Conservation Corps (CCC), to baking. After the event of Pearl Harbor on Dec. 7, 1941 he and two brothers ran away from home and enlisted to serve their country. Jack Pritchard enlisted in the Navy on Dec. 27, 1941 from Albany, New York.

Mr. Pritchard served in the Navy as a Baker 3rd Class. He was attending Chief Commissary School in San Diego, California when he received an Honorable Discharge from the Navy on Oct. 1, 1945. After the Navy, he worked for Consolidated Aircraft in the mid- to late-1940s.

By the mid- to late-1950s, Jack Pritchard became a News Agent for the Southern Pacific Railroad. He eventually became a Carpenter in the Bridge and Building Department of Southern Pacific Railroad and helped build and repair many of the railroad bridges throughout Arizona, New Mexico, and California.

Mr. Pritchard came to settle by 1962 in Benson, Arizona where he worked for the Town of Benson and Apache Powder. He also began volunteering with the Police Department of Benson, Arizona during this time. In 1970 Jack became a Deputy Sheriff in Tombstone, Arizona.

He brought his family to San Manuel, Arizona in 1971 where he worked as a Machinist with Magma Copper Company retiring in the mid- to late-1980s. By 1975 he was a Deputy Sheriff in Florence, Arizona and as a volunteer became the Reserve Police Chief of Mammoth, Arizona. He served 14 years with the Mammoth Police Department. In 1978 he also volunteered as an Ambulance Attendant through the Arizona Corporation Commission. He has served his community through volunteering to unload trucks, delivering food, and playing Santa Clause.

Jack Pritchard was the last surviving member of his family. Preceding him in death are his parents, John Pritchard and Violet Filer; brother, Willis Pritchard; sister, Cleo Pritchard; brother, Ashley Pritchard; brother, Roger Pritchard; sister, Dorothy Harrington; sister, Marcia Noon; brother, Paul Pritchard; and brother, Edward Pritchard. Also preceding him in death are two children from a previous marriage, Marcos Juan Pritchard and Maria Catalina Pritchard.

Surviving Mr. Pritchard are his wife, Frances Pritchard; two daughters from a previous marriage, Maria Socorro Rivera and Maria Eugenia Leyva, both of California; children, Christine Hester of Tucson, Karen Badia of Snowflake, Sharon Boyden of Texas, Ashley Pritchard of Mammoth, Lisa Clark of Utah, and Wesley Pritchard of Tucson, Arizona. In addition to his many children, Jack Pritchard is survived by numerous grandchildren and great-grandchildren.

Amadeo John 'Johnny' Madrid



Amadeo John "Johnny" Madrid, born on Sept. 16, 1953 in Pueblo, Colorado, passed away peacefully after a courageous battle with renal failure on Jan. 9, 2020, with his son, Gabriel, by his side.

Johnny was a loving father, friend and a devoted Christian who enjoyed preaching the gospel. He had a love for God that he carried close to him during his 40-

year run with renal failure.

Serving in many different callings throughout the Tri-Community, Johnny was a member, then appointed as the pastor of the Iglesia De Dios church in downtown Mammoth. He was awarded the Certificate of Appreciation in recognition of his service as Cub Master by the Boy Scouts of America in 1992. Prior to returning to Mammoth, Johnny worked for American Fence Co. in Show Low as a yard foreman before being diagnosed with renal failure and moving back to Mammoth.

His greatest love was the Lord. He enjoyed his fellowship with many of what he called his "brothers and sisters" throughout the Tri-Community and he was well known for his faith in God. Johnny was an inspiration to many who knew him. He was a beacon of encouragement for his

dialysis family and was known for having made several house visits throughout his life to speak to recipients who were discouraged to continue on dialysis. Johnny was known for opening his home to many in the Tri-Community who were affected by the narcotics lifestyle, welcoming them in to lend an ear and provide words of wisdom – with prayer to follow.

Johnny always had his guitar and Bible in close proximity. He loved his time playing guitar and singing with his brothers, while teaching nephews how to play guitar.

He is preceded in death by his father, Amadeo Madrid, and mother, Rosario 'Rose' Apodaca Madrid. He is survived by his two sons, Christopher J Madrid and Gabriel J Madrid (Mandy); siblings, Steve Madrid (Lydia), Manuel Madrid, Millie Madrid, Betty Martinez (Jesus), Arnold Madrid (Maria), Lillian Madrid, Lorenzo Madrid and Andrew Madrid (Joyce); 5 grandchildren, Hannah Moran, Andreyra Madrid, Nicholas Madrid, Gianna Madrid and Adrian Madrid.

Johnny is a beacon whose bright light will not easily fade. He will be missed and loved by all. His family appreciate all those who have helped and cared about Johnny, all the Nurses and staff at the Fresenius Kidney Care in Mammoth.

Memorial service will be held at 10 a.m. Saturday,

Feb. 1, at the Oracle Assembly of God Church with Pastors Nathan and Leasa Hogan officiating, followed by a luncheon at the Mammoth Community Center. A balloon tribute will take place at the luncheon to celebrate Johnny's 40 Years on dialysis.

Driver in fatal crash arrested

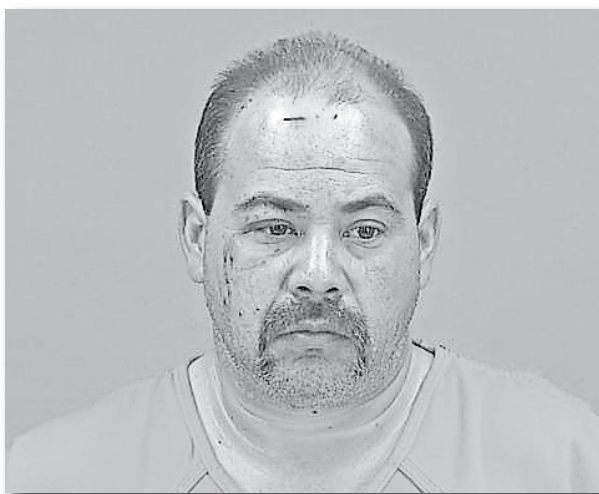
Pinal County Sheriff's Deputies arrested Alex Lujan, 42, following a crash last week that left his passenger, Elizabeth Raschke, 44, dead.

First responders from San Manuel Fire Department and the Pinal County Sheriff's Office were dispatched to the scene of an accident in the area of W. Webb Dr. and W. Main St. in San Manuel at 3:53 a.m. Tuesday morning, Jan. 14, after a 2014 Nissan Maxima, driven by Lujan, collided into the rear of a parked steel utility trailer.

The victim sustained critical injuries and was pronounced dead at the scene. Lujan was transported to a hospital by ambulance with non-life threatening injuries.

On Wednesday, Jan. 15, PCSO Public Information Officer reported that Lujan was arrested and booked into the Pinal County Jail in Florence. He was charged with manslaughter and driving while under the influence and was being held on a \$25,000 bond.

(Lujan's age was originally reported to the San Manuel Miner as 49. PCSO corrected that. He is 42.)

CVIT board member named All Arizona Board Member of the Year

Cobre Valley Institute of Technology (CVIT) is proud to announce that Arizona School Board Association (ASBA) has selected Mike Fane for the All Arizona Board Member of the Year Award for 2019. For art lovers, the Tour will showcase exquisite, handmade pottery from the village of Mata Ortiz in Mexico. The artists themselves will be bringing a load of their beautiful wares to the event. Weather permitting, pieces will be fired in an open flame during demonstrations. It's hard to resist taking home a piece of this special pottery!

In conjunction with the Home Tour, the Superior Fire Department will host a pancake breakfast at the event.

Forging a vibrant future while retaining its distinct charm as a historic mining town, Superior will soon proudly feature a world-class mine. In this region of Arizona, "copper is king," and will continue to be for many years as more and more uses of this precious commodity are discovered. Visitors to Superior will enjoy a bounty of shops, restaurants, art galleries and outdoor activities. 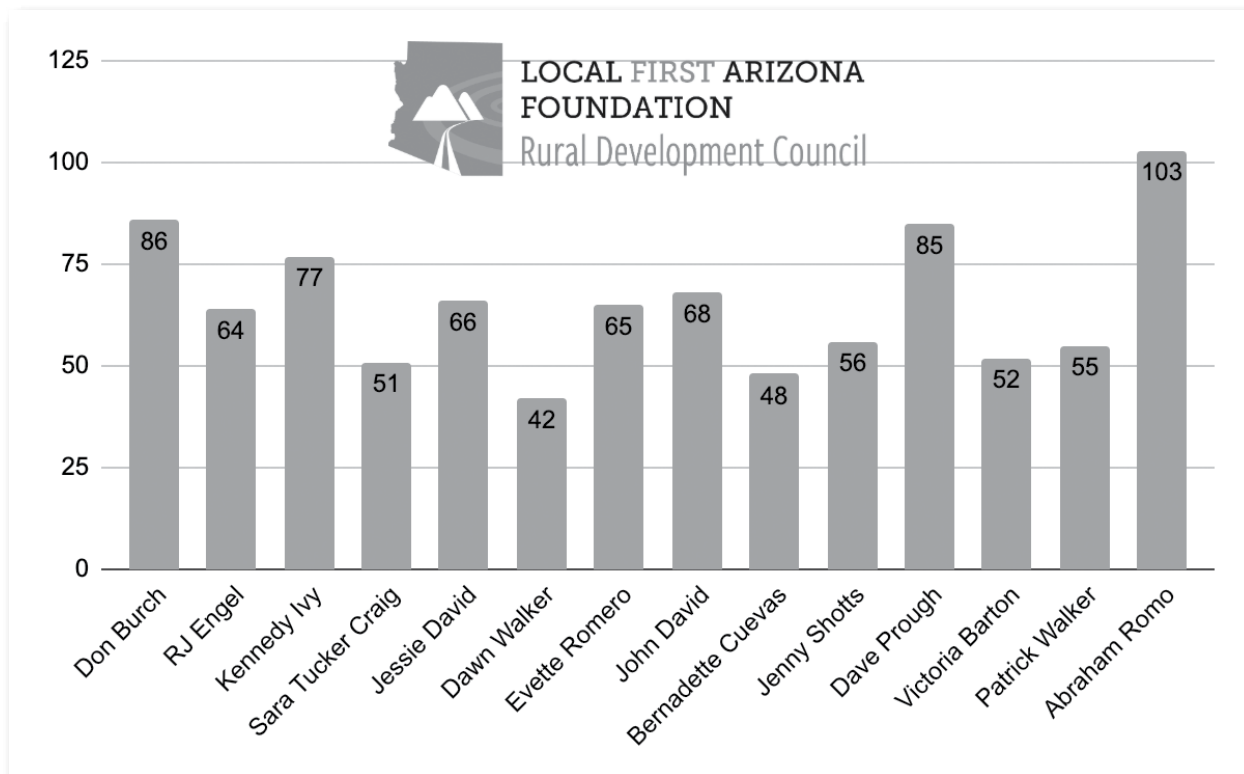

Miners play full game in victory against San Miguel

The No. 13-ranked San Manuel boys' basketball has found difficulty playing with the same intensity and skill level after halftime most of the season, and it was especially evident during a recent stretch when the Miners lost three of four games. But against visiting San Miguel last Tuesday, San Manuel put it all together in a dominant 52 – 25 victory.

"I thought we played a complete game," Miners head coach Damon Lovato said after his team's 14th win of the season. "The third quarter has been our bugaboo [all season]. I thought we did a really good job of re-establishing our energy and tempo after halftime against San Miguel. That's been one of our biggest challenges."

San Manuel senior Javy Tamayo scored a game-high 21 points and dished out four assists with a pair of steals. Senior Caleb Quintero added 13 points and was one of five Miners with four rebounds. Jose Moreno, Adrian Lizzarraga, Tamayo, and

Benny Laguna were the others. Quintero led the team with three steals in the win.

Lovato acknowledged that the Miners must correct the second-half issue if they hope to make the deep run in the playoffs that many, including themselves, expect.

"(We) can't come out and allow a team to go on run in the third quarter and eliminate any momentum we've created," he said. "It's something we're going to continue to work on."

With just over a couple weeks left in the regular season, the Miners want to move up in the rankings. A ranking of No. 8 or higher eliminates a play-in game to start the playoffs. Lovato believes the remaining schedule provides ample opportunities to make the climb.

"I think we can," he said. "Our focus is on winning one game at a time. We have the (opponents) left on our schedule to have things work out, but it doesn't matter if we don't execute."

Up next: Jan. 23 at Ray, Jan. 24 vs. Santa Rita and Jan. 28 at Globe. All games are scheduled to tipoff at 7 p.m.

Lady Miners rout Lady Vipers, 60 – 13

San Manuel sophomore Aubrey Encinas and junior Victoria Zazueta combined for 42 points in the 22nd-ranked Lady Miners lopsided 60 – 13 win against visiting San Miguel last Tuesday night. The win extended San Manuel's winning streak to five games.

The 13 points allowed by San Manuel matched a season-best, which it also accomplished on Jan. 9 versus Superior. It was the third time this season the Lady Miners limited an opponent to 16 points or less.

“(An) all-around great performance against San Miguel is what to expect from the Lady Miners when they're all on the same frequency [and] playing for one another,” San Manuel head coach Rome Porrás-Romero told the *Miner*. “(We) controlled the pace from the get-go and constantly looked for ways to get each other involved.”

Senior Araceli Curry finished with eight points and seven assists. In addition to her game-high 27 points, Encinas added 13 rebounds. Zazueta, who scored 15 points, finished with nine rebounds, 11 assists and four steals. Natalye Pinedo, a sophomore, had a team-high seven steals.

The Lady Miners winning streak was snapped in their next game, a 26 – 24 loss at Tombstone. No. 3 San Carlos defeated San Manuel last Friday night, 98 – 15.

Despite consecutive losses for the first time in three weeks, San Manuel can benefit from some humble pie.

“We played two very aggressive teams back-to-back, and I think the losses taught us that we can't take anything for granted,” Porrás-Romero said. “We realize that there are no easy wins this late in the season and we are dedicated to getting back to our winning ways.”

William 'Buffalo Bill' Cody

Annual Cody Days to celebrate Buffalo Bill's birth, time in Oracle

On Feb. 22 and 23, 2020, Cody Days will be celebrated in Oracle at the Oracle Inn. This is the 5th Annual Cody Days which celebrates William F. "Buffalo Bill" Cody's birthday and the times he spent in Oracle and the Santa Catalina Mountains. The event is free.

Buffalo Bill was a famous Indian scout, mining entrepreneur and iconic entertainer with his Buffalo Bill's Wild West Show.

Cody spent many a winter in Oracle beginning in the early 1900s until his death in 1917. His connection to Oracle were the numerous mining claims including the Hi Jinks, Southern Belle and Maudina mines in the Santa Catalina Mountains. Some say he had an interest in searching for the legendary Mine with the Iron Door. He was a constant visitor at the Mountain View hotel owned by his friend from his scouting days, William Neal.

Cody Days opens on Saturday, Feb. 22, from 1 to 5 p.m. The entertainment will include a free magic show

for the kids by Ross the Magician. Don Larry will give a presentation about Cody as Senator. There will be Native American jewelry displays and sales, book talks and free slices of Buffalo Bill's birthday cake.

On Sunday, Feb. 23, from 1 to 5 p.m., Robert Zucker will talk about the legends and history of the Santa Catalina Mountains, Cody and his mines and Oracle's unique history. Zucker is the author of the book, Treasures of the Santa Catalina Mountains, in collaboration with William "Flint" Carter. It is an interesting history of mining and the legends of lost treasure in the mountains, includes history of Oracle and the surrounding areas. It contains maps, photographs and illustrations.

This year's event will also honor William "Flint" Carter, founder of Cody Days. Flint was a prospector who searched the Santa Catalina Mountains for over four decades for gold and treasure. He held over 100 mining claims in the Santa Catalinas. Flint passed away in December 2018.

Gerald Cody, a member of the Cody family will be this year's guest speaker and will share some Cody family stories. He was President of the International Cody Family Association (ICFA), a non-profit organization for 15 years. The ICFA organized in 1925 and helped fund the original site for the Buffalo Bill Cody Museum in Cody, Wyoming.
