Superior School Superintendent O'Donnell could face charges for assaulting a student

An altercation between Patrick O'Donnell, superintendent of the Superior School District, and a 7-year-old special needs student will apparently result in charges of child abuse and aggravated assault being filed against O'Donnell.

Superior Police Chief Mark Nipp told the Superior Sun that the police department's investigation of the incident resulted in a recommendation that O'Donnell be charged by the Pinal County Attorney's Office. As of late Monday, those charges were still pending.

As news of the police investigation became known, the Superior School Board voted to put O'Donnell on paid administrative leave during an emergency meeting last Friday evening.

The investigation began early last week after the 7-year-old boy accused O'Donnell of hitting his head on a table in the aftermath of the special needs student being escorted off a school bus following an altercation with another student. Security video showed O'Donnell, who also is principal of Superior's Kennedy Elementary School, where the boy attends first grade, tightly holding onto the child's wrist while taking him to his office to wait for a ride home. When the boy's older brother arrived to drive him home, he told police he witnessed O'Donnell forcibly push the younger boy into a chair, which O'Donnell admitted to the police.

During their investigation, police uncovered a second incident captured on video from Dec. 11, 2014, during which O'Donnell was seen slowly pushing a small table until it pinned the boy sitting in a chair between the table and the wall. The young student was not injured during the incident though continued

to move and rock the table afterwards.

Police were alerted to the incident by the boy's mother, Michelle Thompson, who has since pulled the child out of school, "for fear for his life." She told ABC15 News that the boy had brain surgery two years ago to correct problems causing him to suffer epileptic seizures. Any injury to his head while he is still recovering could be life threatening, she said, adding that after the incident, when she noticed a visible mark on the child's forehead she rushed him to be checked out by a doctor.

Superior police, however, reported that the boy had not been injured.

As a result of the surgery, the boy is having to relearn basic skills like discipline and reasoning, Thompson added.

ABC15 News also reported that a Kennedy School secretary told police of witnessing other incidents between O'Donnell and other children, but feared retaliation if she reported them. Superior police are investigating to determine if there are other victims.

After voting to put O'Donnell on paid administrative leave, members of the Superior School Board have refused further comment on the matter, on the advice of the district's attorney.

O'Donnell has not been arrested but has been barred from school property until legal matters are settled.

"The Superior Police Department takes violence on campus very seriously, recognizing that schools should be safe places, and will continue to investigate reports of school violence vigorously," Chief Nipp said.

"The school district will continue to cooperate with the Superior Police Department in their ongoing investigation," members of the school board promised in a statement.

Kearny family, fifth person tests positive for measles

The Pinal County Public Health Services District announced Tuesday that it had confirmed a fifth case of measles in an adult male, who is now recovering. This individual was exposed to the family of four other cases identified last week residing in the Kearny area. This new case raises the possibility that some Pinal County residents or others in the area may have been exposed to measles since the patient visited public locations while infectious. This patient was born after 1957 and reported only having one dose of MMR (measles, mumps, and rubella)

vaccine. Two doses of MMR vaccine are recommended in persons born after 1957.

Pinal County Public Health Services District has identified several public locations this patient visited while infectious. If a person is unvaccinated or unsure of their vaccination status and visited any of the following businesses during these specific dates and timeframes, contact the Pinal County Public Health Department at 520-509-3555 or toll free at 1-888-431-1311.

On Tuesday, Jan. 20, 2015, this patient

visited four public locations in Kearny:

- Big D's, 1113 Tilbury, Kearny – 5:30-8:30 a.m.
- Gordon's IGA, 352 Alden Rd, Kearny – 3-8 p.m.
- Kearny Health Mart, 338 Alden Rd, Kearny – 4:30-7 p.m.
- Kearny Post Office, 388 Alden Rd, Kearny – 3-8 p.m.

On Wednesday, Jan. 21, 2015, this patient visited one public location in Kearny:

"We have already contacted these places of business this patient visited. These businesses are assisting the health department by placing signs at their entrances to inform customers and employees that they could have been exposed if they were in these locations during specific timeframes" said Public Health Acting Director Kore Redden.

On Jan. 22, 2015, the Pinal County Public Health Services District identified four cases of measles in one family. The individuals had travel history to

ASARCO to challenge arbitration award

Tucson—ASARCO, LLC President and COO Manuel Ramos announced recently that ASARCO would challenge an arbitration award concerning the eligibility of certain workers to a quarterly bonus based on the price of Copper. ASARCO filed a petition in the United States District Court for the District of Arizona to vacate the award.

Mr. Ramos explained: “The arbitrator in this case acted outside of the authority given to him under the labor contract between ASARCO and the unions. The labor contract stated that the arbitrator could neither add to nor change in any way the terms of the contract, yet the arbitrator took it up himself to do exactly that. ASARCO must challenge this award to uphold the integrity of the agreement between the Company and the unions and to prevent other arbitrators from rewriting parties’ collective bargaining agreements in the future.”

ASARCO, the United Steelworkers, and several other unions previously agreed in their labor contract that only employees covered under ASARCO’s pension plan are entitled to payment of a quarterly copper price bonus. The unions drafted this language and insisted on its acceptance as a pre-condition

to entering a labor contract with ASARCO in 2007, while ASARCO was in bankruptcy.

In 2011, after the bankruptcy, ASARCO and the unions’ leadership negotiated certain modifications to the labor contract. Chief among those modifications was a provision stating that employees hired on or after July 1, 2011 are not eligible to participate in the Company’s pension plan, thereby precluding those employees from receiving the copper price bonus.

When the union slate claimed that they failed to understand the effect of what they negotiated and that had been imposed upon ASARCO while ASARCO was in bankruptcy, ASARCO made numerous efforts to resolve the problem without success. The United Steelworkers rejected those efforts and ultimately initiated the arbitration process.

The arbitrator issued an arbitration award on December 5. In the award, the arbitrator stated that there is no language in the labor contract that requires ASARCO to pay a copper price bonus to employees not covered by the pension plan. Despite explaining that he could not find for the unions based on the language of the labor contract, the arbitrator decided to rewrite a specific provision of the

labor contracts so that employees hired on or after July 1, 2011 would be paid the copper price bonus even though they are not covered under the Company’s pension plan.

ASARCO is a subsidiary company of Grupo Mexico with approximately 2,720 employees. The Company is an integrated copper mining, smelting and refining company headquartered in Tucson, Arizona and operates mines, mills and a smelter near Tucson and a refinery in

School district addresses change in administration

This action was designed to protect the interests of all concerned.

Principal William (“Bill”) Duarte will be the District’s acting Administrator. Please contact Mr. Duarte if you need the type of assistance or support typically provided by the Superintendent. Mr. Duarte will continue to spend most of his time at the Jr/Sr High School, but will also spend time at the District office and at the Elementary School. I will be keeping in close touch with Mr. Duarte and other District and site personnel in the coming weeks. Our top priority is to keep the focus on teaching and learning.

Superior Police report activity

On Dec. 6, 2014, the Superior Police Department received a report of an accident that occurred on the dirt road off of Golf Course Road just outside of the Superior town limits. Disneyland between December 16th - 20th, 2014, and are believed to be linked to the ongoing multi-state outbreak associated with Disneyland. All four family members affected were unvaccinated and reside in the Kearny area. The Pinal County Health Services District is in the process of identifying individuals who may have been exposed and is working closely with the Arizona State Department of Health Services and other related organizations to notify those at risk.

Measles begins with fever (101 degrees F or higher), red, watery eyes, cough and coryza (runny nose). This is followed by a maculopapular rash (red, raised, and blotchy). The rash begins on the head at the hairline and moves down the trunk to the lower extremities. The rash may last for 5-6 days and turn brownish. Symptoms typically appear 7-12 days after exposure to measles but may take up to 21 days. A person with measles is considered to be contagious 4 days before rash onset (generally one day prior to fever) through the fourth day after rash onset.

“This is a case where a family that has decided to not vaccinate their children are experiencing the consequences of that decision in a very real way” said Public Health Director Tom Schryer. “These cases of measles will trigger a very intensive effort on the part of public health throughout the state and nation to identify others that they had contact with who are also unvaccinated so we can stop the transmission of this serious disease.”

Director Schryer also said, “Parents who make the decision to forgo vaccination for measles need to know that the complications from this disease are serious.

One child of every 1,000 who get measles will develop encephalitis (swelling of the brain) which can lead to convulsions and can leave the child deaf or mentally retarded. For every 1,000 children who get measles 1 or 2 will die from it. When making medical decisions it is imperative that we look at all of the risks involved and the science shows that vaccination saves lives so I urge all parents to immunize their children for measles - it can save your child's life. It is very important to also note that children under the age of 1 years old are unable to be vaccinated. This age group needs to be protected from exposure. This reason alone is why parents should not take their infants to Disneyland.”

Two doses of MMR vaccine provide full protection against measles. Those that have not been vaccinated or have just received 1 dose of MMR should obtain vaccination immediately. For those that are unsure if they have previously received MMR vaccination, they should obtain at least 1 dose of MMR vaccine.

Healthcare providers and pharmacies should have MMR vaccine available. The Pinal County Public Health Services District has MMR vaccine available for both children and adults.
