

# Worst Financial Decision in Pinal County History

n 2004, the Pinal County Jail held an average of 600 to 700 inmates in a facility which was originally built to only hold 472. Then, Sheriff Roger Vanderpool worked with the Pinal County Board of Supervisors to expand the jail. County Supervisors at the time agreed with Sheriff Vanderpool's plan to offset construction costs by housing ICE detainees. The jail expansion project expanded the jail to hold 1,499 inmates/detainees.

In 2006, a contract was signed by the Pinal County Board of Supervisors and U.S. Immigration Customs Enforcement Detention Removal Operations (ICE

DRO) to hold an average of 625 detainees per day. ICE DRO agreed to pay \$59.64 per day for each detainee who was placed in the jail.

In January of 2013, Pinal County Internal Audit completed an analysis of the contract and determined the County was losing \$2 million dollars each year. At that time, Sheriff Babeu pointed out that the auditors were using old ICE population numbers which skewed the audit and the revenue was much higher using the current population averages.

The Board of Supervisors at the advice of then County Manager Fritz Behring attempted to negotiate a new contract rate of \$87 per day. Due to the Federal Government Sequestration the negotiations took longer than they wanted.

Sheriff Babeu asked the Board of Supervisors to do a staffing study of the jail before any attempt to cancel the ICE contract as our staffing levels could not return to pre ICE standards. The Board of Supervisors refused and County Manager Fritz Behring at the direction

of the Board of Supervisors sent ICE a "100 day contract cancelation notice."

Per U.S. Senator Jeff Flake's Office, when ICE received the 100 day notice they ended the negotiations process.

After the ICE Contract was cancelled, the BoS had a staffing study completed by an independent company they

hired. The staffing study and County Manager Stanley confirmed the jail could not return to pre ICE Contract staffing numbers and in the end 113 jail employees were laid off. The plan also only cut \$7.2 million from the jails budget.

Since 2009 the County received an average of \$10,975,441 per year from ICE. During 2013 which was the last full year of the ICE contract they received \$11,669,758 and in 2012 they received \$11,744,308.

The 100 day cancellation notice was the worst financial decision in Pinal County history. The County now has over \$4 million dollars of lost revenue they would still be receiving had they not sent the 100 day notice to cancel the ICE Contract. The cancellation also resulted in 113 positions largely worked by residents residing in Pinal, that will no longer be filled.

# DPS releases names of victims in Jan. 30 fatal crash

On Friday, January 30, 2015, DPS officers investigated a two vehicle collision involving three fatalities and multiple injuries. The collision occurred on State Route 77 near Aravaipa.

The collision occurred at about 7:48 a.m. when a white pickup was northbound on State Route 77 in the area of milepost 123.

For an unknown reason, the driver of the pickup switched lanes, going northbound in the southbound lane of traffic. A white van, which was traveling southbound, saw the oncoming pickup and attempted to avoid a collision with it by changing lanes into the northbound lane of travel.

At that point, the pickup changed lanes back into the

northbound lane and the two vehicles collided head-on. Three people in the van received fatal injuries. The driver of the pickup and four other people from the van were transported to a hospital in Tucson for treatment. One of the injured sustained life-threatening injuries.

The driver of the van, Rodger D. Fugett, 53, of Mammoth died at the scene from injuries sustained in the collision. Passengers Francisco R. Calzadillas, 49, of Winkelman and Troy A. Brownrigg II, 34, of Oracle also died at the scene from their injuries. The driver of the pickup, Mark J. Reynoso, 32, of Mammoth was transported from the scene to a hospital in

Tucson for treatment of injuries sustained in the collision. Passengers in the van, William L. Reidhead, 53, of Mammoth, Jeffrey R. Herelko, 61, of Oracle, Freda F. Davis, 62, of Kearny, and Francis L. Hawkins, 34, of San Manuel were also transported to Tucson for treatment of their injuries. DPS was assisted at the scene by personnel from Pinal Rural Fire Rescue, Mammoth Fire Department, Dudleyville Fire Department, San Manuel Fire Department, Golder Ranch Fire District, Southwest Ambulance and Rural/Metro Ambulance.

The investigation of this collision is in its early stages and impairment has not been ruled out.

All of them are in excellent condition and will require only minor attention and proper decals.

All of this has been done while staying well within budget restraints. There are still areas of need, especially with our





The changes being brought about are real. Change sometimes pinches a few of us. Are you used to casually parking on the wrong side of the street? Do you make illegal u-tuns on Alden Road? Most of us have done these things. I ask for a spirit of cooperation with our department as they work to improve the safety of Kearny in small ways as well as in large.

According to state law, there are two methods by which police may arrest suspected offenders. The suspect may be physically taken into the department and booked into jail, or the arresting officer may write a citation and release the suspect to appear in court later. All suspects are presumed innocent until proven guilty in a court of law. Only criminal citations are listed. All damages are estimates.

nce again, the Pinal County Sheriff is attempting to place fault for the termination of the Immigration and customs enforcement contract at the doorstep of the board of supervisors. The sheriff is also blaming Pinal County's former county manager for raising the ICE contract issue. County Manager Fritz Behring brought to the board's attention that county taxpayers were losing between \$3 to \$4 million dollars annually on this

contract. Behring would have been totally

# **CAHRA** provides weatherization program

**Community Action Human Resources** Agency (CAHRA) has funding to assist eligible low-income homeowners in Pinal County with weatherization, according to Mary Lou Rosales, executive director.

"Under the weatherization program, improvements are made by CAHRA to help reduce energy consumption and energy costs," Rosales said. A thorough assessment of the eligible home is performed including diagnostic and blower door testing to determine where the house is losing energy and what can be done to stop the loss. The auditor will also assess health and safety issues that might exist in the home. A test to determine carbon monoxide leakage is also done.

Minor repairs are made to make the home safer, more sound and secure. "Families

are counseled as to changes in their energy use habits, which will complement the work done on the homes, and help promote the conservation of energy," she explained. After making the efficiency upgrades, the home could save from 5 to 30 percent on the family's energy bill.

Based on the home assessment, weatherization repairs may include repair or replacement of old cooling and heating systems, repair or replacement of leaky ductwork, replacement of old or inefficient refrigerators and the addition of sunscreens to sun struck windows. Staff may also be able to assist homeowners with the repair or replacement of inefficient or non operable appliances and water heaters.

Yet, Sheriff Babeu continued to grandstand and "bad mouth" the federal government and homeland security in the press, for a variety of reasons. He would intentionally go out of his way to "slam" Homeland Security Director Janet Napolitano and ICE on immigration topics.

Well guess who ICE reported to? Yes, Janet Napolitano and homeland security!!

And the sheriff can't figure out why the ICE contract with Pinal County Sheriff's Office was not renegotiated by the feds? The sheriff may have had a good working relationship with middle management workers in ICE. But when it came to negotiating with decision-makers in Washington DC, even our Congressional delegation that was attempting to help Pinal County, asked the sheriff to stay



Homes needing larger repairs such as roofing, ceilings, floors, window or door replacement, plumbing, electrical or major rehabilitation may not be eligible for the program.

Funding is provided by the Department of Energy and Low-Income Home Energy Assistance Program through the Arizona Governor's Office of Energy Policy. Utility companies, Arizona Public Service, Salt River Project and Southwest Gas Corporation also provide funding for the program. Funding for minor home repairs and appliances is provided by Utility, Repair, Replacement and Deposit funds through Arizona Community Action Agency. CAHRA does not have funding for emergency home repairs or rehabilitation.

Eligibility includes: 1) household must be low income, 2) the home must be owned by the applicant or be in process of purchasing, 3) applicant must have lived in the home for least 12 months. An application must be completed and verification of income, home ownership and other documents must be provided.

"It's important to stress that the weatherization program is not an emergency home repair program and applicants may be placed on a waiting list," Rosales stated.
