## Worst Financial Decision in Pinal County History

n 2004, the Pinal County Jail held an average of 600 to 700 inmates in a facility which was originally built to only hold 472. Then, Sheriff Roger Vanderpool worked with the Pinal County Board of Supervisors to expand the jail. County Supervisors at the time agreed with Sheriff Vanderpool's plan to offset construction costs by housing ICE detainees. The jail expansion project

expanded the jail to hold 1,499 inmates/detainees.

In 2006, a contract was signed by the Pinal County Board of Supervisors and U.S. Immigration Customs Enforcement Detention Removal Operations (ICE DRO) to hold an average of 625 detainees per day. ICE DRO agreed to pay \$59.64 per day for each detainee who was placed in the jail.

In January of 2013, Pinal County
Internal Audit completed an analysis of
the contract and determined the County
was losing \$2 million dollars each year.
At that time, Sheriff Babeu pointed out
that the auditors were using old ICE
population numbers which skewed the
audit and the revenue was much higher
using the current population averages.

The Board of Supervisors at the advice of then County Manager Fritz Behring attempted to negotiate a new contract rate of \$87 per day. Due to the Federal Government Sequestration the negotiations took longer than they wanted.

Sheriff Babeu asked the Board of Supervisors to do a staffing study of the jail before any attempt to cancel the ICE contract as our staffing levels could not return to pre ICE standards. The Board of Supervisors refused and County Manager Fritz Behring at the direction of the Board of Supervisors sent ICE a "100 day contract cancelation notice."

Per U.S. Senator Jeff Flake's Office, when ICE received the 100 day notice they ended the negotiations process.

After the ICE Contract was cancelled, the BoS had a staffing study completed by an independent company they hired. The staffing study and County Manager Stanley confirmed the jail could not return to pre ICE Contract staffing numbers and in the end 113 jail employees were laid off. The plan also only cut \$7.2 million from the jails

budget.

Since 2009 the County received an average of \$10,975,441 per year from ICE. During 2013 which was the last full year of the ICE contract they received \$11,669,758 and in 2012 they received \$11,744,308.

The 100 day cancellation notice was the worst financial decision in Pinal County history. The County now has over \$4 million dollars of lost revenue they would still be receiving had they not sent the 100 day notice to cancel the ICE Contract. The cancellation also resulted in 113 positions largely worked by residents residing in Pinal, that will no longer be filled.

## Pinal County Contract With ICE

nce again, the Pinal County Sheriff is attempting to place fault for the termination of the Immigration and customs enforcement contract at the doorstep of the board of supervisors.

The sheriff is also blaming Pinal County's former county manager for raising the ICE contract issue. County Manager Fritz Behring brought to the board's attention that county taxpayers were losing between \$3 to \$4 million dollars annually on this contract. Behring would have been totally negligent in his duties had he not raised this issue.

The sheriff knew for a long time that the

ICE contract needed to be renegotiated to stop the bleeding of taxpayer dollars. This didn't pop up overnight, everyone from the supervisors to the sheriff were on the same page following several meetings about the details of the contract.

Yet, Sheriff Babeu continued to grandstand and "bad mouth" the federal government and homeland security in the press, for a variety of reasons. He would intentionally go out of his way to "slam" Homeland Security Director Janet Napolitano and ICE on immigration topics.

Well guess who ICE reported to? Yes,

Janet Napolitano and homeland security!!

And the sheriff can't figure out why the ICE contract with Pinal County Sheriff's Office was not renegotiated by the feds? The sheriff may have had a good working relationship with middle management workers in ICE. But when it came to negotiating with decision-makers in Washington DC, even our Congressional delegation that was attempting to help Pinal County, asked the sheriff to stay away.

The failure to renegotiate the ICE contract and the scores of detention officers and families that lost their jobs lies squarely at the foot of the sheriff's office. And all because Sheriff Babeu couldn't resist grandstanding and mugging for the TV cameras.

## DPS releases names of victims in Jan. 30 fatal crash

On Friday, January 30, 2015, DPS officers investigated a two vehicle collision involving three fatalities and multiple injuries. The collision occurred on State Route 77 near Aravaipa.

The collision occurred at about 7:48 a.m. when a white pickup was northbound on State Route 77 in the area of milepost 123.

For an unknown reason, the driver of the pickup switched lanes, going northbound in the southbound lane of traffic. A white van, which was traveling southbound, saw the oncoming pickup and attempted to avoid a collision with it by changing lanes into the northbound lane of travel.

At that point, the pickup changed lanes back into the

northbound lane and the two vehicles collided head-on. Three people in the van received fatal injuries. The driver of the pickup and four other people from the van were transported to a hospital in Tucson for treatment. One of the injured sustained life-threatening injuries.

The driver of the van, Rodger D. Fugett, 53, of Mammoth died at the scene from injuries sustained in the collision. Passengers Francisco R. Calzadillas, 49, of Winkelman and Troy A. Brownrigg II, 34, of Oracle also died at the scene from their injuries. The driver of the pickup, Mark J. Reynoso, 32, of Mammoth was transported from the scene to a hospital in

Tucson for treatment of injuries sustained in the collision. Passengers in the van, William L. Reidhead, 53, of Mammoth, Jeffrey R. Herelko, 61, of Oracle, Freda F. Davis, 62, of Kearny, and Francis L. Hawkins, 34, of San Manuel were also transported to Tucson for treatment of their injuries. DPS was assisted at the scene by personnel from Pinal Rural Fire Rescue, Mammoth Fire Department, Dudleyville Fire Department, San Manuel Fire Department, Golder Ranch Fire District, Southwest Ambulance and Rural/Metro Ambulance. The investigation of this collision is in its early stages and impairment has not been ruled out.

## Measles, the Border and Disneyland

ases of measles including four in Pinal County have been traced to the Disneyland theme park in Anaheim, Calif. Republicans like Rush Limbaugh and Congressman Mo Brooks of Alabama have suggested that "illegal aliens" are the cause. Possible presidential candidate Dr. Ben Carson has also blamed undocumented immigrants for the outbreak. In Arizona, Pinal County Attorney Lando Voyles told a State Senate panel on Wednesday that he knows how the measles outbreak got into Arizona and his county; it's from having an open border with Mexico.

A report on KFYI radio quoted Voyles as saying, "No one has even brought up the point that we've opened the border." "For years we had measles completely contained here in the US." Now Voyles is not just an attorney, he is an epidemiologist, either that or he stayed at a Holiday Inn Express, probably at tax payer's expense.

It is no surprise that Voyles is speaking out against the

"porous border" after all that is what his mentor and running partner does on a regular basis. Yes, lets face it people, Voyles wouldn't have been elected without Sheriff Babeu and his political base. Now he is following Babeu's lead. We all know how the sheriff feels about the border and undocumented immigrants. We saw his true colors last year when he helped organize a protest of unaccompanied Central American immigrant minors along with his Tea Party, nativist and border militia followers. They were crying out that these kids were dangerous gang members and bringing in infectious diseases. None of which turned out to be true.

## Exploring the archaeology of Redington

With our beautiful Arizona weather there is much to be explored in our area including many archaeology sites. Between 1275 and 1400 prehistoric people occupied the San Pedro Valley. Just around the corner from San Manuel in the Redington area there are many archaeology wonders to investigate for the outdoor enthusiasts. Many volunteers monitor the archaeological sites on state and federal land. The links between the past and the present help people see why cultural sites should be protected and preserved.

Archaeology is the study of past human life and culture by the recovery and examination of remaining material evidence such as buildings, tools, pottery, fossil relics and graves. Prehistoric archaeology studies the cultures that didn't have a written language. The remains of past cultures help us to understand the history. Some of the historical records may include diaries, census and tax records, deeds, maps and photographs. Through the combination of documents and archaeology evidence, a better understanding of past human behavior can be acquired.

Archaeology Southwest indicates there are approximately 500 sites between Winkelman and just beyond Benson. There are some large architectural features such as ballcourts, walled villages and architectural field systems. The preservation of these sites has

been successful because there is little development in the region and the local landowners are stewards of the land, protecting these sites.

One of the Site Stewards in the area is Diane Tuck. Diane has a love and passion for the history of the area. On our outing she enjoyed describing and showing us a few of the sites here in Redington. Some of the goals of a Site Steward is to preserve prehistoric, historic and paleontological resources for the purposes of conservation, scientific study and interpretation; to increase public awareness of the significance and value of cultural resources and the damage done by artifact hunters; to discourage site vandalism and the sale and trade of antiquities; to support and encourage high standards of cultural resource investigation throughout the state; to promote a better understanding and cooperation among agencies, organizations and individuals concerned about the preservation of cultural resources.

Archaeological sites and artifacts on private land are the property of the landowner. Many of the sites in Redington are on private land. When the sites are on public land or in the path of proposed project like highways or developments, many state and federal laws are provided for the study and protection of the land.

The excavation or removal of antiquities on public land is a criminal offense forbidden by law. The archaeological sites are non-renewable resources once they are destroyed or excavated they are gone





Based on the home assessment, weatherization repairs may include repair or replacement of old cooling and heating systems, repair or replacement of leaky ductwork, replacement of old or inefficient refrigerators and the addition of sunscreens to sun struck windows. Staff may also be able to assist homeowners with the repair or replacement of inefficient or non operable appliances and water heaters.

Homes needing larger repairs such as roofing, ceilings, floors, window or door replacement, plumbing, electrical or major rehabilitation may not be eligible for the program.

Funding is provided by the Department of Energy and Low-Income Home Energy Assistance Program through the Arizona Governor's Office of Energy Policy. Utility companies, Arizona Public Service, Salt River Project and Southwest Gas Corporation also provide funding for the program. Funding for minor home repairs and appliances is provided by Utility, Repair, Replacement and Deposit funds through Arizona Community Action Agency. CAHRA does not have funding for emergency home repairs or rehabilitation.




