Nelda Joan 'Jody' Long Towery

Jody Towery, born March 4, 1930 in Climax, Texas, died Feb. 8, 2014, at the age of 83 in her home in San Angelo, Texas. Her mother, Lucille McCormick, raised her beginning on a farm near Farmersville, Texas.

A born teacher, who even in her teens, taught Vacation Bible Schools for black church's children, went on to Howard Payne University gaining a B.S. in Elementary Education in 1951.

She married Britt Towery,

Jr. in Brownwood, Texas
July 28, 1950 and served
in many Baptist churches
where Britt was pastor:
Mt. Zion (Brown County),
Stag Creek (Comanche
County), First Baptist
Church, Eustace, Texas, San
Antonio, Texas. She, with
her husband founded and
developed the First Baptist
Church of San Manuel,
Arizona (1954).
Jody and Britt were

appointed Southern

Baptist missionaries by

the International Mission Board, Richmond, Va., Dec. 20, 1956, to the Republic of China, Taiwan. Ten years in Taiwan resulted, among others, in the founding and building of the Pingtung Baptist Church in the southern part of the island. Adept at the Chinese language she worked in Taipei, Keelung, Pingtung and Kaohsiung churches. She led a kindergarten for American military family children. Her English Bible class in Pingtung reached a young Chinese teenager who later became an outstanding Taiwan Christian pastor. In 1966 she taught 7th Form students in the Pui Ching Middle School, Kowloon, Hong Kong and later classes in the early years of Hong Kong Baptist University. She also taught a year at the Hong Kong International School

The years 1982-1992 she was instrumental in making and developing friendships with the China Mainland Christian churches in 20 provinces of China. Churches began to re-open on the mainland in 1979. She was a bridge between American churches and those emerging from the 1966-1977 Cultural Revolution years.

She was invited to teach special theological English to the graduate students of the Nanjing Theological Seminary the fall semester of 1989. She was teaching an English class at the University of Nanjing when news broke of the fall of the Berlin Wall. An exciting and edgy time for students who had just been a part of the democracy protests in many cities, most notably in the Tian'anmen Square tragedy of June 4, 1989.

Upon retirement from the IMB she taught three years in the Marlin, Texas, elementary system. Became a fan of Baylor University baseball and basketball just a block from her home. She did enjoy watching any Baylor team play.

Besides her husband, she is survived by two daughters, Linda Holder, of Waco and Patricia Mayland Douglass Towery of San Angelo; a sister, LaVerne Whitaker, Farmersville, Texas; and three grandsons: Greg Garcia and wife Tiffany, of Waco, Texas: Britt and wife Ashley Garcia, and greatgrandson Emerson Garcia of Grapevine, Texas; Zane Mayland of San Angelo. Numerous nephews and nieces.

Rios: I did not support 20 percent raises

By now, many of you might have heard that three members of our Board of Supervisors have waived county policy to give over 20 percent raises to their administrative assistants.

I want to tell you, unequivocally, that I did not support that measure and did not vote for those raises. I was joined by my fellow board member, Steve Miller, in opposing the action.

No matter what you call it, or, how you defend these pay raises, it comes down to one simple fact: our policy was not followed. The policy was thrown to the side for a select few to gain a large increase in their pay. As the policy making body of Pinal County, the Supervisor should be held to a higher standard when it comes to following the rules we pass. Unfortunately for the 1,988 employees of the county, this did not happen.

One of the arguments by the majority who passed these

pay raises was that it took too long to go through Human Resources for the position reclassification. To me, this argument falls flat, when you have a Human Resources Department which previously did a position survey for the Supervisors administrative assistant and found all but one of their salaries to be right on target for the marketplace.

These pay raises are a direct slap in the face to those Pinal county employees, such as our law enforcement personnel, that have not seen a raise in six years. While we did pass a 2.5 percent increase for 2014, it is not even in the ballpark for three employees receiving a very generous 20 percent salary raise. It boggles the mind to think that these three employees, who carry on the same day-to-day duties as my assistant and Supervisor Miller's assistant, merit such a high increase.

I enjoy working with my four fellow supervisors. I feel that they have the best interests of the county at heart.

But, this action of tossing policy for pay raises, while we are expected to encounter at \$9,000,000 deficit at the end of this fiscal year is not wise, nor does it work in the best interest of the county.

Supervisors bypass HR, approve raises

Regarding the Board of Supervisors (BOS) meeting held on 2/5/14, agenda items 9,10,&11:

On 1/9/2013, the first meeting of the new board, Supervisor Smith appointed his Executive Assistant, Marlene Pearce at pay grade 5, salary \$46,987. Now a year later he and Supervisors House & Chase want to give their Ex Assts. a raise of over \$10,000 a year to \$57,241 (22+%). No one in this county has received a raise in 6+ years unless promoted.

The BOS went to the **Human Resources** Dept. (HR) asking for a reclassification for their Ex Assts. HR said they would do an analysis to see if it was warranted. HR did not do it fast enough for them so these Supervisors used the description for Assistant to the County Manager. They copied that job description word for word with a few enhancements added in and have created the position, Assistant to the BOS. They used the exact pay scale for their new classification, \$54,454 - \$75,192. Current

Ex Asst. scale is \$42,515
- \$58,760. They said they had 3 votes and didn't need HR and chose to proceed themselves, without following appropriate Pinal County policy. It is my understanding that HR has finished their analysis and stated that no change is

warranted.

At the 2/27/13 Meeting Supervisor Smith said there would be no reclassifications of pay grades approved until the compensation study was completed -- it is NOT complete. To circumvent this, these Supervisors claim it is not a reclassification, it's a new job title.

Supervisors Smith, House and Chase have elevated themselves above following Pinal County policy! They have forgotten that they work for the citizens of Pinal County.

Nicole Borquez; greatgrandchildren, Celeste Borquez, Mia and Copper Dale, Frankie and Dominic Coronado.


She was a long time member of St.

Mammoth not the friendliest place to stop

Background: Fourth Generation Arizona native with great-grandfather moving to Cottonwood in 1891. Raised in Tanque Verde and summers in Remington on the San Pedro River areas, east of Tucson. Graduated University of Arizona Bachelor Science and worked for Department of Agriculture for 33 years.

Situation: My wife had to be in Sahuarita, south of Tucson, to help our daughter-in-law with a newborn cesarean baby and two other children. I needed to pick her up, and, my son is a Firefighter

Engineer for Golden Ranch
Fire District on the north end
of Tucson, south of Oracle.
So, we planned to meet in
Mammoth, Sunday, January 5
at 6:30 am, to meet my son's
schedule. I live in Snowflake
and had to leave about 3 am
to make that time schedule.
Therefore, at 4 pm on
Saturday evening, I decided to
drive down Saturday evening
to not have to maneuver
through the Salt River at 4:am
in the morning.

We enjoy our favorite Mexican food meal, and, often work our schedule to eat at La Casita. I also get gas at Mammoth, as the prices are similar to Tucson and I enjoy small town businesses, and the lower gas prices get me further home before I have to buy higher-priced gasoline in the White Mountains.

I arrived and pulled over to sleep at the Mammoth Parkway, along the highway. I was sound asleep (sometime after 10 pm .. I never looked at the time), when I was woken by the bullhorn, spot light and headlights aimed in my eyes. A voice on the bullhorn was advising that a Police Officer of the Mammoth Police Department was requiring that I put my hands up and keep them in plain sight at all times.

I was asked to unlock the door and keep my hands in plain sight, but, with the spotlight in my eyes, I was not sure if it was the police or not; but, I immediately complied, not knowing if a gun was pointed at my head or not. I was asked to produce my driver's license, which I did. My information was called in to dispatch. With my driver's license, I also handed my State of Arizona weapons permit, to help with my identity.

I asked what the problem was. The officer stated that I am not allowed to sleep in the Mammoth Town Park, nor, anywhere else, after 10 pm. I stated that there were not any

signs and I apologized, and, explained that I was meeting my son and wife there at 6:30 am.

I was asked to leave town and maybe find a place in San Manuel, or, maybe I could head north. I reminded the officer that heading north would be backtracking, and, I needed to be here at 6:30 am. I asked if the San Manuel Junction would be okay, which he agreed to. I moved on as instructed.

My last ticket was in 1993, and, then, 10 years before that. My car being driven was a pearl white 2013 Toyota Venza, so, I do not think I looked like a highprofile vagrant or risk. In summary, I am sure it makes no difference to anyone in the Town Council, or, anyone living in the Town of Mammoth with your policies, since I am just a non-local passing through, several times monthly, on my way to see family, but, as for me and my family, we will have to say that Mammoth has become the most unfriendly Town in the western United States.

Mammoth can keep its Mexican food and gas, as there are much better and people-friendly alternatives to where our family spends its money, traveling through. Sincerely,



Arriving around 9:30 a.m., with the help of the Mammoth-San Manuel School District Maintenance Department, a 72 square foot chicken coop painted barn red was delivered to the school.

The project was part of Pima County Joint Technical Education District (JTED). There and back again: Oracle Road Race to San Manuel a success

The first of what could become an annual event was held on Sunday, Feb. 2 in Oracle. The Oracle Road Race was organized by the University of Arizona Cycling Team and sponsored by Sabino Cycles of Tucson. The race included collegiate Team Time Trials (TTT), Men's Professional, collegiate men and women's teams, and club riders of different age and class divisions. The races were divided by class and distances. The distances were varied with the Collegiate TTT being 10 miles. There were races of 20 miles for juniors, 40 miles, 60 miles and 80 miles depending on the class and age division. Riders from other parts of the country, Canada and even a team from Hermosillo, Sonora Mexico participated.

The races started at the Pinal County Court House. The course went down American Avenue to Highway 77 turning right onto Redington Road to Webb Avenue up the back road to Mt. Lemmon Road and continuing into Oracle and the court house, a 20 mile loop. The race was organized by Joey Iuliano, vice president, Road of the U of A Cycling Club. He said he was helped by many volunteers and Alicia Bristow, president of the Oracle Women's Network. He wanted to recognize and thank the Oracle businesses for their support and donations. The business sponsors were Oracle Ford (Mark Phelps), **Huntington Chiropractic** (Dr. John Huntington), Oracle Land and Homes (Helen Vinson). Supporters were Casa Rivera (Rudi and Gloria), Oracle Market and Oracle Inn (Darimont Family), Pinal County Sheriff's Office, El Rancho Robles, and OWN (Oracle Women's Network). At the awards ceremony, Joey Iuliano thanked everyone and urged them to try some of the local businesses and restaurants. He mentioned the following by name, Oracle Inn, Patio Café, DeMarcos, Nonna Marias, and Casa Rivera's.

Close to 800 people showed up for the race which included 430 cyclists and their family, friends and supporters. Joey said that 200 more racers showed up than they expected. He said for the first time having the event and for only giving the town of Oracle a weeks notice, the event went really well. Next year it will be better planned and more notice will be given. He would like to see more locals come out and cheer the cyclists on.

This could be a big thing for Oracle if held annually. The people attending and participating in the race spent money locally and with more promotion and community involvement, could be a bigger and better event. Many of the racers were from other parts of the country and Canada. Some of them train in Tucson and ride up to the Oracle and San Manuel area frequently. Joey is also looking at trying to attract the Collegiate Nationals to the area as the racing course was popular and scenic. There are 300 collegiate cycling teams. This would bring even more people to the area.

The Collegiate teams racing were the University of Arizona, Arizona State University, Northern Arizona University, and Grand Canyon University. They are members of the Southwest Collegiate Cycling Conference which also includes the University of New Mexico, Santa Fe Community College, University of Texas at El Paso (UTEP), and Prescott College. Some of the winners in the collegiate races were first place men's, Quinn Keogh (U of A); second, Constantine Schreiber (ASU); and third, Max Rich (U of A). Collegiate Women's first, Amy Chandos (NAU); second, Alexis Gannis (Grand Canyon University) ; third, Lindsey Ryder (ASU).

The University of Arizona Cycling Club is made up of UA faculty, staff, graduate and undergraduates students who come together to enjoy bicycling. They have group rides, races including competition in the SWCCC. They also promote and support the cycling community. They currently have 50 members. 




