Volunteers needed for Foster Care Review Board

The Foster Care Review Board (FCRB), a program within the Dependent Children's Services Division of the Arizona Supreme Court, is seeking volunteers. Statewide, the FCRB has about 108 Boards and a little over 500 volunteer positions filled by dedicated board members who have a desire to advocate on behalf of children in Arizona's foster care system. In Gila and Pinal Counties, the FCRB facilitates 10 boards which are each comprised of 5 citizens from the community. The Board members are appointed by the Presiding Judge of each county's Juvenile Court.

"We have an urgent need to fill vacancies in both counties," explained Gioia Kaid who works for the Arizona Supreme Court. Currently there are five vacancies in Gila County and 15 in Pinal County.

Foster Care Review Board volunteers commit to meeting one weekday per month to review the cases of children who are in out-of-home care. The meetings are completed

As children return home, are adopted, have guardianship granted or age out of the system, new cases are added to the Board's review day. The Board makes recommendations to the Juvenile Court and interested parties involved in the case. Currently, Boards in Gila and Pinal Counties are reviewing the cases of about 900 children. Volunteers receive the training needed to serve in this role.

Jesse Leetham is starting his third term serving on the Foster Care Review Board in Gila County. Leetham is an active member of his community, serving on the Globe City Council and several other boards.

"I enjoy serving on this board, it is a great feeling to help both the children and parents, and be advocates to ensure they get what they need," he explained.

Leetham also explained that the board members receive training and serving on the Foster Care Review board isn't as demanding as serving as a Court Appointed Special Advocate (CASA).

Pinal County Assessor announces that 2024 property valuation notices mailed; how and when to appeal your valuation

The 2024 valuation notices were mailed to Pinal County property owners last week and should now be appearing in mailboxes. If you believe that your property is not correctly valued or if it should be listed with a different legal classification, you have two options:

• File an administrative appeal with the Assessor's Office (no fee)

• File an appeal with the Arizona Tax Court (check with the Tax Court for fee schedule)

If you choose to file an appeal with the Assessor's Office, please read below for important information before filling out the Petition for Review of Property Value. If you choose to file a case in tax court, please contact the Arizona Tax Court.

To appeal the value of a residential property, use Form 82130R (https://bit.ly/3xnSiGc). To appeal the value of commercial/industrial property, vacant land, agricultural land, or other non-residential property, use Form 82130

(https://bit.ly/3IkrtsB). Please read on about important changes due to Proposition 117.

When filling out either form, you have the choice of requesting an optional meeting to discuss your appeal. Our office will carefully and thoroughly consider your appeal if you do or do not request to meet.

If you would like to appeal your value, please indicate if you are using the market comparison, income, or cost approach to arrive at what you believe is the correct value of your property. We are required by law to use sales data from the previous 2 years when valuing your property, so please use sales, income, and/or cost data from the 2019 to 2020 time frame in your appeal.

For sales comparisons, try to select the most recent sales of like properties from 2021 and the first half of 2022.

The deadline to file an administrative appeal of your 2024 value is April 17, 2023. You may mail in your appeal or drop it off at our main office in Florence during regular

business hours or at the County Annex in Apache Junction on Monday through Thursday from 8 a.m. to 4 p.m., in San Tan Valley on Tuesday and Thursday 8 a.m. to 4 p.m., in Casa Grande on Monday through Thursday from 8 a.m. to 4 p.m., and in Maricopa on Tuesday through Friday from 8 a.m. to 3:30 p.m.

Administration Appeal replies will be mailed no later than Aug. 15, 2023.

If you have not received your notice of value, please use our search page (https://bit.ly/3YRV9CH) to find your property and to check the value for 2024. If you disagree with the value and would like to file a Petition for Review, please follow the steps outlined above.

Property taxes are calculated based on the Limited Property Value (LPV) and in most cases that amount cannot increase by more than 5% a year. The Full Cash Continued on page 5

opportunity to appear before the Board and speak about their concerns, successes, wants and needs. The Board asks questions and considers all information available before making recommendations. The program specialist prepares a written report which includes the Board's recommendations and statements given by the interested parties. The report is distributed to the Juvenile Court and all case participants.

To become a volunteer, you must be at least 21 years of age and pass a fingerprint background check. You can



request an application by going to the FCRB website at: www.AZFCRB.org or by calling 520-388-4300. You can also email FCRBT@courts.az.gov to request an application.

Another way to get involved is a program with similar requirements called Court Appointed Special Advocates (CASA), in which volunteers are appointed by the Court to advocate for a specific child with whom they are paired. On the day of the review, an FCRB staff member (program specialist) facilitates the case reviews. Interested parties for each case have an

Wilma Huggett: Queen of the Rodeo

Wilma Elna Huggett was a rancher, rodeo champion, storyteller, artist, writer, historian and a nominee for the Cowgirl Hall of Fame. As a young lady, she also was the Queen of the Fiesta de los Vaqueros/Tucson Rodeo. In 1950, Wilma entered the competition for Rodeo Queen. She was sponsored by the COD Ranch and its owner, Elna Huggett, Wilma's mother.

It was the 25th Anniversary of the rodeo and plans were in the works to make it the biggest and best event ever. The Junior Chamber of Commerce (Jaycees) Vigilante Committee were in charge of selecting the Queen for the rodeo who would lead the parade on opening day. In those days the selection of the queen was determined by which contestant sold the most tickets to the pre-rodeo dance held on Feb. 22, 1950.

On Monday morning, Feb. 20, it was announced that Miss Wilma Huggett was the Tucson Rodeo Queen. More tickets had been sold in her name than the other contestants. Runners-up were Gloria Kinney of Red Rock, Isela Sammons and Marion Peters of Tucson. They would serve as attendants. An ad announcing Wilma as the Queen was placed in the Tucson papers. A few hours later, a formal complaint was filed with the Vigilante Committee questioning Wilma's eligibility to be queen. The rules of the committee explicitly stated that to qualify as a contestant the entrant must be 18 years of age or older. Wilma was 17 and would not turn 18 until March after the rodeo was over.

The committee held a hearing that evening which included Wilma, her mother, the runners-up and their

representatives. Loveless Gardner, Vigilante Chief, had called the meeting to order. Gardner declared that Miss Huggett had told him she was 18 when she entered the contest. The Committee argued that the protest was filed too late and should have been done before they had declared Miss Huggett queen. They would stand with their decision. Representatives of the runners-up said that until the queen is crowned, all facts and arguments should be considered. After hours of heated discussions and arguments, the Committee said they would hold another meeting the following day.

At the next day's meeting, the Committee said they had talked with Miss Huggett and said she had acted in good faith believing in her own mind that she was 18 when she entered the contest. John Riley, a Tucson attorney representing first runner-up Gloria Kinney, called for justice and demanded that the Committee abide by its

rules.

Willard Glaze representing Isela Sampson said that his client "entered the contest under the rules and we believe the queen should be chosen on the basis of those rules." Miss Huggett's victory "is based on fraud and misrepresentation and it's up to you to tell her she was wrong and that she has disqualified herself." Jim Bloomfield, Chairman of the dance committee, told the protesters that his committee would consider their grievances again in the morning when all the Vigilante Committee members could be there and make a final decision.

On Feb. 22, the Committee decided that both Wilma Huggett and Gloria Kinney would be crowned Queen of the Fiesta de los Vaqueros. Gloria was named official Queen of the Rodeo and Wilma would be unofficial queen. The Committee said that Miss Huggett had voluntarily stepped aside as queen and "in appreciation of Miss Huggett's sportsmanship and work" it was agreed to recognize her as unofficial queen. Elna Huggett was unhappy with the decision but her protests were in vain. Gloria and Wilma were both crowned at the Vigilante Rodeo Dance that evening. This dance was so large and popular that it was held in two ballrooms, the V.F.W. Ballroom on East Broadway and the Pioneer Hotel Ballroom on Stone and Pennington.

On Thursday the "twin queens" as the newspapers called them and their attendants led the largest Tucson Rodeo Parade, viewed by the largest crowd in its 25-year history. It would also be the first and last time that two queens were selected to reign over the Fiesta de los Vaqueros.

Value (FCV) will no longer have a direct effect on your taxes.

State law only allows you to appeal your FCV because the LPV is calculated based on a formula set in statute. When considering whether to appeal your value, check to see if the 2024 LPV is below what you believe to be the correct FCV or market value of your property. If the 2024 LPV is less than what you believe is the proper FCV of your property, winning your appeal will not reduce your 2024 property taxes.

Deciding whether to appeal or not appeal the assessed value is up to the property owner. If you still have questions about the appeal process, please contact our office at 520-866-6361 or email assessor@pinalcountyaz. gov.

Arizona Medical Eye Unit visiting Oracle


The Arizona Medical Eye Unit (the Unit) from the Lions Vision Center, Inc. will be visiting Oracle at the Living Word Chapel, on Highway 77 on March 2, starting at 9 a.m. to give Ophthalmological medical eye examinations. This visit is sponsored by the Circle of Friends.

Appointments for eye examinations can be made for Oracle residents and those from surrounding localities by calling 775-934-1005. Since only 20-30 patients can be examined in a day, it is important for those who suspect they have eye problems to call and schedule an appointment as soon as possible. Fee per patient is \$45, cash only.

The completely equipped Arizona Medical Eye Unit was donated to the Lions Vision Center, Inc. and is sponsored by the Arizona Ophthalmological Society. Members of the Arizona Ophthalmological Society provided the funding for the 2012 Ford F-350 truck.

These members unite with other agencies and organizations to bring medical eye services to outlying areas of Arizona where ophthalmic care is not readily available. Arizona Ophthalmologists, who are in private practice, volunteer their time on the Medical Eye Unit, and receive no remuneration.

A large percentage of the Ophthalmologists in Arizona have volunteered their time and service on the Unit, which has been in operation since January 1976. The Unit covers around 13,000 miles annually to aid numerous people living in rural parts of Arizona.






