The Department of Public Safety has been generous with us in providing his services at minimal cost to the towns.

The Church of the Good Shepherd. They want to engage community members and seek their ideas and help for rebuilding the Gila River since the fire, and possibly to develop a town park to make the river more accessible and also to serve as a fire break. This meeting will begin at 2 p.m. Call Town Manager Anna Flores for more details.

# Man, horses killed in early morning accident

An accident early Sunday morning near Dudleyville left one man and four horses dead.

According to the Arizona Department of Public Safety, a black passenger vehicle traveling on Hwy. 77 ran into a

group of about eight horses that were on the roadway at milepost 131.9 at approximately 4:17 a.m. Four horses were struck.

The driver of the passenger vehicle identified as Joseph P. Ragsdale, 31, of

Dudleyville, DPS said, died of his injuries at the scene. Three horses died at the scene as well and one more had to be put down due to injuries.

A second vehicle, a pickup truck driven by William Jones, 43, San Manuel, stuck one

of the deceased horses. The vehicle was slightly damaged and Jones was uninjured.

Hwy. 77 was closed during the collision investigation and traffic was re-routed through Dudleyville.

The collision remains under investigation.

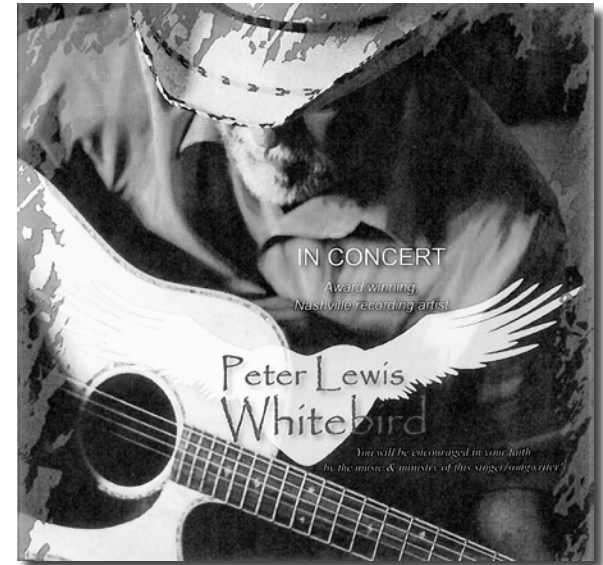

Release of Draft Environmental Impact Statement and Notice of Public Meeting

Proposed Tailings Storage Facility: Ray Mine – Pinal County, Arizona

The U.S. Army Corps of Engineers, Los Angeles District ("Corps") has released a draft environmental impact statement (EIS) for a tailings storage facility that Asarco LLC ("Asarco") is proposing for the Ray Mine in Pinal County, Arizona. The draft EIS is available on the Corps' website at <http://www.spl.usace.army.mil/Missions/Regulatory/ProjectsPrograms.aspx>.

To comply with Corps' regulations associated with Section 404 of the Clean Water Act, Asarco submitted an application to the Corps in 2013 for the proposed tailings storage facility. To evaluate the project's environmental effects on the human and natural environment, the Corps has prepared a draft EIS in compliance with the National Environmental Policy Act (NEPA).

Asarco has proposed to construct and operate a tailings storage facility in the Ripsey Wash watershed, an ephemeral wash that is tributary to the Gila River. Asarco has stated that this facility is required to support continued long-term copper mining activities at the Ray Mine. Tailings from the Ray Mine concentrator would be transported via a new tailings pipeline that would cross the Gila River near the current Florence-Kelvin highway bridge. Water would be recycled back to the Ray Mine concentrator from the proposed tailings storage facility. The proposed facility is designed to store approximately 750 million tons of tailings and would have a facility footprint of approximately 2,574 acres once completed.

The Corps is hosting a public meeting on this draft EIS on Wednesday evening, February 24, 2016 at the Ray Elementary School cafeteria in Kearny, Arizona from 6:00 to 9:00 PM.

The public meeting will allow interested parties to learn about the results of the draft EIS, the Corps' regulatory obligations under its 404 permit process, and the plans and schedule for completion of a final EIS. The meeting will open to the public at 6:00 pm; the Corps will make a presentation starting at 6:30 pm. At the conclusion of the presentation, the Corps will provide an opportunity for any interested parties to make an oral statement that will be recorded by a court reporter for the administrative record. A maximum of two minutes speaking time per person will be provided, at the discretion of the Corps.

The Corps is soliciting public comment on the draft EIS and requests that any comments be submitted in writing to Michael Langley, Senior Project Manager, U.S. Army Corps of Engineers, Los Angeles District – Arizona Regulatory Branch, 3636 North Central Avenue, Suite 900, Phoenix, Arizona 85012-1939 or via email at [michael.w.langley@usace.army.mil](mailto:michael.w.langley@usace.army.mil). The Corps requests that commenters include their full name, physical address and the project title "Ray Mine Tailings Storage Facility Project" with any comments. 
