CCEDC offers leadership training to local residents; deadline to apply Feb. 27

The Copper Corridor Economic Development Coalition is looking for local residents to step up into a leadership role in local communities.

But they aren't going to send those new leaders out into the public without a little training and guidance.

The Copper Corridor Economic Development Coalition or CCEDC has partnered with Valle del Sol to bring a Leadership Academy to the Copper Corridor area.

Valle del Sol is an organization that offers

primary care, behavioral health and social services to communities in Arizona and New Mexico. They were founded in 1970 to fill the gap in behavioral health and social services provided to the Latino community and underserved populations.

They also have a very successful leadership development program, the Hispanic Leadership Institute (HLI), which is open to individuals of all diverse backgrounds. This is the program that the CCEDC plans to bring to the Copper Corridor.

The Hispanic Leadership Institute-Copper Corridor is a 10 week leadership institute designed to educate and assist



individuals in developing their leadership skills to take an active part in the community by serving on a non-profit/government board or commission. The mission of HLI-Copper Corridor is "to promote individual development for increased participation in leadership roles and to serve as a principal education and networking resource for expertise and advocacy on leadership issues impacting Arizona communities." HLI-Copper Corridor will proactively assist participants with tools and skills to prepare for leadership roles at the local level and beyond.

"I have had the pleasure of addressing the Valle del Sol Hispanic Leadership Institute for a couple of decades," said Pete Rios, Vice-Chairman of the Pinal County Board of Supervisors. "I have consistently been impressed with the quality of candidates and the content of program. Besides teaching how to impact political and social systems, the Institute provides practical knowledge on the 'nuts and bolts' of the governmental process. I would encourage anyone who is interested in improving the quality of life for themselves, family and neighbors to get involved with this terrific leadership opportunity and become a voice for societal improvement."

The HLI-Copper Corridor plans on holding sessions in many different locations throughout the Copper Corridor so participants will be exposed to other communities and local leaders. The different sites have not been determined but will be based on those who plan to attend. Sessions will be held weekly for 10 weeks from 6-9 p.m. There is also a mandatory all day Leadership Retreat (date and location to be determined).

The curriculum will offer the participants an opportunity to become involved with top business and public policy authorities in a continuing dialogue about leadership and those issues important to residents of

the Copper Corridor.

HLI-Copper Corridor has a competitive application process open to individuals of all diverse backgrounds. The tuition cost of the program is \$200. The deadline for applications is Feb. 27. Sessions for HLI-Copper Corridor Class of 2015 begins Wednesday, March 18.

Elizabeth Magallanez, President of CCEDC, is a graduate of the HLI Leadership Institute and is excited by the possibilities that this partnership brings to the Copper Corridor.

The price of copper has been dropping. Six months ago it stood at \$3.25. Last week it had plunged to \$2.48, and has since crept up to about \$2.60.

The price of copper is perplexing. The experts can't tell you much about the why and wherefore of rising or falling copper price. All we know is that international affairs have about the same weight as supply and demand. China's role in this is a big factor, and so is the conflict in the Ukraine, for the United States, China, and Russia are participating in a complex economic dance.

When prices go down, about the only response mines have is to reduce output to make copper more valuable. The word on the street is that ASARCO will soon have layoffs and will reduce its tonnage. It is likely that solid details will be released later this week, but in the meantime the people of Kearny and the whole Copper Basin will have to begin a "rethink" about life in the next several months.

This has happened time and again. It's the nature of a mining economy. But it's never pleasant when things go South. No one who has

Several letters of nomination were received for Martina and they say it all. Quoting from the letters of nomination we find out the following:

In the 70s, 80s and 90s there was a great deal of rivalry between the towns of Hayden-Winkelman and Kearny. But as people moved or passed away, the residents who remained realized that they had to depend on one another from the other communities. A person who helps bring the Tri communities together is Martina Burnam. Martina does not care about rivalries or keeping the towns separate. She strives to help in activities that benefit all of our communities.

Martina is vice-resident of the Copper Community Action Board (CCAB). This group has participated in different activities, from Breakfast on the Bridge and painting a house, both in Winkelman, to Haunted Night at Pinitos Park in Hayden, to Kearny cleanup day, ice cream social in Kearny, picking up trash in Winkelman, Hayden and Dudleyville. CCAB has also hosted community concerts, produced by Martina at

the two local schools. These concerts have encouraged residents to show off their singing abilities. These were fundraisers for CCAB to obtain their non-profit status. Thanks to the hard work of Martina and the CCAB members their paperwork is underway.

Martina is an avid hiker and likes exploring our beautiful area. She has been the president of the Aravaipa Hiking Club since 2004. Martina has been a member of the Copper Basin Chamber of Commerce for many years and has spearheaded Winter Wonderland and helped with Pioneer Days. She has advocated through the chamber for activities in the Hayden, Winkelman and Dudleyville areas. She started the Copper Basin Idol in 2005 and has brought the Women's Expo to Winkelman. This year the event will be on Feb. 28.

Other letters state that she is a loyal friend and has helped host fundraisers for those in need. She has served as a mentor, is a good citizen and has a passion for the Copper Basin area. She volunteers countless hours of her time to lead or help with functions or events with no hidden agenda. Her mission is very transparent to those who work with her and it motivates us to follow her and help her to accomplish her vision. Her humbleness does not let her recognize the gift she has to inspire and move people but that is what makes her unique.

Another project dear to Martina's heart has to do with celebrating her heritage. Her father Jerry was working on a project to recognize his father, Martina's grandfather, Lon Burnam for the work he did for Hayden in its early days of incorporation. This was after Kennecott gave up the town to what is now the Town of Hayden. Jerry died before he could get the project underway and Martina in her spare time has tried to organize a campaign to recognize her grandfather.

In 1952 a group of PTA members wanted to start a circulating library but Lon thought, "why borrow books from the schools for a circulating library when we could buy our own books and start our own library." Due to his work and dedication the Hayden Library was built. His community resume almost sounds like Martina's. This was Lon Burnam as a PTA member working with others to make his town a better place to live. But the tall, soft spoken metallurgical accountant, is active in many other community activities, of which there were many, and all civic in nature which included Knights of Pythias especially scholarships for students, scouting, Campfire Girls board, Hayden-Winkelman Recreation Board, Gila River Sharpshooters, and Hayden Methodist Church. These only name a few of many.

Just like her grandfather, Martina has certainly contributed more than is required of a citizen.

Cascabel Working Group, Friends of Aravaipa Region respond to BLM approval of SunZia project

Tucson, Arizona – On January 24, 2015 Secretary of Interior Sally Jewell signed the formal federal approval for the SunZia Southwest Transmission Project, a high-voltage transmission line that will cut north along the San Pedro River, destroying previously untouched wildlife habitat and disrupting primary wildlife migration corridors between the Galiuro and Santa Catalina/Rincon Mountains. The final route selected by the Bureau of Land Management (BLM) would irreparably harm some of Arizona's most important natural and cultural resources and irreversibly damage a unique and important ecosystem.

SunZia is proposing to build two 500-kilovolt transmission lines between central New Mexico and Arizona purportedly to

deliver predominantly wind-generated electricity to Arizona and California. This project would create one of the largest new utility corridors in the western U.S. and cause significant harm in some of the most important wildlife areas in Arizona. The damage that this project would do to Arizona's lower San Pedro Valley region cannot be justified given the questionable and unproved claims that this project is needed to promote renewable energy resources.

"The harm this project will cause to our river valley is entirely unnecessary given that the project is not needed to meet any renewable energy needs in Arizona or California and would squander both financial and environmental resources if built,"

says Mick Meader, Co-Chair of the Cascabel Working Group, formed by Middle San Pedro Valley landowners concerned about the project. "California and Arizona have both demonstrated that they can easily meet present and future renewable

- Shall **not** be a member of the Democrat Party and shall reside **outside** of Maricopa County
- Shall have been registered to vote continuously recorded for at least five years immediately preceding appointment with the same political party or as an independent;
- Shall be committed to enforcing the Act in an honest, independent and impartial fashion and to seeking to uphold public confidence in the integrity of the electoral system;
- Shall be a qualified elector who has not, in the previous five years in this state, been appointed to, been elected to, or run for any public office, including precinct committeeman, or served as an officer of a political party;
- No commissioner, during his or her tenure or for three years thereafter, shall seek or hold any other public office, serve as an officer of any political committee, or employ or be employed as a lobbyist.

energy needs with their own resources. Building this project will not increase the use of renewable energy, merely rearrange which resources are developed, if even that."

This routing would impact 40 years of conservation efforts by federal and state government agencies, corporations and conservation organizations, which have spent more than \$40 million to protect more than 200,000 acres of valley lands. The San Pedro River is the last undammed river in the Desert Southwest and the principal migration corridor for birds, plus it hosts the greatest mammal diversity in North America. The alternative SunZia route that the BLM considered – the one preferred by SunZia proponents – threads its way between the Aravaipa Canyon, Galiuro Mountains and Santa Teresa Wilderness Areas and would fragment the largest block of intact habitat in Arizona outside the Grand Canyon region.

"Siting this proposed transmission project in some of Arizona's most sensitive and unfragmented lands is unacceptable," said Sandy Bahr, chapter director for Sierra Club's Grand Canyon (Arizona) chapter. "Due to the known significant negative impacts this project would have on the San Pedro Valley and the important habitat it provides, the impacts on cultural resources, and the fact that the project is just as likely to carry fossil-fueled electricity as renewables, Sierra Club strongly opposes the SunZia Transmission Line."

In addition, the BLM's use of an idealized and untenable energy development scenario to assess cumulative environmental impacts negates much of the analysis for the project. The BLM essentially dismissed public comment on the Draft Environmental Impact Statement, Resource Management Plan Amendments, and Environmental Assessment. Such dismissals are inconsistent with the National Environmental Policy Act's requirements for a full analysis of reasonable alternatives; an assessment of the direct, indirect, and cumulative impacts; and the intent of the law to create the clearest possible picture of the project.

"We strongly object to sacrificing high-quality environmental values to such an inadequate and corrupted process and will work to correct this however we can," said Peter Else, chair of the Friends of the Aravaipa Region, a group of lower San Pedro
