were able to give \$4,500 worth of scholarships.

Every year the Rotary Club of Kearny also organizes their "BookShelf Project." They provide the supplies for the Ray High School Shop class to build bookshelves that are presented to every first grader moving on to second grade at the end of the school year. The Rotary Club also buys a selection of eight to 10 books for each student to start their book collection for their bookshelf. These students continue to receive additional books through the end of the third grade. The Rotary Club arranges additional funding from a SaddleBrooke Outreach Program Grant to help with the book purchases. Hundreds of Ray school students have discovered a love of reading through this program, now in its 10th year!

Last year the Town of Kearny needed a \$1,100 hose diffuser so that our fire department could pass state inspection of fire hydrants. Rotary paid for and donated the diffuser.

Rotary donated \$600 to pay for the music and rights for the Ray High School Marching Band to play the theme from the movie "Frozen" during half-time shows for this past football season as well as in parades and at competitions. For the past six years the Kearny Rotary Club has sponsored and hosted the annual Scholarship Banquet in the courtyard of the General Kearny Inn. They cook and serve a nice meal for all the scholarship recipients and their families as a prelude to the awards ceremony as a way of providing a nice setting for all the recipients to be featured in the spotlight in front of their parents, grandparents, and peers.



# County Makes Important Donation for Veterans

he recently released movie *American Sniper* has launched a conversation in this country on the treatment of our veterans once they returned from combat activities. This

includes veterans from WW II, Vietnam, etc. It's a conversation that is overdue when you see the effects of soldiers suffering from PTSD and other injuries, some seen, some unseen.

In December, the Board of Supervisors unanimously voted to sell (donate) our unused Discovery Class RV Conversion vehicle to Hiring and Helping Our Heroes of Pinal County Incorporated for one dollar.

The RV had been purchased by the county in 2007 for use in the Maricopa area as a mobile public health clinic. We received a grant from the Gila River Indian Community to purchase the vehicle. In 2012, the county opened a permanent health clinic in Maricopa making the RV obsolete.

Since that time the RV sat unused in our

# Pinal County Should Not Subsidize the Federal Government

S ubsidizing the federal government. Not exactly the words everyone wants to hear.

There has been a lot of speculation on why the Supervisors cancelled the contract with with Immigration and Customs Enforcement (ICE).

Pinal County had the contract with (ICE) to house their detainees. In short, we were losing millions on an agreement that was signed in 2006. In a prudent move, the Board directed our Internal Audit to look at the contract to see what the true numbers were when it came to what we were receiving from ICE.

Following that audit along with an independent audit, it was determined the taxpayers were actually subsidizing the federal government to the tune of \$3.5 million a year.

In 2013, the Sheriff even created a contract coordinator position to oversee negotiations from the Sheriff's side. I personally supported the creation of this position because it showed that the Sheriff was also very concerned about the loss of taxpayer money. A memo from that office to ICE admits the department was losing around \$2 million a year.

Looking at the costs of running the detention center, in fiscal year 2011/12 the per diem rate recommended from the study conducted by MGT, the breakeven point to house ICE detainees was determined to be in the area of \$13.7 million. Instead we were bringing in only \$9.6 million due to a per diem rate set in 2006. That is quite a loss to the county general fund.

Fact, we were losing money and the Board of Supervisors stepped up and took the necessary action to remedy a bad financial deal. It is terribly unfortunate to have to lay off 43 employees in January. I have worked among those people and I feel for their situation.

It's time to stop playing politics when it comes to the taxpayer's money.

As a youth, I remember my late grandfather who always talked to us about standing up for our Apache People and protecting what belongs to us Apaches. That includes our water, our land, our natural resources and our identity as being Apaches. This is why I am speaking out against what is happening to us as Apaches and many of you don't know the real story. The Southeast Arizona Land Exchange

Bill that was passed last December, 2014, sabotages one of the most important and basic environmental and cultural protection laws in the U.S., which is the National Environmental Policy Act (NEPA). Under NEPA law, the public would have been able to comment and obtain information from the USFS about the significant environmental , cultural and human right impacts and harms caused by this mine. Exempting the mine's structure and plan of operation from NEPA is like taking away the Magna Carta or being exempt from the U.S. Constitution or taking away the Bill

# Rough section of SR 77 to be smoothed by ADOT, Rios says

MAMMOTH - Pinal County Board of Supervisor's Vice Chairman Pete Rios is pleased to announce that the Arizona Department of Transportation (ADOT) will begin a maintenance/repair project on a section of State Route 77 north of Mammoth.

"I have been working in conjunction with Senator Barbara McGuire's office to find a solution to a rough section of State Route 77 between mile posts 116 and 120," the Vice Chairman said. "Earlier this week Senator McGuire reported that ADOT will be working on that section of the road beginning on March 4. This has been an

issue I have been concerned about for the past year."

According to ADOT, they will be carrying out a project to remove the friction coarse from Wednesday, March 4 until Thursday, March 5. They will then fog coat the roadway to seal it and come back a couple of months after to perform a crack seal. In the fall, they anticipate chip sealing the roadway to finish off.

"What I understand is that the friction course placed on the road is raveling and creating ruts for drivers on the highway," Rios said. "ADOT will be removing it and completing the work to make the road

here should we begin? Maybe with the fact that our old water system has cost us in the neighborhood of \$300,000 over the last few months, and that we have had to dip into our financial reserves. Or maybe we can start with the good news that, after stripping off the old fiberglass lining on the town pool, we happily discovered that the underlying concrete form does not have structural problems

(but the restoration of the lining and some other work will cost about \$222,000).

Perhaps we should begin with the ATV corridor built several years ago with a grant on the Copper Basin right-of-way, enabling unlicensed vehicles to get to the off-road area past the water tanks. The corridor needs improvements, but the unlicensed vehicles it originally was built for have declined in number, to the point where the corridor is rarely used. Should the town continue to provide the corridor? Community input is needed.

How about the layoffs at ASARCO? How are they affecting those who are now without a job? And what about the businesses in this area?

# **CPR class held in Dudleyville**

On Saturday, Feb. 7 a CPR training class was held in Dudleyville. The training was put together after Lora Snow from Kearny ambulance had spoken at an Aravaipa Property Owner's Association meeting and suggested it. Residents of Aravaipa felt that due to the length of time it takes for an ambulance to get to Aravaipa that it would be a good idea to learn CPR. Members of the Aravaipa Property Owners Association contacted Olivia, Chairman of the Aravaipa Fire Department and the class was organized.

The CPR class was taught by Karen Hauca, Bill Predgo and Cheryl Primero–Predgo. All three instructors are former fire department personnel and first responders. The class was taught for free. The instructors said they were "not in it for the money but to save lives". There was a charge of \$10 for the Red Cross certification card.

Twenty people attended the class which included learning to operate an AED (Automated External Defibrillator). Class members were from Dudleyville, Aravaipa, Kearny and the Hayden-Winkelman area. The Dudleyville Fire District is looking at starting a Community Emergency Response Team (CERT). The instructors are certified to teach CERT and are interested in doing a combined CPR – CERT training.



# Lady Cats knocked out in second round of state tourney

The No.13-seed Ray girls' basketball team advanced to the second round of the 2015 Division IV State Basketball Championship tournament before No. 4-seed Phoenix Country Day ended its season, defeating the Lady Cats, 62 - 43. The Lady Cats faced No. 20-seed Tohono O'Odham in the first round of the tournament, which took place on Feb. 20 at the Prescott High School. The Cats cruised to the 56 - 38 victory against the Eagles, who entered the game with a record of 14 - 3.

The Lady Cats, who finished their season with a 17 - 9 record, fell behind early


Despite the disappointment of their season ending, the Lady Cats had an outstanding season, one that could result in a top 10 ranking at season's end.


