His hospital crib consisted of bedding in a cardboard box placed on the open lid of a stove for warmth. He joined his railroader family living in a remodeled box car right by the tracks. His father, grandfather, and uncle were all railroaders. His father,

His grandfather and great uncle came West from Pennsylvania in 1906, working for the Santa Fe as well. His grandfather, Samuel Lichtenburger Hosler, was the manager of the Childs Power Plant in Fossil Creek Canyon for a time. His paternal grandmother came west from Ohio at about the same time, providing housekeeping for her father, a traveling salesman. The couple married in Winslow and returned to Ohio for a time before living the rest of their lives in Arizona.

Sam's mother, Ada Lucretia Gould Hosler, came to Arizona from Oklahoma in the 1930s, settling in Pine. For a time the family lived in the historic Strawberry Schoolhouse until they could be settled in their own home. Sam's parents purchased property in Strawberry in the early 1940s and are said to have been instrumental in bringing electricity to the mountain town.

Sam attended elementary school in Seligman, and high school in Winslow. He then attended the University of Arizona, graduating in 1967, and then Bexley Hall, an Episcopal seminary in Ohio. He met and married his wife, Carol Edith Smith, at that time. He returned to Arizona to be ordained an Episcopal clergyperson at Trinity Cathedral in 1970 where he served for two years.

The couple's sons, Joshua Luke and Seth Stephen, were born while the family resided in Scranton, Pennsylvania. Subsequently, Sam also served Episcopal parishes in Delaware, Idaho, and the Upper Peninsula of Michigan before returning to serve, with his wife (also an Episcopal priest) in Holbrook and Winslow. They retired to Kearny in 2005 where Sam enjoyed being Mayor of the small copper mining town for a term. He worked tirelessly, even after his official term, to improve the health of the town. His biggest regret was not being able to complete, with others, the local purchase of the uptown. He always enjoyed the sound of the



Copper Basin Railway trains as they zipped by their home near the tracks. The flag at Kearny Town Hall was hung at half-staff over the weekend in his memory.

Sam is survived in his immediate family by his wife of 50 years, Carol Edith Smith Hosler; son, Joshua Luke Hosler, an Episcopal priest in Seattle and his wife and daughter; son, Seth Stephen Hosler, a translator in Japan and his wife and son; sister, Martha Hosler Ahrens of Strawberry and her husband and daughter, and multiple nieces, nephews, and cousins.

A Celebration of Life will be held at Good Shepherd Church in Kearny on Saturday, Feb. 29, at 11 a.m., officiated by the Rt. Rev. Jennifer Reddall, Bishop of the Diocese of Arizona. An overflow crowd is expected but arrangements are being made for that. Rather than having an overabundance of flowers, Carol is suggesting that memorial contributions be made to Good Shepherd Church for its life and ministry in the Town of Kearny. 



Raise your hand if you thought at the season's outset that the San Manuel boys' basketball team would finish its season just three wins shy of a state title.

Outside the group in the locker room every game, you're probably in the minority if your hand is raised.

The then No. 14-seed Miners defeated Valley last Wednesday, 61 – 55, to qualify as the No. 13-seed in the 2A State Championship Tournament, where San Manuel played No. 4 Glendale Prep Academy, which earned one of the eight automatic bids in the 16-team championship bracket.

Led by three players that combined for 53 points – Javy Tamayo (19), Benny Laguna (18) and Javi Duarte (16) – the Miners pulled off the biggest upset of the tournament, defeating the Griffins last

Friday night at Prescott High School, 70 – 65.

"We had a good game plan and the boys executed it to perfection," San Manuel head coach Damon Lovato said. "We knew they would live or die by the three [and] that's what made it interesting (at the end)."

No. 5-seed Rancho Solano Prep defeated San Manuel in the quarterfinals on Saturday, 64 – 39, ending the Miners' season.

Despite the loss, the Miners made the run they thought they could make all season, even if some didn't think it was possible. In the end, they bet on themselves and sometimes that's the surest bet.

"I'm sad it's over," Lovato said. "This group of seniors and I spent a lot of time together to get to our goal. We may have fell a little short, but I'm grateful for the journey with them. I have coached them in over 250 games. I'm going to miss them."

Hayden, San Manuel wrestlers compete at State Championships

A trio of wrestlers from Hayden and San Manuel High Schools competed at the AIA State Championships, which took place Feb. 14-15 at the Findlay Toyota Center in Prescott Valley, Ariz.

Hayden senior Pablo Acuna (195), a No. 2 seed, defeated Chinle's Dion Tossie in the first round before a loss to Yuma Catholic's Jaco Webb, a No. 1 seed. Acuna advanced in the consolation bracket, before being eliminated by Parker's Anthony Taylor, who placed sixth at the championships.

"He did well," Hayden head coach Ruperto Gonzales said, adding that this was only Acuna's second year of wrestling. "He could've qualified for state all four years if he started sooner. He's got a big heart."

San Manuel junior Adrian Romero (182), a No. 2 seed, lost his opening match before advancing in the consolation bracket with a 5-1 decision against No. 4-seed Jerome Peshtony of Ganado. Romero was eliminated by junior Cylis Gonzales, a No. 2-seed from Winslow. San Manuel junior TJ Madrid, a No. 4 seed, suffered consecutive defeats at the championships, first against top-seed Broden Harold of ALA-Gilbert North and then in the consolation bracket to No. 3-seed James Thomas, a sophomore from St. John's.

"(I) and the coaching staff couldn't be any prouder of what (the boys) accomplished," San Manuel head coach Michael Borg said. "Our season didn't end at state, we just started next season.

"As we all know wrestling is a tough sport [and] we learned a few lessons all year and also at state. Now it's just time to get back and work on what will get us to the next level."

Congratulations to all of the wrestlers for a great season.

The Wilson Barn at Rancho Linda Vista is currently hosting the eclectic and colorful drawings of Victoria Guerrero. Vicki's art is unusual in that is done with Sharpie pens on poster board. She has been drawing seriously since 2010. She says she likes to put on good music from the 1970s and then starts drawing. Her paintings "are all about peace, love and happiness." Speaking about the bright colors of her drawings, Vicki says, "colors make anyone feel good." Her show runs until Feb. 29. Victoria would like to thank Mary Ann Davis for the opportunity to exhibit her work.

At the Rancho Linda Vista Gallery, Juan Enriquez Portraits & Jeff Litvak Tarot is a dual exhibit on display. Juan grew up in Mammoth and is a San Manuel High School graduate and one of the founding members of Raices Taller Gallery in downtown Tucson. Juan's exhibit includes portraits of family members including a large portrait of his uncle, Juan Ramirez Jr., taken from a photograph while he served in the army in Vietnam in 1969/1970. His uncle was at the exhibit's opening reception.

Jeff Litvak is a friend of Juan Enriquez. His Tarot exhibit is made up of paintings of Tarot cards. He said that many artists have done paintings of Tarot. It is a tradition over the years. He does his own interpretations of the Tarot. The dual exhibit runs through Feb. 29.

At the Oracle Center for the Arts (ORCA), two local artists are exhibiting their work. Judy Walsh and Carol Goldberg are the artists with the show "Over the Edge". Judy's art is

encaustic painting and Carol's work is clay sculptures. Judy will be part of the Oracle Artist's Studio Tour.

Encaustic is an ancient beeswax based medium containing pigments. It was used by the Greeks, Romans and Egyptians in the 1st Century B.C. and is now finding popularity with contemporary artists who are attracted by its versatility.

"My work is about that which lies below the surface ... the hidden, the unconscious, the surreal. Painting spontaneously without plan, I respond directly to the paint, color and texture. Like a young child, I discover what I am painting while I paint; images form and reform, dissolve and resolve in a non-logical way. As ideas and forms are discarded, major destruction takes place. I often flip the plane and work upside down removing layers of paint to expose previous textures, figures and forms. Over time, shapes and symbols reappear without my conscious

decision to use them," Judy said.

"As an artist, my work is the process I go through to trick and frustrate that part of me that follows rules, uses logic and sees the world 'the way it really is," she added.

Carol grew up in Montreal, Canada and moved to the U.S. 30 years ago; first to Pennsylvania and 10 years ago to Arizona. She painted and drew the human figure for many years but since moving to Arizona has mostly worked in clay.

She creates both functional and sculptural works of art; but her heart lies in creating sculptures of the human figure. The figures range from characters that are whimsical to those that convey a political/social message. While some figures stand alone, others are shown interacting with a second or multiple figures.

Carol tries to capture the spirit of what she is sculpting: the figure evolves slowly as she manipulates the clay. She may start with an idea; however, the end result comes from the dialogue she has with the clay as she builds. As the idea evolves it becomes a conversation between her and the clay. In the end, she hopes that the sculpture will speak to those that view it.

Over the Edge will be exhibited at ORCA, 700 Kingston Street in Oracle until March 29, 2020.
