They were parishioners of St. Elizabeth Ann Seton Catholic Church and took great honor in practicing the Catholic faith and instilling it in their children.

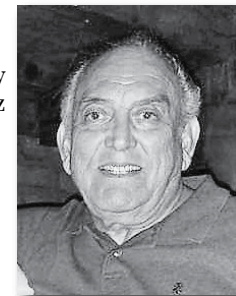

From the Mayor's Desk: Projects for the Town of Kearny

Hello Kearny! I am so excited to officially be the Mayor of our wonderful little community. Thank you so much for putting your trust in me to represent you. I was elected on Aug. 4, 2020 and sworn in as Mayor on Dec. 21, 2020. I hosted my first meeting on Jan. 18, 2021. While I was waiting to be sworn in,

I completed my Grant Development Certification through ASU's Lodestar Center. In December, I completed my Arizona League Training for Newly Elected Officials. Grant research has been ongoing, researching grant opportunities for our community. Right now is the time to apply for Park

grants and I am on top of that. In August, I researched a grant for the lake and was directed to Friends of Reservoirs and will be applying for a large project grant for our reservoir at Kearny Lake Park.

I had an opportunity to speak to our Public Works Manager about projects the town is working on. Among those is the repair of the wells and maintenance to keep them in good operating condition. It is very important that we have this back up system in place so that we do not run out of water. Because it has been a very dry year, and we are in a drought, the water allotted to us is less than in previous years. There are things we can do to conserve on our water usage. Because of our reduced allotment, we must be very careful as to how we use our water. Reclaimed water will be used to water the Little League fields. We may look at ways to make Hubbard park drought tolerant while also enhancing the landscaping. You can help save water by reducing your water usage. If you have grass, consider watering for shorter periods of time. We must all be committed to conserving water to help our town.

Road paving will be commencing again so that we can get our streets in shape. Several

people have asked about the road from the airport to the wastewater plant area and that will also be getting an update.

I am so grateful to the San Carlos Apache Tribe and Gaming Enterprise for their generous donation of \$17,499.50 for the Town of Kearny's ambulance service.

The ambulance cost has been a strain for the town budget and the town has been in an uphill battle to maintain our service. Copper Valley Regional Medical Center has been working with the community and surrounding areas to find a solution to the issue. We are hopeful that the ambulance will be staying under the CVRMC plan. Along with such changes for the ambulance we are also going to be seeing a redevelopment of the CVRMC facility. An article in the August 29, 2020 *Copper Basin News* mentioned: "The Copper Basin Community Health Care Foundation has received a Grant from the Brownfields Assistance Program and the Arizona Department of Environmental Quality. The Grant will provide funds for assessment and cleanup of asbestos and lead materials at the site of the Kearny Medical Clinic. The Grant will allow for future redevelopment of the

Justice of the Peace Nancy Discher retires from office; Board of Supervisors to appoint replacement

The Pinal County Board of Supervisors last week accepted the resignation of Nancy Discher, Justice of the Peace over Precinct 5, and set out the process to appoint a replacement to see out her remaining term.

Judge Discher, who has served the Copper Corridor Justice Court, representing much of eastern Pinal County since January 2015, retired from office effective Jan. 20, 2021.

Judge Discher was a dedicated servant to the people of Precinct 5 over the past six years, implementing a redistricting plan that combined three JP courts into the one Copper Corridor Justice Court.

Judge Shaun Babeu, from Precinct 1's Pioneer Justice Court, paid tribute to Nancy Discher, "Judge Discher has been a friend and colleague for the past six years serving as Justice of the Peace for the Copper Corridor Justice Court. Judge Discher is a dedicated public servant who cared about every individual that came into her courthouse and operated her court in an efficient and effective manner.

We wish her well in her well-deserved retirement."

Precinct 5 sits within Supervisor Districts 1 and 4. District 1 Supervisor Kevin Cavanaugh commented, "Pinal County has been blessed to have a person of such incredible talent and integrity as Nancy Discher serving as a Justice. I am sad to see her go and am committed to appointing a person in JP 5 who measures up to her high ideals."

The Pinal County Board of Supervisors are constrained by law on how to select her replacement.

The law that covers vacancies in county offices makes a distinction between whether the vacancy occurs within the first two years of an official's term or afterward. In the case of a mid-term vacancy that occurs after the completion of the first two years of service, Arizona Revised Statute 16-230.A.2 is invoked. This states:

If a county office becomes vacant, the Board of Supervisors shall appoint a person of the same political party as

the person vacating the office to fill the portion of the term until the next regular general election. If the person vacating the office changed political party affiliations after taking office, the person who is appointed to fill the vacancy shall be of the same political party that the vacating officeholder was when the vacating officeholder was elected or appointed to that office.

Judge Discher was elected as a Republican, so the Pinal County Board of Supervisors is only accepting applications from registered Republicans for the Justice of the Peace position, Precinct 5, Copper Corridor Justice Court.

To be eligible for appointment as Justice of the Peace, Arizona law specifies that each potential candidate meets the following criteria:

- Must be a legal Arizona resident living within the Precinct 5, Copper Corridor Justice Court
- Must be registered to vote
- Must be able to read and write the English language

- Must be at least 18 years of age
