February is Heart Month

t's here! February, the most romantic month of the year. The month where we celebrate love on Valentine's Day. We buy or loved one chocolates, flowers and other trinkets to show them how much we love them. So how did February get its name? February is derived from the Latin word "februs" meaning "to cleanse." The month was named after the Roman Festival, Februalia, a month-long festival of purification and atonement. Now that you know how February got its name and what holiday we all think of when we hear "February" what do we do you know about our heart?

Here are some facts on the organ we call our "heart".

The average human heart is constantly working 24 / 7 to pump blood throughout your body and it pumps approximately 2,000 gallons of blood each day. A healthy adult heart should beat anywhere from 60 to 100 times a minute while at rest. Do the math, and it adds up to around 100,000 beats a day and 2.5 billion beats in the average lifetime. A woman's heart beats at a rate of six (6) beats per minute faster than men. But because a male heart is bigger (by about 25 percent), so it can pump more blood in a single beat.

Newborns have the fastest heartbeats, at 70 to 190 beats per minute, and the hearts of well-trained athletes tend to beat slower, at a rate of 40 to 60 beats per minute.

Most people believe our heart is located on the left side of our chest but that's not true. Our heart is located in the center of the chest. That's why when you perform CPR you place your hands in the center of the chest directly over the heart.

Another thing, while it may be a compliment to be told you have a "big heart" actually having a big heart isn't





Miners defeat Vandals on Benny's buzzer beater

San Manuel senior guard Benny Laguna drained a 14foot floater at the buzzer last Friday night at Miami to give the 16th-ranked Miners a 43 – 41 victory against the No. 12 Vandals.

"It actually wasn't," the 5-foot-8 Laguna answered



afterwards when asked if the final play was designed for him to take the final shot. "It was a play that we ran, and it didn't go as planned. I was the last resort. I went up for a three, but I knew I wasn't going to make it. So, I drove and put up a little easy floater and it ended up going in."

Miners' head coach Damon Lovato acknowledged that Laguna wasn't the first option on the play – Caleb Quintero then Javy Tamayo were. The Vandals defense on those two left Laguna with the chance to be the hero and he didn't miss – his chance or the shot.

The Miners were mad following a lopsided 64 – 35 loss at home to Miami on Jan. 7 and on Friday they got even.

"We've been playing better on the road all year long," Lovato told the *Miner*. "We thrive on going into those hostile environments, where there is the student section, the band is there, and we're on our own. I think the boys feed off that. We really wanted to play the game we know we should've played at home."

Laguna fished with nine points, three assists, a rebound, and a steal. Senior Jose Moreno filled the stat sheet with

10 points, nine rebounds, five assists, three steals. Senior Gilbert Pinedo added eight rebounds. Tamayo scored a game-high 16 points in the win.

After avenging the ugly loss to the Vandals earlier this season and the region tournament starting in about a week, the Miners are feeling good as February Frenzy approaches.

"It was a really good win and we needed that game to reset our confidence a little," Laguna said. "We just have to keep pushing and hopefully we can get ourselves a championship.

"We've been putting in work all season and doing great, but we still need to come together as a team to do what we have to do."

According to their head coach, the Miners are doing just that in timely fashion.

"We're playing good ball right now," Lovato said. "We're getting hot at the right time."

Mark Fouxman is a man of many talents — concert pianist, charismatic and inspiring piano teacher, inventor, audio and electronics engineer, microphone designer, and owner/chief designer of a successful microphone production company. 

necessarily a good thing. An enlarged heart is a symptom of heart disease. The average adult heart is about the size

Here's a question for you ... What do you think is the most common day of the week when people experience a heart attack? The most common day of the week for heart attacks is Monday. The European Journal of Epidemiology found that the incidence of heart attack was 20 percent higher in men and 15 percent higher in women on Mondays. Other popular heart attack days are Christmas, the day after Christmas and New Year's. There are many factors that contribute to this phenomenon.

Our bodies contain three different kinds of blood vessels: Arteries carry blood from the heart to our other organs, veins carry blood from organs and limbs back to the heart, and capillaries connect the two. Together, all of the arteries, veins, and capillaries in the body are long enough to go around the world more than twice. Our height plays a role in exactly how many "miles" of vessels are in our body. How tall are you? Think about it.

Many people have heard of a thing called hardening of the arteries. The medical term, atherosclerosis, is the result of cholesterol and fat buildup in the vessels, which causes plaque. It can lead to coronary artery disease, heart attack, and stroke. When it comes to sneezing, many people think your heart stops for a minute or so. During a sneeze, a momentary change in the pressure in your chest may affect blood flow but your heart doesn't stop when you sneeze. That doesn't mean you should stop saying "bless you" or "gesundheit" after a sneeze, though. It's only polite! And lastly, despite the name,

your heart doesn't stop during heart failure either. It just can't pump blood as effectively as it should. The only time the heart stops is during cardiac arrest.
